## GVHC Will Poll Members on Dogs; Plan Quarterly Meeting Elections

A mail referendum on dogs and cats was authorized by the Greenbelt Veteran Housing Corporation board of directors at last Friday's regular meeting. Post-card questionnaires will be sent to all GVHC members in the next few weeks.

The purpose of the referendum is to determine the extent to which members approve the current ban on dogs and cats contained in the mutual ownership contract. The board is also desirous of knowing to what extent the membership would approve such drastic action as terminating a member's contract in the event a member refuses to dispose of a dog or cat after being given fair warning.

### Quarterly Meeting

In preparation for the quarterly membership meeting on Monday, May 13, the board approved the printing of a ballot for the election of two members of the audit committee and five members of the nominations and elections committee. GVHC manager John O. Walker expressed a desire that the names of all nominees be turned in a week before the election so that they could appear on the ballot. The board also expressed a hope that the number of candidates would exceed the number of positions available.

The board also approved submitting to the membership a by-law change permitting the corporation to invest reserve funds not needed for taxes or insurance in treasury bills, notes, and direct obligations of the Federal government. At present the board is restricted to the keeping of reserve funds in savings and checking accounts in insured banks. Walker pointed out that because amounts in excess of the first \$10,000 are not completely protected in insured banks, it would be advisable if GVHC invested part of its reserves in guaranteed Federal securities.

## McDonald Scores Rescue Squad Chief On 'Missing Call' in Hanging Case

Conflict between the Greenbelt Rescue Squad and city manager Charles McDonald over last week's ambulance call grew more bitter when the city council, at its regular meeting on Monday, April 15, heard a letter from the Rescue Squad signed by Joseph D'Agostino, chief of the organization.

D'Agostino took the city office to task for not properly handling the telephone call requesting an ambulance be sent to the Wertz home at 13-U Hillside where ten-year old Richard had accidentally hung himself. The letter, pointing out that a tragedy might have occurred, asked that prompt attention be given such calls. (The boy is recovering from the accident.)

McDonald, declaring that the letter virtually accused the city of neglect of duty, vigorously denied that any call had been received from Miss Mary Wertz, Richard's 18-year old sister, who has said she made the call and that it was answered "city office." The city manager said he was very much disturbed by the charge, which he considers "a serious matter."

Mayor Thomas Canning agreed with the manager that it was hard to conceive that such a call would be brushed off. McDonald said he felt reasonably sure that the call was not received since the girl at the switchboard habitually informs him when an ambulance call is received. She notified him when the call came in later, through the county fire board. Neither McDonald nor Canning questioned that Mary Wertz actually placed the call and assume that she was questioned with the wrong party. The city manager noted that the Rescue Squad made no attempt to check with the city office directly as to whether it received the call.

## Swim Pool Rates Up But Kids Pay Same

The rates for the Greenbelt swimming pool were raised slightly by the city council at its regular meeting on Monday, April 15, in order to provide funds for the maintenance and repair of the pool. The sum of \$1300 is to be spent immediately on urgent repairs.

All rates for the pool were raised five cents except the charge for Greenbelt children between the ages of six and twelve, for which the charge remains at ten cents. The new rates are as follows: Greenbelt residents—adults, 50 cents; ages 16-21, 30 cents; ages 12-16, 20 cents; ages 6-12, 10 cents. Non-residents pay the following fees—adults, 80 cents; 16-21, 55 cents; 12-16, 30 cents; and ages 6-12, 30 cents.

Under six years of age there is no charge when the child is accompanied by an adult. The family rate of 50 cents after six p.m. was not changed.

## 'Great Books' Leaders Training Course Open

The annual leader-training course for Great Books discussion group leaders will be held for interested persons in the Washington area, beginning Monday, April 15, at 7:45 p.m. The course, consisting of one session each Monday for six weeks, will be given at the Cleveland Park Branch Library, Connecticut Avenue at Macomb Street, N.W. There is no fee. Its purpose is to train adults in the techniques of effective group discussion so that this leadership will be available for Great Books discussion groups in the Washington area and surrounding suburbs. Currently there are twenty-two such Great Books groups which meet regularly every two weeks to discuss one of the great books of our civilization.

The leader-training sessions are conducted by staff members of the Great Books Foundation, a non-profit organization whose program is designed to foster liberal education for adults through group discussion of good books dealing with the basic problems of mankind.

The program is community sponsored in cooperation with the Foundation. In the District of Columbia the adult education division of the public library acts as a major co-sponsor, and in the suburbs other similar community organizations—libraries, churches and club groups—perform the same function.

The service will start with a trumpet prelude. The Branchville Methodist youth choir will sing. Other young people will lead in the call to worship, prayer, choral reading "On Easter Morning" from the book of John, chapter 20, and a dramatic presentation from the "Diary of Mary" and "Thomas."

**Money order service** - Sale of money orders to the public will be discontinued effective April 29, 1957.

## 'Non-Critical' Council Report Sets New Procedures for Juvenile Cases

After meeting for a total of six sessions as a special committee, the city council at its regular meeting on Monday, April 15, presented its final report on the keeping of juvenile police records as well as other records regarding citizens where no formal complaint has been issued.

The report lists six recommendations, which mayor Thomas Canning said do not reflect criticism on the handling of police records in the past but were made in the interest of tighter control of juvenile records. The report reveals that a number of citizens appeared before the special council committee in response to a call from the council for those who may have felt themselves "aggrieved as a result of the use of police records." However, the report does not indicate the nature of their grievances. The report also does not state to what extent the new procedures differ from those previously in use.

Counsel and recommendations were received by the council from Judge Grover L. Small of the County Juvenile Court and Major George J. Panagoulis, chief of the county police department and former head of the Greenbelt police. Major Panagoulis confirmed city manager Charles McDonald's statement that the complaint and investigative records of the Greenbelt police department conform to Federal Bureau of Investigation standards for small police departments.

The complete text of the report follows:

At the regular meeting of February 4, 1957, Council moved, empowering the mayor to appoint a committee consisting of the entire Council to investigate "the type of records being kept by the City police for use in proceedings in the juvenile court, including the methods and procedures used in the formulation of such information, including further the type of records being maintained by the City with respect to any citizen where no formal complaint is issued and to determine whether such records and documents conform to any lawful purpose."

The Council committee met on February 7, 14, 21 and 28, April 1 and April 8. At the invitation of the Committee, Judge Grover L. Small of the County Juvenile Court and Major George J. Panagoulis, of the County Police Department, appeared to give counsel and recommendations for the Committee's guidance.

The committee in formulating hearing procedures, agreed to limit discussion by those appearing before the committee to police records and their usage. During the hearing various residents of the community, responding to a public notice from the committee soliciting the appearance of citizens feeling themselves or their family members aggrieved as a result of the use of police records, appeared before the special committee. These citizens discussed with the committee incidents of which they and/or members of their families had personal knowledge concerning the use of such records and related matters. The experience and views which they related proved especially helpful to the committee in determining whether administrative changes were necessary to provide more adequate safeguards for individuals while permitting the necessary freedom of action to the authorities.

In the course of its investigation, the committee examined the complaint forms used and discussed with the City Manager the procedures by which entries are made, and the usage made of the records thus prepared, both in a general manner and as regards specific instances.

At the request of various members of the committee, complaint records were extracted from the files and their contents read to the Committee. This procedure was employed, also at the request of the citizens who appeared before the Committee.

As reported to the Committee by the City Manager, and corroborated by the former Director of Public Safety, Major Panagoulis, in whose administration the present system was initiated, the complaint and investigative records of the Greenbelt Police Department conform generally to the system recommended and approved by the Federal Bureau of Investigation for small police departments.

On the basis of its studies, the Committee makes the following recommendations:

1. That complaints involving juveniles need greater administrative control and direction, characterized by wisdom, prudence and good judgment.
2. That all records concerning juveniles shall be kept in a locked file in the custody of the chief of police, shall be confidential, and are not to be removed therefrom.
3. That no juvenile complaints shall be retained in the file for a period of longer than two years from the date of the first complaint, unless there are additional complaints within that period tending to establish a pattern of delinquent behavior.
4. That the chief of police shall be solely responsible for the review and disposition of each juvenile complaint except that cases which include prepared statements by Greenbelt Police to be used in Court shall be reviewed and approved by the City Manager prior to presentation in Court.
5. That immediately after a juvenile is apprehended by the police, the officer shall without failure notify the parents or guardian in the following manner: Where possible, by telephone or in person, and where this procedure fails, by registered mail. Such notification shall include the following: (1) nature of the complaint, (2) date of complaint, (3) disposition of complaint. The monthly report of activities of the Department of Public Safety shall include the total number of registered letters addressed to the parents or guardians of such juveniles.
6. Whenever complaints are made to the Greenbelt Police Department involving juveniles, whether or not petitions or releases are involved, these complaints shall be used only for investigative work in the Greenbelt Police Department and are not to be taken from the files or used as such as supporting evidence in any juvenile court case.

In conclusion it is expected that full cooperation with the juvenile court and probation officers shall continue as in the past in cases coming before the juvenile court.

### Beware of Phonies

Door-to-door solicitors implying they represent Veterans Administration or have VA endorsement for a product are acting without sanction of VA.

The statement was issued today by Dr. Edwin J. Rose, manager of Mount Alto VA Hospital in Washington, and V. S. Garrett, manager of the Veterans Benefits Office, which operates the VA medical clinic in the Munitions Building on Constitution Avenue.

Dr. Rose said he has received inquiries from individuals and groups seeking verification of verbal statements made by agents soliciting subscriptions or funds, or selling products on behalf of veterans.

"VA does not endorse any product, project or commercial endeavor for the profit of individuals, organizations, or corporations," Dr. Rose said.

### Dogs, Dogs, Dogs

Because of the many inquiries received regarding the city's authority to control dogs in Greenbelt, the NEWS REVIEW, in the public interest, is reprinting the existing ordinance on this subject.

#### AN ORDINANCE FOR THE CONTROL OF DOGS WITHIN THE CITY OF GREENBELT, MARYLAND Ordinance No. 154

BE IT ORDAINED, by the Council of the City of Greenbelt, Maryland, that it shall be unlawful for any dog to be allowed to run at large or be in any public place or area within the City of Greenbelt, Maryland, unless said dog is muzzled, is on a leash, and is under the control of a responsible person; and

BE IT FURTHER ORDAINED, that any owner or other person who owns, has control of, or is in possession of a dog which is permitted to run at large or be in any public place or area within the City of Greenbelt without being muzzled, on a leash and under the control of a responsible person shall, upon conviction, be deemed guilty of a misdemeanor and shall be fined not less than Two (\$2.00) Dollars and not more than Twenty-five (\$25.00) Dollars for each separate offense; and

BE IT FURTHER ORDAINED, that any dog found running at large and in violation of this ordinance may be apprehended and disposed of by the police in order to protect the public health and safety of the residents of the City of Greenbelt; and

BE IT FURTHER ORDAINED, that in apprehending and disposing of any such dogs the police shall use such methods as may be necessary for their own safety and the safety of the public.
