### Parade - 11 A.M., Fireworks - 10 P.M., All-Day Carnival Set for Fourth

A day-long program of festivities, beginning with a parade at 11 a.m. sharp and ending with fireworks at the Lake at 10 p.m., will mark the annual Greenbelt Fourth of July celebration this Thursday. During the day there will be a carnival at the Lake featuring games, kiddie rides, food and refreshments. The entire program is under the sponsorship of the Greenbelt Volunteer Fire Department and Rescue Squad.

There will be 14 trophies awarded for the various entries in the parade, which will form on Southway below Ridge and proceed to Centerway, then along Crescent to the Lake. Heading the parade judges is Harry C. "Curly" Byrd. President Emeritus of the University of Maryland. Parade marshal is Sergeant Austin Green of the Greenbelt Police Department.

The trophies will include awards for the best appearing fire company, pumper, rescue truck, ambulance, ladies auxiliary, marching unit, civic float, horse drawn unit, and best decorated bike (for youngsters). There will also be four awards for senior and junior majorettes.

There will be a special program at the Lake beginning at 1 nm., with Reverend Donald N. McKenzie, minister of the Community Church serving as master of ceremonies. "Curly" Byrd will be the featured speaker.

Throughout the afternoon and athletic contests are scheduled to be conducted by Warren Leddick, recreation director, The Fire Dept. and Rescue Squad will also put on demonstrations and displays. The fireworks display. s'ated for 10 p.m., a later hour than usual, is promised to be bigger than previous displays.

### City Elections; How to Vote

The election for a City Council will be held September 17, 1957. To be eligible to vote in the election, a person must be registered in the city's books. To be registered for County, State, and National elections does not qualify a person to vote in the City election. If a person has registered once for the City election and has voted in one of the last two elections (1955-1953) it is not necessary to register again.

To be eligible to register to vote a person must be a citizen of the United States, at least 21 years of age, of sound mind, a resident of the City of Greenbelt for at least six months and of the State of Maryland for one year immediately preceding the

Any person who is eligible to register to vote in the city election but is NOT registered may do so between the hours of 9:30 a.m. and 4 p.m., Monday through Friday at the City Clerk's

The last day for registering is 4 p.m., Monday, August 19, 1957. Any person interested in being a candidate for Council may procure petition forms from the City Clerk.

### **County Civil Defense** Gets AEC License

"Pursuant to the Atomic Energy Act the Prince Georges County Civil Defense Agency has been granted an A.E.C. license to use byproduct material," Civil Defense Director R. Hal Silvers announced.

"The byproduct material will be specifically used in the training of Radiological Defense Monitors and in the calibration of instruments," Silvers said. He also pointed out out that "the maximum amount of radioactivity which this Agency will possess at any one time will be thirty (30) millicuries and further each source will be sealed (capsule form) and will have permanently attached to it a durable, legible and visible tag-clearing identifying the product".

"The byproduct material to be used for training will be under the strict supervision of the Prince Georges County Civil Defense RA-DIAC CHIEF who is well trained in this field." He is a graduate of usetts Institute of Technology and the training program inaugurated last year by the County Civil Defense Agency has already produced an umber of civil defense personnel during its training sessions held at the University of Maryland.

'Radioactive materials will be safely secured in a vaul and every safety precaution will be taken to protect personnel," Silvers assured.

The board had received complaints that plumbers were charging \$50 or more for the additional venting on the grounds that it was rejuired by the WSSC code. GVHC spokesmen now state that this is a mistaken notion and that any plumbers who insist upon such venting should be referred to the GVHC maintenance office.

"However," Walker said, "WSSC does require that where the kitchen sink waste line goes through the floor beneath the sink, a nonsiphoning type of sink trap should be installed in place of the existing type trap. This is only a problem for the brick houses, since the non-siphoning type of trap had not been developed at the time original Greenbelt was constructed. With the frame houses, no change would be necessary in the type of sink trap used.'

It is estimated that the nonsiphoning type of sink trap should cost about \$15.

Fire Siren

The board heard a plea from Charles Helwig, 2-G Research, to reconsider its decision granting permission to erect an auxiliary fire siren on top of the heating plant opposite 3 court of Research. Helwig stated that he was sure there must be other sports in North End where a fire siren would disturb fewer people than the location approved. He suggested the North End School, the water tower, or even an especially erected tower in the woods. "The location chosen," said Helwig, "is about 150 to 250 ft within the heavily populated 2 court of Research with its 12 families."

Director Bruce Bowman stated that the Greenbelt Volunteer Fire Department and Rescue Squad had' petitioned the Board of Education unsuccessfully for permission to install a siren on the North End School. While the principal approved, the Board of Education, according to Bowman, turned the proposal down because of the fear a siren would excite the children and make them unmanageable. However, Bowman thought that if the school trustees and PTA make a strong case for the siren, the Board of Education might reconsider its decision.

As for a siren on the water tower or on a specially built tower in the woods, GVHC president Ed Burgoon doubted that such a siren would be effective because its blast would be muffled by the woods.

Burgoon pointed out that the North End siren would be low pitch and would not be used after 11 p.m. except for extreme emergencies, involving fire calls. It would not be used for ambulance calls, as the Rescue Squad has specific men assigned for duty each

Burgoon also held out the hope that the auxiliary siren may be only a stop-gap measure, since the Fire Department has plans for eventually contacting its members directly through its own phone system.

Walker announced that arrangements are being made with a local building supply house for GVHC members to purchase high-grade aluminum screen-storm doors at practically builder's prices. Details will be published in the corporation's News Letter. Director Peacy Andros also announced that negotiations are proceeding with a large distributor for obtaining electrical appliances at discount prices.

Burgoon distributed to board members an architect's plans for the renovation of the newly-purchased North End store and adjacent property. After the board members have had a chance to study the plans, Burgoon stated, a special meeting will be called.

The board voted to appropriate \$25 as its contribution to the Labor Day Festival. The money will be used for the purchase of two tre-
