## Festival **Contest Starts**

Entries are now being accepted for the annual Popularity Contest, which is one of the highlights of the Greenbelt Festival held over the Labor Day weekend. All civic organizations and business establishments have been invited by Festival officials to enter a girl to represent them in the contest.

Contestants must be unmarried girls between the ages of 16 and 25 as of August 31. Previous first place winners are not eligible. All entries must be in by midnight, August 19, in order to provide equal publicity for all contestants.

The contestant with the largest number of votes at 11 p.m. on Sepember 1 is crowned Queen of the Festival, receives a Queen's Trophy, rides in the Labor Day parade, and is honored at the "Dance of the Queen" held later in September. The second and third place winners are awarded Princesses' Trophies.

Votes are credited to each girl at the rate of one vote per penny. However, each penny contributed prior to 9 p.m. on August 12 will be counted as two votes. Similarly organizations which submit entries prior to that time, which must be accompanied by a \$10 fee, will start off their candidate with 2000 votes rather than 1000 votes.

All funds collected in the Popularity Contest go into the Festival Youth Center fund.

### Fisher, O'Loughlin Run for City Council

Two more candidates have filed nomination petitions for the forthcoming City Council election. They are Mrs. Rita Fisher, 2-H Gardenway, and Joseph O'Laughlin, 11-R Laurel Hill. They are the first candidates who are not incumbents on the present board.

Other candidates have until August 19 to file their petitions. August 19 is also the deadline for registering to vote for the council. According to Marilyn Spitz, city clerk, 73 persons have registered since July 16. They join the more than 1,100 qualified voters on the permanent registration list.

Rita Fisher Rita Sue Fisher, a native of New York, has been a resident of Greenbelt for seven years. She resides with her husband Victor and her four daughters, Natalee, Vicki, Mindy, and Lori, at 2-H Gardenway.

An active Greenbelt citizen, she has been a staff member of the Greenbelt News Review for about six years. In the past she served for two years as a Girl Scout Leader. She has also held executive positions with the Women's Society of Christian Service of the Greenbelt Methodist Church and the Lodies Auxiliary to the Greenbelt Volunteer Fire Department and Rescue Squad. She is also Secretary to the Greenbelt Businessmen's Association and the Greenbelt Democratic Club.

Mrs. Fisher is currently employed by the Hyattsville Telephone Answering Service which is also known as the Prince Georges Medical Bureau.

In a statement to the News Review, Mrs. Fisher commented that she is suspending many of her activities in order to concentrate on her candidacy for City Council.

City manager Giese was directed to prepare clarifying language so that the council could take action at its next meeting on August 19.

Election officials The council decided to expand the number of election clerks from 5 to 7. Appointed were Evelyn Barcus, Marion Moraz, Ada Snyder, Belva Weisel, Shirley Clute, and Margaret A. Feeney. A seventh clerk will be appointed later. Mae Zoellner was appointed judge of election. Rate of pay was determined as \$30 for the judge and \$25 for the clerks.

#### Personnel Plan

The council adopted for first reading an ordinance establishing a personnel system for the city. This ordinance consolidates and revises all the personnel regulations of the city. The ordinance was first drafted by the Maryland Technical Advisory Service and reviewed and revised extensively by the City Manager, the Personnel Board, and the city council. An ad hoc committee consisting of Bill Hoff, Bordenet, and Al Herling reviewed the document.

The ordinance, consisting of 20 sections, defines the role of the city manager, the city council, the Employee Relations Board, and the Personnel Advisory Board in matters of personnel administration and policy. It also defines the manner and kinds of appointments to city service, holidays, annual leave, sick leave, and other fringe

benefits. The ordinance further defines causes for disciplinary action and procedures for establishing and maintaining a compensation plan and a position classification plan for the city.

#### Planning Board

council appointed Cyril Kovalchik, 4-F Hillside, to the vacancy on the Advisory Planning Board caused by the death of Charles M. Cormack. His term will run to October 1965. Kovalchik is an elementary school principal and has had planning experience in connection with school and county matters. He was nominated by Goldfaden and there were no other nominations.

Mayor White noted that another vacancy on the APB would be created by the resignation of Bernard Sisco. He put into nomination Mrs. Velma Chapman, 35 Ridge. and asked the council to submit other nominations by the next meeting. Mrs. Chapman has been active in GHI committees.

#### Boxwood

The council accepted an agreement with Charles Bresler, developer of Boxwood Village, for the conveyance of 9 acres in fee simple to the city. This strip of land lies between Boxwood and Lakewood subdivisions. The council asked that the agreement with Bresler regarding the pavement of Ridge road be drawn up and signed before the city recommends approval of Bresler's zoning request, to the county commissioners.

Swimming Pool

The council postponed final action on the ordinance providing for a swimming pool reconstruction bond issue in order to get the views of the Recreation Advisory Board. A tentative meeting of council to consider final passage was scheduled for next Monday.

#### STREET RENAMING

To the Editor:

Several weeks ago the News Review wrote of a proposed change in the name of a street, in a new development being planned in Greenbelt. At that time, this development was the center of a zoning controversy, and the proposed new name was that of a serving county commissioner, well respected citizen of Greenbelt.

I would like here to cast my vote against such a name switch. Assuming all parties act in good faith, it is still almost inevitable that such a renaming will cause speculations and rumors. In a city such as ours, hearsay has a persistence matched by few documented facts, and the new name will serve it as a constant reminder. If indeed we wish to honor a deserving person, let this be done in a manner free from any controversy.

There is, however, one renaming which, it seems, would be very timely. As announced in the News Review (June 27, 1963), the Goddard Space Flight Center is now being incorporated in the city of Greenbelt. It would be altogether fitting and proper to mark this event by naming one of the city's streets after the pioneer of the space age whose name the center bears. Almost singlehandedly. Dr. Goddard had developed and tested in the period between the two world wars, those principles of rocket flight which now help in putting Americans in orbit and on the moon and in making the name Goddard Space Flight Center, Greenbelt, Maryland familiar to scientists all over the world.

The road leading to the Space Flight Center, Glenn Dale road, is presently being converted into a 4-lane divided highway. When this work is finished, let it be rededicated to honor the name of Robert H. Goddard. David P. Stern

RESOLUTION

TO AMEND THE GREENBELT CITY CHARTER, SECTION 731-A (P.L.L. 1953) TO PROVIDE FOR THE ESTABLISHMENT OF AN EMPLOYEE RELATIONS BOARD IN PLACE OF A PERSONNEL

RESOLUTION NO. 35

BE IT RESOLVED AND ORDAINED that Section 731-A of the Charter of the City of Greenbelt, Maryland (P.L.L. 1953) shall be amended as follows (Added material is capitalized; deleted material is (bold face):

731-A. (Personnel Board) EMPLOYEE RELATIONS BOARD-

Appointment, Removal, Duties. There shall be a (Personnel Board) AN EMPLOYEE RELATIONS BOARD consisting of (five) THREE members who shall be appointed by the Council. The Council shall designate one of the (five) MEMBERS as chairman. Members of the (Personnel Board) EMPLOYEE

RELATIONS BOARD shall serve for a term of (six) THREE years, except that of the members first appointed: One shall be appointed for (six) THREE years, one shall be appointed for (five) TWO years; AND one shall be appointed for (four years) ONE YEAR. (one shall be appointed for three years; and one for two years.) Vacancies in an unexpired term shall be filled by the Council by appointment for the remainder of the term. A membr of the Board may be removed by Council for cause only and after being given a written statement of the charges against him and a public hearing on the charges if he so requests. A certified copy of the charges and a transcript of the record shall be filed with the City Manager. No member of the (Personnel Board) EMPLOYEE RELATIONS BOARD shall hold any other elective or appointive office in the city government. Members of the Board must be residents of, and residing in, the City

The Board shall have power and shall be required to:

(1) Advise the Council and Manager on problems concerning

personnel administration. (2) During the months of January and February make any study which it may consider desirable concerning the administration of personnel in the municipal service, and report to the City Manager and the Council on or before March 10 its findings, conclusions and recommendations.

(3) Perform such other duties with reference to personnel administration, not inconsistent with this charter, as the Council may specify by ordinance or resolution.

(4) The Board shall have the power to establish, amend, repeal,

or add to rules on its own initiative governing its operation, but such rules shall be in conformity with this charter. (5) Conduct hearings, public or private, if requested by the employee, in accordance with this charter and its own rules an appeals filed under the provision of Section 754 of this charter

(1) CONDUCT HEARINGS, PUBLIC OR PRIVATE, IF REQUESTED BY THE EMPLOYEE, IN ACCORDANCE WITH THE PROVISIONS OF SECTION 754 OF THIS CHARTER AS AMENDED.

(2) HEAR GRIEVANCE COMPLAINTS ARISING OUT OF UN-OR OPPRESSIVE TREATMENT OR WORKING CONDITIONS OR ANY REPRISAL ARISING OUT OF ANY GRIEVANCE COMPLAINT OR TESTIMONY BEFORE THE EMPLOYEE RELATIONS BOARD AND TO MAKE FIND-INGS AND RECOMMENDATIONS THEREON.

(3) REVIEW PERSONNEL POLICIES AND PRACTICES AS THEY RELATE TO GRIEVANCES BROUGHT BEFORE THIS BOARD AND TO MAKE RECOMMENDATION THE COUNCIL AND MANAGER FOR THE PURPOSE OF PREVENTING GRIEVANCES FROM ARISING.

IN AN APPEAL FROM A DISMISSAL ACTION; CALL WITNESSES AND COMPEL THE TESTIMONY OF OFFICERS AND EMPLOYEES OF THE CITY AND TO REQUIRE THEM TO SUBSCRIBE TESTIMONY AND MAKE OATH OR AFFIRMATION THERETO BEFORE A PERSON AUTHORIZED TO ADMINISTER OATHS UNDER PENALTY OF DISMISSAL.

BE IT RESOLVED AND ORDAINED that Section 754 of the Charter of the City of Greenbelt, Maryland, (P.L.L. 1953) shall be amended as follows (Added material is capitalized; deleted material is (bold face):

754 Responsibility of Manager-Power of appointment and Removal. The City Manager shall be responsible to the Council for the proper administration of all affairs of the city placed in his charge, and to that end he shall have the power to appoint and remove all Cont'd. Page 4

officers and employees except the City Solicitor who shall be appointed or removed only with the consent of the Council; provided, however, (except for the City Solicitor,) the City Manager shall place the charge which motivated his action to reduce, remove, or suspend an employee HOLDING A POSITION IN THE CLASSIFIED SERVICE in writing, (serving copies upon the aggrieved employee and the Personnel Board, including a copy of this section to said employee or employees) AND SHALL SERVE A COPY UPON SUCH EMPLOYEE TOGETHER WITH A COPY OF THIS SECTION. If the (aggrieved) employee desires to appeal, he shall in writing within 15 days of notice of such reduction, removal or suspension, request a hearing and mail

or deliver such a request to the City Clerk. Unless an appeal is filed with the City Clerk by (an aggrieved party) AN EMPLOYEE within 15 days OF RECEIVING NOTICE OF REDUCTION, REMOVAL, OR SUSPENSION, the decision of the City Manager to suspend, reduce, or to remove shall become final. If an appeal is filed timely, THE CITY CLERK SHALL MAIL OR DELIVER COPIES OF THE APPEAL TO THE EMPLOYEE RELATIONS BOARD AND THE CITY MANAGER WITHIN 24 HOURS OF RECEIPT. THE CITY MANAGER, UPON RECEIPT OF A COPY OF THE APPEAL SHALL IMMEDIATELY MAIL OR DE-LIVER COPIES OF THE CHARGE WHICH MOTIVATED HIS ACTION TO REDUCE, REMOVE OR SUSPEND THE EMPLOYEE TO THE EMPLOYEE RELATIONS BOARD. THE (the Personnel Board) EMPLOYEE RELATIONS BOARD shall fix a date for hearing within 30 days after the request is filed with the City Clerk. The (aggrieved) SUSPENDED, REMOVED OR REDUCED employee shall have a right to counsel and to ask for a public or private hearing. The burden of proof shall rest with the City Manager who shall be furnished the service of the City Solicitor. The suspended, removed, or reduced employee shall have the right to present testimony and other evidence, call witnesses, including city employees, and the right of crossexamination. Within 15 days of the final day of the hearing on appeal, the (Personal Board) EMPLOYEE RELATIONS BOARD shall render its decision in writing and such decision shall stand as the decision of the City of Greenbelt.

Appointments made by the City Manager shall be on the basis of executive and administrative ability and of the training and experience of such appointees in the work which they are to perform and no discrimination shall be made because of political or religious opinions or affiliations. All such appointments shall be without definite terms (unless) EXCEPT for PROBATIONARY, provisional, temporary or emergency service

RESOLUTION

TO AMEND THE GREENBELT CITY CHARTER, SECTION 760 (P.L.L. 1953) TO PROVIDE FOR A CLASSIFIED SERVICE FOR CITY EMPLOYEES

RESOLUTION NO. 36
BE IT RESOLVED AND ORDAINED that Section 760 of the Charter of the City of Greenbelt, Maryland (P.L.L. 1953) shall be amended as follows (Added material is capitalized, deleted material is (bold face):

Sec. 760. Administrative Departments — (Compensation) CLASSI\_FIED SERVICE.

(a) The administrative branches of the city government established by this charter are the offices of the City Clerk, and City Solicitor the departments of finance, and of public safety, but any other offices or departments may be established by ordinance. The Council may by ordinance provide that any or all offices or departments may be combined subject to separation, whenever, in the opinion of the Council, the conduct of the business of the city shall so require. The City

Manager may hold any office or combination of offices.

(b) The Council may change or abolish any office or department established by ordinance and may prescribe, distribute, or discontinue the functions and duties of offices and departments so established. Additional functions and duties may be assigned by ordinance to offices and departments established by this charter but no function or duty assigned by this charter to a specific office or department shall be discontinued or assigned to any other office or department by ordinance. (The Council shall classify all persons employed by the city and establish a schedule of uniform compensation rates for like services with maxima and minima for each class of positions. Subject to such schedule, the City Manager shall fix the compensation of all such employees on the basis of efficiency and seniority.)

(C) ALL OFFICES AND POSITIONS OF THE CITY ARE DIVIDED INTO THE CLASSIFIED SERVICE AND THE EXEMPT

SERVICE. THE EXEMPT SERVICE SHALL INCLUDE THE FOLLOWING:

- (1) ALL ELECTED OFFICIALS AND MEMBERS OF BOARDS AND COMMISSIONS.
- (2) THE CITY MANAGER AND THE CITY SOLICITOR (3) VOLUNTEER PERSONNEL AND PERSONNEL APPOINT-ED TO SERVE WITHOUT PAY. (4) CONSULTANTS AND COUNSEL RENDERING TEMPOR-
- ARY PROFESSIONAL SERVICE. (5) TEMPORARY, SEASONAL, PROVISIONAL, EMERGENCY SERVICE OR PART-TIME EMPLOYEES NOT SPECIFI-

CALLY INCLUDED IN THE CLASSIFIED SERVICE BY ACTION OF COUNCIL. THE CLASSIFIED SERVICE SHALL INCLUDE ALL OTHER POSITIONS IN THE CITY SERVICE. ALL PERSONS HOLDING

POSITIONS INCLUDED IN THE CLASSIFED SERVICE SHALL HAVE PERMANENT STATUS UPON COMPLETION OF A PROBA-TIONARY PERIOD.

(d) THE CITY MANAGER SHALL MAKE AN ANALYSIS OF THE DUTIES AND RESPONSIBILITIES OF ALL POSITIONS IN THE CLASSIFIED SERVICE AND HE SHALL RECOMMEND A POSITION CLASSIFICATION PLAN TO THE COUNCIL. THE COUNCIL SHALL THEREAFTER APPROVE A CLASSIFICATION PLAN. UPON RECOMMENDATION OF THE CITY MANAGER AND WITH THE APPROVAL OF THE COUNCIL, THE CLASSIFICATION PLAN SHALL BE REVISED FROM TIME TO TIME AS CHANGING CONDITIONS REQUIRE.

(e) THE CITY MANAGER SHALL RECOMMEND A PAY PLAN (e) THE CITY MANAGER SHALL RECOMMEND A PAY PLAN TO THE COUNCIL. THE COUNCIL SHALL THEREAFTER APPROVE A PAY PLAN. THE RATES OF PAY SHALL BE BASED ON THE PRINCIPLE OF EQUAL PAY FOR EQUAL WORK AND VARIATIONS IN RATES OF PAY SHALL BE IN PROPORTION TO SUBSTANTIAL DIFFERENCES IN THE DIFFICULTY RESPONSIBILITY, AND QUALIFICATION REQUIREMENTS OF THE WORK PERFORMED. THE PAY PLAN SHALL INCLUDE A WORK PERFORMED. THE PAY PLAN SHALL INCLUDE A MINIMUM AND MAXIMUM AND SUCH INTERMEDIATE RATES AS MAY BE DESIRABLE FOR EACH POSITION. SUBJECT TO SUCH SCHEDULE THE PAY OF EMPLOYEES SHALL BE DETERMINED ON THE BASIS OF EFFICIENCY AND LENGTH OF SERVICE. THE PAY PLAN MAY BE AMENDED FROM TIME TO TIME AS CIRCUMSTANCES REQUIRE.

(f) The City Manager may, subject to appropriate adjustment in scheduled compensation, permit any employee in the classified service to accept other employment not inconsistent with his duties and to receive compensation for such employment.
