Council Fights New Petition By Stidham Tire For C-2 Zoning

Sharp reaction to news that a C-2 (general commercial) zoning was being considered for the tract opposite the Greenbelt Junior High School at hearings conducted by the county commissioners was voiced at the special meeting of council on Monday,

The site at Kenilworth and Edmonston rds, had been requested for an I-1 (light industry) classification by Stidham Tire Company last spring. The company had in mind a recapping plant. The previous council turned down the Stidham request after receiving an adverse report from the old Advisory Planning Board. The Maryland National Capital and Park Planning Board had also recommended denial to the county commissioners.

City manager James Giese reported that at the November 20 hearings held by the county commissioners, Stidham representatives indicated that it would be satisfied with a C-2 zoning instead of I-1. The area is presently zoned R-R (rural residential). They did not feel that its recapping operations really warranted an I-1 zoning.

The county commissioners asked Giese whether the city council could consider a C-2 zoning, and make its recommendations. The hearings were suspended until November 26 in order to get the council's views.

The council was unanimous in its opposition to the C-2 zoning. Only the previous week it had concurred with the MNCPPC's recommendation, already transmitted to the county board, that the site be zoned C-O (professional offices.)

A motion by Councilman Bernstein was passed, to the effect that the County Commissioners be advised that the city vigorously opposes any more rezoning of Greenbelt's land for C-2 or I-1; C-O would, however, be acceptable in certain areas, following recommendations of the Park and Planning

Intersection

Manager Giese briefed the council on the two plans which exist at present for the relocation of Crescent and Ridge Roads, near Kenilworth. The State Roads Commission plan would have Ridge, Crescent and Edmonston come together just east of Kenilworth, and the single road so formed would intersect with Kenilworth. The Maryland National Capital Park and Planning Commission objects to this plan because of the number of intersections so close to each other; it has proposed separate intersections of Ridge and Crescent with Kenilworth.

The Park and Planning Commission's proposal was judged by the manager and the council to be more desirable from the city's point of view. However this raised questions of acquisition of right of way, maintenance of the roads, and other practical matters that everyone agreed could only be settled by more discussions with the representatives of both commissions. Mayor Smith voiced concern especially on the question of who would shoulder the costs involved. A motion by Bernstein was passed (4-1) to have the manager advise both Commissions, at this time, that the city is in favor of the MNCPPC plan, or any modification of it that would take care of future traffic

Community Goals

The master plan of community objectives, which has been drawn up during the last year by the Advisory Planning Board, was considered next, point by point. Bernstein, assisted by Councilman Simonson, discussed the significance of each item; these two councilmen served on the Board at the time the master plan was drawn up. The plan, which has been published in a recent issue of the News Review, consists of 35 separate points, under seven headings: character of the community, land use, fiscal, health and sanitation, traffic and safety, education, and recreation. A great majority (32) of the points were accepted by unanimous passage of motions. Items 2 and 7 were provisionally accepted, with the latter altered to include the words "planned" and cooperatively owned" to the objective "To preserve and develop to the maximum individually-owned homes or apartments rather than rentals."

A mild objection was also registered by former city manager Charles T. McDonald, in behalf of apartment dwellers; he, as well as councilman Hoff, said it wasn't fair to say that " rental" people don't make good citizens. Bernstein explained that this inference was not intended by item 7, but that the goal was to develop the ownership interest in the com-

Item 9, giving a population maximum for the city, was also referred back to the APB for a realistic figure. George Neumann spoke from the floor to have the objectives include an item on minimizing city tax. Bernstein moved to recommend that the APB frame such an item, under the "Fiscal" head-

In general, the listed community objectives were very favorably received.

Public Hearing on Human Relations Board Attracts Heavy Turnout

The city council at its regular meeting Monday night, forced by the unusually large attendance to adjourn to the Youth Center, heard the views of citizens on the proposal by the Greenbelt Citizens for Fair Housing that council establish a Human Relations Advisory Board. After more than two hours of discussion, council voted unanimously to take the matter under advisement for further consideration.

The Fair Housing group at the last council meeting had petitioned for the setting up of such a Board on the grounds that "Negro families may want to move here in the near future." It further stated that a Human Relations Advisory Board would "provide a means to insure that the transition will be as smooth and as peaceful as possible."

The chief topic of discussion was a circular distributed over the weekend by the Greenbelt Civic Association commenting on a plan which had been submitted to council by a representative of the Fair Housing group along with the petition. The Civic Association in its circular stated that it was concerned because the plan proposed that the Board should consider "all matters of inter-racial, interreligious, international, inter-sex or inter-class matters." Another strong objection by the Civic Association was that the document said that the Board should "have the authority to require the parties concerned to comply with the fairest solution as arrived at by the Board by a majority vote."

Document Unofficial

Jan Turkiewiez of the Fair Housing organization explained at Mondays' meeting that the document had been prepared by two members of his organization as an informal document which was actually labeled "mark-up draft". This draft had not been presented to the Fair Housing membership for approval before being submitted to council. Councilman Lewis Bernstein commented that he had asked Turkiewiez for suggestions on the composition of the proposed Board, and Turkiewiez had then submitted the document.

In the light of this background, the question was raised whether the contents of the document was a proper subject for discussion in connection with the establishment of the Human Relations Advisory Board and whether the Greenbelt Civic Association should have commented publicly on this document.

Francis White, former Mayor of Greenbelt, speaking as a member of the board of directors of the Greenbelt Civic Association, stated that the plan was a matter of public record because it was presented at a public meeting, therefore, he maintained, the Civic Association had a right to express its opinion of the contents.

Mayor's Ruling

A ruling was asked on this point by Councilman Bernstein and Mayor Smith ruled that the document was public information. Council-Barnstein made a motion t overrule the Mayor, but the motion failed for lack of a second.

The citizenry of Greenbelt spent two hours voicing opinions or making statements which were pro, con, or impartial. Gordon Gemeny argued that Prince Georges County established a Human Relations Council a year ago and this group should suffice to serve the needs of Greenbelt.

Speaking in favor of the proposal, Bruce Bowman stated that other communities have already established Human Relations Boards within the county. He cited the cities of Easton and Salisbury which had such Boards and no apparent racial uprisings. Then he noted that the city of Cambridge did not have such a board and the upheaval there over the racial problem created much publicity.

John Gibson cited the fact that The slate of officers proposed by the County had an Advisory Planning Board and so did Greenbelt. He also stated that the County had an Advisory Personnel Board, and so did Greenbelt. Why not, he reasoned, couldn't Greenbelt have a Human Relations Advisory Board? even though the County had already established one?

APPARENT CONFUSION To the Editor:

At Monday's meeting of the City tirs that appeared in the News Review were read. These excerpts indicated confusion and contradiction regarding the attitude of Greenbelt Citizens for Fair Housing and its members to integration.

The letter signed by the organization in the issue of October 17th expresses the official position of GCFH. This letter said in part "We will neither solicit Negroes to buy homes in Greenbelt nor look for home owners who will sell to Negroes". At least two of the other letters quoted were individually written before GCHF had adopted its position. The confusion is quite understandable.

It should be added however that each member of GCFH is free to act on his own if he does not involve the organization. It is doubtful that there will be much urging of Negroes to move to Greenbelt as it is inevitable. The inevitability is one thing that has never been denied.

Ex-Greenbelter Writes On **Experiences Abroad**

Greetings from "down under" to all of our Greenbelt neighbors and friends!

It has been a little more than two months since we left our beloved Greenbelt. But it seems ever so much longer than that really. Perhaps because we've traveled so far and have had so many new experiences.

During the first three weeks of our journey, we traveled over 4,000 miles saying "hello' and, all too quickly, bidding "goodbye" to our friends and relatives across the United States. Among these were former Greenbelters, Larry and Mary Wotko and their three children of Ames, Iowa, and Russ and Hattie Dietzel and two children of Albuquerque, New Mexico.

On October 7 we left Los Angeles International Airport aboard a jet DC-8. Soft Hawaiian background music and lovely stewardesses garbed in long fitted dresses of gay colored print immediately put us in a holiday mood as we boarded the plane for Honolulu. The children's eyes sparkled with excitement as the huge plane lifted smoothly off the ground and we were airborne. The plane climbed quickly. We watched small islands slip beneath us and viewed the United States coastline as it rapidly sped out of sight behind us. Soon we were flying at 28,000 feet and looked down upon fleecy white cloud formations. The world outside our plane was a levely bright blue and white, no other colors

We loved our two-day holiday in Honolulu! Gentle breezes, bright blue skies, a friendly "aloha", and cool drinks of pineapple juice greeted us upon our arrival in the fiftieth state. Sightseeing was fascinating. We visited Ulu Mau Village where we learned interesting facts about the native Hawaiian culture, history and handicrafts. We saw samples of patchwork quilts that the New England missionaries had taught the natives how to make many years ago. The children enjoyed participating in some of the games that Hawaiian children play. We learned, also, how poi is made and tasted the product concluding that it was a food for which one would have to develop a taste.

Our big plane left Honolulu about midnight, October 9. Our next stop was Nandi (in the Fiji Islands). We crossed the equator during the night. Each of us received a certificate. We stopped at Auckland, Wellington and Christchurch before arriving in Dunedin. At each stop in New Zealand there was a welcoming committee awaiting us. How wonderful to finally hear those friendly voices bidding us "Welcome to Dunedin!" Three cars whisked us and our baggage along the country-side and to the house. high on a hilltop, in the city of Dunedin, that was to be home. There we found another welcoming committee and a warm meal on our table. The pantry was filled with food. We hadn't even completed the tour of the house when the telephone rang. Someone said, "A call for Mr. Hillebrand." Eleanor commented, "Ah, just like

Xmas Checks

Artificial trees are becoming more popular. However. purchasers should be made aware of the fact that some artificial trees are not flameproof or fire resistive.

We strongly recommend that you look for the "UL" (Underwriter's Label) on all electrical wiring and appliances in, on or around any tree. We do not recommend any electrical wiring or lights on the metal trees due to the possible shock hazard; a flood light is preferable.

Electrical toys should be listed by underwriters laboratories to show they have met shock and fire hazard standards.

Now is the time for complete check of all your holiday electrical

equipment. Wax candles on trees are highly

dangerous. A flyer on "A Fire-safe Christmas" will be distributed by the Department to the schools and also available to others. We encourage you to read it very carefully and follow the safety hints provided.


