# COUNCIL DISAPPROVES PROPOSED PLAT PLAN FOR SPRINGHILL LAKE

Among the action items at the regular March 21 city council meeting were the following: The council recommended disapproval of a Springhill Lake plat plan, completed action on ordinances establishing penalties on delinquent trash accounts and repealing city authority to assign parking spaces, approved July 4 fireworks, and voted to open council meetings with a prayer.

The council turned down the Springhill Lake Plat plan for development of the area north of Capital Beltway upon the advice of its Advisory Planning Board. The APB pointed out that there were no provisions for a perimeter road (as called for in the Master Plan) and that only 25-foot wide streets were designated. This width is considered inadequate and a safety hazard since the roads can be easily blocked.

The repeal of the city ordinance governing assignment of parking spaces in Greenbelt Homes, Inc. courts ran into some audience objection on the grounds that the system has worked well in some of the courts. Mayor Edgar Smith pointed out that the city has no authority to enforce the ordinance. It was hoped, however, that some cooperative arrangements could be made to continue assignment of spaces on a voluntary basis.

The ordinance providing for delinquent charges calls for a penalty of \$1 for trash collection accounts remaining unpaid 30 days after submission of bills and discontinuance of servce after 60 days delinquency.

#### Fireworks Fund

The council authorized up to \$1,000 to be expended for July 4 fireworks with the general understanding that the celebration would be held at Greenbelt Lake. The council also authorized participation in the State mosquito control program.

The council voted unanimously to open council meetings with recitation of The Lord's Prayer. Several alternatives were also considered such as opening the meeting with a silent prayer or inviting local ministers to deliver appropriate prayers.

Council referred to APB a request by the Maryland National Capital Park and Planning Commission technical staff for city recommendations on parcels 7 and 8. Parcel 7 is the rectangular tract of land adjacent to Boxwood Village which is proposed for a neighborhood shopping center by its owners (Bresler and associates). long strip between Ridge Road and Kenilworth Ave. owned by Crescent Leasing which is also proposed by the owners for commercial use. The city's Master Plan calls for singlefamily homes on these parcels.

Council heard a request by the State Police for permission to erect a 120-foot high radio antenna on city-owned cemetery property adjacent to the old city warehouse. This request came after the State Roads Commission had turned down a similar request to erect such an antenna on its new highway office building. Council took the matter under advisement.

Council received a status report on improvements to walkways to St. Hugh's. The city manager reported that the Capital Budget for next year calls for construction of a new sidewalk on the south side of Crescent from Parkway to St. Hugh's. The Capital Budget also calls for continuation of the sidewalk to lake park. In the meantime, patch work will be done to existing sidewalks and also to parking lot adjacent to St. Hugh's.

#### Miscellaneous

gel to the Charter Review Committee to take the place of George Neumann who was appointed to the APB . . Council agreed to permit enclosure of part of sewer easement by Lakeside property owners, as long as 5-foot strip was deeded to city for use as public . Council approved walkway . . transfer of \$4,000 from contingency reserves to street maintenance fund. Costs have exceeded budget due to unusual amount of snow removal work and extensive pavement damage caused during thaw-

#### Sgt. Green Retires

A city worker who is almost an institution in Greenbelt will retire next week after more than 20 years of service to the city. He is Sgt. Austin Green of the Police Department. Green, whose first day of work here was on January 25, 1946, retires officially on April 1.

During this 20-year period he has worked at various jobs. He has been a municipal bus driver, a fireman, a utility mechanic, and a policeman. He was first hired by the police force as a special (parttime) officer in 1946. He went on full-time status in October, 1947. In 1955 he was promoted to sergeant.

As a police officer he is probably best known as organizer of the school safety patrol, a program which he has been directing since 1959. He has also served for many years as parade marshal for July 4 and Labor Day Festival parades. He also arranged for the marching band for the Little League programs.

Green, a local resident, resides in Boxwood.

## **CFPG Annual Meeting**

## Council Refers School Site Question to Zoning Attorney

At a special meeting on March 15, the city council agreed to refer the matter of school sites to its special zoning attorney, Joseph DePaul, to determine if the city has any legal recourse in preventing the location of a senior high school in parcel 2.

The County Board of Education has scheduled a meeting for today (Thursday, March 24) to act upon the offer of the developer, (Charles Bresler and Associates) of 55 acres in parcel 2 for a 3-school complex.

The city council has sent a letter to the school board informing it that its previous offers are still available. The letter also draws attention to a recent court of appeals decision in a condemnation case involving testimony by an expert appraiser.

The appeals court held that while the probability of a tract being rezoned to a higher classification in the reasonable near future can be considered, it is manifestly improper to allow a real estate appraiser to value property as if it were in fact already zoned to the higher classification.

The pertinence of this decision involves the estimated value of the city-preferred Beltway-Lake site, which has ranged from \$15,000 to \$30,000. This site is presently zoned rural-planned-community which would lend credence to the lower

## "GOLDEN TRIANGLE" REZONING DELAYED BY LACK OF EVIDENCE

The Greenbelt Master Plan got a new lease on life when Circuit Court Judge Ralph Powers remanded the Golden Triangle zoning case back to the District Council on Tuesday, March 22. Judge Powers instructed the county commissioners to provide documentation of its basic findings and conclusions in accordance with the requirements of zoning legislation which went into effect on June 1, 1965.

## Govt. OK's Parkland Buy; Hospital Hearing Put Off

The go-ahead signal from the Federal government for proceeding with the parkland acquisition program was received by the city last week. Up to now the city had been unable to initiate negotiations for the purchase of the privately-owned parkland around Greenbelt Lake, since its application for Federal financial assistance under the open spaces program of the Housing Act of 1961 as amended was pending.

The city has in mind acquisition of four parcels of land around the lake. The largest tract is 15-acre parcel 11 owned by Consolidated Syndicates (Charles Bresler and associates), located between the Lake and Crescent Road. The owners have petitioned for a special exception to construct a private hospital. Last Friday, the county commissioners postponed the hearing on this petition. A new date was set for Friday, April 15, at 1:30 p.m. in the County Service Building in Hyattsville.

Greenbelt voters, by an overwhelming vote at last September's referendum, approved a \$250,000 bond issue for the purchase of the parkland.

## G. C. S. Delegates Sought

There are 6 available seats on the 12-man Greenbelt delegation to the Greenbelt Consumer Services ("Co-Op") Congress, the advisory body composed of elected representatives from the various areas. All delegates will be elected for a two-year term.

Those candidates having already filed are Marjorie Bergemann, Ethel Rosenzweig, Mary Barstow, Sylvia Lewis, Robert Hill, and Gerard Weber. Additional candidates must file before the March 28 deadline. All G. C. S. members affiliated with the Greenbelt store area are eligible to vote, to nominate candidates, and to run as candidates. Nomination forms are available at the information booth at the store.

The election of Congress members will open at the annual Delegation dinner meeting, Monday, May 9, and voting at the store will continue until Saturday evening, May 14.

The city and private citizens had sought the court appeal following a decision by the county commissioners on July 6, 1965 to zone the 57-acre tract for a regional shopping center (General Commerical C-2). Both the city's Master Plam and the MNCPPC Area 13 plan opposed such zoning for the tract bounded by Greenbelt Rd., Kenilworth Ave., and the Capital Beltway. The vote of the county commissioners was 4 to 1, with commissioner Gladys N. Spellman opposing the commercial zoning.

Greenbelt's z o n i n g attorney, Joseph DePaul, presented four major arguments: (1) The District Council went beyond the record of hearing in making its decision. For example, it referred to evidence of a leading economist in the Washington Metropoltan area that there is a surplus of office space when in fact such evidence was not in the record.

(2) The District Council did not properly consider the traffic problem. The evidence showed that the road system was inadequate to accommodate the heavy increase in traffic and there was no possibility of alleviation of such road and traffic conditions in the immediate future.

(3) There has been no substantial change in the character of the neighborhood which would warrant rezoning.

(4) The District Council had not complied in providing written findings of the basic facts and conclusions as was its duty under the statute in this contested hearing.

Albert Ginsberg, attorney for Greenbelt Homes, Inc., supplemented DePaul's arguments. Another party supporting the appeal was First National Realty Corporation, developers of Beltway Plaza. James Vance and William Avrutis, attorneys for First National, emphasized that there had been no substantial change in the character of the land. They argued that First National was a proper party to the suit since the rezoning affected its property as far as size and development was concerned.

James Lombardy, representing the county, argued that the District Council's action in rezoning substantially complied with the requirements of the law. The owner of the Golden Triangle is Milton E. Selig who was represented by Mr. Lancaster.

#### Last Chance

To the Editor:

Now is the last chance GCS members have to block the grocery corporation's final descent into complete bondage. If members do not act now, if they go along with proposed bylaw changes now, they never again will exercise any control over the organization.

GCS members who care must do these things: (1) Enter candidates in the Congress elections who believe in a democratic outfit. (2) Defeat any candidates for delegation (and later for Board) who support the policy that only the leaders are fit to run GCS. (3) Reject the proposed bylaws in the June 12 GCS corporation meeting

Two proposals which the Congress adopted by a nearly unanimous vote follow: (1) Board members would be elected for 3-year terms with one-third elected each year, in order to make it impossible for the members to overturn the Board majority in less than 2 years (they admitted the reason). (2) Members running for local office (delegation member) must be a local resident or regular user of the local area facility. Seems innocent until you realize that there's no way of proving you're a bonafied regular user, that many people don't live near a co-op, and that the local Congress delegation is the sole practical way of getting into GCS political affairs. In effect it is a jim-crow amendment though some of its sponsors don't mean it that way.

I've been fighting almost a solo battle for 5 years, and I'm tired. I'm tired of trying to pry information loose, and tired of being told when some data finally becomes available that the members can't be told. For instance, after years of silence it was revealed to the Congress - but not to you, the members - that since 1960 GCS lost a total of over \$300,000 in real estate activities because of long term contracts that will continue for years to come. I'm tired of double- and triple-talk on management salaries. I'm tired of hush hush. It's up to other members to act now or you'll never get another chance.
