## Bid to Gain Control of Co-Op

An unexpected element has been added to the annual election of the board of directors of Greenbelt Consumer Services (Co-op) with the last minute appearance of a slate of 20 candidates representing poverty areas in Washington. The majority of these candidates had been members of the cooperative for only a day or two before filing their candidacy and their petition is supported by a total of 32 members only (signatures of 10 members are required from each candidate). According to the metropolitan press, the number later simmered down to five (same number as the vacancies on the 9-member board): Timothy Jenkins (attorney and deputy equal employment commissioner), Mari Haupt, James Speight, Steven Lowenstein (Civil rights coordinator for the Office of Economic Opportunity) and Alan McSurely (United Planning Organization).

The man behind this take-over attempt, billed as "mystery man" in a front-page story by *The Sunday Star* of May 22 is an unemployed Washingtonian named L. D. Pratt. Pratt had been a Co-op member for some time and served as representative to the Co-op Congress from Penn-Mar last year. According to the secretary of the board of directors, Donald H. Cooper, Pratt first approached GCS resident general manager Robert E. Morrow in November 1965 with proposals to transfer control of the Piney Branch store to the "Washington-Baltimore Freedom Partnership" and turn it into a shopping outlet for the city's poor. Pratt envisioned a fleet of small buses to bring shoppers to the store from downtown Washington and threatened GCS with demonstrations in case his offer was turned down. Nothing came out of these schemes.

### Not on Ballot

The mail ballot (in legal language "proxy") which was due to be mailed to approximately 26,000 Co-op members this week will not carry the names of the dissident candidates, due to a Securities Exchange Commission regulation which has been extended this year to GCS along with about 6000 other smaller corporations. This regulation stems from concern by the SEC about the take-over of corporations by underworld operators through manipulation of proxy votes, and requires any candidate for the board not nominated through the corporation's usual procedure to have his application cleared by the SEC. As far as is known, the D.C. slate has not taken this step.

According to Cooper GCS would like in the future to get exempted from this regulation, so as to adhere better to the spirit of a cooperative; meanwhile, however the only candidates whose names appear on the proxy are those nominated by the Co-op Congress, a body of over 100 representatives elected by Co-op members throughout the area (12 from Greenbelt). These include 4 incumbents - President Benjamin Rosenzweig (4-E Crescent rd., Greenbelt), Donald H. Cooper, W. Clifford Hoag and Dorothy Wheeler - as well as Darwin E. Bremer, who is running to replace David H. Scull. The dissident candidates will be invited to present themselves at the annual membership meeting, scheduled to be held at the Greenbelt Youth Center Sunday, June 12, at which time any candidate can be voted for.

### Factors Behind Take-over Bid

Motivating the attempt to gain control of GCS is the undisputed fact that food prices are considerably higher in poverty areas than in the suburbs. By and large, supermarket chains are not attracted to the poorer residential areas of the District: store rental costs there are about twice those charged in the suburbs, sales lean towards low-profit staples and customers often prefer neighborhood groceries which, though more expensive, extend credit and are more accessible

to shoppers not having a car available. A store in the city often turns into a source of loss for the chain operating it and is forced to close. Thus it is the poor, ironically, who are forced to either pay premium prices at poorly stocked neighborhood stores or to find ways to travel to faraway supermarkets where prices and selections are better.

A situation not much different from this prevailed when Greenbelt was founded: it was at that time an isolated community in which no supermarket would open a store. As a result, local residents organized in 1938-39 and raised money by sale of shares to form Greenbelt Consumer Services. Originally, this was strictly a local cooperative and until after the war it ran not only the grocery store but also a beauty shop, theatre and dime store. The first step outside Greenbelt came as late as 1951, with the opening of the Takoma Park Co-op (now a toy store across from the Super Co-op on New Hampshire ave.).

### Mixed Feelings

The present board of directors, many of whom helped found GCS 26 years ago and have invested considerable effort in its growth since then, view the preceding developments with mixed feelings. They feel proud of helping create a highly successful cooperative venture in a relatively competitive field, including at present a dozen supermarkets 8 pharmacies, 8 auto service center and 4 furniture stores, with annual sales exceeding \$32,000,000. Therefore even though they do not regard the present take-over bid as a real threat, they resent the idea of "outsiders" trying to gain control of an achievement which is not theirs.

On the other hand, they are fully aware of the problems confronting Washington's poor when buying their groceries. On this subject, Cooper noted that around the same time GCS was founded, 3 cooperative groceries opened in the District of Columbia. All failed soon afterwards with considerable loss, the one opened in an all negro area in Anacostia lasting only 3 months.

Recently Co-op has been studying the opening of a store in Washington, but so far no plan which would lead to a self-sustaining supermarket there has been found. In the meantime the board is meeting with social aid agencies to find a solution to the problem and has offered to help Washington groups organize their own Co-op stores.

## Pool Open Saturday; Dedication on Monday

Weather permitting, the Greenbelt Swimming Pool will open this Saturday, May 28, two days earlier than usual so that residents can enjoy the facility for the entire holiday weekend. Pool hours will be from 1 p.m. to 8:30 p.m. on non-school days and from 4 p.m. to 8:30 p.m. on school days.

At 12 noon on Memorial Day, May 30 following the American Legion-DAV Memorial Day ceremonies at the War Memorial in Centerway, a brief dedication ceremony will take place at the Pool in order to commemorate the completion of the pool reconstruction and expansion work undertaken last year. A bronze plaque will be unveiled by Mayor Edgar L. Smith. Greenbelt residents are invited. Refreshments will be served, and the pool facilities will be open for inspection. Music will be provided by the Greenbelt Junior High School Band, Frank Troy Director. Upon the conclusion of the ceremonies, the pool will be open for business as usual.

The pool renovation and expansion project, costing more than \$160,000, was financed primarily by a \$150,000 bond issue, authorized by a referendum in September, 1963. Designed by Greenhorne and O'Mara, the construction work was done by Ira C. Rigger Inc. and E. Don Bullian in joint venture. The renovation work consisted of reconstruction of the 60 by 120 main pool to such an extent that this pool can be considered a new pool. A new diving pool, 36 by 48 feet, has been constructed. The deck has been replaced and enlarged, and the wading pool re-lined with concrete. There is a new and larger grass sunbathing area, new benches, umbrellas, diving boards, and a slide.

A new diatomaceous earth filter was installed as well as new chemical feeders. New electrical controls and panels and pipes were also installed. The system is designed to provide swimmers with high quality treated and purified water during peak periods of operation as well as normal times of use.

While lack of funds prevented a major renovation of the bath house, considerable repair and fix-up work was done. The bath house wings

## GHI Elects Shinderman, Polaschik Keene and Simonson to Directorship

Incumbents Nat Shinderman and Steve Polaschik had relatively little difficulty in nailing down two of the four openings on the board of directors of Greenbelt Homes, Inc., at last week's election. The third incumbent, Josephine Seay, however, found herself in a losing three-cornered contest for the remaining two vacancies, as Katherine Keene and Cliff Simonson outdistanced her. Only 14 votes separated the three.

## Budget Hearings Spur Parks, Works Programs

Items of interest in the recreation budget were the skating program at the Youth Center and initiation of Springhill Lake summer playground program. Recreation Director Richard Stevenson stated that attendance at the skating program has increased since shoe skates were made available.

Among the items considered at the May 20 budget meeting was the capital outlay program for public works. The council is considering augmenting the roads budget to allow \$5,500 for resurfacing of Lakeside Drive. The road has received quite a battering as the result of construction in Lakecrest. There is already \$8,000 in the budget for similar work on Lakewood streets.

One proposal in the budget may be postponed. This is erection of 7 new street lights at Centerway. Council felt that this item might be better considered in connection with urban renewal possibilities.

The council expressed concern that the shopping center property owner has not been bearing his equal share of the cost of maintenance and cleaning, as directed by city ordinance. Manager was directed to look into the matter.

Manager was also directed to look into matter of extending garbage pick ups from two to three weekly for Lakeside Drive residents (with proportionate increase in charges). The rest of the town is on three-a-week pickup and the difference causes administrative problems.

A series of budget meetings was held last week by the city council in preparation for the public hearing on Tuesday, May 31 at 8 p.m. in the city offices. The budget must be adopted by June 10.

The park maintenance program occupied much of council's attention at its May 17 budget meeting. The council has been disappointed in the speed at which progress is being made. Last year council appropriated \$15,000 for a stepped up park maintenance program but the city expects to spend only \$9,000 by June 30, 1966.

City manager James Giese explained that the city has been handicapped by difficulty in securing labor. Existing labor force has been stretched to the limit by street paving commitments and by emergency work required as result of last winter's snows.

Council directed management to explore every possible method, including contracting out, to accelerate the program and regain lost ground. \$12,000 is in the budget for 1966-67 and council may add to this.

The pathway pavement program was another item that attracted council support. Among the projects scheduled for this year are additional pathways leading to the lake.

Memorial Day Services, sponsored by American Legion Post No. 136 and D.A.V. Chapter 23 will start on Monday at 10:55 a.m. at the Greenbelt Center with the advance of colors. Mrs. Francis White will sing the Star Spangled Banner and the Greenbelt Junior High School band, under the direction of Mr. Troy, will play. State Delegate Edward Conroy will be the guest speaker, and County Commissioner Frank Lastner, Joseph Kuntz and William Melton of the D.A.V. will also speak. Mrs. Elinor Rimar will deliver a recitation.

Father Victor Dowgiallo will deliver the invocation and the Rev. Edward Birner the benediction.

## JOG ALONG SATURDAY

Saturday, May 28, at 10:30 a.m. at Braden Field; The monthly 1½ mile Jog Along will be held for all those interested in physical fitness.

The top vote-gatherer was Shinderman with 235 votes out of 302 ballots cast, followed by Polaschik with 227 votes. In third place was Miss Keene with 196 votes, and 8 votes behind was Simonson. Mrs. Seay garnered 182 votes, just 6 short of Simonson's total. A sixth candidate Sam Schwimer obtained 81 votes. Board members' terms are for two years.

The winning four candidates now join the present five incumbents—Charles Schwan, John O'Reilly, Gerald Gough, Norman Weyel, and James Smith—to round out the 9-man board. The organization of the new board and election of officers will take place at the board's regularly scheduled meeting tonight.

### Audit Committee

Winners for the 3-man audit committee were Thomas White (199), Pat Savage (158), and Seymour Kaplan (155). The other two candidates—Norman Charles and George Phibbs—received 138 and 114 votes, respectively.

Elected unanimously at Wednesday night's meeting to the Nominations and Elections Committee were George Adams, Elizabeth Allen, Darwin Beck, Andrew Feeney, and Jack Downs.

The 302 ballots cast topped last year's total of 284, but otherwise were the lowest number registered since 1959, when 275 votes were cast. There are about 1,550 GHI members. No proxy votes were cast.

Wednesday's membership meeting, at which no controversial items were scheduled, drew about 100 persons. Scrolls of recognition were presented to retiring board member Ed Burgoon and Superintendent of Maintenance David Kane for their past service to the corporation.

## Wear A Legion Poppy

Greenbelt American Legion Auxiliary Unit No. 136 will again canvass the Center inviting citizens to join in commemorating America's war dead by wearing a bright red Legion Poppy. The poppy promotion will begin Friday evening, May 27 and continue throughout the Memorial Day weekend. Junior members of the Auxiliary will conduct the campaign along with Little Miss Poppy, Patty Fendlay of 9-N Southway, whom they elected last month. She will preside over poppy activities during the weekend and will appear at other civic functions throughout the year.

Highlight of the weekend will be Monday's memorial services at which time the markers honoring Greenbelt's war casualties will be decorated with flowers.

## Carnival Coming To Town

A springtime carnival will be held this Monday, May 30, through June 4 in the North Parking Lot of the Greenbelt Shopping Center. A variety of rides for children of all ages will be available, as well as bingo and other concessions. Hot dogs and cokes will be on sale.

The carnival is sponsored by the Golden Age Club, and proceeds will benefit the club's building fund. Discount tickets for rides will be sold at the Co-op store (Consumers Discount supermarket) as long as the supply lasts.

To the Editor:

I was astounded to read in last week's News Review that the GHI Board has set the month of August to start construction of the four free standing homes on land which is now separation green-strips between subdivisions when such land use seems so inconsistent with GHI's policy and planning for lower density housing.

Surely the crowding of housing of any description, let alone special housing for large families is not in keeping with GHI's policy and efforts of trying to prevent the zoning and development of high density building on any land in the Greenbelt area.

GHI's handbook points with pride to its development of a master land use plan and its assistance in setting up small land cooperatives around the perimeter of GHI land holdings. In doing so it established certain green-trip scenic easements, as it were to keep the new subdivisions from encroaching on GHI property. It is inconceivable that, even at this early date, GHI is ignoring their own planning principles and policy by crowding in these proposed new dwellings on these green-strip areas.

Certainly the residents of Woodland Hills have a right to expect better treatment from GHI.

It is indeed urgent that Greenbelt City Council concern itself about the proposed use of this property, not only from the standpoint of increased density but also from the improper use of established green-strips.

Amendments to the Charter of the City of Greenbelt, Maryland were adopted on May 2, 1966 by the City Council of Greenbelt. The title of each Resolution, which is a fair summary of each amendment, is as follows:

**Resolution Number 92**

Resolution of the City of Greenbelt adopted Pursuant to the Authority of Article 11E of the Constitution of Maryland and Section 13 of Article 23A of the Annotated Code of Maryland (1957 Edition as amended) title "Corporation-Municipal", sub-title "Home Rule", to amend the Charter of the City of Greenbelt, said Charter being Section 40 of Article 17 of the Code of Public Local Laws of Maryland (1963 Edition) and Containing in Whole or in Part the Charter of the City of Greenbelt, by Repealing and Reenacting with Amendments Section 40-35 title "City Manager" to Provide Procedures for the Removal by Council of the City Manager upon the Adoption of a Resolution by the Majority of all Council Members after a Public Hearing is Held if Requested by the City Manager and to further Provide for the Designation of an Acting City Manager by the Council to Perform the Duties of the City Manager During any Temporary Absence or Disability of the Manager.

**Resolution Number 93**

Resolution of the City of Greenbelt adopted pursuant to the Authority of Article 11E of the Constitution of Maryland and Section 13 of Article 23A of the Annotated Code of Maryland (1957 Edition as amended) title "Corporation-Municipal", sub-title "Home Rule", to amend the Charter of the City of Greenbelt, said Charter being Section 40 of Article 17 of the Code of Public Local Laws of Maryland (1963 Edition) and containing in Whole or in Part the Charter of the City of Greenbelt, by Repealing and Reenacting with Amendments Section 40-33 title "Interference by Council Prohibited," in order to delete the Provision that the City Solicitor shall Prosecute an Action Brought Under this Section.

Resolution of the City of Greenbelt adopted Pursuant to the Authority of Article 11E of the Constitution of Maryland and Section 13 of Article 23A of the Annotated Code of Maryland (1957 Edition as amended) title "Corporation-Municipal," sub-title "Home Rule," to amend the Charter of the City of Greenbelt, said Charter being Section 40 of Article 17 of the Code of Public Local Laws of Maryland (1963 Edition) and Containing in Whole or in Part the Charter of the City of Greenbelt, by Repealing Paragraph (b) title "Records" of Section 40-39 title "City Manager; duties."

With the opening date for the municipal swimming pool set forward from Memorial Day to this Saturday, May 28, the city crew has been concentrating on getting everything ready for the occasion. The pools have already been painted and filled with water. This week the redwood benches are getting a new coat of stain.

Also this week blacktop has been laid to complete the public walkway leading down through the woods between 4 and 6 Cts. of Ridge to Lakeside at Maplewood. A concrete walk with steps was put in by a sub-contractor to the city between 8 and 10 Lakeside.

Mowing lawns and collecting heavier than usual loads of garden debris and similar seasonal jobs also kept the Public Works Department busy.

Anyone around the old municipal sewage disposal plant this morning might have seen a once-in-a-lifetime event, when the old brick chimney collapsed after an explosive charge was put to it. The rest of the building was demolished last week. A new office building for the engineer of District 3 of the State Roads Commission will go up on that site.

were re-sided with aluminum siding and the paint was removed from the brick center section of the building by sandblasting. The roof was repaired. The interior was cleaned and repainted. New chain pull showers and lavatory partitions were installed.

This spring the pools were coated with a special mixture of lime and cement in order to protect the concrete from the corrosive effects of chlorinated water. Pool users will note that the coating will also make the pool surface smoother as well as whiter, giving the pool water a

sparkling crystal clear blue appearance.  
Season passes to the pool are now on sale and can be purchased at the Treasurer's Office on weekdays. Passes can be purchased by mail, using the order form in the brochure delivered to homes throughout the city or included in the city's advertisement in this week's News Review. Passes may also be purchased at the pool on evenings and weekends when the City offices are closed.
