# Ad Hoc. Committee to Meet **On Use of Lutheran Property**

What to do with the Lutheran Church property on Ridge Road was the subject of a special committee meeting held February 20. The ad hoc committee, appointed by the City Council, will meet again Thursday, March 20 to further consider what steps the City and GHI can take in this matter.

The Lutheran Church needs to sell their property-about 3 acres including their sanctuary-to help finance their new sanctuary on Greenbelt Road. Previous efforts involving use of the site for a nursing home fell through when the city council, supported by GHI and other groups, voted to oppose the request for a special exception zoning when it came before the county commissioners.

The city council appointed an ad hoc committee to see what the city and GHI, separately or jointly, might do to help. The committee consists of Richard Pilski member of the city council and representative of the City; James W. Smith and Ted Pritzker, representing Pastor Birner, Arthur Winker, and Darwin L. Beck, representing Holy Cross Lutheran Church; George Beauchamp, of the Citizens for a Planned Greenbelt; Stephen Polaschick, of the Advisory Planning Board; John Churchill, representing the Park and Recreation Advisory Board; and Lawrence Goldberger, Chairman of the Advisory Planning Board and Chairman of this ad hoc committee

The first meeting produced a general concensus amoung committee members that the public interest was involved and the committee, together with GHI and the city, must make every effort to see that disposition and future use of the property serves the best interests of the whole community.

Representatives of the Church continued to support the search for such a solution, but noted that financing their new sanctuary on Greenbelt Roard was ultimately dependent on revenue from the sale of their present property. If a solution favored to public interests is not found resasonably soon, the church must seek a buyer for the propery and such a buyer might or might not be satisfactory to Greenbelt's public interests. Committee members noted that the city and GHI had a special responsibility, if they

are to further assert the public interest in this property, since both had opposed the first opportunity the Church had for a sale of the property.

Both city and GHI representatives were asked, If you owned this property right now including the church building, what would you do with it? How much would it cost to renovate the building, grade and landscape the land, to make it most useful to you?" Neither the City nor the GHI representatives were prepared to answer this at the first meeting, but at the meeting, to be held March 20 at the council chambers managers of both GHI and the city will be prepared to discuss plans and estimates with the committee.

It is clearly understood, however, that such a discussion will not commit or even imply that the city or GHI is going to acquire the property. The exploration is solely to assist the committee in determining in what way, if any, city and GHI needs might make acquisition of the property by either or both of them desirable or feasible. Neither GHI nor the city are now actively considering purchase of the property, although both noted that it would be a useful and desirable acquisition under certain circumstances.

GHI representatives noted that it would be a useful and desirable acquisition under certain circumstances, but that no GHI action would be taken in any event without full debate and approval of GHI members. The city would not consider action, said councilman Pilski, unless public hearings and formal city council approval were taken. Thus the detailed feasibility studies promised to the committee on March 20 will be advisory only. After examining the property and exploring, with the city and GHI managers, feasibility, funding, and needs, the committee will propose to GHI, the city, and the church, what action, if any, the committee recommends they take.

# **REGISTRATION FOR CITY ELECTIONS**

Greenbelters will have an opportunity to register to vote in city elections on Saturday, March 15 from 10 a.m. to 4 p.m. at the Springhill Lake Community Center, North End Elementary School and the Municipal Building. Anyone living in Greenbelt on or before March 15 will be eligible to vote in the City Council elections on September 16, 1969, provided he registers. To be eligible to register, one must also be a United States citizen and 21 years of age by September 16, 1969. Registration for city/ elections is separate from that of registration for county, state and national elections,

# **Council Faces Busy Agenda And Concerned Citizen Groups**

Time-wise, much of the March 3 meeting of city council was devoted to hearing pleas by citizens. One group from Research-Hillside area succeeded in having construction halted on a new playground, while the powers-that-be investigate alternate sites. Another group representing sport enthusiasts pushed successfully for a speed-up of repairs and improvement of the various ball fields to put them in playable condition for the coming season. In this, they were joined by the 8th grade of St. Hugh's who were attending the council meeting as part of a school assignment.

Other action of council included approval of a new ordinance requiring wider residential streets, approval of an application for Federal open-space grant for acquisition of parcels 7 and 8 near Boxwood Village, approval of \$500 for compilation of data needed for a parks and recreation master plan, approval of the city's participation in a mosquito control program, approval of a decorating project for the underpasses by Center School children, refusal to accept a driveway entrance on Gentry Drive into the city road system, and opposition to using the Baltimore-Washington Parkway for Interstate 95 traffic.

#### Board of Supervisors

The council also received three messages from city manager James K. Giese on subjects which were placed on the agenda for future meetings. One dealt with amendments to the city charter so as to create a Board of Election. Supervisors for city elections. The Board would be charged with the responsibility of employing election workers and registrars, providing polling places and voting equipment, handling nomination petitions, registering voters and maintaining registration books and lists. and determining and certifying the results of all elections.

The role of the city clerk, who is presently responsible for most of these duties, would be reduced to one of assisting the Board in taking registrations during normal office hours and in serving as the office for the Board. Giese has drafted alternate provisions dealing with the number of members on the Board, method of appointment, length of term, and designation of chairman.

#### Center Mall Improvement

The second message dealt with bids for the Center Mall improvement. Giese reported that the combined bids for paving work and landscaping were some \$16,000 above the budgeted amount. He suggested that council might want to consider a negotiated bid whereby several items could be deleted, such as the retaining wall for the statue and some landscaping. Council decided to meet first with the architect and planner to get his views.

#### Swimming Pool Rates

The final message dealt with swimming pool rates for the coming season. Giese reported that present rates meet current operating expenses plus debt service requirements. However, in 1972, annual debt service requirements will increase by approximately \$5,000. Present pool rates were anticipated to provide some surplus to be set up as a reserve to be applied against the added debt service after 1972. This, however, has not materialized. He asked council whether they wanted to consider an increase in rates to build up this reserve fund. Councilv, in turn, asked for further data as to the size of the reserve that would be built up with varying increases.

tions were in the process of being accomplished. He mentioned the additional lights, bringing in of new soil mixture, and raising the infield. He was not sure how feasible at this time would be other suggestions, such as resodding the outfield and placing drain tile around the outfield. He agreed that the creek bed needed reworking and new piping installed to run off the water.

Mayor Edgar Smith asked Giese to review PRAB's report with the city engineer and come back to the next meeting with recommendations and cost estimates. Smith also noted that the ball field near St. Hugh's was in bad condition and asked for recommendations on that.

#### Playground

North End residents submitted a petition signed by 40 homeowners protesting the construction of a new playground on a triangular piece of property near the corner of Hillside and Research. They cited the traffic hazard to small children and argued in favor of the present heavily-wooded site behind 1 Court of Research.

Giese said that a few years back. residents had complained of the condition of this playground. In investigating these complaints, the city reached the conclusion that site behind 1 Court was not the suitable for a playground because of poor terrain, tree stumps, erosion, inaccessibility for city equipment, and poor visibility for checks on vandalism. Thus, the city chose a new site, but, Giese said, in light of the complaints, all work has ceased.

John Prah, speaking for the petitioners, suggested an alternative site some 20 yards to the north of the present site which, he said was level and which would not create erosion problems. Council suggested a meeting with GHI and a further review of the area to determine if the present site or a See COUNCIL, P. 2, Col. 2

#### nearby one would be feasible. Road Ordinance

The new road ordinance adopted by council calls for a 40-foot width instead of the present 36-foot width for residential roads to service multi-family dwellings. Giese said that when 36-foot wide streets are heavily lined with cars on both sides, the driving lanes are below minimum standards. The 40-foot width can be waived where there is sufficient off-street parking.

After a prolonged discussion with city engineer Richard Reed, council decided because of deficiencies, not to approve a driveway entrance on Gentry Drive to serve the Equitable Trust bank. Council also made plain that it did not want to consider the driveway separate from the dedication of the entire street. Reed said that the driveway was in substantial compliance with city specifications but not entirely and acknowledged that the contractor had failed to notify him when the work was going to be done.

Council concluded the meeting by taking positions on several bills pending in the State legislature. Among the bills favorably viewed were ones enabling city policemen to cross jurisdictional boundaries during emergencies, requiring mandatory jail sentences for persons using guns in committing a crime, and permitting reconsideration by county commissioners of zoning decisions where no construction has begun within seven years of date of zoning.

### **City Notes**

#### A crew from the Public Works Dept. spent two days last week cleaning debris from the shoreline of the lake. According to a city spokesman, there still remains a lot of debris in fairly deep water off the peninsula. How to get it out is the problem. At present, the Department is contemplating using a system of poles and lassoes, but they acknowledge that they may have to launch a boat to get nearer to the target. The city is still negotiating with a volunteer men's group to help with the lake cleanup. If such help materializes, the group would be assigned to clean the north shore of the lake and along the stream bed toward Braden Field.

Two crews of two men each operated snow plows Friday morning throughout the city. During better weather the city crew patched street pavement in the north end and on Edmonston Rd.

The Parks crew seeded barren areas around the city, including a section along Breezewood Dr. where there had been a washdown from a nearby hill.

Some minor amelioration of the erosion problems at the Beltway Plaza has occurred with the construction of a retaining wall at the base of the clay bank above Klein's department store and the removal of some of the hill of dirt at the rear of the shopping center. Some of the dirt has been sold to a brick company and some to the U.S. government for reconstruction of the C & O Canal. The dirt is a heavy clay which is considered ideal for such purposes.
