## OUTGOING GHI BOARD PROUD OF ITS RECORD

On the note of "a job well done" the "old" Greenbelt Homes, Inc. board met for its final session on May 13. Board member Tom White seemed to echo the thoughts of most of the other members when he stated that "Enough can't be said about the productive work of this board." And board president, Nat Shinderman, thanked each member for making his job "an easy one."

The night's business was routine and dispensed with an alacrity seldom witnessed at GHI board meetings. Of special interest to the membership is the structural survey of the frame homes, a project recommended to the board by the Planning Committee, whose purpose was to see that "frame house members . . . enjoy the maximum availability of these homes in an optimum of maintenance and care."

The board had received two bids for the survey and had met as a Committee of the Whole, with members of the Maintenance Committee, on April 30, to discuss all aspects of the survey. The committee then decided to ask management to clarify the specifications and to consult with experts in the field (Society of Architectural Engineers and the Association of Industrial Architects) for sources of additional information and to seek out more firms for bidding. Manager Roy Breashears reported that his office was in the process of complying with this request.

The outside Auditor's Report was accepted by the board, with the comment by treasurer Darwin Beck that it was difficult to understand in terms of the way it was written. Breashears commented that the auditing firm was aware of the problem and will try in the future to make the report more informative to non-auditors. (The report was made available at the May 19 membership meeting.)

### Parking Request

A request by a member to park a camper in the court parking lot was unanimously denied by the board. It was noted that the member could park in the GHI lot especially maintained for boats, trailers, and campers or could park in a commercial lot, but that a special exception to the rule in this one case would lead to parking problems of a similar nature in other courts.

An amendment to the shed regulations now states: ". . . shed regulations will permit at most one shed other than that used to store garbage cans on the dwelling lot."

The board acknowledged the receipt of the seven-page letter handed out to each member by townhouse purchaser Gordon Allen, noting the many dissatisfactions Allen found with his house. Allen further stated that, in his opinion, "it would be a pity if we have to upgrade the new housing as fast as the old housing."

Darwin Beck replied that it seemed to him, after reading Allen's letter several times, that Allen had purchased a house which didn't meet his needs and which he didn't like. "What solutions do you propose to help the board" make some decisions, he asked Allen. Allen replied that there was "no solution as long as I sit here whining and you sit there ignoring me." He then stated that he felt that the board should go on record as accepting the houses as a liability.

President Shinderman stated that all of the townhouse purchas-

ers seemed reasonably satisfied with their homes and that "with the benefit of hindsight, I don't know what we would have done differently."

### Attorney's Opinion

At a previous board meeting, the Landscape Committee had made several suggestions for regulations which would cover children's actions in the courts, on roadways and near structures. The board had sought legal opinion on the subject, and attorney Al Ginsberg reported to the board that in his judgment the proposed regulations stating that "a member shall not permit his children to play in, on, or about public buildings, or in any of the driveways is completely unenforceable." The portion saying "that a Member-parent shall be responsible to pay the cost of repairing any damage is sound in principle . . . and could be enforced." Another portion, stating that if the party who performed the damage could not be determined the members of the adjacent courts would be assessed the costs of the damage, the attorney rejected as "totally unacceptable." Management was asked to collate the attorney's suggestions into the Landscape Committee's report.

### Paper Pick-up June 4

The Greenbelt City Council has approved newspaper - magazine recycling drives on a monthly basis. The next scheduled pick-up will be on Friday, June 4. City crews will be around that morning picking up the bundles in all areas of the city regularly receiving trash service, as well as Springhill Lake and Lakeside North Apartments. Other apartment complexes are being excluded from this drive in an effort to determine their impact on the last pick-up.

Plans for the summer call for organizing many of the various civic organizations to assist in the project.

## Council Lowers Voting Age; Hears Debate Over Sidewalks

Two issues — the lowering of the voting age to 18 and sidewalks along Lakeside Drive and Northway — attracted more than 50 persons to the city council meeting on Monday evening, May 17. In between lengthy discussions on these issues, the council adopted a new animal control ordinance and urged the county council to reserve parcels 1 and 2 for single-family R-80 zoning.

After an hour discussion, the council unanimously voted to amend the city charter to permit 18 to 20-year-olds to vote in the coming city council election in September. The amendment will become effective in 50 days, unless it is petitioned to a referendum vote within 40 days. The petition for referendum must be signed by 20 percent or more of the registered voters of the city.

The City Elections Advisory Committee was split on this issue, with the majority composed of Joseph

Hanyok, Eunice Coxon, and Hal Siegel opposed to the lowering of the voting age. Ted Reiss and his successor on the committee, Richard Alpher, were in favor of the lowered age, and George Beauchamp, chairman, had an alternative position which in effect would permit voting to those youngsters who successfully passed a written objective examination testing their understanding of the government and administration of the city of Greenbelt.

Hanyok argued that it was hypocrisy to grant youngsters the franchise without also making age 18 the age of maturity for signing legal contracts, owning property, and incurring other responsibilities. He took exception to the argument that if one is old enough to fight, he is old enough to vote. The two require different abilities, he said; fighting men have to be daring, reckless, etc., while voting requires calm reasoning and reflection.

Mrs. Coxon expressed the view that 18 to 20-year-olds have shown little interest in voting and have a lower participation rate in elections than the older age groups. She suggested that the question be put to an advisory referendum in the coming election.

Beauchamp was concerned about the arbitrary selection of age 18 as the age when youngsters could be deemed mature enough to vote. He wanted to get away from an inflexible standard and suggested a voting test. City solicitor Emmett Nanna, however, felt that application of any voting test would have to be applied to the entire population to be constitutional.

Beauchamp also expressed the view that youngsters are not too interested in local affairs and that they get little in the way of education for participation in local affairs. Two youngsters, Robert Peterson and Gabriel Sucher, took issue with these comments. Peterson said that his high school class is learning all about the managerial form of government and the rejection of the charter amendment would be "turning the city's back on the youth."

Councilmen Robert McGee and Joel Katz led the argument for granting the vote. By age 18, McGee said, youngsters are pretty well developed in all their major capacities and that denying them the vote was in effect telling them "to get lost."

Katz felt that the youth actually had more direct contact and interest in local affairs than in national affairs, citing their interest in recreation. He did not see Greenbelt facing any problem with transient college youth seeking to dominate the city.

The other council members also made statements in favor of lowering the voting age. Mayor Edgar Smith summed up by saying that the youth have more intelligence, energy, and interest than they are generally given credit for and he wanted to give them an opportunity to become involved.

### Sidewalks

Although council announced at the outset of the discussion that it would refer the matter of sidewalks along Lakeside Drive and Northway to the Advisory Planning Board, the audience made it clear that it wanted to be heard. Both subdivisions had been built without sidewalks and some of the residents have requested the construction of sidewalks as a safety measure. The city had sent out letters to residents involved asking for their views.

The sentiment was generally against the construction of sidewalks. One big hitch concerned

## City Workers Request More Fringe Benefits

A report on employee benefits for Greenbelt city employees was submitted to city council at a special meeting on Monday, May 10. Among the major recommendations were increased life insurance coverage, improved sick and annual leave provisions, and a larger share of hospitalization costs paid by the city. Other proposals included uniforms for public works employees, a 10th holiday (for Good Friday), a new provision to cover leave for personal reasons, and a program of post entry training.

The recommendations were drawn up by city of Greenbelt employees under the aegis of department heads. City manager James Giese told council that he will submit his own comments on the proposals at a later date. The budget submitted by Giese, however, does incorporate some of the proposals, such as the city's paying two-thirds instead of one-third of the cost of hospitalization, increased life insurance coverage, and provisions for uniforms. The cost of these items in the budget comes to \$10,400.

The proposal for additional life insurance coverage appeared to receive the most sympathy from council. At present, the city carries \$2,500 group life insurance for each employee, with \$4,000 for department heads. The employee committee had suggested coverage equal to one year's salary, with a minimum of \$10,000.

The council had most doubts about the committee's suggestion for reimbursing employees for their unused sick leave. This proposal consisted of annual reimbursements each year, plus reimbursement upon retirement, within certain limitations. Mrs. Mabel Kandler, spokesman for the employees, felt that some incentive was needed for employees to conserve their sick leave. Several councilmen, however, wondered whether this would be making the best use of the fringe benefit dollar.

The employees also expressed concern about the amount of sick leave allowed. Greenbelt, which allows nine days yearly, plus a maximum accumulation of 60 days, had the lowest amount of all the jurisdictions surveyed in the area. The committee recommended 14 days of sick leave a year with unlimited accumulation.

Similarly, with respect to annual leave, Greenbelt rates among the lowest, allowing 10 days per year for the first three years. The committee recommended 13 days annual leave in the first three years, with the number of days increasing with service.

The committee suggested adoption of a "personal leave" provision against which an employee could charge leave for personal reasons such as death or illness. At present, such leave must be

**Suggestions on Trash**

To the Editor:

I am the party who made the ridiculous suggestion that the citizens of Greenbelt dump their unneeded trash and waste in the woods in and around the city and in the Research Farms. The suggestions that I made were done in satire to prove a point, the point being that some citizens, without regard to the environment and their fellow neighbors, do dispose of their trash in the woods surrounding Greenbelt. This problem does not just exist in this city, county, state or country. The problem is worldwide. The problem of how to dispose of trash and waste has long existed and has only recently come to light before the general public. Likewise, various solutions to the problem have only recently come to public attention.

On the premise that people, and not institutions, corporations, or governments create trash and the problems of trash disposal, I make the following axiom. Insofar as people create waste, the responsibility for the proper disposal of trash and waste rests with the people. The responsibility rest with people as individuals, communities, institutions, organizations corporations and bodies of government.

I make the following suggestions to the people of Greenbelt concerning the problem of trash and waste disposal:

(1) Every citizen of Greenbelt save all newspapers for the next recycling pick-up to take place on June 4.

(2) Every citizen demand that we all save our newspapers in the future for recycling pick-up.

(3) Every citizen of Greenbelt save all cans and nonreturnable glass containers for recycling pick-up.

(4) The city of Greenbelt, acting as agents of the citizens of Greenbelt and at any cost, continue to pick up all newspapers, metal cans and all nonreturnable glass containers for recycling.

(5) The city of Greenbelt pass a city law making it unlawful to sell soft drinks and beer in non-returnable containers.

(6) That we the people acting as individuals, community organizations, workers and owners of business, donate time and money, if necessary, to the city of Greenbelt for the continuation of recycling pick-up of all newspapers, metal and nonreturnable glass containers. That the donation of time and money continue until such time that recycling pick-up becomes self sustaining.

I further suggest that we all attend the City of Greenbelt budget hearings on May 24 and petition the city to continue the pick up of all newspapers and nonreturnable metal and glass containers. Again, I remind you, the citizens of Greenbelt, that the above suggestions are made on the premise that you and I as people of this city have created trash and waste and that there is a need to find the best possible solutions to the proper disposal of our trash and waste in such a way as not to spoil our environment. I further suggest that all of us acting together can and must solve our ever mounting trash and waste problems.

**Recycling Facts**

To the Editor:

10 percent by weight of an average city's trash is newspapers. It takes 340 trees to make the newspapers read by Greenbelt residents in a week. If you recycle a stack of newspapers 36 inches high, you save a tree. To make 1 ton of the unbleached pulp used for newspapers, it takes 275 pounds of sulfur, 350 pounds of limestone, 60,000 gallons of water, 9,000 pounds of steam and 225 kilowatt-hours of electricity. You save all this pollution if you recycle newspapers.

The above facts are based on the city's estimate of 20 tons/week of newspapers used in Greenbelt, and facts contained in "The User's Guide to the Protection of the Environment," Paul Swatek, Friends of the Earth/Ballantine 1970.

**PREVENT FOREST AND FIELD FIRES**

Thousands of acres of forests and fields have been destroyed by fire and the cause of much of this needless destruction is Man.

All it takes is a careless flick of a cigarette or a few smoldering coals left untended, and a forest disappears, says Mrs. Evelyn R. Nantz, Extension home management specialist at the University of Maryland.

Several rules that will help prevent forest and field fires are: never smoke in the woods or near dry brush or tall grass; if you smoke while driving, use your ashtray; don't throw smoldering cigarettes or cigars out the window — they could land in some dry vegetation on the roadside.

When camping out, it is advisable to build campfires in holes or trenches in the ground. Clear a wide area around these fires and look out for overhanging branches. Most important of all, make certain that the fire is completely out when you have finished using it.

Be extremely careful when burning leaves or trash in an outside receptacle. Do not leave a fire unattended at any time. If it is windy or extremely dry, do not burn anything outside. Always remember to follow any outdoor burning regulations or restrictions.

**Sheep Shearing At Oxon Hill Farm**

Oxon Hill Children's Farm in Oxon Hill, Md., will be the scene for a weekend of sheep shearing as National Capital Parks' "farmers" and others show visitors "What Happens to the Sheep's Wool" Saturday and Sunday, May 22-23, from 9 a.m. to 4 p.m. 14 sheep will be hand sheared, using electric clippers.

Shearing of sheep is a process—usually done in the spring—that clips the wool off in one piece, leaving enough wool on the sheep for protection against the weather. Each fleece generally weighs eight to nine pounds.

While the sheep are being clipped, members of the Potomac Craftsmen and National Park Service naturalists and farm guides will illustrate other skills used to turn the wool into finished fabric. These include the carding, dyeing and spinning of wool.

Carding is a machine technique that "combs" or unsnarls the clipped wool before it is spun into yarn.

Oxon Hill Children's Farm is administered by National Capital Parks to depict farm life as it was in the early 1900's. It is located at 6911 Oxon Hill Road and can be reached from Exit 37 of the Beltway at Indian Head Highway.



An Amendment to the Charter of the City of Greenbelt, Maryland was adopted by the City Council of Greenbelt on May 17, 1971. The title of the Resolution, which is a fair summary of the amendment, is as follows:

CHARTER AMENDMENT RESOLUTION NUMBER 1971-3  
RESOLUTION NUMBER 211

RESOLUTION OF THE CITY OF GREENBELT ADOPTED PURSUANT TO THE AUTHORITY OF ARTICLE 11E OF THE CONSTITUTION OF MARYLAND AND SECTION 13 OF ARTICLE 23A OF THE ANNOTATED CODE OF MARYLAND (1957 EDITION AS AMENDED) TITLE "CORPORATION-MUNICIPAL, "SUBTITLE, "HOME RULE," TO AMEND THE CHARTER OF THE CITY OF GREENBELT, MARYLAND (1963 EDITION AS AMENDED) AND CONTAINING IN WHOLE OR IN PART THE CHARTER OF THE CITY OF GREENBELT, BY REPEALING AND REENACTING WITH AMENDMENTS SECTION 40-15 TITLE "VOTERS," WHICH SECTION WAS PREVIOUSLY AMENDED BY CHARTER AMENDMENT RESOLUTION NUMBER 90, ENACTED JUNE 8, 1966, TO PROVIDE THAT THE AGE REQUIREMENT AS SET FORTH IN THIS SECTION SHALL BE LOWERED FROM 21 TO 18 YEARS OF AGE.

### Parkdale Summer Program

Summer school registration will be held at Parkdale High School on June 14, 15, 16, 17, and 18 from 9 a.m. to noon.

Three types of programs will be offered: repeat courses for students having already taken the course and wishing to improve their grade, and two types of enrichment courses. These advanced courses fall into two categories: original credit and non-credit.

Sessions will begin on June 21 and end July 29. Hours for repeat courses are scheduled for 8:20-10:10 a.m. and 10:10-12:05 p.m. The price is \$20 per course for Prince Georges County residents and \$30 for non-residents. Original and non-credit classes will be held from 8:20-12:05 p.m. Tuition for these courses is \$40 for county residents and \$60 for non-residents. Driver education is \$50.

Repeat courses to be offered include Algebra I and II, Biology, Business Arithmetic, Chemistry I, English XX-IV, French I and II, Geometry, Problems of Democracy, Physical Science, U.S. History, and World History.

Original courses include Advanced Clothing, Algebra I, American History, Art, Boys Physical Education, Chemistry I and II, English III and IV, Field Biology, French IV, Journalism II-Public Relations, Mechanical Drawing, Physics, Problems of Democracy, Spanish IV, Speech, Trig- Analysis, Typing I, and World History.

Non-credit courses offered are Abstract Algebra, Art and Graphics, Beginning Clothing, Creative Communications, Creative Writing, Custom Drapery, Data Processing, Developmental Reading, Drama Workshop, and Driver Education.



the fact that the city, with some exceptions, has followed the practice of assessing adjoining property owners for such improvements as sidewalks. These costs can run from \$3.50 a running foot in normal situations to more than \$7 a foot for the Lakeside Dr. situation, which has an underdrain problem.

Some residents argued that the sidewalks were for the general benefit of the community and should be paid for by the city, similar to the sidewalks along Southway and Crescent. Other residents were against sidewalks under any circumstance, arguing that the inner walkway system should be expanded.

Jim Bates, president of Woodland Hills Development, reported that a poll of his neighborhood revealed that 23 were opposed to sidewalks and 12 were in favor. This prompted councilman McGee, who as a resident of Northway was one of those polled, to comment that he had voted in favor of the sidewalk (though his family would have little use for it) "to be a good citizen" and was perplexed by the results.

Bates said that the overwhelming sentiment was in favor of completion of the internal walkway system. Mrs. Maffay said that the inner walkway system has its own disadvantages.

**Safety Factor**

The major argument in favor of the sidewalks was to relieve a hazardous situation for school children who have to walk in the streets. Beauchamp said that "we have been very lucky all these years to escape any serious accidents along Lakeside Drive."

David Stern argued that it is the council's responsibility to act when health and safety are involved. "You don't take a referendum to find out individual wishes when it's a matter of safety," he said. "You pass a law which everyone has to follow."

He noted that Lakeside Drive today would not meet current standards with respect to width or lack of sidewalks. Unfortunately, he said, these standards were adopted after the road was put in but they represent what the community now thinks is necessary for safety.

George Loutsch was disturbed that the city does not have a uniform policy with respect to assessments for improvements. He urged that everyone be treated equitably. City manager Giese explained that the sidewalks on Southway were not assessed against GHI because GHI has already paid for the inner walkway system.

**Cherrywood Lane Traffic Light**

Council was not pleased by a reply it received from Sidney J. Brown, Beltway Plaza developer, regarding a suggestion by council that he contribute to the costs of operating a traffic signal at the intersection of Greenbelt Road and Cherrywood Lane. Brown wrote that he is dumbfounded and flabbergasted that he was asked to participate in the cost of a traffic light made necessary by his giving the city \$200,000 worth of ground to create a road which he didn't need and which he didn't want.

"Maybe we should take back his gutter cuts," said councilman Joel Katz, referring to the plea made by Brown last November for a city

variance of driveway entrance requirements for a car wash off Cherrywood Lane. "We won't forget this," said another councilman. "Wait until he comes to us for another favor."

**Surplus Federal Land**

Council went on record in favor of acquiring a 14-acre triangular piece of surplus Federal land located between parcel 1 and the Baltimore-Washington Parkway. This tract was originally a part of the Agricultural Research Center, was transferred to the National Aeronautics and Space Agency, and was used for the disposal of the refuse from the portion of the city's sanitary landfill which was acquired from the NASA interchange. The council also expressed the view that any unutilized Federal land should be disposed of only for specific approved purposes, and not to private ownership for speculative development purposes.

**Other Matters**

The city will continue its once-a-month collection of old newspapers with the next drive scheduled for the first week in June. Councilman Dick Pilski suggested that civic organizations be given an incentive to participate by earmarking some of the proceeds for them. . . . The city public works department received commendation for its preparation of the Little League ball field and fence in Springhill Lake. . . . Council agreed to hold a special voter registration at night, tentatively scheduled for Wednesday, June 23.







**CITY WORKERS** from p. 1 charged against sick leave. Leave of 3 to 5 days for this category was suggested.

The committee report also went into other things, such as using private cars for official business and liberalization of the police retirement system. The committee was concerned that employees are not protected under city insurance when driving their own cars on official business. It suggested that the city provide sufficient vehicles through an automotive pool so that an employee would never be required to use his own car.

The committee also supported a police department proposal for retirement after twenty years of service. The present requirement is 30 years. It suggested that municipal police officers be eligible to participate in the State police retirement system (which has a 20-year requirement) or that a separate system be set up for police officers.
