#### Zoning Hearing on Parcel 1,2 Is Rescheduled for June 2

On Wednesday, June 2, the Prince Georges County Council will resume its public hearing on the four zoning petitions for the parcel 1 and parcel 2 tracts (land between the Baltimore-Washington Parkway and Greenbelt Homes, Inc. property on Ridge Road). The time will be 10 a.m. at the county court house in Upper Marlboro

The earlier hearing on March 19 had been recessed shortly after getting under way when two county council members — former Greenbelt mayor Francis W. White and Gladys Noon Spellman - disqualified themselves. White had been challenged on the grounds that he was mayor of Greenbelt at the time that the city was making recommendations on the tracts. Mrs. Spellman disqualified herself on the grounds that she owns a house (for her daughter) on Northway.

This action left only seven county council members to participate at the March 19 meeting (two other members being absent). This number was not deemed sufficient to render a decision since, according to Maryland law, a county council needs a two-thirds majority (8 votes) to overturn a municipality recommendation and an approved master plan. Hence the recess.

#### Oppose R-30

The city of Greenbelt is opposing R-30 (14 apartment units per acre) zoning requested by the owners of parcels 1 and 2, Charles Bresler and Theodore Lerner. The city's position is that in view of the sewage moratorium and other changes produced by the removal of the senior high school from parcel 2, any rezoning at this time is premature. At the time when zoning is considered for this land, the city will recommend R-80 single-family zoning on the grounds that no single-family homes have been built in the city for a number of years and that there is a serious need for such housing in Greenbelt. The land is presently zoned R-R (rural residential).

The Prince Georges County Planning Board is also urging denial of R-30 zoning. Instead, it is recommending that 88.6 acres of the vacant land be zoned R-80 (3 units per acre) and that the remainder (35.5 acres) be zoned R-T (townhouses, 10 units per acres). This is in accordance with the College Park-Greenbelt Master Plan, which provides for R-T zoning to the south and west of the proposed perimeter road and R-80 zoning to the north and east of the perimeter road.

the Board of Education. The County Planning Board, in denying R-30 zoning, noted that the R-30 zoning would create an imbalance of multi-family dwellings, producing a density detrimental to the public interest and incompatible with the surrounding development and proposed facilities. The Technical Staff of Maryland National Capital Park and Planning Commission had estimated that the R-30 zoning would produce 1,674 apartment units, whereas the proposals recommended by the Planning Board would produce 621 dwelling units 266 single-family homes and 355 town-

Proposals for rezoning parcels 1 and 2 have had a long history. As long ago as February 1962 a request by the previous owners (Garvin and Martin) to zone the land from R.P.C. (rural-planned-community) to R-18 (21 apartment units per acre) was denied by the county commissioners, who rezoned the land to R-R.

# 63% MAJORITY RACKED UP BY GHI BOARD SUPPORTERS

In a near-record turnout, Greenbelt Homes, Inc. members gave a substantial vote of confidence to incumbent board members and their associates at last week's annual election. The candidates supported by the "GHI Members for a Responsible Board" received generally majorities of 63 percent over the ticket supported by "Critics of the Board." The exceptions to this pattern were the high men on the respective slates — David Lange, whose 512 votes topped the entire field and George Adams, whose 349 votes were the highest among the opponents of the board (see accompanying box for results).

The other four candidates elected to the board for 2-year terms (in order of finish) were Donald Volk, Nat Shinderman, James, and Norman Weyel. Lange, Shinderman, and Weyel are incumbent board members. The winning candidates now join the present four members of the GHI board-Steve Polaschik, Katherine Keene, Darwin Beck, and Tom White to round out the 9-member board. The organization of the new board and election of officers will take place at the board's regularly scheduled meeting tonight (May

The only candidate among the Critics of the Board to break into the winning circle was Mabel Kandler. She squeezed out a third spot on the 3-member audit committee, beating by 17 votes Fred

#### Impasse Over Beltway Embankment Design

Confussion continues to reign over the status of the corrective embankment work at Beltway Plaza. As the result of a veto by the County Office of Building Inspections and Permits (BIP) on proposed engineering plans worked out by the developer, Sidney Brown of First National Realty, with the State Department of Water Resources (SDWR), all work is at a standstill.

Interviews this week with the leading participants revealed that the impasse still exists. Tom Rennie, BIP Grading Control Engineer, who authored the April 15 letter requesting that no permit be granted for the Beltway Plaza work, said that he has yet to receive an explanation from Brown or his engineers as to why the plans were changed from their original form.

Rennie said that the original plans proposed by Robert Balter, soil consultant for First National Realty, were excellent. (Corrective work on that part of the slope near Greenbelt Road was completed several years ago.) He couldn't understand the switch in plans which, he said, now do not fully comply with the county grading ordinance.

The original plan provided for stabilization of the soil by replacing some of the unstable clay with a granular type material having sufficient weight so that it would hold like a wall. The new plan, Rennie said, no longer shows this means of control. Instead, there is a provision to control the soil by removing the water through a paving ditch on top and a flattening or benching of the slope.

According to Roger Kanerva, SDWR spokesman, Balter indicates that the internal seepage problem is not bad for that part of the slope remaining to be corrected and can be contained by the methods he outlined. SDWR has felt that if serious seepage conditions occur during construction of the new slope, adjustment of the plans can be made on the spot.

Kanerva said that it appears a technical meeting with Rennie will be necessary to straighten things out. (A meeting was set for the latter part of this week.)

Adding to the confusion is a report that the Prince Georges County Board of Education may no longer be willing to grant Brown an easement at thetop of the slope where the school board's maintenance building is located. The original plan called for such an easement to permit construction of a concrete swale with a berm (channel) to insure proper drainage and a proper angle of re-

Birchard. The other two candidates supported by GHI Members for a Responsible Board — Alexander Barnes and James Foster — easily finished first and second, respectively.

The 795 votes cast in last week's election was the second highest in the corporation's history and represented more than 50 percent of the eligible voters. The highest vote was in the 1963 election when 903 ballots were cast. Last year 421 votes were cast.

Of the 799 ballots issued (4 were not cast or voided), 376 were issued to brick home owners and 423 to frame home owners. There were 9 proxy votes cast.

At the Wednesday evening meeting, a 5-man nominations and elections committee was elected consisting of Jule Churchill, Edward Burgoon, Cathy Foster, Barbara Likowski, and Jacqueline Shabe. Other candidates nominated were Mary Welsh, Shirley Egenreider, Dolores Downs, and Roberta McNamara.

The Wednesday meeting reflected only to a minor degree the acrimony that had developed during the campaign between the rival groups. Candidate Edward Devonshire protested a last-minute distribution of a flyer which reported his support of a structural survey, saying that "only fools never change their minds." Candidate Jim Smith, supported by Mat Amberg, complained of receiving discourteous treatment from the board, but the discussion was cut short when former GHI president Burgoon recounted the practice of not using the general membership meeting to air personal problems.

A GHI maintenance employee said that the corporation owed him \$117,000 in back pay if the figures quoted by Martha Hutzler in a campaign flyer were correct. He was referring to figures which seemed to imply that maintenance employees were earning \$20,000 a year.

Otherwise, the audience listened attentively to a report on the year's activities by GHI president Shinderman and to a report by audit committee chairman James. It also gave a strong round of applause to a statement of commendation for departing board member Charles Schwan, delivered by Shinderman. Schwan steps down, having served on the board since May 1963, 61/2 years of which were as GHI president. GHI general manager Roy Breashears was also the recipient of a round of applause after being singled out for praise by Shinder-

A resolution was passed unanimously by the membership urging the city to continue its monthly collection of newspapers for recycling.

Over 180 members attended the Wednesday night meeting.

RESOLUTION OF THE CITY OF GREENBELT ADOPTED PURSUANT TO THE AUTHORITY OF ARTICLE 11E OF THE CONSTITUTION OF MARYLAND AND SECTION 13 OF ARTICLE 23A OF THE ANNOTATED CODE OF MARY-LAND (1957 EDITION AS AMENDED) TITLE "CORPORA-TION-MUNICIPAL, "SUBTITLE, "HOME RULE," TO AMEND THE CHARTER OF THE CITY OF GREENBELT, MARYLAND (1963 EDITION AS AMENDED) AND CON-TAINING IN WHOLE OR IN PART THE CHARTER OF THE CITY OF GREENBELT, BY REPEALING AND RE-ENACTING WITH AMENDMENTS SECTION 40-10 TITLE "VOTERS," WHICH SECTION WAS PREVIOUSLY AMEND-ED BY CHARTER AMENDMENT RESOLUTION NUMBER 90, ENACTED JUNE 8, 1966, TO PROVIDE THAT THE AGE REQUIREMENT AS SET FORTH IN SHALL BE LOWERED FROM 21 TO 18 YEARS OF AGE.


