### **DOT Delays Building** Roads Affecting City

Greenbelt officials last week learned first-hand of the status of two highway projects of interest to the city - the Kenilworth Ave. Greenbelt Road interchange and the Outer Beltway (Intercounty connector). These projects were discussed at a meeting between county officials and Maryland Secretary Transportation, Harry Hughes, on Dec. 9 at the State offices on Kenilworth Ave.

The news on the interchange was not optimistic. The Department of Transportation (DOT), although agreeing that this project was a high priority item, said that construction could not begin until after 1982, even if funding were available today.

Despite requests for stepping up this project, the DOT would not move from its contention, explaining that project planning would require two years, another 18 months for the design and right-ofway acquisition. It said that a consultant has been hired and the planning process begun.

The latest word on the intercounty connector is that it will be built from I-270 to just east of I-95. The intercounty connector is a shortened version of the Outer Beltway which was intended to parallel the Capital Beltway but further north near Laurel. The Greenbelt council has opposed extending the connector to the Baltimore-Washington Parkway because of its impact on Parkway traffic as it passes Greenbelt

DOT advised that in order to take the project any further east, it feels it must study the extension allthe way to the B-W Parkway. In order to receive Federal funding. even for the planning and engineering phases, DOT feels that local once and support will have to be evident. So far, there has been much opposition, though there is some sentiment for an access road to the new Laurel-Beltsville

DOT indicated that it would like to study an eastern extension to the Parkway, but apparently will not do so if opposition continues. In any event, construction on the connector is not expected to begin during the next five years.

One other highway item of interest to Greenholters was mentioned. Extending Kenilworth Avc. as a 4-lane highway to Route 1 will not be funded during the next five year period.

#### CITY NOTES

Notification was received recently that the Economic Development Administration has accepted the City's \$282,860 Public Works application for processing. The City applied for a Federal grant on November 10 for funding an addition to the Municipal Building.

The next two steps in the application process are a determination of eligibility for funding and award. The city should hear by the end of December or early January if funding is approved.

The architect is completing final plans and the city has applied for a building permit. This process is expected to take up to 2 months.

All salt spreaders have been installed on trucks; the lights and other mechanical equipment were checked out and snow plows have been removed from storage and are ready to be mounted.

The paving contractor completed the paving of Ridge Road from Eastway to Northway.

The soil behind the new curbing on Ridge Road was raked smooth and debris removed following the repaving. Contractors have completed repaying in Lakewood and concrete sidewalk replacement.

The leaf vacuum has been in operation. Leaves were raked from around the Municipal Building and the center mall. New refuse barrels have been installed in some parks and playgrounds.

# Council Votes to Have Its Own Task Force on School Closings

In addition to community Task Forces set up by the Board of Education to study closing some elementary schools, the City Council voted unanimously to hold a citizens' meeting after the Christmas holidays with school board representative, Lesley Kreimer, to form a Greenbelt Task Force which will "not be controlled by the administrative staff at the Board of Education", as Councilman Tom White put it. This task force would reflect Greenbelt's concerns-not just those of the school board.

White, and other councilmen, felt the school board staff was calling the shots on their task forces and would not operate as independently perhaps as an all-Greenbelt group. The Greenbelt Task Force would conduct a mirror study of the school closing situation and come up with its own recommendations to the school board.

#### Housing for Elderly

An architect for the housing for the elderly project has been chosen, subject to further contract arrangements to be worked out by city manager, James Giese. Lawrence and Grimm of Adelphi was the choice of the city manager and received a high recommendation from the city's consultant, Metropolitan Associates. Council decided that the city manager and the consultants probably knew more than it did about architectural firms and that a further meeting with the consultants on this matter would only cause unnecessary delay in building the housing pro-

#### Rehab, for GHI

The county's rehabilitation program for owner-occupied housing has led the city, in concert with Greenbelt Homes, Inc., to apply for block grant funding, from the Community Development Administration. This funding, subject to approval by the County Executive and the County Council, could lead to GHI's receiving \$150,000 for architectural and engineering work plus rehabilitation programs in a particular "block" of GHI homes. For this same geographical area, the city has applied for \$135,000 to be used for street renovation, outdoor recreation facilities for elderly residents and playground renovation.

The city council endorsed the city manager's recommendation to pursue the program with GHI and the county as such a grant would benefit the entire city of Greenbelt.

#### Hazardous Roads

Katherine Keene brought to council's attention for the second time the hazardous conditions for pedestrians who walk along Greenbelt Road to the Eleanor Roosevelt High School. The city has formally expressed its concern about the situation to the State Highway Administration and suggested the trimming of overhanging shrubbery and extending the white line leading from the Baltimore-Washington Parkway to Greenbelt Road, to keep cars away from where students might be walking. But, stated Giese, the state does not want to provide for pedestrian traffic along that road.

Council pointed out that the Greenbriar developer planned a walkway along Greenbelt Road to the B-W Parkway, and the city was planning to build a walkway along Southway; therefore either the state or the Board of Education should consider a walkway for the remainder of the road. Ms. Keene also suggested a guard rail along the road might improve the safety factor, particularly along the curved area.

Glese was directed to write again to the highway administration and to the school board to see what safety features could be developed.

Mayor Gil Weidenfeld also brought to council's attention the hazardous condition which prevails when the motorist is making a right turn at the "yield" sign from Kenilworth Avenue onto Greenbelt Road and either fails to see, because of the angle of the road, or doesn't realize other motorists will be making an immediate right hand turn onto Edmonston Road. Giese was asked to study the sitnation and determine how the notential hazard might be reduced.

Municipal Parking Lot

Councilman White suggested, and the council voted, to ask the Greenbelt Postmaster to park the

mail trucks either in the bottom parking lot at the Center or the National Guard Armory parking lot. This action was taken after it was noted that parking in the Municipal lot was acute and a number of mail trucks were using these premium spaces.

Another parking problem, this time related to the Lake Park, was deferred to an early February meeting as the Park and Recreation Advisory Board informed council that it was seriously considering recommending parking stickers for city residents to limit the use of the Lake Park by non-residents. The stickers would be obtained through payment of a small fee and every car without a sticker would be ticketed by the police department Giese also told council that his staff was considering parking meters as a possible alternative to alleviate the overcrowded conditions.

PRAB thanked council for its actions relating to the bike trail improvements along Crescent Road and Lakecrest Drive. The city hopes to undertake the construction of these paths during the spring.

#### Bicentennial

Council thanked members of the Greenbelt American Revolution Bicentennial Committee for its activities during the two-and-onehalf years of existence, and authorized an official picture to be taken of the committee for the Tugwell Room in the library. The committee, whose existence is now ended, listed as its accomplishments the establishment of Greenbelt Day as a city celebration and the holding of two Greenbelt Day dances; the erection of three historical markers in the community; the holding of special community Independence Day ceremonies for the past two years; the holding of an official Greenbelt Musical March Contest; and the establishment of a Greenbelt Trail.

Tom White also suggested that . one of the committee's projects, which it was not able to accomplish, be begun or completed by Greenbelt Day each year.

#### Other

The city agreed to purchase two 1977 Chevrolet Nova police squad cars at a total cost not to exceed \$9,786.62. Council voted to transfer \$5,000 from reserves to the insurance budget to cover rising liability insurance and the employment of an insurance consultant to audit the city's casualty insurance program. The city agreed to a request by the developer of Greenbriar to run an underground pipe along the city street right of way in front of the site in order to tie in its heating, ventilating and air conditioning system between buildings on either side of the school. Greenbriar will accept responsibility for maintenance of the pipe.

### Special Invocation

### Police Blotter

### **METRO Meeting Cancelled**

The meeting between the city council and the representatives of METRO, originally scheduled for January 5, has been cancelled. A new date will be set later. The council is anxious to discuss the preliminary site plan for the METRO station on the Springhill Lake industrial tract.

The Golden Triangle developers are also concerned about the location of the station. They see a METRO station on Greenbelt Road as being advantageous to the development of the tract bounded by Greenbelt Road, Capital Beltway, and Kenilworth Ave.

The latest construction and design schedule released by the METRO board last month calls for the Greenbelt "E" line to be completed by June 1983, provided — a big if — there are timely funding, planning and engineering decisions and there is no continued delay in setting the alignment for the Greenbelt route. The previous schedule, adopted in August 1974, called for a July 1981 completion date.
