Membership Action on James' Petition Would Be Improper, GHI Attorney Says

At the January 19 meeting of the GHI Board of Directors President Don Volk read a letter from Patrick J. Clancy of Krooth & Altman (counsel for GHI) advising the board on the legality of a recent petition submitted to GHI calling for the membership to vote for the removal of Kenneth Kopstein as General Manager. Clancy advised that if the relevant GHI bylaws were satisfied, the petition would have to be included on the agenda of the special membership meeting now scheduled for March 19. However, Clancy further advised that ". . . it is illegal for the matter to be considered by the membership and thus must be ruled out of order by the person who presides at the (March) 19th meeting."

According to Clancy, both under Maryland law and pursuant to GHI's own bylaws the power to appoint or remove the General Manager is vested in the Board of Directors. The membership may elect or remove members of the Board of Directors, the Audit Committee and the Nominations and Elections Committee, The membership is not authorized to appoint or remove the general manager or other administrative personnel under Clancy's reading of the bylaws. Clancy further advised that removal of an administrative officer by a vote of the membership could subject GHI to liability for breach of an employment contract or for improper termination of services.

At the conclusion of the reading of the letter, board member Ed James disputed the Clancy opinion and indicated that he believed that the bylaws do authorize such action by the membership. James is the author of the petition in question. There was no further discussion of this matter during the public portion of the

Demonstration Projects

The board gave the green light to several monitoring and demonstration projects proposed by board member Steve Curtis. The board agreed to conduct a monitoring program to determine the actual costs of electric heating. Members living in the 3 rows (18 homes) now converted to electric heat will be asked to participate in a data gathering program. Participation is voluntary. Curtis said that the program could help to dispel some current misimpressions about the high cost of electric heat. However, when Curtis volunteered to conduct the experiment himself, board member Wayne Williams said that he thought that it would be more appropriate for management to take the survey. Williams so moved and picked up the support of board member Margaret Hogensen on the vote, but board members Curtis, Lewis, James, Conrad and Donaldson voted the motion down, leaving Curtis in charge of the project. Joe Jenkins was absent from the meeting and had advised Volk of his inability to attend because of ill-

A second project (approved by a unanimous board vote) involves conducting two tests to determine the best technique for blowing-in cellulose insulation in frame attics with boarded floors. One method (proposed by Curtis) involves removal of several boards and blowing in the cellulose under sufficient pressure to compress the insulation already there and fill up the air pockets. An alternate method (proposed by management) involves drilling holes in the floorboards and then blowing in the cellulose.

A third Curtis demonstration

project to test the efficiency of polysterene perimeter insulation to prevent energy losses through the crawl space under the block and brick homes was referred to the staff engineer and an architect for evaluation."

"Greenbelt Historic District" Announced

The Maryland Historic Trust has informed the city that the original portions of Greenbelt including city parkland and part of the green belt have been accepted ento the National Register of Historic Places, with designation as "Greenbelt Historic District." The National Register is a division of the Heritage Conservation and Recreation Service, U.S. Department of the Interior.

This historic listing carries with it certain protections at the fed eral level and in time will help measurably with preservation and protection at the state and local levels. Listing on the National Register makes all property owners eligible to be considered for federal matching grants-in-aid for historic preservation. Listing also affects both the federal tax status of restoration or demolition of National Register structures used for commercial purposes and the state tax ctatus of restoration of all National Register structures.

In a separate but related matter, the Prince Georges county council and the P.G. County Planning Board of the Maryland- National Capital Park and Planning Commission recently held a public hearing on a proposed preliminary "Historic Sites and Districts Plan."

The proposed plan would amend the county's General Plan. It would recommend that important historic resources proposed for demolition or significant exterior alteration be subjected to a review process for consideration of alternatives. The Plan also recommends the application of various benefits and incentives to encourage private restoration or adaptive re-uses of historic re-

The Plan identifies 150 important historic sites and two districts to be fully protected under the proposed ordinance, and further identifies 450 potentially important sites which have yet to be evaluated. This secondary category includes a number of sites in the Greenbelt area.

Since Greenbelt sites do not appear on the first list, Greenbelt would not be subject to the proposed ordinance upon its initial adoption. Greenbelt Homes, Inc. had previously expressed concern that the proposed county ordinance, if applied to GHI, could affect the rehabilitation program in an adverse manner.

Council Holds Work Session On Lake Park Master Plan

The Greenbelt city council and city staff have begun work toward a master plan that would guide future development of Greenbelt's Lake Park. In a work session on January 27, City Manager James Giese and Assistant City Manager Dennis Piendak presented the staff's recommendations to Mayor Gil Weidenfeld and Councilmen Richard Castaldi, Charles Schwan, and Thomas White. The city's advisory boards are to be consulted, and a public hearing is planned, probably within the next two months.

Until now, there has been no master plan for the Lake Park, even though various studies have been made over the years. The most recent guidelines for lake area development have been city staff recommendations put together in 1971. The master plan, when adopted, will provide an organized way to decide where any funds that become available for park purposes should best be spent.

The city staff recommendations include 25 specific proposals. Council plans to have the pro posals made available for public review before the hearing. Some of the more significant recom mendations are these:

- 1. The vehicle entrance to the lake parking lot from Crescent Road should be improved and the entrance made more attractive. Staff study of this aspect is not yet completed, but the city's con sulting engineer, John Emler, has in effect recommended that im provements should be made at the present location of the entrance roadway rather than trying to change the location. (The problem of overflow parking at the lake during the warm months is not a part of the current study. Council plans to review that issue before spring.)
- 2. A bandstand should remain at the present location, but a professionally designed structure should be built in the future.
- 3. The concession stand should be located at the northwest corner of the lake, built into the hillside. The stand should have restrooms included, and a group pic nic shelter either attached or close. The design should include access for the handicapped.
- 4. The present vehicle service road which passes through the playground northwest of the dam should be replaced by a new service road along the west side of the park. Parking for the handicapped should be provided either at the concession stand or along the service road.
- 5. A multi-purpose play court should be built at the bay end of the lake. This would not include pre-teen play equipment.

Other recommendations include leaving wooded areas of the park in their natural state but improving pathways with gravel or stone and adding plantings at several places. A seating area and land scaping are proposed for the pen



Rehab Bulletin

The rehab program generally is on or ahead of schedule.

Roofing work has been discontinued for approximately a month because the roofing material must be applied at 40 degrees or above. It is anticipated that this work will be completed on schedule; 55 percent is now complete.

Numerous callers have testified to greater comfort in their homes after insulation has been installed. Crawl space insulation is now more than 55 percent complete in the frame homes. Approximately 60 attics were insulated in January. Progress in this area was slower than anticipated because many attics were not cleared, and a number of fully floored attics were found. These problems are currently being addressed. It is believed that the problems regarding cold spots will be satisfactorily resolved.

Serious structural problems have been found in some homes and repairs are being made. This work will increase in the spring and summer.

If weather permits, the installation of the windows will be completed by late May.

Complaints

In a project of this size there are always a few problems that must be resolved. When a letter or telephone call is received in the rehab office (474-2300), it is recorded on a multi-part form. When it is necessary, an inspector goes in the field to verify the exact nature of the problem and report back to the rehab office. This information is added to the initial report on the "Complaint Form" and a copy is given to the subcontractor for appropriate corrective action. A follow-up file is maintained, and after resolution. a copy of the form is filed in the individual file of the member.

Claims

A claim form for loss and damrge is available in rehab office. A copy may be picked up or will be ma.lcd if member calls 471-2300.



Greenbelter Surveys Seniors On Crime

"I have no complaints," "I have no problem with problems," and "I have no problems, no com-plaints, and it doesn't matter," went the dialogue as city council humorously stretched out a slow evening January 19 while discussing a revised job description for Office Assistant I. Council decided that the job entails dealing with problems, not just complaints, and then approved the new job description.

Senior Citizen Survey

Earlier in the evening, council appreciatively accepted the report of a survey of Greenbelt senior citizens and their experiences with crime. The survey was made by Greenbelter Betty Timor in cooperation with the police department for a university course. While three-fourths of Greenbelt's senior citizens feel Greenbelt is a safe place to live, the report found that 11% of the 110 senior citizens surveyed had been victims of crime in Greenbelt. Feeling they could be easy victims, many senior citizens avoid dangerous areas and going out at night. These areas include the parking lot near Candy Cane City and the Center Mall at night. Lack of enough lighting behind Beltway Plaza, in the Center Mall, on pathways, and in underpasses were noted. Other concerns were bicycles in the Center and overgrown bushes beside pathways. Suggestions of improvement were more, and more visible, police officers such as walking patrols. Educational programs about crime prevention were also mentioned.

The most frequent crimes were break-ins of cars or residences, purse or wallet snatchings, and assaults. Although the most common Greenbelt and national victim is female, other Greenbelt statistics are contrary to national norms. In Greenbelt, victims usually don't live alone and don't know their assailants; nationally the opposite is the case. Interestingly, almost all Greenbelt victims reported crimes to the police, but nationally only 50% do so. Timor suggested the discrepancy resulted from the fact that most studies are done in big

The police department and Green Ridge House already have copies of the report. Council decided to send other copies to Springhill Lake Management, Beltway Plaza Management, Council of Governments, Park and Planning officials who are studying Center Mall, and the Community Relations Advisory Board (CRAB).

In a related matter, council accepted a CRAB report on steps it has taken to determine the needs of the elderly in Greenbelt. At two meetings last summer, concerns raised were transportation, lawn care, housework, home maintenance, and discount purchasing. CRAB detailed the varied options and costs of conducting a city-wide survey on the matter and asked for Council di-

rection. The report will be considered at a future meeting.

Police Car Bids

The city has received bids for the purchase of three new police cars. In addition, Prince Georges County has taken bids on police cars, and the city can make a purchase through the county. After drawn-out discussion of sizes of engines, frequency-ofrepair reports, comfort of police officers, adequacy of police response, and the future of the Chrysler Corporation, the council (with Castaldi dissenting) came down in favor of saving the taxpayers \$900 per car by getting three Chrysler LeBarons through the county.

Ethics Law

The Maryland Legislature in 1979 adopted an ethics statute which requires that all local jurisdictions in turn enact ethics laws applicable to their employees. A State Ethics Commission was established to assure compliance. The city, by July 1, must set up a law that meets the minimum requirements of the state law.

The council will have a work session on Tuesday. Feb. 17, to determine the scope of ethics legislation which it wishes to consider for enactment.

Advisory Boards

Council renewed for three years the appointments of Monsignor William O'Donnell and Pastor Edward Birner to the Community Relations Advisory Board. Council also accepted the resignations of Ronald Colton from the Advisory Planning Board and Donna Fluke from the Park and Recreation Advisory Board.

C. G. Sokol Is Commended For WSSC Contract Work

A Greenbelt resident has received the highest employee award given by the Washington Suburban Sanitary Commission. On January 27, WSSC contract manager Charles G. Sokol, of 7818 Hanover Parkway, won the General Managers Award for outstanding performance. Two of Sokol's inspectors shared in the award with him.

The three men successfully completed a contract for muchneeded improvement to the water and sewer line for the Bethesda area, doing so ahead of schedule despite numerous county ordinance restrictions and operational delays. The severe traffic conditions at the major intersection of Wisconsin Ave. and East-West Highway required that much night work be done and created severe problems with the public. Sokol and his two inspectors were commended for the way in which they effected changes in contractor work schedules and equipment to reduce noise and traffic interference, and for their effectiveness in dealing with the public. Sokol was given special mention for his effectiveness in dealing with individual citizen complaints and inquiries by officials.

City Council Postpones Action on GHI Revenue Bonds, Agrees to Send Letter

Four items on city council's February 2 agenda related to the revenue bond financing of the Greenbelt Homes Inc. rehabilitation program — Phase II. Council, however, took up only one - a letter to Governor Hughes requesting an allocation of \$20,600,000 of the Maryland State Ceiling for 1981. "We need to get our request before the governor as early as possible in order to be included," explained Mayor Gil Weidenfeld, "If the bonds are not needed, the request can always be withdrawn." Council unanimously approved sending the letter.

City Council was not ready to move ahead on the final ordinance and supporting resolutions which would commit the city to issue revenue bonds for the rehab program if so requested by GHI.

The Maryland Community Development Administration expects to do the initial financing through a temporary construction loan. CDA has already issued a bond anticipation note. The money has been placed in a bank to be drawn upon after the mortgage agreement has been executed by GHI and CDA. The bond anticipation note is for a two-year term, with the maximum interest rate not to exceed 81/2% As a condition of the temporary financing, CDA has asked GHI to get a commitment from the city in case CDA is unable to issue the permanent revenue bonds or if GHI finds it advantageous for the city to issue the revenue bonds rather than CDA.

The February 28 settlement deadline CDA had set for GHI has now been pushed back 30 days allowing GHI more time to tie up loose ends before going to its membership for one last vote of approval. The membership meeting has been delayed until March

GHI NOTES

*Tax Rebates-Under Maryland law, people may be eligible for a credit on their property tax bill up to \$900, based upon gross family income. This program is available to homeowners of all ages. Since eligibility for the program is based upon income, it may be convenient for people to apply for this tax credit at the same time they are preparing their Maryland and federal income tax returns. Any credit due on property taxes will be given by one of several methods to be used as a subtraction from combined City or County/State/municipal property tax bill usually received by the homeowner in July of each

Also, there is a law in Maryland which allows a property tax credit for renters who have reached age 60 or who are disabled. The purpose of the law in providing property tax credits for qualified renters is that renters indirectly pay property taxes on their rental unit through the monthly rent, and, thus, should receive a credit as homeowners do if the portion of their rent attributable to property taxes exceeds a fixed limit for their specific income level. Qualified renters can receive a property tax credit of up to \$450 a year, based upon their income.


Members of the general and parks crews were called in early to work on Jan. 7 morning due to the snow. Snow and ice removal kept the crew busy the remainder of the week.

The salt pile, which had become a solid mass due to the moist weather, was crushed and plow units prepared for the next


Deadwood was removed from the Lake Park. Ducks at the Lake are being fed every day during the cold weather.



(This is the second in a series of three articles on Greenbelt's sister city of Greendale, Wisconsin. The articles are the result of a trip to Wisconsin last May by our editor and her husband.)

Greendale, Greenbelt and Greenhills (Ohio) were planned on the English garden city pattern and built by the federal government as part of Franklin Roosevelt's New Deal The Vilin the mid-thirties. lage of Greendale lies along the Root River, eight and a half miles southwest of Milwaukee on gently rolling terrain.

As a village, Greendale's powers under Wisconsin law have been much broader than Greenbelt's. For example, as a result of zoning control by the village, development has been fundamentally different from that of Greenbelt in a state with stronger central controls at the state and county level.

The surrounding green belt in Greendale, which used to comprise 200-acre dairy farms has been lost to development, but not at the whim of private developers. Greendale, unlike Greenbelt, controis planning, zoning and building. In 1952, all vacant land, some 67 percent of the total land area when the federal government sold the project, was purchased by the Milwaukee County Development Corporation (MCDC). The holding company was created by three local corporations in an effort to keep out Chicago land speculators, according to one brochure. These men are described in several village pamphlets as "public-spiriattesting to the friendly relations between village and officials and developers.

According to Village Manager Donald Fieldstad, MCDC's staff of planners has worked well with village officials in preparing development plans and zoning ordinances. He believes that MCDC's

Like a good neighbor, State Farm is there. Thus the development of the community has been carefully planned, orderly, and offers a wide variety of homes and therefore a broad base for village taxes.

This year construction will begin on the last large area to be developed.

Greendale today has an even larger stock of free standing homes - 75 percent. The rental apartments have been located in small groups throughout the community.

Streets

While Greendale is cris-crossed with a half dozen straight streets of Milwaukee's grid-iron, the newer internal streets are carefully planned to serve specific purposes. Only loop residential streets give access to homes. They are relatively narrow, short and sharply curved to discourage speeding and to limit traffic to residents and their guests. These service streets empty into village traffic streets. Intended for heavier traffic between neighborhoods, they are wider but curved to ensure slower speeds. The village has effectively screened residential areas from some of these collector streets, using a variety of spring flowering trees and shrubs. They were beautiful in May. Comprehensive planning allowed for designing into each neighborhood, as it was developed, the roads which would connect to future adjacent neighborhoods. Fieldstad is proud that the original concepts have been built into each new part of the village.

Parks, Overpass

Another original concept that has remained an integral part of planning has been the inner park system. Milwaukee county, famous for its parks, controls a sizable portion, over 780 acres. Neighborhood and entrance parks add another 95 acres. The major park area follows the Root River as it flows from the northwest

corner where it enters the village, curves east below the original community and then exits to the south. Smaller stream valley parks connect from other areas. Dale Creek runs through the original com-Twenty-acre Scout Lake lies just east of Loomis Rd., a six-lane limited access state highway which bisects the village. A path encircles the lake and there is a pavillion for ice skaters.

The state has agreed to finance 75 percent of a pedestrian overpass which it built across Loomis. Previous efforts to have the speed limit reduced or a traffic light installed had been rejected by Wisconsin state highway authorities. according to Fieldstad. The Catholic parochial school lies just opposite the lake across Loomis to the west, and from there a main walkway provides safe access to the village center . Thus the overpass connects the eastern half of the community with the stores, churches, parochial schools and the public high school of the center as well as providing safe passage from the west half of the village to the lake and residential areas to the east. 

Over the years Gerton has provided noteworthy service and leadership to the Greenbelt community. In the 1960's when zoning was a major issue, he served on the residential - commercial- and industrial zoning subcommittee of the Greenbelt Advisory Board, the city's goals committee and the GHI zoning committee. He was also a member of the committee which worked to bring about construction of the present Greenbelt Library. During the 1960's Gerton was also active in the Labor Day Festival Programs and, as chairman, worked on the rebirth of the festival following the death of Eli Don Bullian, the previous chairman. In 1969 the U.S. Jaycees awarded Gerton its distinguished service award for "outstanding service to our commu-

Illness in the early 70's kept Gerton out of active service; but in 1972, as a member of the Board of Trustees of the Heart Association of Southern Maryland, he persuaded the association to conduct heart and related disease screening programs for Greenbelt citizens. He chaired the Greenbelt Risk Factor Screening Committee, which helped recruit hundreds of volunteers and screening of over 2,000 citizens. He also organized the CPR program in the community.

Gerton has also served on the City Council and on the Board of Directors of Twin Pines Savings and Loan Association, Because of his dedicated service to the community, he was chosen Greenbelt's Outstanding Citizen for 1977.

Other organizations that he has been active with include Citizens For a Planned Greenbelt, the Lion's Club, the Freedom of the Press Committee, the American Legion and the Jewish War Veterans of the USA.



GREENBRIAR NEWSLETTER STORY ON POLICE DISMAYS COUNCIL

The Greenbelt City Council, at its regular meeting, February 2, reacted with dismay to an article appearing in the current issue of the "Greenbriar Crier," a quarterly newsletter distributed to Greenbriar residents.

The article, entitled "Crime Prevention-What the City Council Can Do," urges Greenbriar residents to pressure council to fill a vacancy in the police department, pass a municipal infractions ordinance and use their political clout-their votes. But it was the way in which these items, apparently all desired by the police officers, who were presenting a Crimestoppers program for Greenbriar residents, were stated in the article that distressed council and manager. For example, the article states: "The Police pointed out . . . there is a vacancy on the police force that city council has chosen for some reason not to fill."

"Council needs to point out," objected Councilman Tom White, "that statement is not accurate." Staff, not council, is responsible for filling of vacancies, a process which usually takes several months, according to City Manager James Giese.

On the proposed municipal infractions ordinance the article says: "The police need an effective means to enforcement that does not tie then down with more paper work than they have now." Council has been studying the possible uses of the infractions law and has expressed serious interest in pursuing the matter. It is the staff, Giese told the News Review later, that has some reservations.

And again, the article states, "The Police noted Greenbriar has the potential to elect the entire City Council by ourselves, and move the entire Police Department into our Community Building."

White deplored this attitude that would "pit one part of the community against others."

White, who placed the item on the agenda, was concerned that what he considers a valuable "out-reach program to advise, inform and educate citizens about crime and security," apparently in this case may have been used to lobby citizens instead.

"I share your concern," Giese told White, "but I don't want to overreact." A number of comments attributed to police officers at the Janary 13 meeting "were inappropriate," he continued. "The problem is how much came from the police officers and how much came from the reporter." Giese told council he has asked Chief of Police William Lane for a report on what was actually said by the officers at the meeting. Giese also acknowledged that Greenbriar had a rash of burglaries during November and December. He said he was sympathetic to their concerns.

"The police deserve to be heard reiterated councilman Charles Schwan, "though city employees should not misrepresent council to its citizens."

Councilman Richard Pilski was not so generous. "Sounds like a familiar story," he said, "one I've heard again and again." He doubted that the problem lay with the reporter. "But I'll wait," he said

Council agreed to wait until Giese can report back to them before going any further.

While also willing to wait, White told council he had spoken to the reporter, asking, "Is the attribution of these statements (to the police officers) correct?"

board tabled a motion which would have approved management's request for authorization to contract for surveying services up to \$10,000. Manager Kopstein told the board that he had obtained an estimate of \$6,000 to \$7,000 for the survey from Oyster, Imus & Petzold, Inc., the firm which did the original survey of GHI in 1952. Kopstein indicated that it would probably be less expensive to have that firm recertify its original survey and do some additional surveying of GHI property which was not part of the original deed than to have the work performed by some other firm. The board balked at the request, however, indicating that they wished to obtain other estimates to see if the Oyster price was reasonable.
