COUNCIL TAKES DIM VIEW OF NEW BID TO REZONE GOOD LUCK LAND

During the second regular city council meeting of 1982, a somewhat wary council voted to disapprove a proposal to rezone a large tract of land along the south side of Good Luck Rd. at Kenilworth Ave. During its January 4 meeting, the city council had heard a presentation about proposed rezoning and development of this vacant land near Parkdale High School.

According to these plans, use of the land would be split to include office buildings, townhouses, and high-rise condominiums. To handle the increased traffic flow, major highway improvements would be needed at the intersection of Good Luck Road with Kenilworth Avenue.

During the January 18 meeting, council began discussion of the issue by considering a report by the city's Advisory Planning Board which expressed several concerns about the proposed "Good Luck Center." These included a recommendation that the high-rise condominium buildings should be limited to less than the proposed 12 or 13 stories, to minimize the visual impact of these structures on users of Greenbelt Park.

Councilman Thomas White expressed what he saw as an even more serious concern. He referred to the low densities of dwelling units shown on a "concept plan" being used by representatives of the property owners to promote the proposed rezoning. White pointed out that the densities allowed by the zoning categories requested would in fact be much higher. He said he thought it dangerous to base rezoning on a concept plan. Mayor Pro Tem Gil Weidenfeld, doing a quick calculation, figured that if the high-rise residential rezoning were approved, a developer would be able to construct 1,152 dwelling units—versus the 359 units shown on the concept plan.

The city council quickly agreed to recommend to the county Planning Board that the proposed rezoning along Good Luck Road be disapproved, on the grounds of the maximum densities of use possible and the severe impact on area traffic.

Md. Trade Center Park

The city council considered various recommendations about the proposed preliminary plan of subdivision for the Sunstates (Coakley & Williams) tract. This 41.2-acre property, which has been rezoned for commercial office and commercial miscellaneous use, is to be known as the Maryland Trade Center Park.

Among various Advisory Planning Board recommendations accepted by the council was one that would limit the height of two proposed high-rise office buildings in relation to the height of the existing Maryland Trade Center building. But another APB proposal, to consider "mixed-use zoning" for the property as a means of turning it into a "24-hour community," was rejected by council after City Manager James Giese spoke against the idea. Giese said that the property has just been rezoned, and the entire rezoning

process would have to be gone through again to adopt the mixed-use concept. That zoning category also allows greater density of use than does the commercial zoning, and Giese was not sure this would be desirable.

Giese pointed out that the general area of which this property is a part is already zoned in ways that will yield mixed uses. On the property itself, in addition to office space, there will be a hotel and a banquet facility. Just to the north is Greenway Shopping Center with its stores and restaurants. And just to the south is vacant land zoned for high-rise apartments.

The council also considered, and accepted, conditions for subdivision recommended by the Technical Staff of the Maryland-National Capital Park and Planning Commission. These conditions include, among others, proposed restrictions on the amount of floor space that may be constructed on the Sunstates property until nearby Greenbelt Road is widened to six lanes.

The city's recommendations and those of the Technical Staff regarding the preliminary plan of subdivision now go to the county Planning Board.

In a separate action, the city council authorized the mayor to sign an annexation agreement that will bring the Sunstates property, including the Maryland Trade Center building, into the City of Greenbelt. The agreement document has been signed by all of the present and potential owners of the property.

Council Tidbits

Council accepted a Park and Recreation Advisory Board (PRAB) report on the closed gate to the Agricultural Research Center. PRAB requested council try to get the gate reopened. If that was not possible PRAB suggested a biker/jogger entrance at the site. PRAB felt more cooperation between Greenbelt police and the Agricultural Center Security Force would help reduce vandalism. The matter will be on council's next agenda.

Work Sessions

In a work session on February 8, council will consider an Advisory Planning Board (APB) report on the Greenbelt Commercial Center Revitalization Study. APB was in general agreement with the MNCPPC study. APB added some concerns and suggestions about parking by the Co-op Supermarket and pedestrian traffic from the Mobil Station to the Center and from the Center to Center School.

Another work session was scheduled for February 2 to review Memorial Guidelines. Commemorative guidelines for naming city properties were developed by PRAB. Council, decided to defer the request to rename two city streets and the Center Mall in honor of Rexford Tugwell, Franklin D. Roosevelt and Edward Filene, until after its work session.

On Sunday, January 24, Penny Gingell, age 19, died of cystic fibrosis. Penny was the daughter of Mae Gingell, an aide at Greenbelt Center School, and a long time resident of Greenbelt. GHI Considers Million Dollar Loan Proposal

The January 21 meeting of the Board of Directors of Greenbelt Homes Inc. centered on discussion of a proposal to bring \$1,000,000 in resale financing to GHI. General Manager Tim Mitter outlined a proposal from John Hanson Savings and Loan offering a commitment of \$1,000,000 for resale financing in GHI. GHI would be required to pay a \$20,000 commitment fee. The resale financing could be used for new sales, to refinance existing owner take-back loans for sales already completed or to provide financing for balloon mortgages which some members now hold and which are coming due.

Board President Jim Smith wanted to know which members this financing would benefit, "Are we using corporation funds to benefit members who have sold their houses and moved away?" he asked. He felt that to use the money for refinancing owner take-backs would not benefit current members who would have to refinance at higher rates than they currently pay. Mitter responded that GHI could require that the money be used only for balloon mortgages and for future sales. Director Margaret Hogenesen was in favor of obtaining the financing especially to benefit members who might be in jeopardy of losing their homes when balloon mortgages come due. Director Wayne Williams felt that "we need to do whatever we can to make our homes saleable." Management further explained that the \$20,000 commitment fee paid by GHI could be passed on in the refinancing and that this offer by John Hanson was the result of lengthy negotiations and represented the first new financing to come into the community.

Thermostats

The board reviewed and approved information to be sent to members on placement of electric heat thermostats. Standard placement will be on the baseboard unit. Members who want thermostats mounted higher on the wall should contact Dennis Lewis, Member Services Coordinator on 474-6644.

Members on boiler #23 on Laurel Hill Road were without heat last Sunday night until Monday mid-day. The boiler had run out of oil and further complications then developed, parts needed to be replaced and repair work done. Steuart Petroleum is responsible for checking and filling the oil tanks. The company has assumed full responsibility, apologized in writing and sent GHI a penalty check of over \$13,000.

The board directed management to develop a policy for placement of TV antennas in response to members' problems in getting Super TV antennas installed and approved by GHI.

Responding to the comment by June Didas that the Personnel Committee had not recommended the full-scale renovation which is underway for the employees lunch




