Five Incumbents and Three Challengers Compete for Five City Council Seats

The September 20, 1983 city council election appears to be devoid of significant issues to divide the candidates. As a result voters in next Tuesday's election may have to look to other factors as they make their selection - things like the candidates' personalities and the degree and length of their involvement, their leadership and experience, in public affairs within the city.

Over 50 percent of Greenbelt's 3,194 eligible voters are expected to cast their ballots on September 20 to elect the five city council members who will head the municipal government for the next two years. Incumbents Robert Zugby, Thomas X. White, Gil Weidenfeld, Edward Putens and Richard Pilski are seeking return to Council. Also, out on the hustings are challengers Francis W. White, Herbert Jones and Antoinette "Toni" Bram.

The current campaign is in many respects a mirror image

Public safety and traffic - in particular the Edmonston Road-Greenbelt Road intersection - are troubling Springhill Lake residents. Greenbelters in all sections of the city have a common interest in Metro and an intra-city bus service.

Major speculation concerning the election centers on (1) who will poll the highest vote among the successful candidates to be in line for selection as mayor, (2) whether a woman will be elected, (3) whether differences among the incumbents in filling a vacancy in early 1983 will be a factor in the voters' decision and (4) whether a former mayor and councilman can return to a position of leadership in the city.

Top Vote-Getter

Councils have traditionally chosen the top vote-getter as mayor although the city charter is silent on this point. Since 1973 - with the exception of 1981 - the selection of mayor has seen-sawed between Gil Weidenfeld and Richard Pilski. Greenbelt pundits anticipate that these two rivals will again vie for the top slot, but they remind Greenbelters of the surprise finish in the 1981 election. Richard Castaldi then out-poll Weidenfeld by 39 votes and Pilski by 170. When Castaldi was elected to the Prince Georges County Council in November, 1982, Weidenfeld again became Mayor and Pilski, Mayor Pro-tem.

Women on Council

Greenbelters have elected four women to city councils since 1938. Ruth Taylor was on the second and third Council from 1938 to 1941. Elizabeth Harrington served from 1947 to 1951, two years as mayor. Elizabeth Mafay was elected in 1969 and again in 1971. Rhea Cohen served from 1971 to 1973. Since 1973, four women have been unsuccessful in their quests for a council seat.

This is Bram's first try for election and, according to pundits, she has a realistic chance of capturing a council seat. Bram threw her hat in the ring with six other hopefuls when the Castaldi vacancy occurred.

She was one of seven to apply for the position, but the field soon narrowed to two during lengthy deliberations on whom council would appoint to succeed Castaldi. See ELECTION, p. 8, col. 1

New Animal Warden

The city has announced that Cheryl Allebach has been hired as animal warden. Allebach has a degree in Animal Science from the University of Maryland. She also has experience as kennel warden for the city of Bowie and in a veterinary's office. On her first day on the job, Allebach apprehended a large German shepherd dog which had been roaming free in the North End area. The dog had been the subject of several complaints.

Election Procedures

Voting on election day, Tuesday, September 20, will be held from 7 a.m. to 8 p.m. at four polling places - the Greenbelt Municipal Building (Precinct 3-Center), St. Hugh's School (Precinct 6-North End), Springhill Lake Community Center (Precinct 8) and Greenbriar Community Center (Precinct 13-Greenbelt East).

Greenbelters will elect five council members for a 2-year term, all at large. In order to be elected a candidate must receive 40% of the votes cast. If fewer than five candidates receive such a vote a run-off election will be held one week later on Tuesday, September 27.

In a run-off election the ballot will consist of those unsuccessful candidates receiving the highest number of votes, up to twice as many names as there are positions to be filled. Candidates polling the greatest number of votes are declared winners in the run off election, regardless of the percentage of votes received.

The 40% requirement for election was introduced in 1967. Earlier a majority vote was required, frequently resulting in run-off elections. Since 1967 no run-offs have taken place. The last run-off election in 1965 pitted Richard Pilski against Clifford Simonson. Pilski won by one vote.

If all five council members are elected on September 20, there will be an organizational meeting on Monday, Sept. 26. (This meeting is set by charter.) If there is a run-off election, the organizational meeting will be held on Monday, October 3.

Upon being sworn in, the newly elected council will choose the mayor.

Voters will be asked to complete a city prepared information questionnaire dealing with city programs and services, possible update on acquisition of and uses for North End School, and types of projects that should be included in a capital improvements bond issue. (See questionnaire, page 6.)

Some 3,194 Greenbelters are currently on the voter registration rolls, down 9.3% from 1981. Registration declined in all precincts primarily because some 682 registered voters who did not vote in the two previous council elections were removed from the registration rolls.

Applications for absentee ballots must be made in writing no later than noon on Monday, September 19. Ballots must be returned no later than 6 p.m. election day. Applications are available in the city office.

The population of Greenbelt is 17,332, according to the 1980 census. It is estimated that there are about 14,000 persons 18 years and over who are eligible to vote. The

Council Postpones Pet Control Issue Until After the Election

The Greenbelt city council released the CRAB recommendations on pet control at its regular meeting on Sept. 12, but, running into a legal bind, voted for a work session on the problem and will take up the recommendations again October 3 after the elections.

CRAB's "Report to Council" lists five recommendations. First, the report states, the present ordinance is "outdated" and should be revised. Revisions should embrace these points: increased fines ("... the present \$10 impoundment fee is not high enough to discourage offenders"), the establishment of an Animal Control Board, proper disposal of wastes, limitation of the number of animals, and a "leash law."

Second, the present ordinance should be enforced, whether it is ever revised or not.

Most of those present at the August 24 CRAB hearing were residents of Greenbelt Homes, Inc. CRAB recommends that the city manager and the GHI manager get together and work out ways for "possible co-operative effort."

Animal wardens should receive "appropriate training to increase their effectiveness."

The CRAB "Report to Council" concludes with the suggestion that "every effort... be made to publish the animal control rules so that all citizens are aware of these regulations." To meet this goal, CRAB recommends use of the News Review, civic and homeowners associations, pamphlets and posted signs.

The council was prepared to take action on a part of these recommendations by listening to a "first reading" of a staff-prepared revision of the penalties contained in the present ordinance. The revision would increase the present \$10 penalty by tacking on a \$5 impoundment fee for each calendar day... an animal is boarded at the city animal control shelter.

During the discussion of this point, City Manager James K. Giese raised a point of related

importance. Even though the city has been issuing animal licenses since the early 1960's, Giese said, State law reserves to the county the right to issue pet licenses.

Emmett Nanna, the City Attorney, supported this point and said the city would have to seek a change in the State law.

Council work on the CRAB recommendations bogged down under other objections.

Joseph Costa, speaking from the audience, said he could not see the connection between the CRAB recommendations and the course of action the council was pursuing with a \$5 impoundment increase.

"The CRAB recommendations (as a whole)," Costa said, "should form the basis of changes in the ordinance."

Mayor Gil Weidenfeld said the council has not yet had the opportunity to discuss the CRAB report. He recommended a work session for September 26 to go over the CRAB suggestions "as a whole, not piecemeal."

Watching the council work in this way, said Eunice Coxon, is like watching "the mountain give birth to a mouse."

She stated again that the city should follow the lead of Bowie and College Park in dealing with its pet control problems and noted in passing that by scheduling the work session for September 26 the council doesn't "have to go to work on this before the elections."

The council moved to have the CRAB recommendations put on the agenda October 3 regular council meeting.

As Councilman Richard Pilski put it, "This will be a good issue for the new council to begin with."

ELECTION SURVEY QUESTIONNAIRE

Residents who are not registered to vote or who otherwise are not planning to be at the polls are encouraged to clip and complete the questionnaire. They should be mailed or returned to the City Offices, 25 Crescent Road 20770. Voters may also, if they wish, complete the questionnaire in the paper and return it to the polls at the time they vote.

of 1981. There are no referenda and no slates. Incumbents are considered to have an edge because the eight candidates' positions are generally similar on zoning and development, transportation and crime control. While all candidates advocate adequate police protection and crime prevention programs, Jones has suggested that "police ethics and practices" is an issue.

Early in the campaign and again at several candidates' forums, problems surfaced concerning unleashed dogs in the center of Greenbelt. Other matters on the minds of residents living in the core include: Center School renovation, North End School uses, intrusion of Parcel 15 and other development into Attick Park and development of Parcels 1 and 2 in north-east Greenbelt and crime control and prevention.

Traffic problems on Greenbelt Road and the impact of encroaching development in Greenbelt East and its environs are key issues in Greenbriar, Glen Oaks and Windsor Green. A major concern in 1981 - police protection - has eased with increased cooperation between the department and residents.

Bring Out the Vote!

It is appalling to view voter participation figures in City Council elections. In 1981, only 1,808 Greenbelters voted out of 3,522 registered. Those numbers represented 13 and 25 percent respectively of the potential electorate, based on 1980 data.

Yet to bemoan voter participation is to miss the point. What the figures reveal is voter apathy. If we could find a way to stimulate interest, we should no longer have a problem of low vote totals.

I do not understand why so many Americans treat with disdain their birthright to participate in governmental decision-making. Much the smaller part of our fellow travelers on this planet shares our privilege. Indeed, at any given time many of them are endeavoring at the risk of imprisonment or worse to secure what we consider a right.

Not to participate in Greenbelt decision-making is especially difficult to comprehend. Council prides itself on being an open forum. Any citizen will be given a courteous hearing. And no one can convince me that most Greenbelters are indifferent about law-enforcement, maintenance of streets and parks and recreation activities.

So come now, registered Greenbelters, take part in the most basic feature of democratic government. Let's raise the 1981 percentage of those voting from just over 50 percent of those registered to 75 percent this year. Anyone for 80 percent?

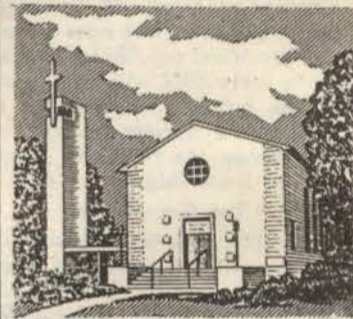

Utopia's "Dr. Cook's Garden" Builds Plenty of Suspense

Dr. Cook's Garden, a mystery by Ira Levin, presents playgoers with a suspenseful and emotionally-charged plot. Conflicting values, characteristics, and feelings, as well as tensions brought on by decisions facing the characters, make for a fulfilling evening of theater.

Dr. Jim Tennyson, played by Jeff Beyrent, returns to Greenfield Center, Vermont after completing his medical training to visit his old friend and mentor, Dr. Leonard Cook, acted by John V. Gentile. When Tennyson makes a connection between a code used in the garden maintenance system and one used on patients' medical records, he realizes that his colleague has been practicing medicine in an unorthodox fashion.

Beyrent and Gentile are well-cast as the young and older doctors, respectively. Beyrent brings the fitting amount of youthful idealism to the role, while Gentile is especially good at not letting Cook's guilty conscience betray him. The two actors bring out well the contrasts of youth versus age, big city versus small town, and youthful idealism versus a rather sinister idealism.

A number of emotions conflict in Dr. Tennyson. He feels gratitude for what Dr. Cook has done for him in the past, yet also horror at what he discovers about the elder's practice. Should he report his findings or not? At one point in the play, the fate of Dr. Cook lies in his hands: how should he act? Should he stay in town or not? Beyrent generally gives a good portrayal of the feelings which come into conflict, but could add some intensity at the points where the greatest demands are made of conscience.

Both Gentile and Beyrent succeed in making the audience believe the lies that Levin uses so skillfully in certain of his plays.

Judy Holland as Bea, Dr. Cook's nurse, and Marie Tousignant as Dora, his cook and housekeeper, bring a great deal of warmth and charm to their roles. Their adulation of Dr. Cook and their own goodheartedness help create an atmosphere in which evil seems an unlikely intruder.

Bruce Chubb Miller, as Elias the gardener, gives a flavorful portrayal of the laconic, New England man of the earth.

The warmth of the set is deceptive and reinforces the theme of appearances versus reality. Additional props could be used to give the set more of the feeling of a doctor's office, e.g., a scale, or a stethoscope on the desk.

Performances will be held at the Utopia Theater, on Fridays and Saturdays, September 16, 17, 23, and 24 at 8:15 p.m. with a matinee performance at 2:15 p.m. on September 25. For information call 474-7763, or 441-8770 one hour before showtime.

With relief and gratitude Greenbelt salutes the Board of Education and its staff for deciding to renovate, not raze, Center School. To have replaced this centerpiece would have meant irreparable damage to the concept of the planned community.

As evidence of the city's gratitude, an offer might be made to the Board of Education for use of North End School while Center School is being renovated. Because it is undesirable, however, that North End School remain idle until 1989—the scheduled date of renovation—the Board might even be persuaded to move forward the 1989 date. Use of North End School would reduce the need to bus children and the overall cost of renovation. In short, a 1984 or 1985 date would be in everyone's interest.

Another possibility would be to raze North End School while continuing to use Center until a new North End School were built.

When that time came, the city would acquire Center School. Possibly the North End site might be too small to continue its use for a school. Or perhaps continued use of Center as a school is needed to keep faith with the original concept of the planned community.

He has continued his affiliation with the U.S. Navy as an active Naval Reservist, now completing 24 years of Naval Reserve service. He is assigned to a Navy Reserve Surgical Team at Adelphi, Md.

White began his active community service in 1962 when he served with the Greenbelt Jaycees, the Citizens for a Planned Greenbelt, and various committees and elective offices of the Greenbelt Homes Inc. (GHI) Cooperative. He served on the GHI Audit Committee for three years, the GHI Board of Directors for four years, and served as the Treasurer of GHI during 1973-74. He was one of the founders of the Greenbelt Save Our Community Committee (SOCC). SOCC was instrumental in preventing the location of a planned three school complex on Par-

cells 1 and 2 west of the B-W Parkway. He led the opposition to the use of a package temporary sewage treatment plant to serve new residential properties in Greenbriar.

Francis White served four terms on the city council, two as mayor, before his election to the first Prince Georges County Council and was the first county councilman to represent Greenbelt. In his second 4-year term he served for one year as county council chairman. In the period 1978-82 White served in the House of Delegates representing the then 26th District.

A graduate professional engineer, registered in Maryland, White first moved into Greenbelt in December 1949 living on Hillside Rd., later moving to 2-A Gardenway for five years. In 1961 he built a house at 42 Lakeside Dr. where he presently lives. White began his political career in recreation, serving five years as a team manager and president of Little League. 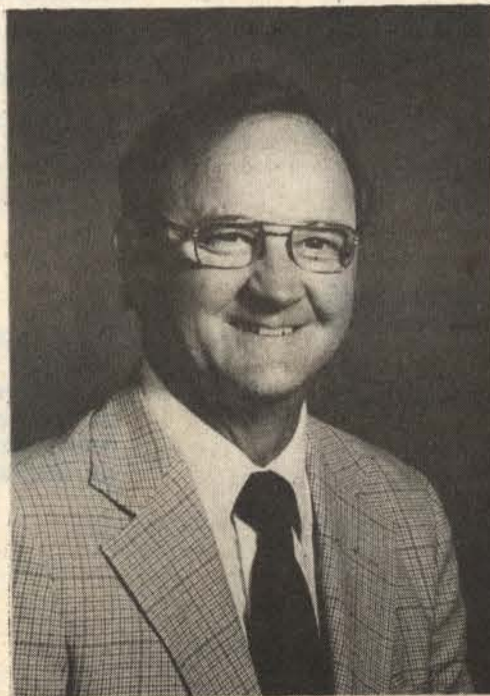






di. In early 1983 Council found themselves stalemated. Putens and Weidenfeld were pulling for Bram, and Pilski and White for Zugby. (In 1981 Zugby had lost his first bid for election, garnering 48% of the vote.) When the deadlock persisted, Bram decided to withdraw.

Comeback?

Francis W. White served four terms on city council, two as mayor, 1961 to 1963 and 1969 to 1971. In the hot 1963 election, when development and zoning were burning issues and almost 81 percent of the registered voters cast ballots, Francis White was defeated in a runoff election in which 75 percent of the voters again turned out. In 1965, he was again elected to council and was reelected in 1967.

Potpourri

Putens and Zugby reside in Greenbelt East, the first representatives of that section of the city to serve on council. Putens' ascent to council in 1981 was the first time since 1971 that a candidate who resided outside the center of the city was elected. In that year Weidenfeld, then a resident of Springhill Lake, was elected to his first term on council. Previously Springhill Lake's Joel Katz ran unsuccessfully. In 1981 Konrad Herling of Springhill Lake garnered 48 percent of the vote in a successful council try.

Weidenfeld, Pilski and Thomas X. White have served together since 1973. All three are from the center of Greenbelt along with Bram, Francis W. White and Jones.

This is the first time that three candidates who have served as mayor - Pilski, Francis W. White

city has 8,100 housing units, with 2,898 in Springhill Lake, 1,198 in the Greenbriar/Glen Oaks developments, about 350 in Windsor Green, and the remaining units in the core of the city. The 1980 census notes there are an average of 2.26 persons per household.

Casting votes in the 1981 council election were 1,801 Greenbelters, 51.3 percent of the registered voters. Sixty-three percent of the electorate voted in the North End, 57.6 percent in the Center, 43.7 percent in Greenbelt East, and 21.9 percent in Springhill Lake.

In 1979, 62 percent of the eligible voters trekked to the polls; in 1977, 59 percent turned out; in 1975, 48 percent; in 1973, 54 percent; and in 1971 54 percent. However, in 1969 a hot election brought out 75 percent of the 2,991 registered voters.

Serving on the Greenbelt Board of Elections are Jule Churchill, chairperson; Joe Comproni, Nat Shinderman, Pat Gardes and Robert Spear.

and Weidenfeld — have filed in the same election.

Two candidates with the same last name are running - Thomas X. White and Francis W. White. Pilski has the longest length of service — nine consecutive terms starting in 1965. He also was appointed and served for several months in 1963.

The 1983 election will probably be remembered as the year in which all candidates subjected themselves to what certainly must have felt like a perpetual sauna bath as they walked through the heat of this extraordinary weather to campaign door to door.

JAVELIN RECORD HOLDER HAD GREENBELT COACH

Bill Webb, son of Mr. and Mrs. John Webb of Crescent Road, has been credited with coaching the new javelin world record holder, Tom Petronoff, to his new status. Bill Webb is coaching at Southern California - Northridge College. Track and Field News magazine for June 1983 carried a feature story on Petronoff twice mentioning Coach Webb. Petronoff's record throw was 327 feet 2 inches. Petronoff recently won four meets overseas but took second place in the world championships in Helsinki, Finland recently. He is America's leading candidate for a gold medal in the javelin for the 1984 Olympics.

Police Blotter

The Maryland National Bank in Greenway Shopping Center was robbed at gunpoint on September 13. Two men, one armed with a handgun, held up the bank about 12:30 p.m. One of the men went behind the counter and removed money from a teller's drawer. Both men wore stocking masks. The suspects are described as black males, 18-25 years of age. One was wearing a blue jogging suit with yellow stripes on the sleeves and legs, white tennis shoes, dark stockings and a navy blue hat with a brim. He was described as having a medium complexion. The other suspect was wearing a navy blue hooded rain slicker and was described as having a dark complexion. After the robbery, the men fled by unknown means.

There was a strong-arm robbery near the A&P store in Beltway Plaza close to Cherrywood La. on Sept. 11 about 8 p.m. A male pedestrian was robbed when a car with four people in it pulled up beside him and demanded that he give them money. The occupants of the car made verbal threats and one of them brandished a piece of pipe.

Another strong-arm robbery occurred on Sept. 9 about 9 p.m. when a male juvenile grabbed a woman's purse and ran off into the woods. The incident occurred in the parking lot near El Torito's in Greenway Shopping Center.

Two cases of indecent exposure occurred on Sept. 12, the first on Gardenway about 5 p.m. and the other in the 45 Court of Ridge Rd. shortly thereafter. Both incidents apparently involved the same man who was described as a white male, 40-50 yrs. of age, 5' 8"-5'10" tall, with gray hair and a pot belly.

There has been a rash of cases of malicious destruction to motor vehicles in several different sections of the city on Sept. 6-8. Antennas were broken and in some cases windows were also broken. The Greenbelt police department again urges residents seeing suspicious persons around vehicles in parking lots to call the police department as soon as possible.

A nighttime burglary occurred in the 24 Court of Ridge Rd. in the early hours of Sept. 11. The home was occupied when the burglary took place. Entry was made through an unlocked door and money was taken.

Officer Michael Rasmussen arrested a male non-resident for breaking into a storehouse in the 6100 block of Greenbelt Rd. on Sept. 7. The suspect was also carrying a concealed deadly weapon.

CITY NOTES

The general and parks crews worked most of last week cleaning up the area of the Labor Day Carnival. The carnival booths were dismantled, painted, and stored.

J. Paul Williams attended a seminar on Traffic Control Devices at the University of Maryland, College Park, on Tuesday. Paul also attended a COG Purchasing Officers' Meeting.

Members of the general crew relocated part of the pathway at Attack Park between Braden Field and the bridge. Work was also done on the drainage ditch between Maplewood Court and Lakeview Circle. The electrician installed new high pressure sodium lights in the east and west parking lots this week.

The parks crew picked up roadside debris and worked on maintenance of the golf course and ballfields.

WARNING

In the past few weeks, several instances of indecent exposure and sexual assault (grabbing and fondling) have occurred, primarily in old Greenbelt. According to the Greenbelt police department, these cases have not been confined to any one specific area or any specific time of day although many have taken place at night.

Police investigators have not determined whether there is more than one perpetrator involved in these occurrences. However, the police department warns women to be especially watchful, to avoid isolated areas and to be particularly careful after dark. All citizens are requested to be alert to suspicious persons or activities. All suspicious activity should be reported immediately to the Greenbelt police department, telephone 474-7200.

A counterfeit travelers check was recently passed in the city. It counterfeited a VISA traveler's check issued by Barclay's Bank.

A motorcycle was stolen over the weekend from Edmonston Court. It was later recovered by Cpl. Thomas W. Miskell.

A locked car was broken into on Sept. 9 in the parking lot of Greenway Shopping Center. A cassette deck was stolen. A stereo was stolen from a motorcycle on Edmonston Rd. over the weekend.

Infant Car Seats to Be

Required by State Law

Car safety seats for children two and younger will be required by Maryland law beginning January 1, 1984. To comply with the law, children must be buckled in safety seats which meet federal standards.

All car safety seats made since 1981 comply with federal standards. "Car safety seats are not car beds or lightweight plastic carriers," explained Lorraine Bernstein-Cohen, Coordinator of Project KISS (Kids in Safety Seats) of the Maryland Department of Health and Mental Hygiene.

Damaged Propane Tank Disrupts Festival Sunday

On Sunday afternoon, September 4, during the Labor Day Festival, a 100-pound propane fuel tank began leaking gas in the vicinity of the swimming pool and the parking lot behind Co-op. The Greenbelt fire and police departments were called and the area of the swimming pool and parking lot was evacuated for over an hour while the gas dissipated.

According to Captain Matt Webber of the Greenbelt Volunteer Fire Department, the tank was being unloaded from a truck for use at the festival when it accidentally fell. As it hit the ground, the valve broke off the top of the tank. This resulted in the gas flowing from the tank with no means for shutting it off. The fire department was called and upon arrival had the area evacuated because of the significant hazards the leak involved. The tank with its broken stem was placed in the area between the parking lot and softball field, where it was left, isolated, for the vapors to dissipate.

After an hour and twenty minutes, when the gas had finally dissipated, and the fire department was satisfied that it was safe to resume activity, the swimming pool and parking lot were reopened.

Dick Good 73rd in 67:56, Bill Bishop 86th in 69:56, Larry Noel 94th in 71:45, Lee Johnson 109th in 73:03, Theresa Downs 5th woman overall and first Greenbelt woman in 134th place in 77:25, Drew Lewis 142nd in 78:48, Ron Douthy 142nd in 78:48, Ray Bodner 161st in 84:39, Mike Kinzie 165th in 85:09, John Prather 167th in 85:24, Carol Prather 175th in 87:48, Charles Farrell 184th in 94:54, and Ken Hendricks 186th in 95:14. Former Greenbelters Martin Greenbaum was 78th in 68:10 and Mike Noel 121st in 76:00.

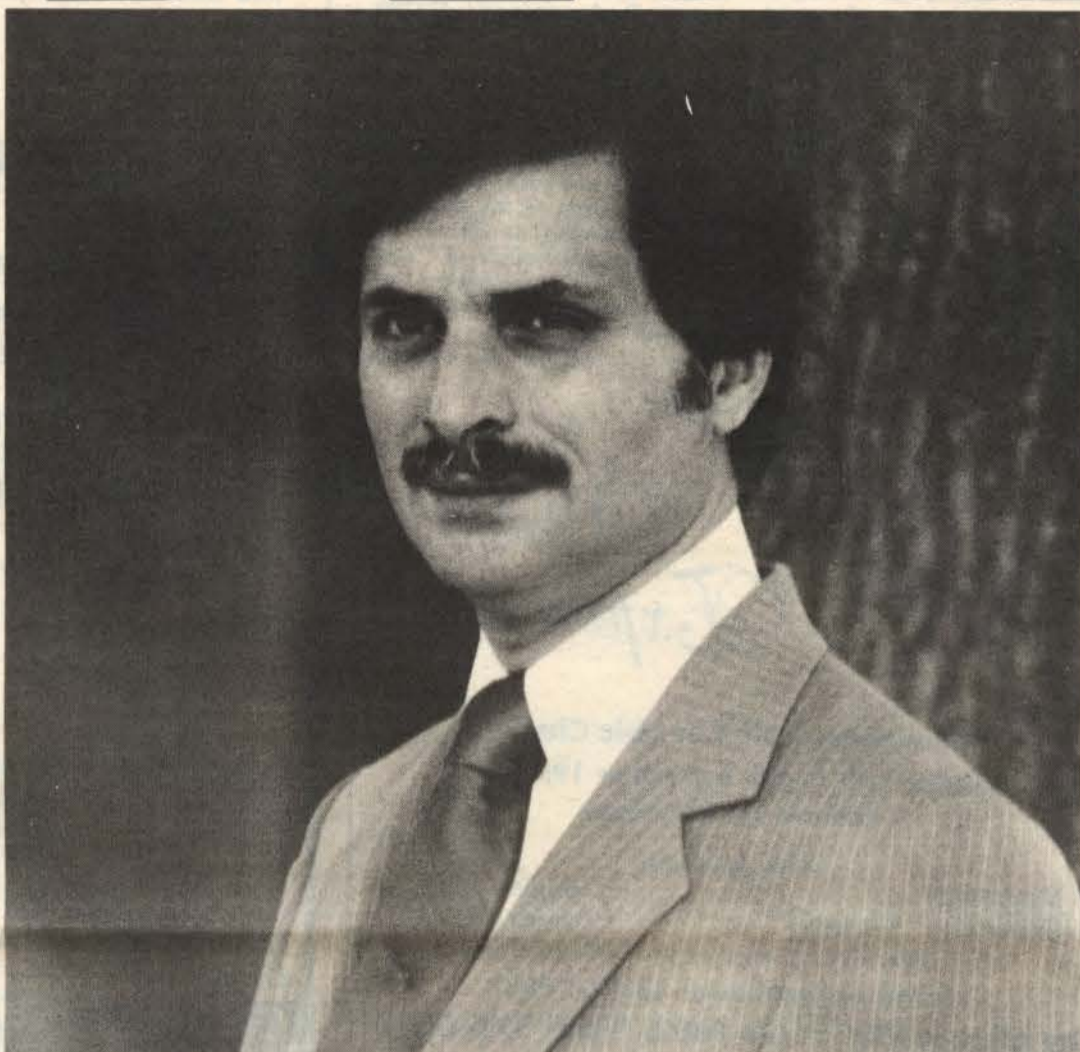

ERHS Students Work To Be in Space Shuttle

Two experiments from Eleanor Roosevelt High School were among eight scientific experiments designed by students of the Prince Georges County Public Schools which were selected to fly aboard a NASA space shuttle in 1985. The selections were made following seven months of intensive research and proposal development by teams of students and teachers at six Prince Georges high schools.

The experiments will be constructed during the next ten months and ultimately placed inside a five-cubic foot canister known as a "Get Away Special" (GAS). The GAS canister was donated to the Prince Georges and Montgomery county public schools by Orbital Systems, Ltd., an aerospace engineering firm located in Glenn Dale, Md.

From a field of 61 original proposals designed by Prince Georges students, the eight finalists were selected on the basis of the merits of their investigation, the probability of acquiring success and their suitability for limited space and power inside the GAS canister.

Following the construction of the experiments during the next school year the eight separate

projects will be integrated into the canister. Once integrated the canister will be sent to Cape Kennedy, Florida where it will undergo further stress testing. The anticipated launch date is early in mid-1985. Each project will include a control experiment on Earth.

The following Eleanor Roosevelt High School projects have been selected to fly aboard a 1985 space shuttle:

"Nematodes." The life cycle development of the nematode *Caenorhabditis elegans* will be studied under weightless conditions to determine if any abnormalities or mutations will occur in the organism development. The life cycle will be halted four times during the flight to study the mutation rates and distribution of the life stages of the population.

This project was developed by tenth graders: Janet Sayre, Yong-Tack Chon, R. Erika Elvander, Chris Harpold, Sanjay Natarajan and Susan Thorton under the direction of Dr. Donald Horrigan.

"Cosmic Rays." By building a device to detect and identify energized ions, this experiment will examine the origin and energy levels of certain cosmic rays. The

She's A New Choice

GHI Boiler Rooms to Be Offered To Adjacent Owner; First Price Set

At a meeting on Sept. 1, the board of directors of Greenbelt Homes, Inc., again wrestled with the problem of setting a policy for the sale of the small boiler rooms without an appraisal on which the price could be based. By membership vote at the last annual meeting, the members in the adjacent units are to be allowed to purchase the boiler rooms 'as is' at a price set by an independent appraisal. Since no appraiser has been found who is willing to put a value on the boiler rooms, the board had requested at its Aug. 11 meeting an opinion from the corporation counsel on the legality of the board's proceeding with such sales.

According to General Manager Shekar Narasimhan's statements, the legal counsel had advised that the board could sell the boiler rooms without an appraisal as long as they adhered to an "objective, reasonable and consistent method" of setting values. Armed with this opinion, the board passed a motion which authorized management to offer these rooms to the adjacent unit owners on the following basis: the space is to be used for living space; the final purchase price, to be approved by the board, would be determined by considering the need for removal of the boiler, structural repair, waterproofing needs and the amount of yard space associated with each room; GHI would have any needed access to the space; the member would repay rehab charges the member's mutual ownership contract would be amended to include the additional space. A further stipulation was that GHI would have the right to repurchase the room for the original purchase price if the member has not completed the work within two years.

This policy-setting motion was passed 4-0, with Director Frank Gervasi abstaining. (Directors Joe Jenkins and Mark Dombrowski were absent; Director Wayne Williams arrived later.) The board then passed a second motion (4-1, Director John Lewis opposed) specifically authorizing the sale of the boiler room adjacent to 16-Z-2 Ridge Road, at a price of \$1,000 plus an estimated \$2,000 in rehab costs.

Land Reserve Loan

In other business, the board turned down a member's application for a loan from the land reserve fund to finance installation of siding and insulation on a block home. The general manager pointed out to the board that the State Historic Preservation Officer had refused permission for installation of siding on the block houses and, in the corporation counsel's opinion, such installation could have an adverse effect on GHI's National Register membership. Narasimhan further noted that GHI's lending funds directly for this purpose might unnecessarily increase this risk.

Members of the board also noted that there had been a moratorium on loans from the land reserve fund. To end that moratorium would entail immediate decisions on interest rates, and length and type of loans. A mo-

tion to refer the issue of loans from the land reserve fund to the Finance Committee was approved unanimously.

The member inquiring about the loan indicated that insulation to ease a heating problem was of primary importance in considering installation of siding. Gervasi cautioned that insulation consisting of at least 2" of polystyrene would be needed to make a difference in the chilliness of the unit. The board referred this aspect of the matter to the Engineering and Maintenance Committee with instruction to work with members who are planning to install siding and installation in order to develop specifications for insulation under vinyl siding.

Masonry Painting Program

The board also heard a report on the remaining issues in the masonry painting program. By unanimous vote the board passed a motion by Wayne Williams which allows trim painting with the 12 colors which are already approved for outside walls. The board also referred unresolved questions on trim painting (including what, exactly, is trim) to the Aesthetics and Environment Committee for recommendations.

Financial Report

The board received a 6-month financial report which showed receipts running \$35,000 above projections and expenditures \$65,000 below. Receipts from home sales and interest income account for most of the income rise while savings in real estate taxes and insurance costs explain the major part of the decrease in disbursements.

The board approved a height exemption for a shed under construction at 48-A Ridge Rd. by a 5-1 majority (Williams opposed) on the recommendation of the A&E Committee. However, the board refused to act on an exemption request for a 6-foot privacy screen for members at 35-J Ridge Rl. This request was referred to the A&E Committee.

Brief meetings of the Green-

belt Development Corporation (GDC) and the Greenbelt Homes, Inc. Development Corporation (GHDC) boards were also held. The GDC board received comparative balance sheets and operating statements showing the corporation operating close to the break-even point. The GHDC board received notification from management that the mechanical ventilation test ordered by the board would be conducted at 2E-K Westway, one of the buildings which had the most severe moisture problems last winter.

Management also informed the board that Lyons Associates are preparing a presentation on their findings about the structural engineering work which would be required on the 17 buildings surveyed. A special work session has been scheduled for Sept. 21 for this presentation. Members are invited to attend.

GHDC also received a financial summary of operations as of July 31. The report showed that cumulative rehab and related expenses of more than \$16 million through that date. Cumulative GHDC administrative and operating costs of \$1,630,771 are included in this amount.

Meetings

The next board of directors' meeting was set for Sept. 15 and the October meetings were scheduled for Oct. 6 and 20 (1st and 3rd Thursday). These changes were made to accommodate travel plans of directors and staff members. President Margaret Hogsden, Director Don Volk, the General Manager and Comptroller Don McGinn will attend the annual meeting of the Eastern Cooperative Housing Organization in Cleveland in late September. In October, Hogsden, Narasimhan and Assistant General Manager Gary Morningstar will attend a conference of the National Association of Housing Cooperatives in Atlanta. Morningstar will present a workshop on the rehab program at that conference.

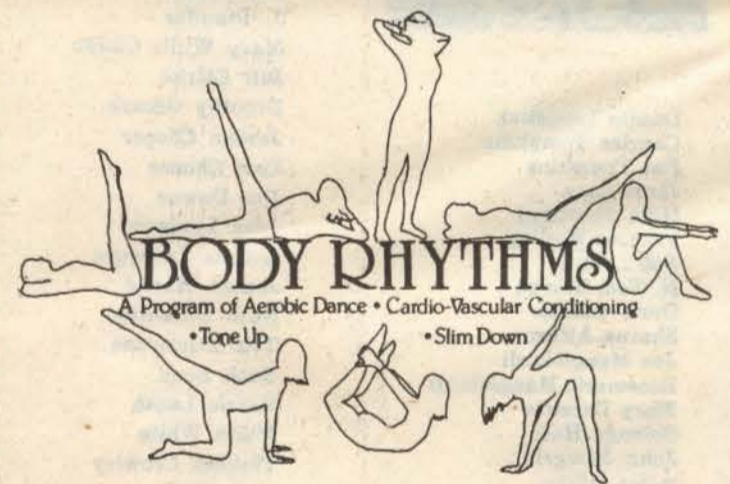

Boxwood Annual Meeting Review of 1982 Actions

On August 18, the Boxwood Civic Association held its annual business meeting. Joe Isaac, president, reviewed some of the Civic Association's accomplishments during the past year: operation of a booth at the Greenbelt Labor Day Festival and sponsorship of a Miss Greenbelt Pageant entry; neighborhood pizza party in October; testimony on local issues—naming of Attick Lake Park and Roosevelt Center; the county budget; and a proposed increase in PEPCO's rate; co-sponsored a debate on the "Trim plus 4"; instituted Crime Awareness activities in Boxwood; and published a new Boxwood Village Directory.

Particularly highlighted among the civic association's achievements was its success in petitioning the city council to erect a bus shelter on Crescent Road at Lastner Lane and a community bulletin board/shelter at Ivy and Lastner Lanes. Actions taken for the coming year include: continued operation of the Labor Day Festival booth and sponsorship of a Miss Greenbelt contestant; a sixth annual neighborhood party—a "Bull Roast" to be held Sunday, September 25 on Parcel 7; creation of a Dog Supervision Advisory Committee to review and comment on proposed city policy; urge police to enforce speed limits in Boxwood; undertake a "Community Pride Neighborhood Clean-Up" campaign; and seek contributions for an annual scholarship or civic award/donation.

To facilitate the free exchange of homes, Narasimhan noted that the cooperative will continue to seek resale financing from a variety of sources. The organization will also continue to focus on making GHI the very first co-op to get access to the secondary mortgage market.

Narasimhan will work to increase the efficiency of GHI's operations. "I'm cognizant of the need to economize," he explains.

In the future, he intends to keep GHI more active in the cooperative movement of which GHI is a part. Currently he is running for Deputy Speaker of the Greenbelt Cooperative, Inc. (GCI) Congress. He holds the position of Vice-chairman of the Coordinating Committee to Identify Viable Alternatives for GCI.

A native of India, Narasimhan received a B.S. in Chemical Engineering from the Indian Institute of Technology in New Delhi. He received his M.B.A. degree from the University of Pittsburgh in 1975. All his previous work

has been in democratic settings for other types of non-profit organizations. Prior to joining GHI, he served as Associate Director for Field Programs of Rural America, Inc., Director of Housing of the Human/Economic Appalachian Development Corporation in Berea, Kentucky and Executive Director for the David

Community Development Corporation in David, Kentucky.

Narasimhan lives in Alexandria. His wife, Charu, is a classical Indian dancer. She also teaches preschool and Indian dance. The rest of his family, his parents and sister, live in Silver

Spring.

Mitter left GHI on September 5 to take a position with Ferris and Company in their public finance division. Mitter has served GHI for three years, spending his first year as Assistant General Manager under Kenneth J. Kopstein.

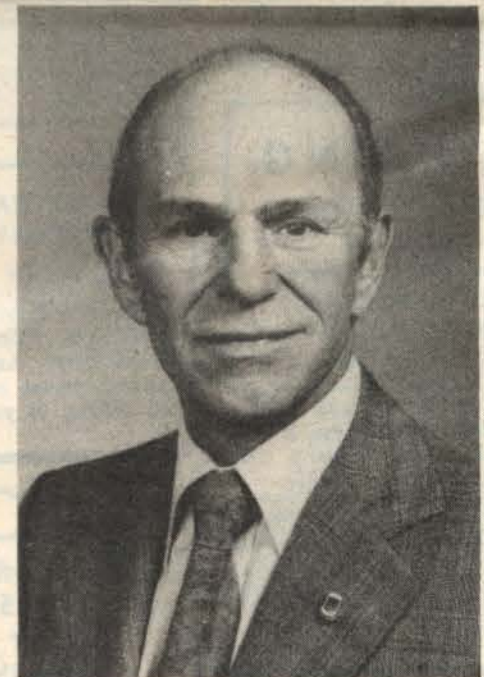
