## County Officials' Pressure Reinstates Metro Line Extension to Greenbelt

It was like the poor child who got the bicycle he wanted but never expected to get. But there it was next to the birthday cake — an unexpected surprise.

That's the feeling much of Greenbelt is having lately about the recent Metro (Washington Metro Area Transit Authority) Board's approval of a plan to move ahead with the Greenbelt Metro line and station and other unbuilt portions of the 101-mile regional Metro-rail system.

The Greenbelt station, expected to be completed in 1992, will be the terminus of the Green Line extension from Ft. Totten. Construction is slated to begin this fiscal year, costing an estimated \$450 million. Twenty percent will come from local and 80 percent from federal funds.

The station, which will be located on the Springhill Lake Industrial tract west of Cherrywood Lane, was originally slated for completion in 1979. However, officials are confident that the funding and routing issues that have delayed the start of construction will be resolved soon. The United States Senate and House are expected to approve measures that would pressure the Reagan administration to lift its 76.4-mile limit on Metro by allowing funds previously authorized by Congress to be used. The long-standing alignment problems in College Park also appear to be close to settlement.

### "Good Achievement"

The inclusion of the Greenbelt station in the plan, although fervently fought for by County Executive Parris Glendening, among others, was a surprise. "You have to remember that going into it (talks with the Metro Board) there was nothing planned for Greenbelt," says County Councilman Richard Castaldi. "And then we come out with 60 percent of the remaining Stark-Harris federal construction funds. I wouldn't say it's a victory because Prince Georges is still a small percentage in the overall plan. I would say it's a good achievement." Castaldi, along with former County Attorney Robert Ostrom, represented Prince Georges County on the Metro Board.

Although Castaldi may be cautious in calling it a victory, County Executive Glendening cer-

tainly calls it that. "This is a tremendous victory for Prince Georges County, the entire metropolitan area, and all those who support completion of the entire system."

Glendening, who Castaldi says deserves "a hero's welcome," first realized in January the precariousness of the completion of the Greenbelt line when he saw that the Metro Board had no plans to continue the Metro line any further than Ft. Totten. He was also hearing reports that the Reagan administration had strong opposition to approving any more funds for Metro extensions beyond 76.4 miles. Glendening said

In its final hours the United States Congress passed and President Reagan later signed a continuing resolution. The resolution also included Congressman Steny Hoyer's amendment authorizing the completion of the 101-mile adopted regional rapid rail transit. Jerry Gough, Metro's government relations officer for Maryland explained, "This action prevents the Secretary of Transportation from withholding approval of any construction grant based solely on any mileage limitations which is less than the full 101 miles." Gough added "This means the E-Route from Ft. Totten to Greenbelt is locked up."

at that time the Metro Board was displaying a "glaring inequality" in terms of construction percentages among the District of Columbia, Virginia, Montgomery County, and Prince Georges County areas. Only 2.9 percent of the federal Metro funds (Stark-Harris) were being spent in Prince Georges County.

Glendening then said it was imperative that the Metro Board include Prince Georges in any future planning of construction, in order to insure the economic safety of the county. "We must go to the wall on this one," he said.

County Exerts Leverage  
Going to the wall meant Glen-

dening's threats to halt all other Metro construction by withholding the county's share of approval for Metro money and refusing to sign agreements with the Metro Board to save any funds that would become unusable in the fall, unless the Board could make an acceptable construction proposal for Greenbelt. "They were close to saying there was no line for Greenbelt. We were at a turning point," said Glendening, who held extensive meetings with Governor Harry Hughes, Congressman Steny Hoyer and other elected and appointed officials to resolve the problem.

With this new situation the Metro Board went back to work and on September 13 came up with an approved construction plan for the promised unbuilt portions of the Metro. Called the Interim Capital Contributions Agreement (ICCA IV), it planned for stations in Greenbelt, Anacostia, Wheaton, Van Dorn, Virginia, and at U Street to be completed.

But the best part of the announcement had to do with the funding—it was already all there for Greenbelt. Ready for spending. The 80 percent would be coming from the remaining Stark-Harris funds, and the 20 percent local match had been provided by Maryland state funds. Dee Allison of the County's Department of Transportation said, "The Prince Georges County share is already paid by Maryland. There seems to be no problem in funding for them."

### Secretary Dole Pleased

However, at a recent Transportation Convention in Washington, D.C., Department of Transportation Secretary Elizabeth Dole said that while she was pleased an agreement had been worked out between the jurisdictions and the Metro Board for completing 89.5 miles of the proposed rail system, she stopped short of guaranteeing that the federal funds would be available for the added miles. A decision by the administration is expected after the agreement is ratified by

## Opposition Surprises Council When Annexation Is Discussed

Hoping to make the city's October 9 public hearing short and sweet on the proposed annexation of 273.9 acres Council member Richard Pilski asked whether any of the two dozen attendees planned to speak in opposition. Council was surprised to hear that one person did so plan.

As Mayor Gil Weidenfeld noted, annexation proceedings began when the residents of Hunting Ridge petitioned to join the city. One reason for the request is that many people have moved into Hunting Ridge believing it is Greenbelt and were disappointed to learn it is not and that they thus cannot receive city services. Residents also want to work with the city in controlling development in the area. The city's Advisory Planning Board has reviewed the request and unanimously recommended city support.

City Manager James K. Giese noted that all legal requirements for notification have been made. He described the boundaries of the proposed annexation as east of the Capital Beltway and south of the city's existing boundary to Good Luck Road and a PEPCO easement except for the Goddard Space Village apartments and Lanham Boys and Girls Club property. Land designated for a Maryland National Capital Park and Planning Commission (MNCPPC) park which would be annexed would no longer be developed by MNCPPC. Instead, the commission recommends that it be sold to Greenbelt.

Barbara Redcliffe, attorney for John Bednarik, expressed concern that her client's property was included. The property, approximately 10 acres near Goddard Space Village, will soon be developed, she explained, and the

Bednariks were concerned about the effects of annexation on the plans. Greg Adams, broker for the property, asked why Goddard Space Village was not included. The petitioned area and undeveloped property was included, city officials explained.

If council was surprised that opposition surfaced, they were shocked with the intimation that being part of Greenbelt would not be desired by the future residents and would not add to the value of

Mr. Smith and his family moved to Greenbelt in 1951 and have lived at 13 Hillside Road since 1958. He belonged to the Greenbelt Garden Club and in prior years was associated with Scout Troop #746. He was an employee of the Louie Glass Company in Weston, W. Va. before accepting a job with the U.S. Government as a Meteorologist Technician in the Weather Bureau of the Department of Commerce in 1950. He was a member of Mowatt Memorial United Methodist Church and a veteran of World War II.

Funeral services were held at Gasch's Funeral Home on September 29 with Rev. Clifton Cunningham officiating.

On October 1 another service was held in Weston, W. Va. Interment was in the I.O.O.F. Cemetery in Fairview, W. Va.

### In Memoriam—Bud Zoellner

Members of the Greenbelt Fire Department and Rescue Squad were saddened to learn of the death of Lifetime Member Marshall H. "Bud" Zoellner.

Bud joined the Greenbelt Volunteer Rescue Squad on February 14, 1949, when the organization consisted of only one ambulance, which was housed in a garage in old Greenbelt. Many a night, Bud would awake to the call for help, and would drive the ambulance.

In December 1951, Bud was elected Chief of the Greenbelt Volunteer Rescue Squad, the third Chief of the organization.

In January 1954, Bud proposed a by-laws change that would include a president and vice president for the organization and in March of that same year was elected as the first president of the Rescue Squad.

In February 1955, the Rescue Squad merged with the Volunteer Fire Department and on February 10, 1955 Bud was elected as the first president of the newly combined organization. He was also elected to that office during the years of 1956, 1958, 1960, 1967, and 1968.

During the years he also found the time and energy to serve as State delegate for the Maryland State Volunteer Fireman's Association, was on the Board of Trustees for the Greenbelt Department and was instrumental in the planning of the present firehouse.

We feel very fortunate to have known and served with such a dedicated and talented individual and this department will always benefit from his many past efforts. Peace be with you, Bud.

## In Memoriam

Lt. Marshall H. "Bud" Zoellner  
 1921-1984

In the death of Bud Zoellner, the City of Greenbelt has lost a lifetime resident and friend who dedicated his working life to the protection of the citizens of Greenbelt. Bud served Greenbelt as an employee of its Police Department for 27 years, retiring in 1981 with the rank of Lieutenant. He was one of the founders of, and a lifetime member of, the Greenbelt Volunteer Fire Department and Rescue Squad, and served as its President, and Vice President. He was also Chief and held other line offices of the Rescue Squad. During World War II, Bud served in the U.S. Naval Air Force as a Petty Officer 1st Class in the Atlantic Fleet.

Bud probably knew as much or more about the history of Greenbelt and its residents as any person in the city. His dedication and loyalty to the city and its police and fire departments were well known. Bud virtually left his hospital bed to attend the Police Department Change of Command Ceremony in June of this year.

The city shares with Bud's family and many friends in mourning his death, and in recognition thereof has placed the City Flag at half-mast.



the proposed development. Two 10-story buildings with over 400 luxury-type apartments are planned for the site. Council members pointed out that suggested rents for the units are merely average for Greenbelt. In response to Adams' lament that he could not get this kind of rents now, council member Ed Putens said, "Know why? Because you're not in the City of Greenbelt."

Council found the argument specious that future residents of this tract should be allowed to decide whether they wanted to be a part of Greenbelt. Council member Thomas White pointed out that only property owners, not rental residents, can petition for annexation.

Council recalled that previous property owners were hesitant about annexation but later found it was profitable. "It's possible you could fare better," explained





CHARTER AMENDMENT**

(ANNEXATION)

At its regular meeting of October 15, 1984, the City Council of Greenbelt, Maryland, adopted Charter Amendment Resolution 1984-2 (Resolution No. 579), and the following Title of Resolution is a fair summary of the amendment:

**RESOLUTION OF THE CITY OF GREENBELT, MARYLAND, ENLARGING THE CORPORATE BOUNDARIES OF THE CITY OF GREENBELT, MARYLAND, UNDER THE PROVISIONS OF ARTICLE 23A, SECTION 19, OF THE ANNOTATED CODE OF THE STATE OF MARYLAND (1957 EDITION AND AMENDMENTS), BY ANNEXING THERETO CERTAIN LANDS AND PROPERTY CONTIGUOUS TO AND ADJOINING THE EXISTING SOUTHERN CORPORATE BOUNDARY OF THE CITY, EAST OF THE CAPITAL BELTWAY (I-95), BEING THE LANDS OF HUNTING RIDGE CONDOMINIUM; HAROLD S. TIDLER, ET AL; THE MARYLAND-NATIONAL CAPITAL PARK & PLANNING COMMISSION; TRINITY ASSEMBLY OF GOD, INC.; TRINITY CHURCH OF GOD, INC.; MICHAEL S. STEINER; JAMES H. SHIMMEL; MAGNOLIA FARMS PROPERTY PARTNERSHIP; HUNTING RIDGE LIMITED PARTNERSHIP; GOOD LUCK PARTNERSHIP; JOHN BEDNARIK; OVERLOOK FARMS LIMITED PARTNERSHIP #1; CAMERON BROWN INVESTMENT GROUP; POTOMAC ELECTRIC POWER COMPANY; PRINCE GEORGE'S COUNTY; AND DEDICATED RIGHTS OF WAYS OF HANOVER PARKWAY, HANOVER DRIVE, AND SPACE COURT, IN BERWYN DISTRICT 21, PRINCE GEORGE'S COUNTY, MARYLAND, AN AREA OF 273.90 ACRES, MORE OR LESS, AS MORE FULLY DESCRIBED IN THE METES AND BOUNDS DESCRIPTION THEREOF PREPARED BY JOHN D. ELMER AND ASSOCIATES, P.A., REGISTERED ENGINEERS AND SURVEYORS, AND AS SET FORTH IN THE RESOLUTION; AND FURTHER PROVIDING FOR THE SPECIAL TREATMENT OF PROPERTY IN THE AREA TO BE ANNEXED AS TO RATES OF MUNICIPAL TAXATION BY DEFERRING THE TIME PROPERTY SHALL FIRST BECOME TAXABLE UNTIL THE FISCAL YEAR BEGINNING JULY 1, 1985 OR UNTIL SIX MONTHS AFTER ANNEXATION, WHICHEVER LAST OCCURS.**

On October 9, 1984 a public hearing was held by the City Council of Greenbelt on the above resolution, and the hearing was advertised and held in all due form according to the laws of the State of Maryland. The amendment shall become and be considered a part of the Charter of the City of Greenbelt, Maryland, according to the terms of the amendment, in all respects to be effective and observed as such, upon the 29th day of November, 1984, unless within 45 days of its passage the City Council receives a petition for referendum in accordance with the provisions of Section 19 of Article 23A of the Annotated Code of Maryland (1957 Edition as amended).



the local governments. There remains 1.7 billion dollars of the Stark-Harris congressionally authorized funds for Metro construction. The balance of the system, about 11.5 miles, is scheduled to open by 1997 and will require additional federal funding beyond Stark-Harris.

**Impact on Community**  
It's an understatement to say that the Greenbelt Metro station will have a tremendous impact on the community — but how much impact is disputable. "We expect for this area to become highly urbanized," said Glendening.

Castaldi is not so sure. "Greenbelt is already one of the heaviest traveled corridors in the county, what with I-95 and the Baltimore-Washington Parkway. This system will relieve a lot of that congestion. And it's going

to allow for more transportation freedom for people. They'll have a choice. (But) I think it's too early to tell what kind of real estate changes Greenbelt will have. If you look at Greenbelt now it's one of the hottest properties in the county today."

Gil Weidenfeld, Mayor of Greenbelt, sees a building boom as a result of the Metro station. "Clearly it will be a community development boom to Greenbelt. More office buildings are being built in anticipation of the Green Line coming to Greenbelt."

Metro's inclusion of Greenbelt is clearly as Metro Board Chairman John Milliken says, "Regionalism at its best". Glendening is pleased with Metro's inclusion because it shows the ability of "our partners in Metro" to "reject the me-first philosophy" and allow for others to share in Metro's beneficial freedom of transportation.


