GHI Looks at Parking, Concrete Work; Block Home Ventilation; and Razing Boiler Plants

Many items of a housekeeping nature were dealt with at the January 23 regular GHI board meeting, most of them included on the regular agenda. However, some new issues were also discussed during the evening. Beside the weekend theft of keys, which the staff had already taken steps to neutralize, interesting questions came up concerning a proposed loan for the townhouse rehabilitation program and disposal of the original GHI steam plants.

The loan amount originally contemplated to be borrowed to pay costs of the townhouse project was \$600,000, but the financing source, Federal National Mortgage Association (FNMA). has notified the Cooperative Bank (NCB), which is handling the transaction for GHI, that loans of less than \$750,000 would be at a higher effective interest rate; therefore the question before the beard was whether to borrow the additional \$150,000 and for what constructive purposes could it be used. General manager Ron Colton noted that useful capital improvements such as parking, concrete work, etc., could be carried out which would have a longer life than the 15-year period of the loan. Board member Ray McCawley suggested replacing working capital reserves which were "drained" by the asbestos removal work, while director Janet Cantwell agreed with Colton that projects such as ventilating the

Colton agreed and stated "We're starting to think the boiler plants are not an asset any more; even as housing they may not be useful" and therefore the staff was going to get bids to demolish the two on Laurel Hill and one on Research Road. The latter site, he said, would be a good place for an additional playground since it is on level land. A rough estimate for such demolition might be \$20,000. McCawley cautioned only that the membership should be given an opportunity to vote on the step.

Mortgage Ownership

On the subject of GHI's contacts with savings and loan conservator MDIF (Maryland Deposit Insurance Fund) concerning the current dispute over mortgage ownership. Colton informed the board that in a communication received by the corporation's attorney from MDIF, there is missing a critical document detailing actual "participation contract" between GHI. Community, EPIC and FNMA. He described the paper - which purportedly transferred Twin Pines loans to FNMA - as essential for ascertaining the facts and said that MDIF's lawyers are "begging the question." In further discussion some reports that Meritor Savings Bank, a subsidiary of the large Philadelphia Savings Fund Society, may buy Community, president Margaret Hogensen explained her opinion that "it's in See GHI BOARD, page 3, col. 1

We cannot be complacent because COG's work is never finished." He proposed that COG begin planning for the future needs of the region by adopting a strategic plan to the year 2000. He also proposed strengthening the structure of the COG board.

Parcels 1, 2 Rezoning Hearing Postponed Again, to March 14

Prince Georges County Zoning Hearing Examiner Barry Cramp on Friday, January 24, agreed to defer consideration of the long-pending rezoning applications for Parcels 1 and 2. The hearing is now scheduled for March 14.

Cramp previously had denied a request for indefinite delay made by Russell W. Shipley, attorney for applicants Charles Bresler, Theodore Lerner and Associates. Shipley had said the continuance was necessary to provide time to complete negotiations with Greenbelt's city council for disposition of the land. The city had not objected to the requested postponement.

Cramp subsequently agreed to the continuance, but with the specific March date rather than for an indefinite time. City Attorney Robert Manzi concurred in the continuance.

The applications involve 112 acres of Parcels 1 and 2, land between the Baltimore-Washing-

ton Parkway and Greenbelt Homes, Inc. property. About 102 acres (Parcel 1) are located north of Northway extended and 10 acres (Parcel 2) are between Hamilton Place and Gardenway.

At a January 8 work session with city council. Shipley put forth a variety of options by which the city could acquire parts or all of Parcels 1 and 2 as well as county land formerly owned by the Board of Education-Among possible options suggest-

County Seeks Applicants In Job Training Programs

Prince Georges County is seek ing applicants for its new Jobs Training Program approved earlier this year. The program will provide training in building trades skills and job placement for young adults living in Prince Georges County.

The eight-week course will include training in carpentry, electrical systems, plumbing and painting, using a combination of classroom instruction and hands on experience. During the training, participants will receive an hourly stipend. Applicants must be County residents, between the ages of 18 and 26, have their own transportation and be physically able to do construction work. The course will be conducted by the Suburban Maryland Building Industry Association and funded by the Department of Housing and Community Development's Housing Authority Bond Program.

Metro Support Promised

Thank you for your letter on behalf of the Eleanor and Franklin Roosevelt Democratic Club in support of completion of the full 101 mile system. I appreciate your members' support for my efforts in Congress to secure continued federal construction funding for Metro.

Throughout the last year, I worked with the members of the House Appropriations Committee on this matter. It soon became apparent that all mass transit systems were going to be subject to some budget cuts. We were pleased at year's end that Congress compromised on \$227 million in Metro construction funding, which was less than had been originally requested but substantially more than the Senate had approved.

The Gramm-Rudman balanced budget legislation adopted by Congress in December setting strict deficit reduction targets for each year through 1991 presents new challenges for Metro construction funding. Already it has been reported that the President's budget will include no funds for Metro for the next year.

Prince Georges County and the State of Maryland have contributed to the Metro system with the understanding that the Green Line, which will serve the largest number of riders of any line in the whole system, will be completed. I will continue to make this goal one of my top priorities in the next year and in every year until Metro measures 101 miles. .



the best interests of the community that this plan to sell Community S&L should succeed." She added also that it might be a good thing if SLSC (Share Loan Service Corporation, the cooperative financing organization) were to take over the EPIC-serviced leans (which have recently caused serious problems for some GHI members). McCawley agreed, and Colton thought such a development could conceivably occur if Meritor took over Community.

Other Items

Satellite "dishes" (antennas); the staff came to the board for direction on whether these antennas, which can be several feet in diameter, should be allowed in GHI. Manager Colton reported that one member has already erected such a dish and has been asked to remove it. After some discussion, at the suggestion of director Cantwell a motion to prohibit was passed.

Service contracts: three of these were approved, two having been examined in previous meetings. The proposal of Geotechnical Services. Inc. for work to solve the drainage problems of 6 Court Hillside was accepted. Tree trimming, removal and cleanup by Hall's Tree Service was also approved, as was the purchase of two vehicles (a 4x4 truck with snowplow and sand spreader, and pickup truck) by the maintenance department. The low bid of Laurel Toyota, about \$17,000, may mean a savings of about \$10,000 to the corporation according to maintenance superintendent Joseph Whalen.

"Fee for service" program: Whalen noted that calls in this category were numerous ("backlogged"), indicating a demand for the service. Such items as hot water heater relocation, bathroom exhaust fans, extra heaters and wall-mounted thermostats were typical requests. Director Hartwick asked that these calls be included in the regular maintenance report. Wright gave costs as ranging between \$10 an hour for ordinary labor to \$20 an hour for electrical work. In response to a query by Audit Committee member Chuck Hess, he estimated the level of work as under one quarter man per week.

Demographics

Demographics: In 1985, about 160 units were sold, 120 being frame and 45 brick or masonry. According to Colton, a comparison of the last three shows that 10% or less of the homes have usually been sold; the number of residents in the 20-30 year age bracket is declining while those in the higher age brackets are increasing, with the median income rising. The category of members purchasing jointly has increased markedly also. People are staying longer in GHI, with almost 20% in residence over 16 years, he noted.

By formal motion, the board established May 14, 1986 as the date of the annual membership meeting.

Next board meetings: These, to allow for upcoming religious holilays, are slated for February 13 and 20, and April 3 and 17.






