## **Chinese Lion Dancers, German Band** Join Throng in Labor Day Parade

by Sandra Smith The 1990 Labor Day Festival Parade promises to be a special event with many musical unit groups, floats, majorettes, antique cars, dancers, community groups, and local officials. Two groups making their first ap-Two pearance in Greenbelt's Labor Day Parade are the Chinese Lion Dancers and the Alte Kameraden German Band. Old favorites returning to the parade include: Potomac River Jazz Club, Blackthorn Stick Irish Dancers, Potowmack Ancient Fife and Drum Corps, and the Prince Georges Police Pipe Band.

In the performance of the Chinese Lion Dancers a lion is led by musicians and colorful banners down the parade route. The lion dancers often perform in ceremonial functions in the District of Columbia. Another group of exotic performers, also making its first Greenbelt appearance, is the Alte Kameraden German Band. This 15-member band, riding an antique fire engine, makes regular appearances in the Cherry Blossom Parade. The Potomack Ancient Fife & Drum Corps, celebrates its 15th anniversary marching in the Greenbelt Parade. This group performs in many events along the east coast, most recently with Willard Scott on the Today Show.

The Potomac River Jazz Club was last year's 3rd place winner in the music division and garnered a first-place marching band award in the 1989 Fairfax Independence Day Parade. Parade watchers enjoyed the group's traditional jazz sounds. The Prince Georges Police Pipe Band is another award-winning band, who will also be performing at the Prince Georges County Fair. Sounds of the Irish abound with the Dunloggin Irish Band and the Blackthorn Stick Irish Dancers.

The Governor and Louis Governor William Donald Schaefer and Comptroller Louis Goldstein will be greeting Greenbelters in the parade. From Congress, expect to see Senator Paul Sarbanes and Representative Steny Hoyer. ## **Candidates Hit Trail to Win Votes for Primary Election**

In the upcoming primary election on Tuesday, September 11, registered voters in Greenbelt will help determine who will be their party's standard'bearers in the Nc/ember general election. Local interest centers on native son Richard Castaldi in his bid for reelection to the Prince Georges County Council and on City Councilwoman Antoinette ("Toni") Bram in her first run for state office.

Bram is seeking to capture one of three delegate seats now held by incumbent Democratic candidates Charles Ryan, Joan Pitkin and Mary Conroy, all of Bowie. Castaldi, former Green-belt city councilman and mayor, is in a face-off with Bowie's Mayor Pro-tem G. Frederick Robinson in the Democratic primary. Faced with a tight race, both are out on the hustings, cam-paigning vigorously and taking nothing for granted. The city of Bowie holds about 51% of the registered voters of the Councilmanic and the 23rd Legislative Districts.

Shaping up as an intense contest is the State Senate race. Incumbent Leo Green and challenger Terezie ("Terry") Bohrer, both Democrats and residents of Bowie, are running energetic campaigns. Contending for the state senate seat also is Donna Jo Campbell of Bowie.

Almost 8,426 residents are registered to vote in the four precincts which serve Greenbelt, down slightly from 1986 (about 75). Some 7,280 who are registered as Democrats or Republicans will be eligible to vote on September 11. About 1,145 voters declined to affiliate themselves with one of the major parties. These voters (known as "unaffiliated," "declines" or "independents") may vote only in nonpartisan elections, such as in an election for a member of the Board of Education. Because incumbent Suzanne Plogman of Greenhelt faces no opposition in her bid to be returned to the Board of Education, Greenbelt's "declines" will not have an opportunity to vote on September 11.

Compared with 1986, Greenbelt voter registration figures for 1990 show that the Democrats lost about 168 registrants while Republicans gained about 186. The ratio of Democrats to Republicans is now about 2.2 to 1. (2.5 to 1 in 1986).

## See PARADE, page 9 **Public Schools Open on Tuesday; 3,000 More Students Are Expected**

Schools will open on Tuesday, September 4 for students in the Prince Georges County school system. 108,-148 students are expected to enroll this year, an increase of about 3,000 over last year. This continues an upward trend that started with the introduction of the magnet schools in 1987. For the 1990-91 school year the county will operate 171 schools. So far 550 new teachers have been hired, 35% of whom are minorities.

A new aerospace program will open this fall at DuVal High School. The opening ceremony was held this morning at the school.

All magnet schools are full and have waiting lists. The magnet schools, which offer specialized programs, were instituted as a means of achieving racial integration. They were filled by lottery this year. Exceptions were the performing arts and TAG schools for which students need an audition or test

The computer program in the comprehensive schools has gone to the final level, sixth up grade. By putting four computers in each sixth grade classroom, the school system has completed this program as a means of upgrading the non-magnet schools.

**Multicultural Program** The major focus this year will be on restructuring, a moving away from homogenous and ability grouping to heterogenous grouping. Multicultural education

will be stressed. This has been set up as a program to help students develop awareness, appreciation and understanding of the history, culture and contributions made by various groups within American society. The program will be instituted for kindergarten through twelfth grade and will be used in English, math, science, social studies, art

A recent all-day meeting was held at Eleanor Roosevelt Senior High School to work out ways the program should be implemented. Each school in the county was represented by a team consisting of parents, administrators and teachers. Guests from other school systems were also pres-

## **GEAC** Meeting Focuses on Recycling; How? When? Who Is Included?

City and county staff. members responsible for recycling attended the August 2 meeting of the Greenbelt East Advisory Coalition (G-EAC) at Windsor Green to talk about the issues and time frame for recycling. The homeowners associations that make up GEAC do not contract with the city for trash service and will not be part of the city's recycling program. They need to reach their own agreement with their trash hauler or the county for recycling services.

Are Condos Single-Family?

Jennifer Mack, from the county recycling office, addressed the question whether "multifamily" dwellings, such as apartmentstyle condominiums like Greenbriar, would be included in the county's recycling plan. Yes, they will, Mack told the meeting. Under legislation establishing the county's program, the distinction rests on ownership, not type of building, so that condominiums will be collected by the county. Owners of buildings that are all rental properties must develop their own recycling plan.

This issue had not been clear in previous meetings, including the city's public hearings on recycling. Mack promised that the county would write a letter clarifying that condominiums, along with townhouses, are "single-family dwellings" for recycling purpos

Will Trash Hauler Recycle? The contractor who handles trash for most of the associa-tions, B&B Refuse, told Greenwood Village that they do not have the trucks or staff to take on recycling. Dave Helmecki, of the city's Public Works Department, said that city staff were available to help the associations establish a program and work with them to encourage their hauler to recycle. Much discussion of the economics of recycling from the perspective of the small trash hauler ensued, encompassing tipping fees, tonnage, trucks, trailers and the market for materials.

"All of the associations are ready and willing to recycle," concluded Charlene MacAdams of Greenwood Village, "but we don't much care who picks up the materials." Homeowners want to know how to sort their trash for recycling and whether recyclables will be picked up curbside, at the rear entrance, from trash rooms or at a dumpster. Who takes it away is not a concern. Mac-Adams, who served on the city's citizen advisory panel on recy-cling, suggested that the city and county staff meet with the contractors. She saw no point in homeowners associations being involved.

Other Recycling Questions GEAC members asked when the county will start picking up recyclables. Mack answered that service is being phased in across the county over the next two years. She said that collection could begin as early as January 1991 in Greenbelt.

Hunting Ridge is currently participating in the county's pilot program, which covers 15 different housing situations and collection systems. Information gleaned from the pilot program will be compiled in a manual that the county will use in its public education efforts as the recy-

cling program expands.

Another question asked was whether the city and county had procurement rules that encourage recycling. How much does the city government recycle and how much of its paper purchases are of recycled paper? Under the county's rules, said Mack, departments can buy recycled paper if the price is within 10 percent of the price of virgin paper. All xerographic paper is recycled.

At the city level, said Helmecki, different departments have different policies. Public Works uses recycled paper but other departments are resisting, he said. Schrom Hills Park

James Foy of Hunting Ridge, GEAC chair, and Sheldon Goldberg of Windsor Green, vicechair, updated the meeting on

the 60 percent design plans for Schrom Hills Park, as presented at city council's special session on July 24. Foy described the course of the 8-foot-wide hiker/ biker trail and of the 6-foot-wide path at the edge of the soccer and softball fields.

He noted that lighting for the softball field was not included in the current plans, although it may be included in final plans or added at a later date. After a discussion of the cost-effectiveness of running conduits for the wiring now, before the field is installed, Foy was directed to check with city staff to see if the conduits could be included in the plans without a final decision on the lighting being

acquires all of the land for the park. Owners of the Steiner property, which will be part of the park, have obtained a delay until December in the city's condemnation suit for the property. Thus, no work will begin until at least February.

#### Fire-Retardant Roofing

Katie Calder of Greenbrook Village gave an update on the legal issues involved with fireretardant plywood used in roofs. The material is susceptible to a fungal-like growth which can cause structural damage if not detected early and treated. Many of the developments in Greenbelt East, as well as throughout the county, have such fire-retardant roofs. A lawyer specializing in the problem met with the Greenbrook Village association following their annual meeting.

Calder outlined various legal actions being pursued by homeowners with roof problems in New Jersey and Virginia, including a class action suit. Defendants in various cases include developers, roofing contractors and manufacturers of the plywood. Homeowners have a statutory warranty of three years from closing, in addition to any actual warranty provided by the developer.

Since no case has yet been decided, legal relief is tenuous, Calder said. Most of the Windsor Green homes, which could be affected, are beyond the threeyear warranty; some of the Greenwood Village homes were built by Porten-Sullivan, which has filed for bankruptcy so that suit against the firm would probably be useless.

The most cost-effective option for concerned homeowners, Calder said, was to continue sharing information and have the roof inspected often.



Growing up for Greenbelt

Richard Castaldi was born and raised in Greenbelt. As Greenbelt's first "native son" mayor, Richard couldn't help but know the needs of his town and the concerns of its citizens. That caring continued when he was elected to represent the Fourth Councilmanic District. Since 1982, he has fought vigorously for Greenbelt interests:

#### puted each quarter. Lunch Costs

Lunch for elementary school children will cost \$1.35 this year; reduced price lunches will be 20c. Milk will be 35c. Lunch for middle and high schoolers will be \$1.40. Breakfast in elementary schools will be 90c, in middle and high schools, \$1.15; reduced cost breakfasts, 10c.

Children will be bringing home information about reduced cost lunches on the first day of school. Parents who think they qualify for these should contact their child's school.

#### **Expulsion** Policy

Strict standards will continue to be upheld for drug, alcohol and weapons (including knives) abuse. Students need to be aware that none of these may be brought to school at any time, and that expulsion will result should this rule be broken. According to the Code of Student Conduct, students will be expelled for the first offense involving the use of or possession of weapons. For incidents involving drugs or alcohol the students will be expelled for the first offense involving distribution and the second offense involving possession. Most of these students are not eligible for readmission to the Prince Georges County school system. Students who are readmitted must remain expelled for at least the remainder of the semester in which the incident occurred and the following full semester. They must also present documentation of satisfactory participation in the alcohol/drug treatment program,

#### Policy on Medication

The Department of Health Services within the Prince Georges County Public Schools, acting on a recommendation from the state of Maryland, has changed school policy regarding the dispensing of prescription and nonprescription medicines to students.

No medicines will be given to students without a physician's medication authorization form PS-51 or PS-51/EPIPEN. Forms are available at all schools.

Parents are asked to inform the school principal, health services staff, and the classroom teacher of any known allergy or serious health problem their child(ren) may have. Every effort will be made to protect all students from injury and to provide a healthful environment.

Students will be transported by ambulance to the nearest medical facility should he/she require any emergency treatment that cannot be provided at the school site. Parents will be notified as soon as possible.



#### **Teacher Transfer Policy Upheld by District Court**

The United States District Court for the District of Mary-land has ruled that the Prince Georges County teacher assignment and transfer policy is con-stitutional, reasonable and valid.

In two separate cases insti-tuted in 1989, the U.S. Justice Department and 12 individual teachers filed suit seeking a halt to the Board's policy of adjust-ing the numbers of black and white teachers in each school when it was necessary to transfer more senior teachers of one race in order to retain a desired number of teachers of the other race.







#### FIND UNCLAIMED FUNDS



For the first time the State Comptroller's Office will be at the State Fair in Timonium August 25 through September 3, with computer hookups so fairgoers will be able to walk in and check to see if the office has any record of unclaimed funds in their names.

Financial institutions, insurance companies and corporations are required to report bank accounts, contents of safe deposit boxes, wages, insurance benefits, security deposits, stock dividends and other funds to the State Comptroller's Office if they remain unclaimed for five years

or more. Once money is reported to the state as unclaimed, the Comptroller's Office attempts to locate rightful owners by mail and through advertisements in local newspapers. If the money re-mains unclaimed, it is turned over to the state.

"However, Maryland's law is custodial, meaning that there is no time limit under which the property or its monetary equivalent may be claimed," State Comptroller Louis L. Goldstein said. "You or your legitimate heirs may claim the funds at any time."
