**Council Adopts \$10.7 Million Budget  
Adds 3 Police, Part Time Recycler**

City Council, at its May 26 regular meeting, gave final approval to Greenbelt's budget for fiscal year 1993 (FY93), which begins July 1. There will be no changes to the city's property tax rate, although increased assessments will raise many citizens tax payments.

At the final budget work session on May 20, City Manager Dan Hobbs greeted council with the news that he now expects city revenues to total \$10,774 million, up \$110,900 from the initial budget estimate. By the end of the night, council had spent all but \$1,000 of that amount, with expenditures totaling \$10,773 million.

The additional money will fund a part-time administrative assistant for recycling, additional contributions to recreation groups and Greenbelt Access Television, three additional police officers, additional consulting services and Greenbelt CARES, a part-time staffer for Schrom Hills Park, and a raise for the city manager.

**Expenditures**

The budgeted expenditures of \$10,773 million represent a 5.6% increase over estimated expenditures in the current fiscal year (4.4% more than the originally budgeted expenditures for FY-92). Other than funding some previously unfunded requests with the increased revenue estimates, council made very few changes to the first budget proposed by City Manager Daniel Hobbs.

**Personnel**

The new hires proposed by Hobbs were included in the approved budget. These include filling the fulltime CARES position, and hiring additional part-time recreation staff for the indoor pool and the self-supporting programs.

Council added several other positions. Three new police officers will join the city staff. One, to be funded on a 50-50 basis by the city and a state

grant, will concentrate on narcotics enforcement. Two others will operate out of a substation in Beltway Plaza with the costs split between the city and the owners of Beltway Plaza and Springhill Lake Apartments, if the city and the property owners can reach agreement on a proposed public-private partnership. The budget provides for starting this program in January.

Another position added by council was a part-time administrative assistant for the public works department. At the public

will receive a \$4,000 increase to \$75,000 (5.6%).

The budget also provides for increases in pension contributions for newer employees, except police officers, to reduce inequalities between the various employee retirement plans.

**Contributions**

Council increased the city's contributions to recreation groups by \$7,400 over the \$31,000 recommended by Hobbs. (Contributions to these groups totaled \$31,000 in the current fiscal year.) The largest in-

hearing on May 18, eight citizens, six of them members of the current or previous recycling committees, asked council to fill this position. At the budget work session, Hobbs argued for "doing it right," filling the full-time administrative assistant position, left vacant for budget reasons, with this person spending one-third to one-half of the work week on recycling.

The council members, however, wanted someone whose only responsibility would be recycling with most council members going so far as to chide Hobbs at the final adoption when he referred to this person's responsibilities being "almost" exclusively related to recycling.

**Pay**

City employees will receive a 2.75% cost of living adjustment in January, provided that the city's revenues do not fall below projections. Hobbs, whose pay is set separately by council,

increases went to the Boy and Girls Club (\$13,000, up from \$7,200 in FY92), to pay for new uniforms and transportation to games, and \$4,000 to fund the Greenbelt Double Dutch Club's trip to the National Championships in Ohio.

**Revenues**

Originally, the city expected to receive \$10,663 million. Several changes combined to produce the \$110,000 increase. City property tax revenues were increased \$66,500 when the city

**City Distributes Surplus Food**

On Wednesday and Thursday, June 10 and 11, the City will distribute surplus food as part of the Prince Georges County Surplus Food Program. Butter, cornmeal, flour, peanut butter, pork, raisins and tomatoes will be available for all eligible persons. Food may be picked up on either day from 10 a.m. to 7 p.m. at the Municipal Building, 25 Crescent Road.

Eligibility requirements are: (1) participation in a public assistance program or in Aid to Families with Dependent Children (AFDC) (Photo ID required), or (2) participation in the Food Stamp Program (Photo ID), or (3) participation in Medicaid Program (Medicaid Card), or (4) Maryland Energy Assistance Program (letter) or (5) an income that is lower than \$9,930 for one person, \$13,320 for two people, \$16,710 for three people or \$20,100 for four people.

**Schrom Hills Park Officially  
Opens Sunday, Greenbelt Day**

Greenbelt's newest park will be officially opened to the public on Sunday, June 7, at a Family Day program scheduled to begin at 1 p.m. The new recreation area in Greenbelt East, named Schrom Hills Park after the family farm originally located on that site, is situated east of Hanover Parkway. For those entering the Parkway from Greenbelt Rd., the park entrance is just beyond and across the street from the Hunting Ridge development. The park will be formally dedicated by the city council at 1:30 p.m.

An afternoon of activities will add to the festivities, starting with Bob Devlin's "One Man Band" show during the half hour before the formal dedication. Clowns, refreshments, and games for the entire family will also be featured. Children's playground equipment, already installed, will no doubt see lots of use. Because seating will be scarce, those attending are invited to bring their own folding chairs or blankets to better enjoy the day's events.

Following the dedication—expected to take about 15 minutes—the city council will conduct a second formal program in honor of Greenbelt Day, the city's 55th anniversary of its formal incorporation as a Maryland municipality. Immediately thereafter a presentation will be made to this year's winner of the David R. S. Craig Memorial college scholarship.

The Greenbelt Concert Band of Prince Georges County, led by John DelHomme, will then provide music from 2 to 3 p.m., followed by a Double Dutch team exhibition. Family Day activities will officially close at 4 p.m.

**Other Weekend Events**

The Sunday program will culminate a weekend of special events in honor of Greenbelt Day. On Saturday evening the Monumental Brass Ensemble, a nationally recognized group, will

perform in a free concert at 8 p.m. outside the municipal swimming pool. Sponsored jointly by the Recreation Department and the Greenbelt Arts Council, they will play both popular and classical favorites, including Renaissance, Dixieland jazz, showtunes and big band numbers. Again, those attending are asked to bring their own chairs or blankets.

Other events listed for the three-day celebration will be a family swim at the pool, with musical background, on Friday evening; a ride-a-bike fundraiser to benefit the County Association of Retarded Citizens between 8:30 and 1:30 p.m. Saturday; and the 55th anniversary Volksmarch between 8 a.m. and 3 p.m., also on Saturday.

## Funds for a Strange Breed

It's a dirty job, but somebody has to do it. Somebody has to go out there and provide first aid, transport the injured and sick to the hospitals, and put out the fires.

We respect those who do become firefighters and rescue squad workers and feel somewhat guilty that we have too much good sense to take on these important jobs helping others. Once again we have a way to assuage our guilt. We can donate to the Greenbelt Volunteer Fire and Rescue Squad annual fund drive.

Although Prince Georges County provides financial assistance to fire departments and employs paid personnel to supplement volunteers, fire and rescue services still are very dependent on the many men and women who volunteer their time to do these essential jobs. We salute these volunteers and particularly those who serve Greenbelt.

We ask that you also pay tribute to them by placing your donation in the fund request envelope that you should have received in the mail. If you haven't, you can send your tax deductible contribution to P.O. Box 35, Greenbelt. Funds will be used to buy equipment.

And, if you should know any young men or women who do not have the sense that we do and would like to help others by fighting fires and rescuing injured persons, tell them that the Greenbelt Department is really in need of more volunteers and would be happy to see them down at the firehouse on Crescent Rd.

## Close the Roads

I would like to respond to Jean Snyder's letter (News Review May 14) urging the closing of Soil Conservation Road from dusk to dawn to prevent wildlife from being slaughtered after dark by vehicular traffic. I agree. Thanks largely to the Beltsville Agricultural Research Center (BARC), this "greenbelt" area is teeming with wildlife. Unfortunately, the carnage isn't confined to Soil Conservation Road.

Several years ago, about 10 p.m., I came upon a deer which had been struck by a motor vehicle on Edmonston Road and abandoned in the middle of the street. As I approached the section of road where it lay, I saw an oncoming car swerve wildly into my lane and then back. Thankfully the driver in back of me noticed it too. Suddenly the deer tried to get up; twice it fell and then surprisingly galloped off into the field where the courthouse is now being built. I was saddened to think someone had injured it and not stopped to shield it from further harm.

On a lighter note, one day as I drove up Research Road, I saw what looked like a tree limb in the street. I straddled the car wheels over it. After passing it, a check into my rear view mirror revealed the "limb" quickly wriggling to safety. And just a couple weeks ago, I was driving to work on Cherrywood Lane in the morning when I spied a

small object in the road on the bridge. A ground hog (I think) stood up on its hind legs and looked around. It was adorable with big round eyes, totally oblivious to rush hour. Then it disappeared. Seconds later a car raced past us in the lane where the ground hog had just come out "to visit us."

I am sure a lot of Greenbelt residents have stories of close encounters more exciting than mine. My point is that we all need to be reminded when driving that this area is, indeed, a wildlife refuge. The least we can do is educate passers-

through with signs and enforce reduced speed limits. Because BARC has become a convenient short cut for a lot of motorists, we urgently need to ask that Soil Conservation Road be closed at dusk to allow the wild animals to roam freely.

In conjunction with the road closing, I would like to see a few large, colorful signs (billboard size) erected at strategic points around Greenbelt informing everyone that this area is a wildlife habitat. I vote for Bambi and Thumper and company to be pictured. I don't know about you, but I loved Smokey the Bear when I was a child, and he taught me well. And to this day I can't bring myself to kill a lightning bug, because I think of Tinkerbell.

I am thankful to God for the privilege of living next to woods and an expansive farm. It enriches me daily.

## Missed the Point

I appreciate having the goals of the Miss Greenbelt Pageant enunciated by members of the Labor Day Committee. Let me reassure them that it has not been my intention to decry the efforts of pageant organizers or participants in assembling the Labor Day Parade or other activities.

However, judging by their response, I obviously haven't made clear my concerns on this issue. Perhaps it will help to share my own personal situation: I am currently in a Master's Degree Program at the University of Maryland. At no time is my "personal appearance," "poise," "presentation" or "personality" considered relevant in the least. What counts is whether I can solve physics problems.

What I said in my original

letter is that women are judged primarily by their appearance. The writers confirm this by defining female achievement almost exclusively in terms of externalities, of image. The existence of inner qualities of substance and ideas—things that cannot be judged by the criteria the writers would apply to their Miss Greenbelt contestants—has not even been recognized.

As a child I was fortunate that I had a strong female role model, my mother, who is a mathematics educator. She has never bought into the traditional value system that judges women mainly by externalities like those listed by the Labor Day Committee. She has always believed and demonstrated that women have brains and should be just as proud to use them as men.

Finally, I must say that I find it incredible that the writers would insist it is "not a beauty pageant," when the very first criterion they list is "personal appearance." Certainly we have made progress since the elimination of the swimsuit competition, but I promise you that at the Miss Greenbelt crowning the audience is not looking at the contestants' ability to do calculus.

If the pageant is not primarily about female appearance, why isn't it open to young men? But I doubt there are many young men out there who wish to be judged primarily by their "personal appearance," "poise," "presentation" and "personality" (and by the way, just which kind of "personality" is the preferred one here?)

Since I am apparently not going to convince the Labor Day Committee to drop the Miss Greenbelt Pageant, I will end

with an appeal to Greenbelt parents: please, parents, let your daughter know that there is more to life than how she "presents herself." Do her a favor by discouraging her from entering a contest based primarily on appearances.

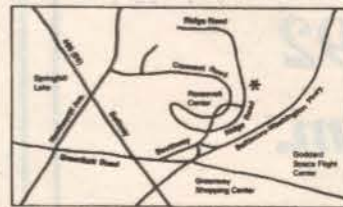

And now there is our friendship to encourage our crossing over.

## New Pesticide Law Requires Lawn Signs

A new county "Lawn Pesticides Law" goes into effect on July 1 requires anyone applying pesticides on public or private property to post caution signs at least 24 hours in advance.

The use of pesticides to control common pest of lawns, gardens, and other areas is widespread. However, pesticides may be harmful if eaten, inhaled, or if they have any contact with the skin of humans and pets.

Pesticides are any chemicals used to control or kill weeds, insects, rodents, snails, worms, fungi or other pests. Lawn fertilizers are excluded and can be used without posting signs.

The County Health Department will begin enforcing this law on July 1. There is a \$50.00 fine for failure to comply with this law.

**New Law Taxes Snacks**

The second phase of tax changes enacted by the General Assembly in April began June 1. Specific snack and prepared foods are now taxable, departing from a tradition that exempted food purchased in grocery stores since 1947.

Consumers visiting the snack aisle will find Maryland's 5% sales tax added to their bills for purchases of potato chips and sticks, pretzels, corn chips, cheese puffs and curls, pork rinds, popped popcorn, nuts and edible seeds and mixtures of these products. The tax applies regardless of the size package

purchased, but only to the specific snack items noted.

At the grocery store's salad bar, salads, desserts and soups became taxable. At the grocery store's deli, party platters, heated food and sandwiches suitable for immediate consumption also became taxable.

In the frozen food aisle, frozen desserts such as ice cream and frozen yogurt become taxable if they are sold in containers of less than one pint. While the family size half-gallon of ice cream remains exempt, purchases of a single ice cream sandwich, for example, will be taxable. A box of a dozen ice cream sandwiches containing a pint of ice cream, however, will be exempt.

Many of the food items which become taxable in grocery stores June 1 have been taxable if purchased in other types of carry-out locations. The General Assembly sought to apply the tax more consistently.

# City Council Moves Forward With Code Enforcement

At its May 4, work session, the City Council agreed to move forward with the city's assuming the code enforcement responsibilities from Prince Georges County. Staff will be preparing an ordinance based on the current Prince Georges County law for discussion in June. This means that the city, instead of the county, will be enforcing the same law that is currently in effect. After six to twelve months of experience with the new enforcement program, the Council will review the ordinance for areas that need stronger or clearer provisions.

Greenbelt possesses a 55-year legacy of being a quality, planned community. A good code enforcement program is critical to insuring that all neighborhoods remain attractive, safe and livable.

The Council has discussed for several years the possibility of taking over the code enforcement responsibility from the county government. Why is this an important area? Greenbelt's housing stock is growing older. Seventy-two percent of all of the housing units are over 20 years old. These are the units at greatest risk of deterioration because of the increased requirements for upkeep.

### Renter Occupancies

Greenbelt has another challenge. Over 50% of all housing units in the city are renter occupied. It is unfortunate, but generally true, that it is these units that would first suffer from pool maintenance and would be more likely to decline in quality. The city must make sure that it is able to hold absentee property owners to the same standards of maintenance that resident owners proudly and voluntarily uphold.

Under a city code enforcement program, there would also be greater control over the quality of commercial property. The community should expect all of the commercial areas in the city to reflect well on Greenbelt.

The timing for this program couldn't be better. The county government is downsizing and reducing its manpower drastically. The city has been informed that starting this spring, field inspectors will not be available to perform their routine enforcement duties in Greenbelt.

If city hall and the community strongly support this program in a partnership, then the city will achieve its objective of protecting the Greenbelt legacy. Strong community support is vital.

The thought of feeding 250 people three meals a day doesn't sound appealing to most of us, but Mess Services Chief Joseph Donellan, a native of Greenbelt and leading mess management specialist for the Naval Air Warfare Center Aircraft Division Lakehurst Galley, Lakehurst, New Jersey, does just that, seven days a week, 52 weeks a year.



# Permits for Cash Lake Angling Now Available

The Patuxent Wildlife Research Center will permit public fishing at the Cash Lake fishing area beginning June 15. Cash Lake is located along Route 197 south of Laurel. The new fishing pier at this U.S. Fish and Wildlife Service facility is especially accessible to individuals with disabilities. Persons with disabilities are encouraged to contact the Research Center at 498-0342 for special permit accommodations.

Day permits are required and applications are now being accepted. The free permits will allow the holder and another licensed angler, or up to two accompanying children under 16 years old, to fish for bass, pickerel, sunfish and catfish.

To apply for a permit, an-

gers must be at least 18 years of age and licensed to fish in Maryland. The application must be by letter only and include name, address, phone number (including area code), and dates for which permits are desired. Applications should be received at least two weeks prior to requested fishing days.

Applications should be sent to Fishing Program, Patuxent Wildlife Center, Laurel, Md. 20708. A total of 25 permits will be issued for each day. If necessary, a random drawing will be held to allocate permits. discovered that the county was not crediting Greenbelt with the Greenspring subdivision. However, because an unusually large number of property owners, including all large commercial property owners, are appealing their assessment increases, Hobbs set aside \$66,500 as an allowance for any assessment reductions. Business and income taxes were down a combined total of \$66,000, while cable television franchise fees are now expected to bring in \$2,000 more than originally estimated.

Several actions taken by the state government in solving its budget crisis will increase city revenues. The city's share of the recent increase in the state gas tax is estimated at \$40,000. The state also found money to contribute \$56,800 towards Greenbelt CARES and to contribute \$37,500 in grant funds towards the hiring of a narcotics officer, although the state aid for police was reduced by \$50,000.

The city council adopted its budget before the county budget was approved. However, the city expects the county government to approve an \$8,500 contribution to CARES. With the county's approval of a 20% increase in the piggyback tax, Greenbelt will receive additional income tax revenue. Hobbs had received a letter from the county executive estimating that the city

would receive \$182,000 in additional revenue. However, at the time of budget approval, county council had not approved its budget, so the city could not be sure what it will receive.

Other revenue increases include \$4,600 more in the management fee for Green Ridge House, \$40,000 more from parking fines and fees resulting from the recent fine increases and \$37,500 for an expected public-private partnership for two additional police officers.

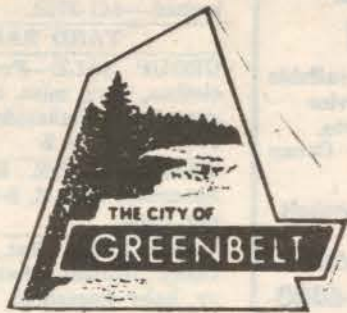
