5-Year Capital Improvement Budget Outlines Plans for Future Projects

City Manager Daniel G. Hobbs has proposed a five-year Capital Improvements Program (CIP) that will spend \$5,146,236 in the next fiscal year, which begins July 1, and another \$3,629,483 between July 1, 1995 and July 1, 2000. The biggest expenditure for the next year will be renovation of Greenbelt Center School into a multi-purpose community center. The \$2,797,500 budgeted will bring the total project cost, including that already spent, to \$4,495,862. The City Council will hold a work session on the CIP on Tuesday, May 10.

"Continued investment in the physical stock of our community is tremendously important if we are to ensure the continued quality of life for all Greenbelters," Hobbs stated in his Budget transmittal letter to the city council. For the coming years Hobbs sees the need to funnel the city's resources into reinvestment in its public infrastructure. Although the more than \$5 million to be spent in the next fiscal year is a significant undertaking, Hobbs notes that there remain as many as 77 potential projects for future funding with a total estimated cost of nearly \$18 million.

City staff put together a list of 138 potential projects with a total estimated cost of \$26 million. At a council/staff retreat held last February, the council

preliminarily prioritized \$1,000,000 worth of community projects.

Developing and updating the CIP begins six months before Budget adoption. It involves the projection of funds available for capital projects, a review of council goals that translate into capital projects, development of project descriptions and cost estimates, recommendations of a funding schedule by staff, review of the draft CIP document by the Advisory Boards for their comments, the formal submittal to council, which holds work sessions and public hearings, and finally council approval.

Project Proposals

Some of the significant projects proposed for the next year are:

•Lakewood Storm Drainage, \$305,850, total cost all years, \$568,390. To be paid in total by the county, the project is to make improvements in storm drainage to reduce stormwater related flooding of homes in the Lakewood subdivision. Planning is to be completed in the next year with construction being completed in FY 96.

•Roosevelt Center Mall, \$20,000, total cost all years, \$120,000. This project is for the renovation of the mall and is to be completed in FY 96. The special assessment against owners of some of the buildings in the commercial center is to fund all but \$10,000 of the project.

•Parkway Reconstruction \$137,000, total cost all years, \$147,000. Reconstruct roadway and sidewalk for the entire length of Parkway and evaluate

the possibility of increasing parking. The project will be funded by federal Community Development Block Grant funds.

•Ridge Road Improvements between Lastner Lane and Eastway, \$175,000, total cost all years, \$350,000. Replace curb and gutter and sidewalk and rebuild storm drains and roadside swales as needed and resurface the street. City funds will be used for the project.

•Youth Center Renovation, \$108,000, \$294,000 total all years. This remodeling project, already underway, will bring the Youth Center into compliance with the Americans with Disabilities Act, adds a ladies locker room and improve the overall appearance of the building. It will be financed with city funds.

•Greenbrook Lake, \$699,246, \$784,857 total all years. The city had planned to begin construction of two ponds for stormwater management and mitigation this year and complete the work with another \$40,000 next year for additional site amenities. However, the recent denial by the state of city plans could delay the project into the next fiscal year and increase costs. The project is to be paid for by Prince Georges County with the exception of site amenities paid for by the city.

•Greenbelt Lake Water Improvements, \$135,000. This project will include streambank stabilization, water quality monitoring and lake clean-up. The city hopes to receive a state grant

Springhill Lake After School Program May be Possible

A proposal for an after-school program at Springhill Lake Elementary School (SLES) was discussed at a meeting on April 21, and it was decided to move ahead with the creation of a pilot project, to open next fall. Author of the plan is Linda M. Sherwood, principal of the school, who has already received assurances from parents that they are prepared to enroll some 40 children for after-school care.

Sherwood estimates that 100 to 150 Springhill Lake students are unsupervised after school, as a result of shifts in family composition and work patterns in recent years. (See separate story.) About 335 children walk to SLES. Others come by bus from Seat Pleasant.

The proposed program would create a safe, supervised environment from 2 to 6 p.m., with a mixture of academic and social experiences for the children. Group leaders would supervise homework and stress self-discipline, teach students how to deal with peer pressure, and help them resist temptations to use drugs.

Enrichment activities are planned, ranging from drama and art to sports; high school and college students will help

Latchkey kids hanging out at stores, easy prey for exploitation by older, streetwise children. Frightened fourth graders with no one to talk to, home alone behind locked doors. Not in Greenbelt, you say? Well, think again.

Population changes, together with shifts in family composition and work patterns, have resulted in a rising number of neglected children in our community, children at great risk for failure in life. Crime, violence, and teen pregnancy are only some of the problems to be predicted when young people lack constructive activities and adequate supervision. And troubled kids are kids who make trouble.

United States Attorney General Janet Reno, describing her visits to children in detention centers, reported being told, "If only you had given me something to do in the afternoons when I was young." She stated, ". . . we've got to have programs in the afternoons (so) children . . . can grow up in sound and safe environments."

After-school Program

In an effort to address this problem, a meeting was held at Springhill Lake Elementary School (SLES) on April 21 to discuss the possibility of creating an after-school program at the school, which draws its 700 students from Greenbelt and Seat Pleasant. (See separate story.) Said Greenbelt City Manager Dan Hobbs, "The game plan is to start a program, however small, and build on it. If I

had to make a prediction, I'd say by next fall."

An estimated 100 to 150 elementary school students in Springhill Lake have no after-school care, according to SLES Principal Linda Sherwood. Few childcare providers are located there, and many parents cannot afford to pay for babysitters.

Census Data

According to 1990 US Census Bureau data, 14% of the Springhill Lake residents are at or below poverty level. Female-headed households have risen to 11% of the total.

Many youngsters return from school to empty households, awaiting the return of a parent from the workplace. The city-run Springhill Lake Recreation Center with its many activities offers a partial solution, but it was not designed as a childcare facility, and cannot provide supervision. Children come and go as they wish.

"We worry about the kids who don't use the Recreation Center," said Hobbs. "We're concerned they will fall under the influence of older children. The city sees a need for assistance for some of our residents, and we're trying to make that happen. The city is an advocate for its constituents."

According to PFC George Mathews of the Greenbelt Police Department, SLES youngsters are hanging out at stores and on the street. Behaviors which often originate as "goofing around" can escalate in social deviance. One local merchant has said he may move his business out of Springhill Lake primarily because his customers complain about disruptive youngsters around the store.

Greenbelt CARES Youth and Family Services Bureau has had many Springhill Lake families pass through its Family Clinic. One unsupervised ten-year-old boy kicked a playmate repeatedly in the head, resulting in the child's hospitalization.

Adult supervision is vital to the emotional and physical well being of all children. They need someone to see that their homework is done, to lend an ear to the successes and challenges of the day, and to intervene when they stray from a safe and reasonable decision. In the words of Suzanne Plogman, Greenbelt's representative on the Board of Education, "An after-school program is long overdue for the children at Springhill Lake Elementary School."

CARES Budget Is Reviewed

Greenbelt CARES will add several more hours in direct service to Greenbelt citizens during the next fiscal year and assist with a broader effort in setting up an afterschool program for "at risk" children in the Springhill Lake (SHL) area. Council met with city staff to explore next year's budget for its smallest department, Greenbelt CARES, on April 18.

The retirement this year of CARES long-time evaluation consultant, Molly Schuchat, will make available added funds for direct services to Greenbelt residents. CARES department head Carol Leventhal is proposing to use the funds to provide an increase of five hours per week for the education/vocation counselor.

The city's social service department will receive a slight increase, 0.17%, in funding over last year's budget, or \$246,100. The state, through its Department of Juvenile Services (DJS) is expected to contribute \$80,200, an increase of \$2,300 over last year. Prince Georges County is expected to maintain its grant of the past several years at \$8,500. While the city is required to provide a 25% match of state funds, it also provides more than half the total budget

for the department, which employs the equivalent of 4.5 full time personnel

CARES provides counseling for youths and their families, teen discussion groups at the two Greenbelt secondary schools, GED and other teen classes, a teen job bank and a discussion group for single adults, among others.

After School Care

A goal for the coming year is to assist in establishing an afterschool program at Springhill Lake Elementary School for the 150 students identified by the principal as having no adult supervision at home after school closes. The city's SHL Recreation Center staff and the city manager's office are also involved, along with school personnel in seeking appropriate funding for such a program. They are hopeful.

Take a Look at CIP

The City Council needs to seek greater community input into the Capital Improvement Program (CIP) before considering its adoption. We find a number of projects that we seriously question, others that have been deferred once again and for too long a time and still others that we consider important that are not even included. Greenbelters are urged to take a close look at what is proposed.

We are particularly concerned because we understand that the CIP is not a staff proposal, but rather reflects decisions of the council made at a retreat not held in Greenbelt. While we do not object to council's holding retreats, we believe that councilmembers have a special obligation to inform the community of consideration taking place there that have resulted in decisions.

Of the projects that concern us, perhaps the most serious is the setting aside of \$330,000 for purchase of land without any specific sites being designated. We believe the public has a right to know what land is to be bought with these funds and to determine whether or not this purchase is more important than other projects. While developers may act in secret, a public body has an obligation to keep the public informed. Some of the proposals we have heard put forth by individual councilmembers are, in our opinion, not good ideas.

We also question building a trail from the Metro Station to a trail along Indian Creek in Berwyn Heights, which is outside the city limits and within the jurisdiction of the Maryland National Capital Park and Planning Commission.

Council has placed a low priority on improving the facilities and handicap-accessibility of Buddy Attick Park. Construction of permanent restroom facilities is not scheduled until close to the turn of the century, trail improvements are several years off. Handicapped citizens need access to more of the park than the chemical toilets.

This year's CIP includes of number of significant changes to those of previous years. It is important that we all take a good look, and that the council gives the public real opportunity to be heard on the projects it proposes. Council has scheduled a work session for Tuesday, May 10.

STOP THE HOUSES

32 Homes to Occupy South-End of Greenbelt Park!!

Although the heading of the 2/18/94 News Review article that apprised us of the forthcoming construction of thirty-some homes to be built on the DiCamillo tract located on the south end of the Greenbelt Park was obscured by headlines entitled "Bids For Youth Center," the facts are now clear to anyone who drives by; the land that abuts one of our pristine national treasures is about to become more urban housing.

What's wrong with this picture? An 11-acre, rural setting without so much as electrical hookups for its visitors, will soon be embellished with 32 homes because the federal government failed to purchase the tract years ago. The Park and Planning Commission approved the project that will be by their own definition, "in conformance with current land use".

Whether intentional or not, word never filtered down to the citizens in an adequate manner so they could respond to the results of a Council/National Park Service meeting on the proposed development. The parcel of land surrounded on three sides by the park, 10 feet from the horse trail, and topographically tenuous, would be turned into residential sprawl.

This construction would cause a "visual intrusion" to one of our last natural sources of beauty in nature. I understand maintenance for the 25-foot perimeter surrounding the environ-

mentally necessary holding-pond will be at taxpayers expense!

The cost to the developer of the parcel. I understand was \$181,611.

I feel this amount, along with other expenses already spent by the developer, should be refunded and the parcel bought and annexed to the park (as it should have originally been) in order to "preserve" the actual current use of the land.

Write and call Senators, Congressmen, and City Councilpersons; let them know shirt-pocket deals aren't condoned by Greenbelters.

Stick to Issues

GHI elections are around the corner and the season for silly and unfounded allegations has begun.

In an ad in the April 28 issue of the News Review, Don Comis, a candidate for reelection to the Board of Directors, charges that in the four years he has served on the Board he has almost never seen a GHI job advertised. Had he checked his facts as I did, he would have learned that at least for the last two and a half years, except for a department head position, there were notices. In each instance a notice of a vacancy was posted in two places in GHI offices, placed in a paid ad in the News Review and in the Prince Georges County newspaper. Ads were also placed in the Washington Post for positions that were difficult to fill.

GHI personnel policies state that each vacancy shall be filled with the best qualified person available and that, in filling vacancies, full consideration be given to employees, and that whenever a person outside the organization with clearly superior qualifications is available such person shall be appointed. This policy has been followed.

Contrary to the contention made by Mr. Comis, there is no provision in the personnel policies or elsewhere, that members of GHI shall be given preference for job vacancies. Nevertheless, when they do apply, GHI members are given serious consideration. As of this date of a staff of 45 employees, there are six employees who are GHI members (including a son of one member), and five employees (including a son of a member), one of whom is a department head, who were GHI members when appointed to the GHI Staff. These 11 employees constitute almost 25% of the entire staff.

Mr. Comis is correct in noting that there was no advertising for the department head vacancy which was recently filled. The employee selected for the position of Head of the Maintenance Department, has more than 20 years of experience in this department, including eight years as Assistant Head, Maintenance, and two months as Acting Head. His performance in these capacities was considered to be outstanding. In recognition of the superior qualifications of this employee, management exercised the authority in the personnel policies which permits an exception to the normal procedures when this would be for the good of the cooperative. This was clearly so in filling this position. The in-depth experience and knowledge of GHI homes, its problems and on-going programs could not be matched by outside candidates.

Can we get on with discussion of real issues and make sure of the facts before we go off half-cocked?

Well, I have to admit I was wrong last week when I recommended that people can start planting annuals. Yes, the average last frost date is in late April, but as any long time resident of the area knows we can have chilly nights even in early May. On Monday night there was frost in some places in the city and at least one gardener that I know had her tomato plants killed.

The prudent gardener waits till mid-May to plant tomatoes and peppers and this year being prudent was wise. But if you did start planting in the end of April you could cover your plants on cold nights, especially if there is a cold wind. For light frosts, even newspapers or sheets or flower pots over a plant will give a lot of protection.

When all is said and done this is still the time of year to plant most of your annual seeds and plants. Just keep an eye on the weather.





for \$100,000.

Land Acquisition

•Land Acquisition, \$330,000, total costs \$2,330,000 of which \$2,000,000 is unfunded. These funds are allocated for the purchase of land as available. No sites are mentioned. In the past individual councilmembers have talked about two sites in Greenbelt East, the Sunrise Property and a small parcel of land outside the city limits at the end of Mandan Road. The CIP also proposes constructing two trails outside the city limits for which property would need to be acquired.

•Indian Creek Trail Extension, \$12,000, total costs, \$187,500. This project would build a hiker-biker trail outside the city limits from the Greenbelt Metro Station to an existing trail built by the Maryland-National Capital Park and Planning Commission along Indian Creek in Berwyn Heights. All funds are to be provided by the city, with the bulk of funds budgeted in FY 1999 and 2000. The city does not own rights-of-way or property in this area.

•Cherrywood Lane Metro Connector, \$12,500, total costs \$117,500. Although beginning and ending within the city, the trail would cross private property outside the city limits and the Indian Creek flood plain in order to provide direct hiker-biker access from Springhill Lake to

the Greenbelt Metro Station instead of the circuitous route now required using Cherrywood Lane and the Metro station access road. All funds are to be provided by the city. The city does not own rights-of-way or property in this area.

Future Projects

Very few major projects are proposed for the following four years. Funded are:

•Police station parking lot expansion, \$119,000, FY 96.

•Crescent Road improvements, Hillside to Northway, \$170,000, FY 96, and from Southway to 7 Court, \$171,000, FY 97.

•New police radio equipment, \$350,000, FY 98.

•Greenhill Road improvements, Crescent to Fayette, \$114,000, FY 98.

•Buddy Attick Park improvements, landscaping and parking lot, \$140,900, FY 98 and concession/restroom facility, \$160,000, FY 99.

•Edmonston Road improvements, \$150,000, FY 99.

•Light all Braden Fields, \$110,000, FY 00.

•Trail, Greenbriar Park to Route 193, \$163,000, FY 00.

GHI Meeting Uneventful

By GHI standards, the April 28 meeting of the Board of Directors of Greenbelt Homes incorporated (GHI) was relatively brief and uneventful. Topics of discussion included door prizes at the Annual Meeting, gifts for the participants in the House and Garden Tour, discussion of the 1993 audited financial statements, and feedback on maintenance surveys.

The Nominations and Elections (N&E) Committee recommended that door prizes be given to encourage more members to attend the Annual Meeting. This was particularly important this year since the agenda is short and non-controversial. Also

the N&E Committee has had difficulty attracting candidates for the Board, the Audit Committee, and the N&E Committee. The Committee felt that offering a door prize such as "Paying the winner's monthly charges for one month," would attract a large audience and encourage member involvement in the cooperative. The Board rejected this proposal as too expensive. Instead, they voted to repeat last year's door prizes — one

\$100 U.S. savings bond and two \$50 bonds.

The Aesthetics and Engineering (A&E) Committee, with no budget this year, requested funds for the House and Garden Tour. The funds would provide garden plants—a way of saying thank you—to each of the 35 participants in that tour. The Committee requested \$350. The Board approved \$200.

The Board of Directors discussed a motion to allocate funds to the replacement reserves and the contingency reserves by using money left over from the previous fiscal year, in which revenues exceeded expenses. The motion divided that money among the frame replacement reserves (\$253,457) and the masonry replacement reserves (\$126,356).

After the subsequent discus-

sion digressed into the rationale for reserves, President Alan Freas reminded the Board that in June the Board will study GHI's reserve policies. The motion passed.

(GHI Treasurer Chuck Hess explained later that this was a routine motion considered annually by the board, since revenues always exceed or fall short of budgetary projections. "This is just shifting equity from one portion to another," said Hess, "and equity is not cash.")

David Condron of Stegman & Company, GHI's auditors, was present to field any initial questions on the 1993 audit. Condron stated that the audit had identified no findings that would require major adjustments. He cautioned that there are still two outstanding suits in court against the corporation which had not been resolved as of 12/31/93. Nat Shinderman asked Condron his opinion of GHI's financial status. Condron's opinion was that, in the short run the corporation is "fine." In the long run, he believed that GHI would eventually need significant funds to maintain its older structures.

Survey

During February and March, the maintenance staff left a survey in all homes where work was performed. While members did not answer all the questions, the responses were generally positive and indicated satisfaction with the service. When negative comments were listed, the general manager or a representative from the maintenance department made a follow-up call. The survey revealed that 85% of the maintenance calls were answered within two days. General Manager Gretchen Overdurf said that "the survey was helpful in determining what problems exist and how we can better serve our members."



Police Blotter

Based on Information Released by the Greenbelt Police Department

As a man was getting out of his vehicle in the parking lot of

the Marriott Courtyard (6300 block of Golden Triangle Dr.) a man came up behind him, grabbed him around the shoulder area, displayed a knife in front of his face, and said, "Let's go for a ride. I'm not going to hurt

you." So the man drove him south on Kenilworth Ave., possibly to Washington, D.C. After a while, the man with the knife told the victim to stop and then demanded money. After removing the money from the victim's wallet, the man with the knife returned the wallet and got out of the vehicle. The victim then drove back to Greenbelt. The malefactor is described as black, in his 20s, about 6'2", 180 lbs., black hair. The incident started around 1:30 a.m. on April 21.

As a woman was getting out of her vehicle in a parking lot in the 7500 block of Mandan Rd. around 11:30 p.m. on Sunday, April 24, a man came up behind her and demanded her purse. She refused, so he displayed a

small handgun and again told her to give him her purse. This time she complied. The man then ran away towards Greenbelt Rd. He is described as black, 5'6", slim build, black hair, wearing a baseball cap and blue windbreaker.

Around 12:15 p.m. on Wednesday, April 27, a strong-arm robbery was reported inside Eleanor Roosevelt High School: a student asked someone for money and was given some change. The student said that it wasn't enough, but the victim refused to give him any more. The student then pushed the victim to the floor, punched him in the face, and removed his wallet from his pants pocket. The victim was not visually injured.

The wallet, without its cash, was found soon afterwards, outside the gymnasium. The student, a 14-year-old nonresident, was arrested and charged with robbery and battery; he was incarcerated at juvenile detention facility pending juvenile court action.

As an employee of Co-op Food was stocking cans on the bottom self in one of the aisles around 12:45 p.m. on Tuesday, April 26, a man approached her, pulled her up into standing position, tried to hug her and made intimidating remarks. She broke free and ran to another area of the store for assistance. Other employees tried to find the man, but apparently he had left. The victim did not recognize him as a regular customer. He is described as black, around 24 years old, 5'6", medium build, close cropped black hair, gold tooth on the left side of his mouth, wearing a white shirt with yellow stripes, yellow shorts, sneakers and no socks.

Around 10:30 a.m. on Tuesday, April 26, officers responded to a report of a person with a gun at Eleanor Roosevelt High School. Witnesses pointed out someone sitting in a car on the school parking lot as possibly being the person with the gun. Upon investigation, marijuana was found on the suspicious person, but no handgun. The person, a 17-year-old nonresident youth was arrested and charged with possession of marijuana with intent to distribute and possession of a pager on school property; he was released to a parent pending trial.

On Tuesday, April 26, a 1990 Dodge van was reported stolen from the 7200 block of Hanover Dr.; it was later recovered.

Kindergarten Registration

Registration for children who will enter kindergarten in September 1994, will be held at all elementary schools in Prince Georges County on May 9, 10, 11, 12, and 13.

The Maryland State Department of Education requires that all children in the State of Maryland attend kindergarten or an alternative program setting.

In July 1992, the state law lowered the minimum compulsory school attendance to five years of age and affects all children who are five by December 31, 1994, and requires that children attend kindergarten before entering first grade.



Proof of residency, immunization records - including a second measles inoculation, and birth certificate are prerequisites for admission to the Prince Georges County Public Schools. Parents/guardians, who are new residents of the County or who are registering a students for the first time, must complete an Affidavit of Disclosure, to establish proof of their legal residence.

NOTICE OF A PROPOSED PROPERTY TAX INCREASE

The City Council of the City of Greenbelt proposes to increase property taxes.

1. For the tax year beginning July 1, 1994, the estimated assessable base will increase by 3.5%, from \$511,442,258 to \$529,570,619.
2. If the City of Greenbelt maintains the current tax rate of \$1.33 per \$100 of assessment, property tax revenues will increase by 3.5%, resulting in \$241,107 of new property tax revenues.
3. In order to fully offset the effect of increasing assessments, the property tax rate should be reduced to \$1.28, the constant yield tax rate.
4. The City is considering not reducing its property tax rate enough to offset increasing assessments.

The city proposes to adopt a tax rate of \$1.37 per \$100 of assessment. This tax rate is 7.0% higher than the constant yield tax rate and will generate \$452,935 in additional property tax revenues.

A Public Hearing on the proposed property tax increase will be held at 8:00 p.m. on Monday, May 16, 1994 in the Council Room of the Municipal Building, 25 Crescent Road, Greenbelt, Maryland 20770.

The hearing is open to the public and public testimony is encouraged.

of \$9 per day for five hours of care, provided a minimum of 20-30 students are firmly committed to utilizing the program. He noted that child care vouchers from the Department of Social Service could be used to pay the tuition.

At the meeting on April 21, Judy Hoyer, the school board's coordinator for Early Childhood Education, supported the proposal. She said there was a good chance that supplementary funds could be obtained from the State's Child Care Block Grants to make the dollar-a-day tuition plan a reality—if not this fall, at some time in the future. These funds are earmarked for proactive prevention programs. Hoyer authored the plan for the after-school program already in operation at the new Greenbelt Elementary School (formerly Center School), a program that has been funded by a private grant.

Move Ahead

Also present at the meeting were Greenbelt City Manager Dan Hobbs; Carol Leventhal of Greenbelt CARES; Rudy Horton and Theresa Youngblood, representing the management of Springhill Lake; Board of Education Representatives Hoyer, Andrea Berggrin, Suzanne Plogman, Kaye Francis; and Vice Principal Sue Bachman and Principal Sherwood of SLES. It was decided to move ahead toward creating a small after-school program that would open this fall at SLES, with the expectation that it would be expanded as additional funding became available.

Sherwood stated that it was important to find money to build a therapeutic component into the plan, such as is included in the existing Greenbelt Elementary program. Unfortunately the Board of Education funds would not cover this service. As an alternative, it was hoped that the Lerner Corporation, owners of Springhill Lake, might decide to underwrite the salary of a counselor. In a not totally dissimilar situation, the owners of the Glen Arden Woods apartment complex contributed two rent-free apartments to house a supervised, early childhood program.

Sherwood will shortly be submitting a formal proposal to the Board of Education. The group agreed to meet again on June 2 to discuss progress.

(Continued from page one) ful that federal dollars may be obtained, though prior grant applications have been unsuccessful.

"Our job," explained City Manager Daniel Hobbs, "is advocacy." While the city could not fund the program, he said, the staff can help with such things as writing grant applications and providing volunteer tutors. The Lerner Corporation, the owner of SHL, may be interested, and the State of Maryland may also have funds available. The Board of Education, Leventhal reported, says it does not have the money to fund the program. (A similar program at Greenbelt Elementary School is currently completing its fifth full year of operation under a five-year private grant. This program is also seeking funding for next year.)

Leventhal pointed out that the SHL students who attend Oakcrest Elementary have not been included in the estimation of the number of at-risk students in the neighborhood — and probably should be.

Outreach

The CARES family counselor began last year to work as a mentor in the SHL Elementary School's Black Male Achievement Program. In further outreach, CARES is assisting in providing a group tutoring program using University of Maryland fraternity and sorority members.

Greenbelt Only?

Councilmember Ed Putens questioned whether Greenbelt taxpayers' dollars are going to help Greenbelters only or were others benefitting through CARES. Leventhal explained that referrals from DJS for counseling will include persons from a wider area than just Greenbelt. But, she said, when there is a waiting list for counseling, which there was all last year, CARES will refer them, when appropriate, to a closer Youth Services Bureau. Putens was also concerned about the make-up of participants in the

discussion groups in the high schools — what percentage are Greenbelters?

Councilmember Tom White expressed a different view: "In terms of (improving) the quality of life in Greenbelt, what difference does it make where the student lives?"

Putens wondered whether Greenbelt should reject state or county funds in order not to be obligated to serve non-Greenbelters. Leventhal speculated that the percentage of Greenbelt dollars is close to the percentage of Greenbelters who benefit from CARES programs. Hobbs could see a "need to define our role in schools — as a catalyst to help that institution do its job"

The population within the school building is a mixture of residents and nonresidents, said White. Students build relationships with other students regardless of where they live, he said. Any help CARES can give provides a better environment for all the students. The question to ask is whether this program is worthy on its merits, White stated.

Hobbs felt that allocation of scarce resource dollars is an appropriate policy question for the city council to ask.

"When the kids are here (in school) during the day they are Greenbelt citizens" said Councilmember Rodney Roberts flatly. He objected to what he characterized as a "nit-picking" discussion.

Unmet Needs

When asked what unmet needs CARES may have, Leventhal responded she would like to see "someone in the police station part of the time to assist parents who are there because of difficulties in the family." Mayor Tonj Bram inquired of Leventhal what the cost of a full-time person with the appropriate background and skills would be. Leventhal estimated the cost at \$31,000 to start. Councilmember J Davis thought there might be grant money for such a position.


