Labor Day Parade Gets a Pass On Monday's Scattered Showers

Greenbelt was lucky. It didn't rain on our parade. The day began gloomily with a weather forecast of 50 percent chance of rain. Looking at weather radar, one saw small rain cells scattered about the metropolitan area. Fifteen minutes before parade time, Greenbelt East experienced a downpour.

The area of rain extended to the easternmost parts of Ridge Road. On parts of Crescent Road, the parade route, there was a light sprinkle.

By parade time that had all cleared away and the sky lightened somewhat.

Once or twice the sun even tried to come out. The annual Greenbelt Labor Day Parade began on time and proceeded – dry and without a significant hitch.

Following a flag honor guard and bagpipe band from Annapolis was a beaming Sylvia Lewis, Greenbelt's 2011 Outstanding Citizen, seated on the top of the back seat of a small convertible with her husband Robert in the front seat and her daughter Janet in the back seat. Lewis was closely followed by the Greenbelt City Council riding atop Greenbelt's vintage fire truck.

This was not a federal, state or county election year, so the parade was shorter, with politicians limited to those holding elective office. Following the council, Congressman Steny Hoyer led the pack, walking the route and greeting well-wishers on either side of the road. For those watching the political scene, does his continued attachment to Greenbelt mean the new Congressional Fifth District will still include Greenbelt?

Newly elected County Executive Rushern Baker also walked. As he passed, greeting bystanders, he hollered out, "Thank you Greenbelt for sticking with me." Greenbelt gave Baker strong support in each of his three tries for election as county executive.

Other elected officials included County Sheriff Melvin High, County States Attorney Angela Alsobrooks; State Senator Paul Pinsky; and State Delegates Ann Healey, Tawanna Gaines and Justin Ross.

Marching Bands

This year the parade was blessed with not just one, but two marching bands. Neither probably would succeed in competition but, hey, there was real live credible marching music. One band was the newly formed Greenbelt Marching Band, distinguished by their colorful hats and a splendid banner. The other was the Eleanor Roosevelt High School Pep Band. There were also the Prince George's County Police Bagpipers and a drum corps.

New to the parade were the Marching Bins, the beautiful

A slide show of images from 9/11 will then be presented. On Sunday, September 11 at 8 a.m. there will be a memorial stair climb at the Maryland Trade Center I, 7500 Greenway Center Drive. Fire service members will convene in high-rise buildings across the United States to climb 110 stories as a tribute to their fallen brothers. Each climber carries the photograph and biographical sketch of a firefighter who was lost on September 11, 2001. On Sunday, September 11 at 11 a.m. there will be a Remembrance Ceremony at the Greenbelt American Legion Post 136 located at 6900 Greenbelt Road.

Voter Registration Required For City Council Election

Participating in the 2011 city election on November 8 – as a voter, candidate for city council or signer of a petition for a candidate – requires being registered to vote as a Greenbelt resident in Prince George's County. For the upcoming city council election, registration forms must be received in the office of the Prince George's County Board of Elections in Upper Marlboro no later than 4:30 p.m. on Monday, October 10.

Although it has taken quite a few years to accomplish, voter registration in Maryland has become "universal" in its interface with voters. People already registered to vote in the State of Maryland are no longer re-

Greenbelt Road Sector Plan Gets Go-ahead from County

On May 17 the Prince discuss how to best coordinate

George's County Council authorized development of the Greenbelt Metro Area and Md. 193 Corridor Sector Plan and Sectional Map Amendment involving the Greenbelt, Berwyn Heights and College Park communities.

The Maryland-National Capital Park and Planning Commission's planning staff has scheduled a series of agency coordination meetings to proactively address concerns on the sector plan identified by residents, workers and visitors. These meetings will serve as a starting point for continued partnerships between all parties as planning and implementation solutions are recommended. At the initial meetings, staff will review the goals and objectives of the sector plan, present issues that have been identified to date by the communities and

Bikes vs. Pedestrians An Issue of Law, Safety

Something happened one day last week that, had it happened at any other time, I probably wouldn't have said anything about it but there was a memorial service this past Sunday for an acquaintance of mine [in San Francisco] who was struck by a bicycle while jogging across a major highway over a month ago.

This lady had the green light and was in the crosswalk. The bicyclist who collided with her was traveling at a high rate of speed and ran the red light. The lady lingered in a coma for nearly a month before being taken off life support. The guy who hit her walked away with minor scratches. He's going to be charged with manslaughter in addition to the traffic violations he already faced.

The other day while walking on one of the pedestrian pathways near Hillside Road, I encountered three children traveling at a rather high rate of speed and an adult trailing behind them. First, I should probably mention that I believe it is illegal to operate a bicycle on a pedestrian pathway. I understand that parents hesitate to take children of this age on to any of our major roadways in Greenbelt but we do have bike lanes on some of those roads and perhaps they need to learn how to ride safely on them. Although I had a fair amount of time to react, none of children seemed to realize that he or she should also slow down. The fact that I needed to stand to the side in order to let these bikers whiz by is important to note because we have a fair number of older people in our neighborhood (I'm one of them) and some of them might not have been able to get out of the way as quickly as I did. One resident is still healing from an injury and currently uses a cane to get around – she might not have been able to get out of the way in time. I've also noticed that we have some sight-impaired residents who also traverse these paths. They would never have seen these kids coming.

Bicycles are supposed to be operated on roadways, obeying the same laws that apply to automobiles and other motorized vehicles. Under no circumstances are they supposed to be using pedestrian walkways. I really do understand the temptation to use the walkways, but if you are going to do so, you need to do it with a great deal of caution. And you need to remember that you have an obligation to recognize that the person on foot not only has the right of way but the law on his side as well.

I don't for a minute think that this group meant any harm or that the adult with them had any ill intent. But had I not been able to get out of the way, the scene could have been ugly. *Catherine H. Hardy*

Editor's note: bicycle riding on public sidewalks is permitted with-in the city.


Unacceptable Storm Response by GHI

In 30 years of construction work I never was called to a multifamily residence in an emergency situation and asked for a quote. It was always "just get it done." GHI is not a poor homeowner who doesn't have the financial ability to address this issue without knowing what the cost will



<u>A Review</u> New Book "Forgiveness" From St. Hugh's Pastor

"Forgiveness: A Catholic Approach" by the Rev. R. Scott Hurd of St. Hugh's, has just been released by Pauline Books & Media of Boston.

Parishioners at St. Hugh's are familiar with Father Scott Hurd's interesting Sunday sermons. He gets our attention with a story or joke to start and then sprinkles his homily with tales of colleagues or saints or TV stars that relate the Gospel teachings to our own lives. Now Father has written a book on one of his favorite subjects, forgiveness, using that same engaging style.

The little paperback book (121 pages) is separated into three parts: Part I "Why Forgive," Part II "Hallmarks of Forgiveness" and Part III "How to Forgive." Each part contains separate chapters with catchy titles, such as "Don't Be a Doormat" or "Kiss and Make Up." The book is easy to read. I almost finished it in one rainy afternoon. But after the first run-through, I realized that it deserves much more study and thought.

Each chapter in the book is a gem in itself. Taken one or two at a time, the chapters could make the foundation for an ethics course for young people or a study guide for a discussion group.

The references used to illustrate each topic, whether to saints, rock stars, theologians or literary figures like Scrooge and Sancho Panza, are always appropriate, sometimes funny, sometimes educational, appealing to teenagers and adults alike. I found myself weeping at the story of Saint Jane Frances de

Chantal, which I had never heard before.

In the beginning of the book, Father lists actions that might cause people to refuse to forgive, actions which to many of us would seem to require justice or even revenge. As I read the list, I thought of situations in my own life and that of my friends which were just like that.

He acknowledges that forgiving is hard to do. And I know that some people could never be convinced to go along with this whole concept of forgiveness. But if by reading this little book, their thinking could be changed just a tiny bit, who knows how many relationships might be healed or at least improved? Father Hurd's book might not bring peace to the world but it could provide a spark.




Now Clara is living in Staunton, Va., and Kirsten in Baltimore and keep in touch with each other from time to time.



just like seasoned Greenbelters who have moved within the city, can change their address with the county Board of Elections by sending in a "Change of Voter Registration Data" form available at the city clerk's office at the Municipal Building, 25 Crescent Road or from the Board of Elections office. Such changes may also be made by simply writing a signed letter to the Board of Elections, 16201 Trade Zone Avenue, Suite 108, Upper Marlboro, MD 20774.

If a new registration is needed, the form may be picked up from the city clerk's office or at the Greenbelt Library at 11 Crescent Road. Easier yet, "let your fingers do the walking" and print the form from the website of the Maryland State Board of Elections at elections.state.md.us/ voter_registration.

Voter registration changes cannot be faxed, emailed or completed online because they must contain an original signature. Forms or letters must be mailed or delivered to the county Board of Elections at the above address. Registration or changes may

also be accomplished in person

at the county Board of Elections office in Upper Marlboro or at any full-service Department of Motor Vehicles office during regular hours.

Eligibility to Vote

Eligibility to vote in the 2011 Greenbelt city council election requires being a U.S. citizen, at least 18 years old by November 8 and domiciled at a residence address within the corporate limits of the City of Greenbelt as of the date of registration. In addition, eligibility to vote requires not having been found by a court to be incapable of voting by reason of mental disability; not having been convicted of buying or selling votes; not having been convicted of a felony or, if convicted, having completed serving a court-ordered sentence of imprisonment, including any term of parole or probation for the conviction.

Lastly – and the one that shows the complete lack of concern and urgency in dealing with this matter – when asked, "Well, if nothing else, couldn't the backing board be replaced to be ready for work?" we were told he "would have to check to see if he had any in stock, as 'special' plywood was needed."

HSUS Reward Now Offered In Greenbelt's Old Deer Kill

A reward just offered by the Humane Society of the United States (HSUS) and the Humane Society Wildlife Land Trust revisits the case of the deer remnants found in the woods behind the garden plots on Hamilton Place near Greenbelt Homes, Inc. headquarters. This incident was reported in News Review articles May 26 (Hunting Stand, Deer Bones, pg. 16) and June 9 (Poachers Seem Less Likely, pg. 1) and a letter June 2 from Brian Almquist.

The two organizations have announced they are "offering a reward of up to \$2,500 for information leading to the identification, arrest and conviction of the person or persons responsible for illegally killing several deer that were found in Greenbelt."

In their announcement they related that, "According to Maryland Natural Resources Police, in late May 2011, the carcasses of about five deer were discovered in the woods near Greenbelt Community Garden. The remains of a tree-stand – an elevated seat that hunters use to scout wildlife "Poaching is a serious crime that not only harms wildlife, but as this case evidences, also puts public safety at risk," said Elise Traub, outreach and policy manager of the Wildlife Abuse Campaign for the HSUS. "The Humane Society of the United States thanks the Maryland Natural Resources Police for their efforts to find the person or people responsible."

It is illegal to hunt in the area where the deer carcasses were found because of the proximity to residential homes, the announcement stated.

Anyone with information regarding this investigation may call the Maryland Natural Resources Police Catch-a-Poacher line at 1-800-635-6124.

According to the June 9 story in this paper, Mayor Judith Davis is quoted as saying at a GHI meeting that "the remains are several years old. Hunters some time dispose of and recycle remains by dumping them in a wooded area to let nature take its course". The story also says that the reported hunting stand was believed to be remnants of a tree fort built by children years ago.

County Holds Hearing On Preservation Plan

The Maryland-National Capital Park and Planning Commission (M-NCPPC) has published a preliminary Priority Preservation Area (PPA) Functional Master Plan. The preliminary plan was developed for Prince George's County in accordance with HB-2 (2006), Agricultural Stewardship Act of 2006.

The PPA Functional Master Plan lays the groundwork for protecting the PPA by continuing to use existing tools and programs and implementing new tools that serve to accomplish the preservation goal set for the PPA plan. It provides guidance expressed through its vision, goal and objective. It also provides policies and strategies to address the preservation of farm and forest land uses in areas of the county best suited for such uses.

The public hearing is to give stakeholders and interested persons an opportunity to express views concerning the Preliminary Priority PPA Functional Master Plan. It will be held on Tuesday, September 13 at 7 p.m. in the Council Hearing Room, First Floor, County Administration Building, 14741 Governor Oden Bowie Drive, Upper Marlboro.

Doors will open at 6 p.m. for participants to view exhibits. Planning staff will be available to answer questions.

Copies of the preliminary plan are available at no cost at the following locations: County Administration Building, M-NCPPC, Planning Information Services (Lower Level), 14741 Governor Oden Bowie Drive, Upper Marlboro; Bowie Branch Library, 15210 Annapolis Road, Bowie; and Laurel Branch Library, 507 7th Street, Laurel. 





Little Paint Branch Trail Design Meeting

At 7 p.m. on Wednesday, September 14 the Maryland-National Capital Park and Planning Commission (M-NCPPC) will hold the kick-off public meeting for design of the Little Paint Branch Trail at Beltsville Community Center, 3900 Sellman Road.

M-NCPPC staff will provide an overview of the proposed trail, review a schedule for completion, give an opportunity for public input and answer questions. The new trail will close the current gap between College Park and Fairland Regional Park in Laurel. It will start where the Paint Branch Trail ends at Cherry Hill Road and will connect at Beltsville Community Center to meet the existing trail. These trails are part of the growing 20+ mile Anacostia Tributary Trail System that links parks, neighborhoods and Metro stations in northern Prince George's County for hikers, bikers and equestrians.

This year, 2011, the Outstanding Citizen is Sylvia Lewis.

Zugby's introduction usually provides a series of obfuscating clues to keep everyone guessing as to whom the honoree might be. This year he seemed to have trouble providing a clue that would keep the audience guessing. For most, particularly Greenbelt Homes, Inc. (GHI) residents, the honoree became easily recognized when Zugby announced the person had served many years on a homeowners board of directors and as president. The clincher was acknowledgment of the person's involvement with founding the Greenbelt Foundation.

Mayor Judith Davis and Maryland Delegate Tawanna Gaines, who were on the stage as the announcement was made, noted the expression of surprise that appeared on Lewis' face as she sat in the audience and came to realize that it was she who was being given the honor. She was doubly surprised when, as she walked up to the platform, she was met by her daughter Janet who was supposed to be at home in upstate New York. Her husband Robert also joined Lewis on the stage.

Credentials

As is the case with most Greenbelt Outstanding Citizens, Lewis has a long list of credentials as a community volunteer and activist. She has been a resident of Greenbelt for 43 years working for the American Red Cross and becoming the executive director of its Prince George's County Chapter until her retirement. She is also a retired Unitarian minister.

As a GHI resident she became active in the cooperative, serving first on the Member and Community Relations Committee, the Audit Committee and the Investment Committee before being elected to the Board of Directors. In that capacity she served for seven years as the co-op's treasurer and for four as its president. Lewis has been a strong advocate of cooperatives, gathering the representatives of all the Greenbelt cooperatives to form an alliance. In other community involvement, Lewis was a founding member of the Greenbelt Foundation, serving as its chair and co-chair. The foundation has awarded \$60,000 in grants to promote education, environmental and artistic endeavors. She also has been active in the Eleanor and Franklin Roosevelt Democratic Club where

she served as its treasurer, was an organizer of the Bike 4 Breast Cancer fund drives, has tutored at Greenbelt Elementary School, worked as a docent at the Greenbelt Museum and volunteered at the Greenbelt Arts Center.

Lewis has been commended by her nominators "for her commitment to social justice and her willingness and courage to take on issues based on her convictions combined with her sincere unpretentious and persuasive attitude and infectious spirit that draws others into projects that benefit our entire community. Despite those many accomplishments Lewis remains unassuming and has no idea just how many lives she has touched and how important her contributions have been and will continue to be to her friends and neighbors."

As with "The Price is Right" contestants, Lewis received prizes as well - perhaps not as glamorous or valuable but given with true generosity and appreciation by those contributing them. The cost of the Outstanding Citizen program has been borne primarily by the Greenbelt Rotary Club. Club President Steve Kemp presented her with the Outstanding Citizen Recognition Plaque. Davis and the Greenbelt Council presented Lewis with a proclamation of recognition as the 2011 Greenbelt Outstanding Citizen. Senator Paul Pinsky and Delegate Gaines presented her with citations from the Maryland General Assembly.

County Councilmember Ingrid Turner, along with County Councilmember Mary Hensel Lehman of District 1, presented Lewis with similar recognition from the county. Continuing tradition, four classmates of the Greenbelt Nursery School gave Lewis a "Greenbelt Is Great" T-shirt, this time done in black. Numerous merchants also donated gift certificates
