New GHI Candidates of Greenbelt

Five members of Greenbelt Homes, Inc. announced their candidacy last week for the 9-man board of directors, to be elected on Wednesday, March 25. They join the present 8 incumbents of the board who had previously signified their intention to run for reelection.

The new candidates are Allen D. Morrison, 58-Crescent, Emory A. Harman, 23-B Ridge, Elliott Bukzin, 6-N Ridge, Paul R. Kasko, 10-R Southway, and R. Hal Silvers, 25-A Ridge.

George Freaner, chairman of the nominations committee, said that his committee is still seeking more candidates. "We would like two nominees for each vacancy," he said. "We also need candidates for the 3-man audit committee and the 5-man nominations and elections committee."

The deadline for receiving nominations was moved back one week—from March 10 to Monday, March 16. Nomination and consent forms may be obtained from any member of the nominations committee or from the GHI office.

Freaner stated that he had proxy forms for any member who wishes to vote but will be unable to get to the ballot box. These proxy votes must be turned in to the GHI secretary, Bruce Bowman, 14-Z-3 Laurel Hill Road, by midnight, Friday, March 20.



Baptist Services Start Mar. 15 in New Church



The first Sunday services to be held in the new church building of the Greenbelt Baptist Church located at Crescent and Greenhill will be held on Sunday, March 15.

The painters have been busy this week completing their interior work using a monochromatic color scheme of a range between beige and tan. The contrasting color is white used throughout the building. The men of the Brotherhood have painted some of the Sunday School rooms on the ground floor. Pews are expected to be installed this week.

Sunday School will convene at 9:45 a.m. for all ages and the morning service wil be held in the sanctuary at 11 a.m. The evening program consists of Training Union beginning at 6 p.m. and the evening service at 7 p.m. The Greenbelt Baptist Church invites all who are not attending other churches regularly to attend these historical

The ground floor is divided into Sunday School rooms comprising three nursery rooms, beginner, primary, and junior department rooms. The kitchen is also located on the ground floor.

The sanctuary chapel with choir loft and baptistry is on the first floor. Two large overflow rooms, to be used for Sunday School classes for intermediates as well as the pastor's study and church office are located on the first floor.

This first unit of a proposed four unit building providing facilities for 250 in worship and education was designed by G. Truman Ward, architect, and built by the C. M. Hale Company of Kensington, Md. The cost of the building is approximately \$64,500.

Membership Vote Sought on Finance Plan to Repurchase GHI Contracts

Half a Road --- Problem In Full to Council

Half a loaf may be better than none, but the city council will not accept half a road as better than none. W. Evans Buchanan, builder of Lakewood homes, requested permission from the council to pave only one half (lengthwise) of Greenhill road, the access street to his new development. He presented photostatic evidence that a representative of the Baptist church had agreed, in 1956, to pay one half the cost of the road and a later letter sent last month, which stated that the Baptist church did not feel legally obligated to share in the expense. The church admitted to a moral obligation but stated it is financially unable to meet the cost at this time. The cost is estimated at \$3000.

Dr. James McCarl, Jr., speaking for the Baptist group, told the council that the original offer was made to the Continental Construction Co. (Warner-Kanter) but since that time the Independence Construction Co. (Buchanan) had purchased the property. McCarl added that the design of the new church building did not require or anticipate a street along one side of its property.

The puzzled council asked citymanager Charles McDonald to notify city solicitor Ralph Bowers and have him investigate the legal responsibilities of the city in this dispute. According to McDonald, the city need not accept in dedication a street that does not meet the standards of the community. However, he pointed out that residents will soon be occupying homes in Lakewood and they would be coming to the city for assistance if Greenhill road is unsuitable,

Instrument on Loan

Any Greenbelt boy or girl between the ages of 9 and 16, even though he or she has never played an instrument before, can obtain an instrument on loan from the Greenbelt Community Band to begin a musical career, a spokesman for the band has revealed.

Clarifying a story in last week's issue which stated that previous private instruction was needed before joining the band, the band official explained that beginners in music could select an instrument from the band collection and then sign up for private lessons. A list of local music instructors is available from the band, although any instructor can be used.

Those borrowing instruments are expected to take lessons. When the instrument has been mastered, the novice musician is given an audition by the band master, who decides when the player is ready to be accepted as a band member. The new band member retains the instrument as long as he is with the band, but he is expected to attend weekly band practice regularly.

All those wishing to obtain a band instrument on this basis should report to the band room of the Center School on Mondays at 8:30 p.m. during the next two weeks.

Following the recommendations of its land proceeds committee, the board of directors of Greenbelt Homes, Inc. decided last Thursday evening to present for membership approval at the annual meeting on Wednesday, March 25, a new resolution to replace the old resolution on the establishment of a plan for refinancing sales. Lloyd Moore, chairman of the 3-man committee (other members, Bruce Bowman and Ralph Bartholomew), stated that the old resolution, which was approved at the March, 1956 annual membership meeting, was in part no longer applicable to the current situation.

The new resolution reaffirms the intent of the board with membership approval to use the net proceeds from the GLIC stock sale (GLIC was the subsidiary corporation of GHI that owned the undeveloped land) for a revolving fund for GHI to purchase back and finance the resale of perpetual use contracts. GHI expects to receive in a few weeks the final payment of \$112,950 due on the land stock sale, of which about \$97,000 will be available after expenses for the refinancing plan.

The new resolution, however, unlike the old resolution, does not spell out the exact formula that will be used to govern the amount of loans or the conditions under which the loans will be granted. The old resolution prescribed that the loan on each individual unit would be limited to 60 per cent of book equity, up to a maximum of \$1,000. Moore stated that these restrictions make the plan inoperative today and suggested that the resolution contain no specific lending formula so that the board would have sufficient flexibility to meet changing conditions.

The committee, Moore said, was in agreement that at present local lending institutions like the Credit Union and Twin Pines Savings and Loan Association are providing sufficient financing for the resale of GHI housing units. Therefore, it was expected that GHI would not need to launch the plan on a large scale, but could get into it on a gradual basis. As an interim measure, the committee proposed that the resolution contain authority for the board to invest amounts not needed for the revolving fund with the local refinancing institutions, provided Public Housing Administration grants approval. At present the board is restricted to investing in insured financial institutions or in government securi-

The proposed new resolution also differs from the old resolution in one other respect. It contains no restriction on the possibility of other corporate funds being placed in the revolving fund.

A simple majority of the dulyconstituted quorum present at the membership meeting will be needed to approve the resolution, unlike a by-law change, which requires a two-thirds vote.

Empty Garages

The board expressed concern over the large number of garages—about 14—vacant in the 2 court of Gardenway. It had before it a proposal to rent these garages for storage of items other than automobiles but decided that renting for such purposes would not be appropriate for a residential area,
