## Doris Maffay of High Point Selected Miss Greenbelt

Doris Maffay was selected Miss Greenbelt of 1967 and Festival Queen at a ceremony on Sunday, September 3, at the Greenbelt Labor Day Festival. She was chosen from a group of seven contestants on the basis of poise, personality, and appearance by judges Mayor William Gullett of College Park, Lester Leonard, and Mrs. Ann Vrana.

The new Miss Greenbelt, a 17-year-old senior at High Point High School, was sponsored by the Lions' Club. She was crowned by Linda Shepherd, last year's first runner-up in the Miss Greenbelt contest. Mrs. Eli Don Bullian presented Miss Greenbelt 1967 with a trophy donated in memory of her late husband, Eli Don Bullian, the guiding spirit of Greenbelt's festivals for many years.

The first runner-up was Deborah Brooks, 16, a junior at High Point sponsored by Greenbelt Homes, Inc., and the second runner-up was Pat Zoellner, 17, sponsored by Greenbelt Variety. Mrs. Don Bullian donated and presented the second-place trophy, and the third-place trophy was presented by donor Leo Gerton, chairman of the Labor Day festival.

The other contestants and their sponsors were: Colleen McCord

(Federal Credit Union); Nancy Wynkoop (Fire Dept. and Rescue Squad); Nikki Ann Brunatti (Kay Dee Furniture); and Paula Shafer (Little League).

The contestants were escorted by members of the Fire Department both Saturday evening at the presentation and again Sunday night. The escorts included Bobby Mogel, Duncan Monroe, Johnny Pendleton, Kenny Stair, Bobby Parrish, Wes Shifflet, and Richard Tatum.

The queen and her court rode in the Labor Day Parade on Monday in open convertibles driven by Ed Wuermser, Dick Garner, Joe O'Brien, George Brunatti and Larry Robertson. They then viewed the rest of the parade from seats in the reviewing stand.

Mrs. Edward Wuermser was chairman of the Festival Queen program, and Ed Wuermser acted as master of ceremonies.

## Exchange of Land Proposed In Greenbelt Fed. Park Plan

Following an announcement of plans for extensive new facilities in Greenbelt Park (*News Review*, August 31), the U. S. Department of the Interior released a map showing the park's general development plan. One of the outstanding features of this plan is that it proposes by means of land exchange and acquisition, to consolidate federal parkland holdings now split up by privately owned enclaves extending into the park.

Two such enclaves exist in Greenbelt Park. The larger one is the 76-acre Jaeger tract, adjacent to Kenilworth Ave., which juts northward and southward into the park. Thirty years ago, this tract had been slated for acquisition by the government along with the rest of the Greenbelt land purchase, but through an error, the appropriation bill listed its area as 56 acres. The owners contested this figure, and since Congress never approved a supplemental appropriation, its acquisition was never accomplished.

At present, 38 acres of the tract are zoned R-H (high rise) and 29 are zoned for garden-type apartments, as was requested by its developers in a 1963 rezoning petition. The board of county commissioners denied this controversial rezoning on November 5, 1963, following a 2-2 tie vote; however, the case was appealed by the developer before Prince Georges Circuit Court, where on January 7 Judge William B. Bowie reversed the commissioners' decision and approved the rezoning. Due to a technicality, this ruling was set aside and a new court hearing held on April 7, 1964, in which Judge Bowie again ruled in favor of the rezoning. The city of Greenbelt then appealed the case before the Maryland Court of Appeals, but the county commissioners declined to join this appeal - by the same 2-2 vote as before - and the court refused to rule on the matter, maintaining that the city did not constitute an aggrieved party. The zoning was approved allows for a potential development of 2500 dwelling units, but so far only one section of garden-type apartments - "Westchester Park" - has been constructed.

**Land Acquisition and Exchange**  
The General Development Plan for Greenbelt Park proposes the acquisition of the two extreme sections of the Jaeger property - a 600 ft. by 800 ft. section reaching closest to the park's center and an irregular wedge pointing into the park's northern part. In exchange, it is planned to give up two sections of parkland - a wedge between the southern part of the Jaeger tract and Kenilworth Ave. and a rectangular area between its northern part and Greenbelt road, adjacent to the Kenilworth Ave. intersection. Both of these sections are surrounded on three sides by land not belonging to the park and thus have little potential for park use; as part of the apartment development, on the other hand, they can greatly improve the residents' access to highways.

The other enclave is the 10-acre Camillo property adjacent to Good Luck Rd., close to the park's southern entrance, which is at present zoned R-R (rural residential). In past years, the county commissioners have twice denied apartment zoning for this parcel - the last time, on August 24, 1966 - and the development plan calls for its acquisition as part of the park. Ultimately, this land is to contain part of a proposed youth hostel complex, with three lodges having a combined capacity of 300 visitors.

### Details of the Proposed Development

At present Greenbelt Park consists of 1100 acres, of which 840, partially developed, are on the western side of the Baltimore-Washington Parkway and 240 acres, undeveloped, are on the eastern side. According to the proposed plan, the eastern part and the northern end of the western part (roughly, that area now served by the loop of the existing park road) will be developed for sports and recreation, while the major part of the land will be used for camping and related activities. Part of a culvert passing beneath the parkway, near the middle of the park, is to be converted into a pedestrian under-

He received his Bachelor of Arts Degree from Washington University in St. Louis in 1957, his Bachelor of Arts Degree from Newton Theological School at Boston, Mass., his Master of Sacred Theology degree from Andover Newton Theological School, and his Doctor of Philosophy degree from McGill University, Montreal.

Mrs. Stover (Doralee) received her Bachelor of Arts degree in education from Washington University in St. Louis. Her early interest was in music, and she is an accomplished pianist and flutist. **Long Distance Race Results**

A total of 57 persons aged 5 to 67 participated in three long-distance races on Sunday, September 3, during the Labor Day Festival. One of the oldest long distance races held by the D.C. Road Runners is the featured 15 kilo (9.32 mile) run through the streets of Greenbelt and out through the Agricultural Farm, returning to the starting place at Braden Field. This event is sponsored by the Festival Committee as is a 1.5 mile Run For Your Life race around the perimeter of Braden Field. The Greenbelt Jaycees organized the races and sponsored a Jog Along run for inexperienced runners (also 1.5 miles).

The Open 15 kilo race was won by nationally ranked Bob Scharf of the Washington Sports Club from Bethesda in the new record time of 46 min. 15 sec. breaking Lou Castagnola's course record of last year by 1 min. and 46 seconds as he beat Castagnola by only 8 seconds.

Frank Newbold, a senior at Wakefield High in Virginia won the Junior 15 Kilo AAU medal run at the same time in 52.51.5. In this excellent field of 35 contestants four Greenbelt men finished: Larry Noel, 17, of Carroll High finished 16th in 56:50 only ten seconds ahead of Martin Greenbaum in 17th place; Harvey Geller was 29th in 65:33 and Hugh Jascourt 31st in 68:17. Two shorter races of 1.5 miles also attracted out-of-town runners who run regularly. In the Run For Your Life race Ralph Rota defeated 15 others to win in 7:35.2 only 1.7 seconds off the course record. Greenbelters finished 3rd, Milt Greenbaum of High Point in 7:59, Chuck Monahan in 10:30 was 10th and Marc Siegel age 8 in 11th place in 11:36. In the Jog Along Carl Simonson (11) won in 10:44 followed by five other Greenbelters, Pete Brachen 11:07, Mark Siegel 11:09, Armand Lenchek (10) 11:58; Gloria Greenbaum 11:59 and the youngest contestant Judy Simonson, finished in 15:03.

The next Long Distance race to be held in Greenbelt will be the Turkey Trot of 20 miles during Thanksgiving time. Other road-running races are held each week throughout the Washington area as well as the Jog Along runs for physical fitness held by the Jaycees monthly at Braden Field.

**Art Show Winners**

Although there were fewer entries in this year's Art Festival, held at the Youth Center as part of the Labor Day Celebration, the caliber of the work was judged to be every bit as good as that in last year's show. Art critic of the Washington Star, Frank Getlein, who served as judge of the competition, implied that the slightly conservative tinge of the majority of the show made it a better exhibition and a more honest one, since the artists were not obviously imitating the current trends in an artificial way.

As might be expected, the largest category of entries came in the Amateur Oils, but the increased participation of the younger people, and particularly the surprising amount of talent shown in the youth category, proved the high spot of the show.

Anne Evanosky beat her competitors for the popular Youth award, given by the Arts Shop of Silver Spring.

**APARTMENT SEGREGATION IN GREENBELT**

In August, the Rev. Alphonsus Smith, Rabbi Maurice Weisenberg, the Rev. Keith Johnson, and the Rev. Perry Smith, together with four other concerned local citizens, petitioned City Council to pass an ordinance to end the racial segregation that exists in all city apartments, save the Charlestowne Village group.

pass and will connect the two sections.

In the northern end of the western section, across from the upper parking lot of the existing picnic grounds, a riding stable and corral is planned. About six miles of bridle trail are projected, following the circumference of the western section, with an east-west cross trail in the middle of the park.

Other developments proposed for this part of the park - the closest one to Greenbelt's center - include the expansion of the existing picnic area from 75 to 350 sites. On the highest part of this area, behind the existing park police substation, a playfield complex is to be constructed, including two softball fields and four basketball courts, while to the west, adjacent to the land slated for exchange, will be several residences for park employees.

Further south, a large day camping area will be developed, with five shelters, 10 outdoor cooking areas and facilities for 400 visitors. The present campground, located further down towards Good Luck Rd., will get 30 new campsites to augment the existing 178, in addition to which three new camping areas are to be provided - a new family campground with 115 sites, a family trailer camping area having 110 sites (complete with utility hook-ups) and a group camping area. Near the entrance to the park will be a youth hostel with dormitories, dining hall and recreation halls, as well as an amphitheatre, a visitor information facility and ranger station, and such general campground facilities as camp store, showers and laundromat.

In spite of the extensive development proposed for the western part of the park, large areas in it are to be left in their present wild state, in particular the section adjacent to the stream bisecting the park from east to west. A network of hiking trails, totalling nine miles, is to be provided.

#### The Eastern Section

The largest part of the eastern section of the park - covering 150 acres and extending to the Beltway interchange - is to be developed as an 18-hole golf course, a proposal which has also been raised in the original draft of the Area 13 Master Plan. A parkland strip about 100-200 feet wide will border this land and will presumably be left forested, screening the golf course from view. This strip is also to be used by the 3-mile long bicycle trail proposed along the circumference of the eastern section.

The golf course will be reached from Good Luck Rd. by a new entrance and is to include a clubhouse and a restaurant. In addition, this part of the park will contain a recreation center and a swimming center, with a 500-car parking lot between them.

In the recreation center, the plans call for three softball fields, four basketball courts, eight tennis courts and 10 shuffleboard courts. For children there will be a fully equipped playground and a miniature railroad. Other projected facilities of the center include a 36-hole miniature golf course and a bicycle rental shop.

### Notice of Charter Amendment

Amendment to the Charter of the City of Greenbelt, Maryland was adopted on August 14, 1967 by the City Council of Greenbelt. The title of the resolution, which is a fair summary of the amendment is as follows:

#### Resolution Number 130

Resolution of the City of Greenbelt, Maryland adopted Pursuant to the Authority of Article 11E of the Constitution of Maryland and Section 13 of Article 23A of the Annotated Code of Maryland (1957 Edition as amended) Title "Corporation-Municipal", Sub-title "Home Rule", to amend the Charter of the City of Greenbelt, said Charter being Section 40 of Article 17 of the Code of Public Local Laws of Maryland (1963 Edition) and Containing in Whole or in Part the Charter of the City of Greenbelt, by Repealing and Reenacting with Amendments Section 40-23, Title "Nominations" to Provide that a Petition for the Nomination of an Elector for the Office of Council Shall be Signed by Not Fewer than 50 nor more than 60 Electors, and to Provide that the Provisions of Paragraph (b) Shall be Mandatory and Not Discretionary, and to Provide that Petitions be Filed with the City Clerk During Normal Business Hours, not Earlier than Sixty Days nor Later Than The Fifth Monday Preceding the Election, and to Provide that the City Clerk Shall Notify the Candidate Within Seven Days After the Filing of a Nomination Petition as to Whether Such Petition is in Compliance with Paragraph (a) and (b) of this Section.
