"Chasanow Story" May Be Featured In Movie

Twentieth Century-Fox is considering producing a movie about loyalty investigations among Government workers.

The studio has announced the purchase of screen rights to a series of newspaper stories by Anthony Lewis published last year in the Washington Daily News about the suspension of a veteran Navy Department employee as a security risk, and his later clearance.

The stories, which won a Pulitzer Prize for Lewis, dealt with the charges of Communist association made by unknown sources against Abraham Chasanow, who was employed for 23 years by the Navy Department Hydrographic Office in Suitland, Maryland.

Chasanow was suspended as a security risk in July, 1953, after the Navy Security Appeals Board had overruled a clearance given previously by a department hearing board. He was restored to his position with a public apology in September, 1954, by order of James H. Smith, Assistant Secretary of the Navy.

Toastmasters Listen To Leland Leasia

The fledgling Toastmasters Club of Greenbelt held its regular semi-monthly meeting Tuesday evening at the Center school. Ed Burgoon presided as Toastmaster of the evening and members provided some very interesting thumbnail sketches concerning themselves.

Leland Leasia of the Civil Service Commission Toastmasters Club spoke briefly, and offered some timely and constructive suggestions.

The next regularly scheduled meeting is set for Tuesday evening, January 27.

Last Monday the council cut: \$600 intended for codifying the ordinances and publishing copies of the city charter; \$100 from "finance"; over \$2000 from "municipal buildings" (several minor repairs and alterations to the community building will wait . . .); \$1000 from "community promotion"; \$250 from "advertising" item of proposed \$500; the entire \$500 for "planning and zoning."

Many of the items reduced will go on a "priority list" to be considered during the year and appropriations made from any accumulated surplus.

City manager Charles McDonald and the council went over the budget item by item. McDonald, following the lead of council ("It is apparent the council's trend is towards reducing the budget . . .") suggested various items that could be delayed or eliminated, and those that were urgent.

Before the budget consideration, letters were read from Abe Chasanow, Tony Madden, Ben Goldfaden, Mrs. Wilson (apartment owner) asking for economies and reduction of the tax rate, and from Henry Walter, asking for economies, but also inclusion of the youth center in the budget.

The council is not expected to consider the youth center item until Monday night. Asked by the News Review for a statement on the \$9000 request for a new youth-center building, Mayor Tom Canning replied: "A drawing submitted by Bev Fonda at the meeting of the building to cost \$20,000 appears to be too small. (The drawing showed three stages of development.) I'd rather build the entire structure at once through bond issue financing—this would have

Local Woman Active

Mrs. Jane Hunt, Greenbelt resident for 12 years, active civic worker, and mother of four boys, is for the second year chairman of the Prince Georges County Volunteer Christmas Bureau, and represents the city of Greenbelt on the PGC Planning Council.

Last year the Bureau served 314 families. This year it expects to give food, toys and clothing to 500 families. Under the sponsorship of the Prince Georges County Community Chest and Planning Council, the Bureau is staffed entirely by volunteers, and all contributions are voluntary.

Since early November Mrs. Hunt and Mrs. Carolyn Wood, vice-chairman, have been working at least 20 hours every week, finding volunteers, coordinating services of many local groups, keeping records, setting up the Christmas Store at the Hyattsville Armory, among thousands of other details.

From December 19 on, contributions will be accepted at the Armory. At any time during shopping hours, toys, food or clothing may be brought to Santa's Hideaway, outside of Lansburgh's Langley Park store. Station WGAY broadcasts from there every day from 2 to 4:30.

On Sunday, December 18, Mrs. Hunt announced, there will be a Teen-Age Dance at the Hyattsville Armory. Admission will be one can of fruit juice or canned milk, per person. Professional musicians are giving their time. Arrangements were made by the Soroptomist International of Prince Georges County, for this affair.

Mrs. Hunt added that if any organizations or individuals wish to give time, food or toys, clothing or cash, they may call AP. 7-8778, daily between 10 a.m. and 3 p.m., or contributions may be mailed to 3723 34th St., Mt Rainier. If you wish to give independently to a family, she asked that the name be submitted to the Bureau, to prevent duplication.

Some cash is needed, she said, to purchase meat and milk to supplement the canned food given by Prince Georges County residents.

The city council appropriated \$2000 from surplus for a tree-planting program in collaboration with Greenbelt Veterans Housing Corporation. Shade trees will be planted along the city-owned right-of-way, with some trees on GVHC property.

GVHC has allocated another \$2000 for the project, making the total \$4000 to be spent this year. It is hoped by council members and GVHC board members that tree and shrub planting will be done each year to enhance the beauty and value of Greenbelt property.
