Police News

The theft of assorted items from clotheslines in the basements of apartments at 22 and 32 Crescent was reported over the week-end.

Two Greenbelt youths were picked up by police for using abusive language and were charged with disorderly conduct.

A teen-age girl was injured by a cherry bomb which had been thrown near the entrance to the bowling alley. A warrant was issued to a 19 year old Beltsville boy for discharging fireworks.

A resident complained to police that a tire and wheel had been stolen from his car which had been parked at a local service station for repairs.

A call was received that two hub caps had been found on the lawn of the Community Church on July 5. Twenty-two minutes later, police received a call from a woman complaining of hub caps being taken from her car. Investigation showed that hub caps lost were the hub caps found.

Two boys were apprehended at the lake with B-B guns. They were released to their parents.

In Grand Jury action taken for the three lawnmower thieves, two who stole were sentenced to six months in the House of Correction. The third person involved, the one who received the lawnmowers, was released following an investigation of his family circumstances.

Jim McCollum, a long-time former Greenbelt resident, has been made manager of the Greenbelt Co-op Store, one of the 11 supermarkets of the nation's largest consumer co-operative chain.

While still a student in high school, Jim started working as a part-time produce clerk in the Greenbelt store. On June 3 of this year, exactly 10 years later, he took over in his new capacity as manager.

His parents, Mr. & Mrs. J. W. McCollum, have lived in Greenbelt almost continuously for 18 years. His mother is presently employed at the Greenbelt Police Department; his father is retired.

Jim is married to a local Greenbelt girl, the former Harriett Riley, and they now reside in Silver Spring. He is presently attending classes at American University, where he is studying Business Administration.

Though his hours on the new job are long, he still finds time to enjoy golfing, bowling, and hunting. According to Jim, "I am very happy to be back in my old environment. I plan to work my hardest to make the best services available to my old friends and neighbors. It's like coming home again."

City Gets New Jeep

Delivery was made Monday, July 10, on the new jeep which the city has purchased for use by the department of public works. The vehicle is to serve many purposes -- chief of which during the winter will be snow removal in various small areas, such as court parking spaces and the center plaza. The jeep can be fitted with a snowplow on the front end; its four-wheel drive is essential for heavy-going.

During other seasons of the year the jeep will be used for transportation if men and equipment.

BANK DIVIDEND PAID

At the regular meeting of the Board of Directors of Suburban Trust Company, Chairman T. Howard Duckett and President J. Robert Sherwood, recommended and the Board adopted the resolution authorizing the payment of the regular quarterly dividend, payable Friday, June 30, 1961, to stockholders of record as of Monday, June 19, 1961, 2 p.m., Eastern Daylight Time, at the rate of 50 cents per share (on the basis \$2 per annum) in the aggregate amount of \$185,000.

Festival Booths

As the result of a proposal by city manager Charles McDonald, council, at its last meeting, voted to turn over to the Greenbelt Fire Department and Rescue Squad the festival booths, which have been in the past maintained by the city. The Fire Department is expected to maintain, set up, and take down the booths for all future festivals (except this year's Labor Day festival, for which the city is already committed to set up the booths). In return they will charge a nominal rental fee to the various organizations using the Booths.

Fishing Rodeo To-day

Over 700 boys and girls from 65 playgrounds were expected to attend the 4th Annual Prince Georges County Recreation Department's Fishing Rodeo, held today at Greenbelt Lake.

The Rodeo started promptly at 10 a.m. with youngsters trying to land the heaviest fish, longest fish, most fish caught and first bass caught.

In the Casting Contest, participants competed in two age divisions, 16 and under and 12 and under. Casting distance for the older group was 60 feet, and for the younger group 40 feet.

Lures in the home-made lure contest were judged for originality and usability and prizes awarded to the winners in the 12 and under and 16 and under divisions.

The annual "Huck Finn" contest offers prizes to the boy or girl who most closely resembles Mark Twain's famous character.

The Fishing Rodeo will be the kick-off for the Fishing Contest, which will run until August 14, and is open to any Prince Georges County boy or girl who is registered on a playground and who is not yet 17. Prizes will be given for the largest legal bass, blue-gill, crappie, carp and cat fish caught. All entries must be registered within 48 hours by the Playground Director and catches verified by an adult.

Council Faces Parking Issue Again, Plans Detailed Study

The recurrent and growing parking problem occupied the center of attention at Monday night's meeting of city council. A broad look at the situation was taken by council, based on reports of several new complaints.

Residents reported that vehicles have been sitting for long periods in court parking areas without being moved. This pointed up a certain dilemma created by the present parking ordinance. This ordinance states that 51% or more of the residents in a court may petition to have court parking assigned; however, since it provides for only one parking space per resident, apparently residents with two or more cars are reluctant to petition for assigned areas.

City manager Charles McDonald in his progress report brought up four parking problems in different courts and suggested remedies in each case for the council's consideration. He noted that GHI was cooperating fully in each instance by granting right of way where necessary, but that it was the city's responsibility to pay for any road work done. Council members agreed that this was true, but they expressed the feeling that more information was necessary before deciding the individual cases, such as estimated expense. They also did not want the changes to detract from the appearance of the courts.

Mayor Kistler called the parking troubles part of a growing general situation which probably would require a corresponding general attack, perhaps by the Planning Committee. In such an effort he felt the cooperation shown by GHI would prove helpful. Councilman Smith agreed, pointing out that the piecemeal remedied would cost more, inevitably, than a final solution. The Planning Committee, consisting of Councilmen Canning, Champion, Smith and City Manager McDonald, decided to hold a special meeting next week to consider the problem.

LAKEWOOD DRAINAGE

McDonald reported that the developers of the Perkins apartments had presented plans for the first units and had looked over the site. He also reported that as directed by council a letter had been sent by the city to try Lakewood developer, W. E. Buchanan, asking the latter to set a meeting date to discuss the Greenhill drainage problem. A Lakewood citizen questioned the time lag of three weeks after direction by Council and the actual sending of the letter, which added to an already inordinate delay of several months, according to the resident. The council listened attentively as other Lakewood residents present described the damage being done to their land, and assured them that the meeting with Buchanan would be pressed.

Proposed control of Centerway traffic flow was outlined next by the city manager with the help of a chart. Traffic islands would be built at both ends of Centerway, and curbs would be rounded to ease the present sharp turns. Total cost would amount to \$2850. He suggested this be considered by the Advisory Planning Board at its next meeting.

As the final item of the meeting special registration hours were decided on for the coming election. These hours are given elsewhere in this issue of the NEWS REVIEW.

Perkins Apartment Plans Delight McDonald

By invitation of city manager Charles McDonald, several representatives of Community Builders, Inc., which will construct the 4000-unit apartment development on the Perkins tract near the junior high school building, called at the city offices Tuesday. They discussed with McDonald the type of buildings that they had in mind and showed him preliminary plans.

According to McDonald, the developers have taken into full consideration Greenbelt's history and general plan. McDonald called himself "delighted" with the way in which the plan has been drawn to utilize the contours of the land and to provide ample green space around the buildings. "We should be very proud and happy," McDonald said, "to have such a development within our city."

Ground is expected to be broken for a 242-unit section of the development this fall. Later sections will include a small lake, an excellent site for an elementary school, and a swimming pool. Ample parking is planned for all sections, and planted strips will separate each parking area, to maintain the green appearance of the development.

At the present time the builders are consulting with engineers and other officials of the Washington Suburban Sanitary Commission and the Park and Planning Commission concerning specifications for sewers, water mains, street grading, and subdivision approval.

John Martone, 58, of 23-E Parkway Road, an auditor for the International Co-operation Administration, died of a heart attack in Seoul, Korea. Martone, who paid for his education by working as a boxer, was a sparring partner of heavyweight champion Jack Dempsey for four months in 1926. He ended his boxing career in 1928. Martone served as physical training director for the Secret Service, as instructor for the Army Counter-Intelligence Corps, as training officer for the Coast Guard and training instructor for the Provost Marshal Section, Army Forces in the Far East. Misleading Packaging Attacked by Co-ops

A spokesman for the nation's longest string of consumer-owned shopping centers said the co-op can't keep up with "the steadily rising volume of false and misleading advertising" and it's "high time" the government helped.

When a food manufacturer ships his products across state lines, the government now requires him to show the net weight on each package and to list the ingredients in their order of predominance.

This isn't enough, the Cooperative League's executive director, Jerry Voorhis, told a Senate subcommittee studying packaging and labeling practices, June 29. The chain of 11 co-op shopping centers that encircle the city here, Voorhis said, believe the government should also see that -- net weight is printed at least one fourth as large as any type on the label and that it appear on the front; -- net weights of similar products are standardized; and -- fractional ounces are abolished.

Voorhis said the co-op, Greenbelt Consumer Services, also believes the government should prescribe names for package sizes -- for example, small, medium, and large -- and abolish such meaningless terms as jumbo, giant, economy, family, and household size.

Congress should also protect consumers from paying "a disproportionate amount" for the package, Voorhis said.

Voorhis said changes in food labeling and packaging are often "calculated to confuse or deceive the buyer." A Chicago co-op, which operates the biggest food store in the city, noted these changes in the past 18 months:

- o Brand A baby foods contained 5 ounces, now have 4 1/2 ounces. Same price.
- o Brand C shredded wheat cereal increased the size of the box, reduced the contents from 12 to 10 1/4 ounces. Same price.
- o Brand E cake flour came in 2-pound box, now is in a "new handy" 1 1/2-pound box.
- o Brand F liquid detergent dropped its "large" size, now comes in an "economy" 1-pint, 6-ounce bottle and a "king size quart."

The same size frozen vegetable packages may contain anywhere from 12 to eight ounces, "depending on the vegetable and the packer," Voorhis said.

The home economist for three customer-owned shopping centers at Berkeley, Calif., he said, believes "most nutritional claims on food labels are misleading." Examples of this, she said, are

-- Breakfast food that has

"power protein." A large serving provides 4 grams of poor quality protein, less than 6% of what an adult needs each day.

-- Bread that "builds bodies 12 ways." Such a claim is meaningless.

In fairness, Voorhis said, American food makers provide a wider variety of generally better quality products than any people ever dreamed of before.

"Their sharp practices and extravagant claims" coincide with the popular notion that it's "stylish to be wasteful and indulgent." "We cannot blame the trade alone for these practices. We must also blame ourselves."

FTC JOINS ATTACK

Deceptive advertising must stop, Federal Trade Commission Chairman Paul Rand Dixon says.

He told the Senate appropriations committee that FTC had two major objectives in its truth-in-advertising campaign:

- getting the cooperation of businesses involved, and
- broadening the attack on violators.

When FTC suspects ads have overstated the quality of a product, it asks manufacturers if they've authorized the claims and if they can substantiate them. The agency also asks for sample advertising during the past six months and the products' formulae.

If a company refuses to comply, FTC can prosecute. The theory is "that instead of protracted investigation," companies "will have to send in evidence," Dixon said.

Some deceptions include misrepresentation of

- size of sleeping bags by confusing "cut size" with "actual size."
- size of houses for sale. Small, custom-built furniture is placed in the house. Buyers believe a room will hold that much furniture, until they try to put standard size furniture in it.
- certificate values in buying books and photo albums.
- cutlery falsely advertised as made in England. -- EA
