Insurance Program and Youth Center Staffing Occupy Council's Attention

Last Tuesday night saw City Council finish the last part of a 27-item agenda, with most of the evening's discussion concerning insurance. Council agreed to cover the city manager and city treasurer each by a \$10,000 bond, with a \$1,000 blanket policy on the other city employees. (Insurance coverage of the treasurer and manager is required by the Charter.) General Insurance Company was the low bidder. Fireman's Fund Group Insurance was the low bidder for burglary insurance.

A request from the recreation director, James Woodridge for a part-time cashier for paid programs was considered by council. The request stated that it was not possible for the Youth Center personnel to act as cashiers, and at the same time properly supervise the program. Some councilmen questioned the necessity for a cashier, pointing out that there are two recreation directors, as well as a paid worker provided by the County two nights a week. Council decided to hold the request and place it on the agenda for the next meeting. In the interim, Mayor Francis White asked for a schedule of Youth Center activities, showing which personnel were on duty during particular programs. Councilman Dave Champion suggested that Woodridge be invited to discuss the matter at the next meeting.

Land Fill

Fritz Schrom, who is clearing the land for the Bresler developments, appeared at the meeting to discuss the use of fill dirt made available from the land grading. The plan is to place the surplus material below the dam at the lake to enlarge the recreation area. Schrom also suggested methods of improving the condition of the lake when the State Fish and Game Commission drains it. This is scheduled for November.

Appointment of an auditing firm to conduct the yearly audit of the city books was considered. A motion was passed to have the city manager contact some firms and report back to council.

Harry Zubkoff appeared to report on the latest developments in the Twenty-fifth Anniversary Celebration.

School Enrollment

Enrollment this year at North End School was 312 students, down 6% over last year's total, according to Mrs. Maxine Grimm, principal. New teachers on the staff are Mrs. Dorothy Wemple, Mrs. Nell Shore, Mrs. Hulda Bomberger, Mrs. Louise Lewis, Mrs. Patricia Kaufman and Mrs. Lucy Wolfe.

Ferdinand Cardano, Center School principal, reports an enrollment of 327, a decrease of 4.4% from last year. New teachers include Mrs. Dorothy Bulloch, Mrs. Bernice Raleigh, Mrs. Betty McElderry and Mrs. Flora Willard. Mrs. Irma Emanuel is the new clerk.

Both North End and Center School have 10 grade teachers and two specials, a physical education and music teacher, the latter Miss Ann Riccardio who is a recent graduate of Catholic University.

St. Hugh's reports a total of 439 students. This is a 2% increase over last year's total of 430. The staff includes the principal, Sr. Laurential C.S.C., 8 sisters, and 2 lay teachers.

Greenbelt Junior High School has an enrollment of 896, up 1.8% over last year's total. Francis Furgang is the principal and Mr. Anderson, vice-principal. There are 42 teachers on the staff (including 2 guidance counselors, special education teacher, librarian), and a full time nurse.

High Point High School opened its doors to approximately 2,000 students with classes beginning at 8 o'clock for one group followed by another group at 9 and the last shift at 10. "Such a shift has made it possible for us to offer each student a full day of school in spite of the increased enrollment," was the statement made by Allan I. Chotiner, principal. Due to this split arrangement the staff at High Point has been drastically increased to ninety one faculty members and seven clerks.

City Notes

Work is proceeding according to schedule on various building and road-construction projects, City Manager Charles MacDonald reported this week. At Spring Hill, the first floors are going up, and brick work is under way. Excavation for the new Klein's Department Store at the Beltway Plaza shopping center is also proceeding rapidly.

Progress has been made on the installation of curbs on Parkway. This work will be done gradually, as conditions permit. The dualizing of Glendale Road from the Baltimore-Washington Parkway to Enterprise Road is proceeding with great speed. The land has already been graded all the way to the Space Agency.

The proposed Boxwood subdivision is being redesigned by the builder. Additional recreational areas will be provided, in accordance with the recommendation of the Park and Planning Board.

Maintenance of Additions to GHI Homes is Member Responsibility

The board of directors of Greenbelt Homes, Inc., has reaffirmed its policy of not accepting responsibility for structural defects in additions. Certified letters to this effect will be mailed to all members who have purchased GHI units with additions.

The occasion for this action was an appeal at the Thursday, September 13, meeting by John F. Downs, 4-D Crescent, for GHI maintenance assistance to correct structural defects in his addition. He had bought the house in June 1961 from the previous owner, who had built the addition. Shortly thereafter the walls began to crack and settle, the window frames bowed, and gaps appeared where the addition and original unit were joined.

GHI has had a policy since August 1954 of not accepting responsibility for structural defects in additions, although responsible for structural defects in the original units. Consequently, no extra maintenance charges are levied for persons with additions. Extra charges, however, are levied for heating maintenance and repairs which the corporation is responsible for in both original units and additions.

(The 1954 board policy resolution read as follows: "That structural changes be maintained by the owner, with the exception of exterior painting which, if done by GVHHC, will also include the additions".)

Downs stated that his contract does not contain any distinction in treatment between the original unit and the addition. Therefore, his addition should be entitled to the same services as his original unit.

Director Bill Helm agreed with Downs that a purchaser of a unit with an addition has nothing in the contract to inform him of the fact that he cannot look to the corporation for structural maintenance of his addition. He therefore voted against the otherwise unanimous board decision not to make an exception in this case.

Notification

General manager Roy Breashears pointed out that as a matter of routine procedure all new purchasers of units with additions are informed of board policy denying responsibility for maintenance of the additions. Helm did not disagree with the policy but stated that unless the purchaser receives something in writing to this effect, the policy should only apply to the builder of the addition.

Mrs. Roosevelt Cancels

Capital Beltway Progress

The State Roads Commission of Maryland has announced award of a contract on the Capital Beltway.

The project calls for grading, drainage and surfacing of the Interstate loop from the Baltimore-Washington Parkway (U. S. Route 59).

The award was made to the Williams Construction Company of Baltimore, at an amount of \$3,911,263.

It includes 3.7 miles of main line roadway, five miles of interchange ramps and dual bridges over the Pennsylvania Railroad.

Progress reports on the Capital Beltway now indicate that the Expressway will be open to traffic in its entirety in 1964 and highway officials will press to establish an early completion date that year. In order to expedite construction Maryland road builders are holding conferences with contractors and others involved in the project.

As an Interstate highway the Capital Beltway is financed out of 90 per cent Federal funds administered by the Bureau of Public Roads and 10 per cent State funds.

that this would not be fair to other members of the corporation, since owners of additions are not paying any extra charges to cover maintenance contingencies. It was also pointed out that the new GHI Handbook (page 25) states that "Maintenance and repairs of additions are the member-owners' responsibility, since the mutual contract agreements with all members provide for maintenance and repair of the basic dwelling only."

Helm took issue with this interpretation of the contract, but Breashears produced a legal opinion from GHI counsel, Krooth and Altman, substantiating the view that GHI has no legal responsibility for providing repairs and maintenance to additions.

The board asked management to develop a rider or attachment to the contract which would clearly outline the areas of responsibility of the corporation with respect to additions. The board also expressed sympathy for Downs' plight and suggested that the maintenance department offer whatever assistance it can within the limits of board policy.

Proposed Changes

The board heard proposals to change both its auditing and attorney services. Audit Committee Chairman Bernard Bordenet argued that as a matter of general principle the corporation should change auditors every five years, at the least. In this way, he said, the corporation would have the advantage of receiving advice from several sources. He also asked that the scope of the audit be changed to include a management audit as well as a fiscal audit.

Helm proposed that the corporation consider engaging on a retainer basis Maryland attorneys rather than District of Columbia attorneys, Krooth and Altman, who do not have a license to practice in Maryland. GHI at present employs local Maryland attorneys to handle its affairs before Maryland courts. Krooth and Altman are used to handle administrative and governmental matters of a co-op legal nature.

Director Ed Burgoon did not see the purpose of making changes when satisfactory services are being obtained. Helm argued, however, that GHI attorneys should be close to the Greenbelt scene. The matter was placed on next meeting's agenda, as were also the recommendations of Bordenet.

Basements

GHI has received word from its insurers that use of the boiler rooms as storage areas would not increase premiums of its fire insurance. The Firemen's Mutual representative, however, recommended that a water sprinkler system be installed. The board is continuing to study means of permitting limited use of basement areas for storage, and management is preparing, as a first step, a list of non-combustible items that could be approved for basement storage.

Tid-bits

GHI garages are not for the storage of airplanes — is the latest decision of the board. Believe it or not, the corporation had one such case The GHI office in the center is now being staffed on weekends. Personnel shortages had prevented manning up to now GHI reports only \$140 in vacancy losses for the first six months of 1962 The board voted to finance cost of Asian flu shots for key GHI employees The board reaffirmed its policy of making land available for additional parking space, but cost must be borne by city Joseph Kendall, chairman of standards and improvements committee, is in dire need of additional committee members. If interested, call GR 4-8098 Medical insurance rates for GHI employee insurance have been increased to \$6.36 per month for the family plan and \$2.50 for the individual plan.

Bresler Plans Announced To Start 21 Houses Now

Charles Bresler has announced that construction of the first 21 houses in his new project on Lakeside Extended will begin within the next week. They will be ready for occupancy between February 15 and March 1, weather permitting.

A total of 61 houses will be built. The remaining 40 will be started in December, and a September occupancy date is planned. All the houses (to range in price between \$25,000 and \$35,000) will have a view of the lake; some will have balconies with patios beneath them.

All houses will have four or more bedrooms, air conditioning, all-electric kitchens with dishwashers, and family rooms off the kitchen. Styles will include split levels, ramblers, and bi-levels (for sloping lots).

Festival Cake Winners

CHOCOLATE CAKE

(First prize winner, Greenbelt Festival Contest, by Miss Jeanette Louk)

Bake at 350 deg. for 50 minutes. Makes 2 9-1 1/2 inch round layers. Sift together into mixing bowl: 3 cups sifted Pillsbury flour, 2 cups sugar, 1 1/2 teaspoons soda and 1 teaspoon salt.

Add 3/4 cup margarine and 1 1/4 cups milk. Beat for 2 minutes. (With electric mixer blend at lowest speed, then beat at a low speed. By hand, beat 300 strokes with a spoon).

Add 3 unbeaten eggs, 3/4 cup maraschino cherry juice, 3 squares (3 oz.) melted unsweetened chocolate, 12 maraschino cherries, finely chopped and 1/4 cup milk.

Beat for 2 minutes. Turn into two 9-1 1/2" round layer pans, well greased and lightly floured on the bottoms only. Bake at 350 deg. for about 50 minutes. Cool and frost.

Since its establishment in November, 1961, the Center has graduated five young retarded and placed them in outside jobs earning \$50.00 a week. The United Givers Fund, which supports this agency, will kick-off its 1962 campaign on October 1, with an overall goal of \$8,042.00.

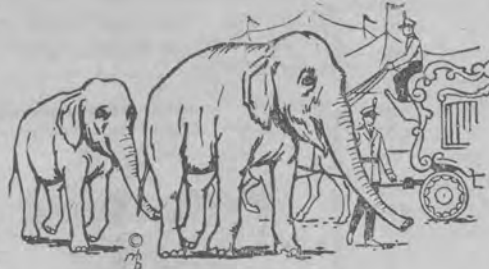
