Boiler Room Storage Banned; G.H.I. Center Office In Doubt

Long-pending arrangements by the board and management of Greenbelt Homes, Inc. to allow storage by members of certain items in boiler rooms came to a sudden halt last Thursday night when manager Royal D. Breashers notified the board of a ruling by the county fire inspector. He ruled that such storage violates the county fire code.

According to the code, no storage is allowed in boiler rooms for multiple-family dwellings unless the boiler rooms are constructed with firewalls, ceilings, and floors. Also, no items can be stored within three feet of the service panel. Thus, even if GHI boiler rooms were made fireproof to conform with the code, there would be no space left for actual storage.

Only by the merest chance was the GHI management apprised of these county regulations. Under previous board action, members were to have been allowed to store only non-combustible articles in the boiler rooms. When Breashers and maintenance supervisor Dave Kane, as well as certain board members, could not reach agreement in defining combustible and non-combustible as related to certain specific items, they appealed to the county fire inspector. At this point they discovered that the whole storage program would have to be scrapped. The membership will be notified immediately of the

changed policy.

Center Office Dispute

Another piece of old business, a source of heated controversy among board members and management in the past, was again chewed over when it was noted that the one-year lease on the Center Office runs out on September 30. The question was whether to pick up a part or all of a 2-year option to renew the lease with Twin Pines Savings and Loan Association. A motion by Joe Comproni to close the office at the end of October, supported by Allen Morrison and Joe Cherry, was defeated when Bill Helm voted with Ed Burgoon, Henry Brautigam, and president Harry Zubkoff against the motion. (Directors Frank Lastner and Ed Peters were absent.)

The board later passed a motion by Helm that a 15-day extension of the lease be requested of Twin Pines to allow the board, at its October 11 meeting, to hear a full report from Mrs. Mary Jane Kinzer, director of the sales office, on the effect of the Center office on total sales. The board was particularly interested to discover what experience the sales staff could report about the four weekends when the office had been manned.

Discussion brought out that total cost of the office-repair of the room, remodeling, air conditioning, furnishing, and rental payments -

Concert and Space Display Begin Anniversary Month

An outdoor Army Band concert and an indoor space-age display at the National Guard Armory this Sunday, October 7, will kick off Greenbelt's month-long observance of its 25th anniversary, according to Harry Zubkoff, Chairman of the city's Silver Anniversary Committee.

The space-age display will feature a Tiros weather satellite, a one-third scale Mercury capsule, a pioneer V satellite, a model nuclear propulsion unit, and a space suit, among other interesting items. The display inside the Armory will be open before the concert, closed during the concert, and reopened at 4 p.m., immediately after the concert. A portable Space-mobile will also be on display at the Armory, complete with moving parts and speaker. The Space-mobile is an educational attraction to acquaint people with the wonders of the space age. During the week of October 8 to October 12, the Goddard Space Flight Center is making the Spacemobile available to the local schools on the following schedule: Monday and Tuesday at High Point High School; Wednesday at the Junior High School; Thursday at the Center School; and Friday at the North End School. St. Hugh's school children will be divided between the Center School and the North End School on Thursday and Friday.

The band concert on Sunday features the 75th Army Band from Ft. Belvoir, Virginia, under the direction of Warrant Officer Bell. This band has an international reputation. The ceremonies start at 1:30 p.m. with the introduction of distinguished guests. The concert itself starts at 2 p.m.

Following up the space age displays this week, the Goddard Space Flight Center will hold an open house for Greenbelters on Sunday, October 14, from 11 a.m. to 5 p.m. Invitations have been distributed to all Greenbelt homes, together with maps of the Center's grounds and buildings. Tours of the Center's facilities will be conducted during these hours.

Fire Prevention Week

By presidential proclamation, National Fire Prevention Week will be observed starting Sunday, October 7. In conjunction with this, the Greenbelt Volunteer Fire Department and Rescue Squad's Fire Prevention Committee has arranged to hold a special "Night-Shirt Parade" on Saturday, October 6, starting at 7:30 p.m. Marchers for the parade will assemble on the west parking lot at the Center and the parade will start there and end at the firehouse. Open house will be held at the firehouse and it is expected that much of the equipment will be tagged as to the cost of the items. A demonstration on fire prevention will be followed by refreshments for all. The public is invited to attend and participate in the parade, which will also feature clowns.

Plans For November 14 Referendum, Registration Days, Set by Council

Preliminary preparations for the November 14 referendum on capital improvements were made by the city council at last Monday's meeting. The council agreed to hold the balloting at the Center School auditorium, if available, and to hold special registration days for new voters the week of October 8 to 13. It voted \$350 for election day expenditures and \$300 for an informational campaign in the *News Review* explaining the city's need for a capital improvement program financed through long-term loans.

The ballot will consist of one simple question: Should the City of Greenbelt be empowered to issue certificates of indebtedness in the amount of \$40,000 for capital improvements? The individual capital improvement items that will be undertaken will not be on the ballot, but the publicity preceding the referendum will discuss the various projects that have been proposed.

Special registration days for new voters will be held at the city offices the week of October 8, every evening from 7 to 9 p.m., and on Saturday, from 1 to 3 p.m. Any person who has voted in either the 1959 or 1961 city council elections is already registered and eligible to vote in the referendum. Those persons who have missed the last two city elections must meet the following requirements. They must be a citizen of U. S., at least 21 years of age, and a resident of Maryland for a year and a resident of Greenbelt for six months immediately preceding the election.

Boxwood Subdivision

The council received a report from the Advisory Planning Board regarding plans for the development of Boxwood Village, to be located in the area opposite Greenbelt Lake between Crescent and Ridge roads. The report noted that the northerly exits from this subdivision empty into

an inaccessible area — the unimproved Ridge rd. In order to provide an adequate right-of-way, it appears that some dedication by the developer as well as adjoining property owners, including the Federal Government, may be required. There is also a problem of financing the costs of paving Ridge rd. The Board also noted that no provisions have been made for suitable recreation areas or sidewalks along Ridge rd.

Charles Bresler, developer of Boxwood, is planning to construct free-standing homes in the area under R-55 zoning, which has a minimum lot size of 6500 square feet. For part of this tract, this would require a change from the present zoning of rural residential, which provides a limit of 1/4 acre to a lot. The Advisory Board recommended that approval of the preliminary plan be withheld until the above deficiencies are corrected.

The council asked the city manager to initiate contacts with the interested parties to secure a dedicated right-of-way along Ridge rd.

In another report, the Advisory Planning Board informed council that it was considering the proposal for widening Centerway in conjunction with plans for overall parking and traffic circulation arising over the pending connection of the east and west parking lots.

Recreation

A motion made by councilman Ben Goldfaden tabled for the second time, the hiring of a much-needed cashier for the Youth Center. While there was general recognition of the need for a cashier, action was deferred until council receives clarification of the recreation program including the schedule of working hours for all recreation personnel.

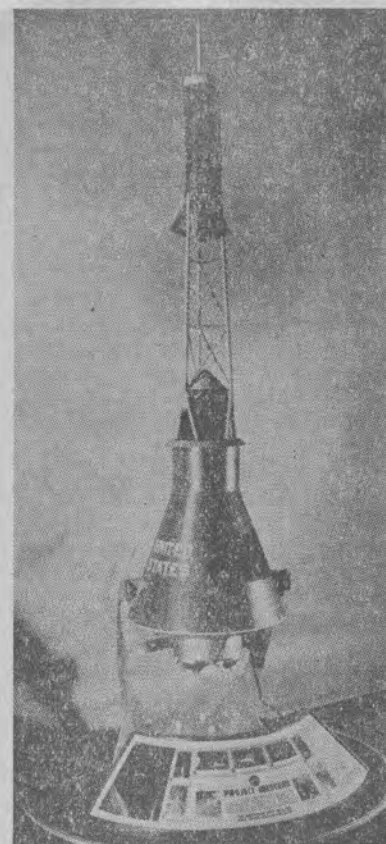

Police News Review

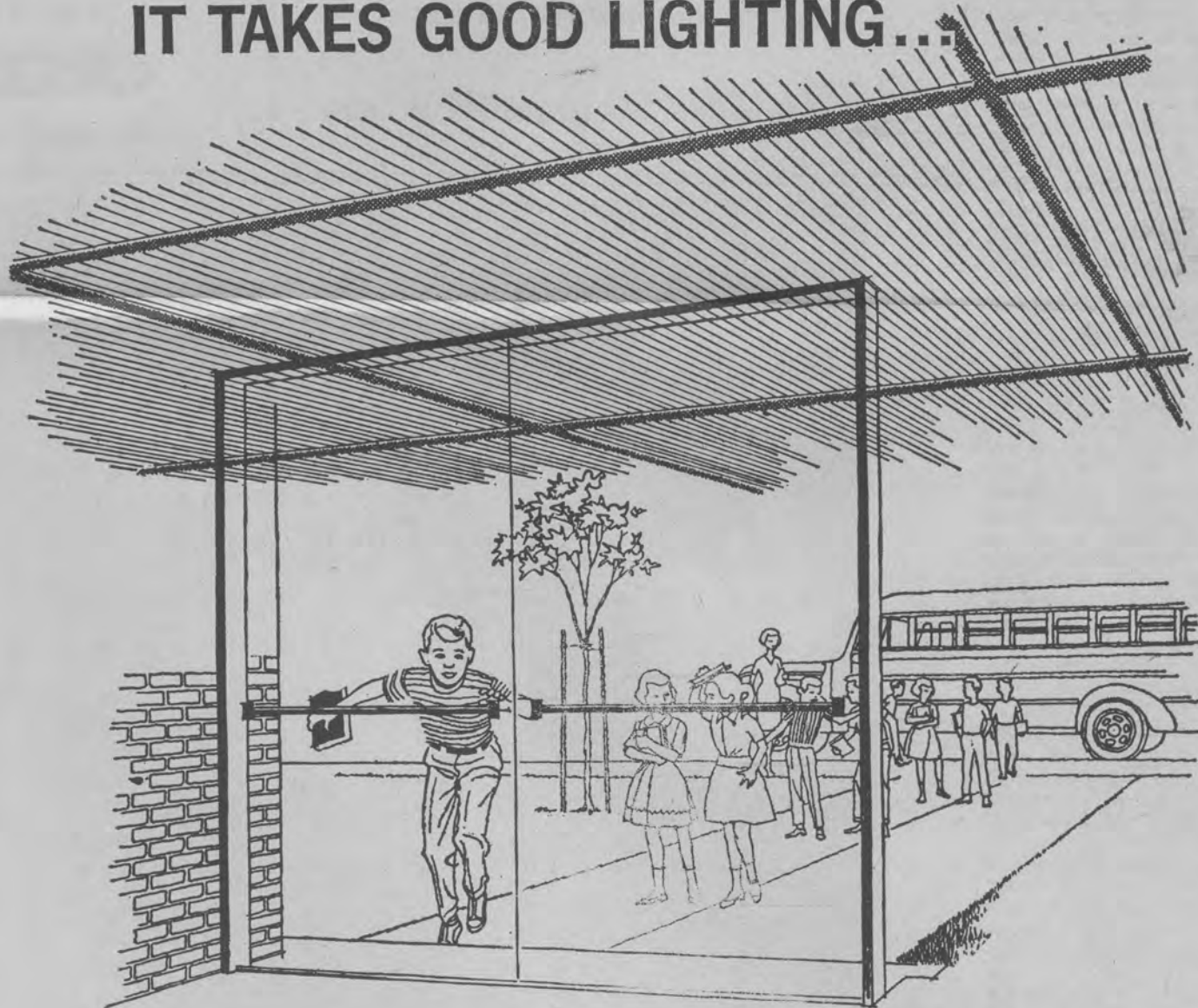

had been about \$2000. Burgoon, supported later in a speech by member Matt Amberg, argued that the office had not been given a fair trial and that its use should be continued at least through the best selling season, next summer. But a motion by Burgoon that the present lease be renewed for 10 additional months was defeated by a four to two vote. Voting against renewal for the longer period were Comproni, Morrison, Helm, and Cherry. Further discussion of the question was reserved for the executive session, which followed the open meeting.

Locked In?

A note of wry humor entered the debate at one point when Helm, speculating on what the board might do if Twin Pines should deny the requested 15-day extension said that he, for one, would be willing to meet over the weekend (in advance of the September 30 deadline, marking the end of the present lease). "Oh, but that wouldn't leave time for proper notification of board members," he noted, to the amusement of both board members and visitors. President Zubkoff suggested, however, that board members could by unanimous action waive the time-limit requirement for notification of meetings—even retroactively, which would be necessary in the case of Peters, who would be out of town through the weekend. This development later brought forth some acid comments from Amberg, who sarcastically stressed the gratitude of the membership to a few board members who had by their previous legalistic niceties locked the board into a position of being unable to meet at short notice, even when "delicate negotiations" were necessary. This was an obvious reference to the so-called "walk-out" of three of the four minority-bloc members from a special board meeting called in the early summer, on the grounds that inadequate notice of the meeting had been given.

Non-members on Committees

A letter written in response to a request from the board, by Beverly Fonda, Chairman of the Nominations and Elections Committee, was read into the record of the meeting. This letter stated the unanimous opinion of his committee that only GHI members should be permitted to hold committee offices in the corporation. The letter pointed to possible dangers to the corporation if non-members should hold such office, particularly to the Audit Committee, which cannot even hold meetings unless its three members unanimously agree to meet. (Both Henry Lyons of the Audit Committee and Ed Wuerms of the Nominations and Elections Committee have refused to resign, even though both have sold their GHI homes and Lyons has left the community.)

On the other side of the question, Helm argued in favor of Lyons' continuance on the Audit Committee. Helm claimed that Lyons is still interested in the corporation's affairs. As evidence Helm pointed to Lyons' protest to the corporation that minutes of board meetings (which were sent to all members of the Audit Committee) were being mailed to his former address. (Lyons, who now resides in Seabrook, sold his GHI house early in July, less than two months after the GHI annual membership meeting, at which he was elected

to the Audit Committee. Lyons had campaigned with the support of Helm, Comproni, Morrison, and Cherry.) No action was taken since the question has been referred to

the By-Laws Committee.
