SPELLMAN CLARIFIES POSITION ON COUNTY-MUNICIPAL RELATIONSHIP

Clarifying earlier reports of her position on the relative powers of municipalities and counties, Gladys Spellman, chairman of the Prince George's County Commissioners stated on Tuesday that "each layer of government should do that which it is best able to perform."

She told a packed county-wide audience of mayors and councilmen at the Greenbelt Municipal Center that "municipalities do provide services other and beyond that provided by the counties." Referring to Greenbelt's splendid recreation program, she said, "If the town of Greenbelt wants to have more in the way of recreation than provided by the county, then they should - if people want to pay for it." But her chief emphasis was that the county is the basic form of government and could best achieve economy of operation and eliminate duplication of services. In addition, it could set up uniform standards for performance.

The invited guest at a special meeting of the Prince George's County Municipal Association, chaired by Greenbelt's Mayor Edgar L. Smith, Mrs. Spellman challenged those officials who had accused her of making a blanket denunciation of all police departments and of wanting to abolish their cities and towns to apologize. She said, "I don't mind a battle, but don't question my integrity. . . Mrs. Spellman maintained that her remarks at the seminar of the Constitutional Convention delegates at Goucher College had been misquoted. Playing excerpts from several tapes of her earlier testimony, she asserted that her statement at the seminar criticized "some" municipalities for untrained police. She said she was well aware that many municipal police forces - such as Hyattsville's and Greenbelt's - "are of high caliber." As for municipalities themselves, she said that they have a "role in our scheme of things, but their power should be spelled out and limited."

Still dissatisfied, municipal officials asked Mrs. Spellman to be more specific on her stand concerning the constitutional role of municipalities. They expressed concern that if certain recommendations of the Eney commission should be adopted by the convention delegates, municipal units would be subordinated to the county governments and could be abolished. At present, cities are responsible directly to the state legislature. Municipal government supporters also contended that the integrity of the municipality must be preserved, that citizens are more responsive to a city and town "grass roots" government and that municipalities could provide services which the county could not afford.

Mrs. Spellman insisted that she did not want to do away with municipalities. It is important she said that we sit down together and understand the problems that the county is facing. Others suggested that a better communication system was needed. Mayor Smith thought that a formal liaison would prevent misunderstandings

and breakdowns in the relationship between county and municipalities in the future.

Present at the meeting were Greenbelt councilmen, Richard Pilski, Francis White, Gerald Gough, and city manager James Giese. Mrs. Doris Cottingham sec'y to the city manager, and Mary Barcus, recreation department employee, served as hostesses at the reception following the meeting.

City Notes

The job of partitioning off the air conditioner at the rear of the city council chamber was rushed for Tuesday night's meeting of the Prince Georges County Municipal Association which was held in that room. The partition itself—made of oak paneling—was complete by the time of the meeting. Still to be done was some duct work and the installation of an exhaust fan.

The main work of the Public Works Dept. was concerned with parks and recreational programs. They installed 15 charcoal grills and two fixed picnic tables with shelter roofs at the Lake Park. For the playground near 73 Ct. of Ridge, where the North End summer play program is being held, the city crew installed a climbing bar.

Last summer's smoothseal repaving program may now be considered complete, with the paving last week of Centerway. The grade on that street had not been laid according to specifications, which called for the grade to slope away from the curb near the stores so that puddles would not collect under parked vehicles. The contractor, Contee Sand and Gravel Co. of Laurel, had been unable to correct the grade earlier because of bad weather and other commitments.

Greenbelt Swim Team Outscores Rock Creek

It was a day for records last Saturday at the local pool. No less than eight new team records were set by the Greenbelters, contributing heavily to the 258 to 199 victory over the visitors. The record breakers were Kixie Aulisio in the senior butterfly, freestyle and medley; George Aulisio in the senior breast stroke; Dan Cassels in the 12-and-under breast stroke; and Addie McCollon in the 8-and-under freestyle. A flashy relay team composed of Glen Adair, Ron Merlene, George Jones, Steve White and Kixie Aulisio also set a new team record.

However, with all the fine work of the Greenbelters, too much cannot be said for Rock Creek's outstanding senior swimmer Chuck Holum, who smashed three pool records, including the butterfly, freestyle and individual medley and took home three blue ribbons for his great day.

The B-team lost to Carrollton last Wednesday, July 12, at Carrollton by a score of 175 to 142. Greenbelt took twelve of the 29 first place awards, with Gail Neumann and Angel Flood accounting for three each. No schedule has been announced for the next B-Team meet.

GHI BOARD HEARS COURT PARKING PROBLEMS, DETAILS ON NEW HOMES

A plea from a member for a solution to the parking problem was one of the first items for discussion at Thursday night's meeting of GHI board of directors.

The member gave the following account of a recent incident; She arrived home one evening with her husband and two very sleepy children. They lived in a court where there was assigned parking. Finding an unfamiliar car parked in their parking space, they blew their horn, hoping the owner of the vehicle would hear it. This failing to bring any response, they commenced knocking on many doors in the court, but to no avail. No one claimed ownership of the car.

Finally, they parked their car directly behind the vehicle, leaving a note asking the owner of the car to please let them know when he was leaving. At about 1:30 a.m., instead of hearing someone knock at their door, they were awakened by the insistent blowing of a horn. It was the owner of the car and a friend. They were two young men who did not reside in that court. The incident ended with harsh words spoken between all parties involved.

At the completion of her story, the GHI member asked the Board if something could be done to correct this situation. Several suggestions were offered, including more strongly worded signs, and the possibility of negotiating with a towing company to tow away the trespassers.

Free-standing Homes

Nat Shinderman, chairman of the Ad Hoc committee on Larger Homes, stated that the first of the free-standing homes should be available for occupancy by August 1, with the remaining three homes becoming available within short periods of time after that date. Shinderman also recommended that the board approve the establishment of property lines between the two homes on Northway and an easement (common area) between the two homes and the already existing homes on Northway. The board approved the recommendation.

Speaking on the development of plans for the 20 to 25 Townhouses to be built in Greenbelt, Shinderman stated that one preliminary sketch had been drawn up by the architect which did not fulfill the expectation of management for the homes. However, another sketch was drawn which met with some approval. The committee has decided to explore the area to find homes with features which could be included in the design of the 25 homes and then consult further with the designer. There will also be serious consultations and coordination with the architect regarding the designing of the townhouses.

The committee is also planning to meet with qualified experts to explore a complete review of available financial progress in existing co-ops and then report to the Board. Shinderman stated that

much had been learned in the activities leading to the construction of the four homes which could be used in the construction of the townhouses. The "transfer of experience" would be considerable, he said.

Storm Drains

Director Jim Smith, reporting on the latest meeting between GHI and city council, stated that they discussed the possibility that the city would give back the lateral storm drains to GHI. In fact, GHI has already been maintaining these drains, but if GHI assumes full responsibility for them, homeowners would be able to build over them. Lateral lines are defined as storm drains on GHI land. Smith recommended that GHI request that the city approve of the official transfer of the responsibility for the lateral drains to GHI and the board approved the recommendation. (Unlike other homes in the county, the original GHI homes are unique in that the original deed stipulated that the city was responsible for all drains.)

Smith reported that research is also being conducted to determine the exact responsibility for the many walkways throughout the city.

Charles Schwan, President of the Board, offered two proposals regarding committee changes. The first was that the Land and Landscape Committee be made into two separate units. The Landscape Committee has been a subcommittee of the Land Committee.

The second proposal was that the Member Relations Committee, which consisted of two elements, program and hospitality, be split into separate elements with specific assignments for each.

Under the Manager's report to the Board, Roy Breashears asked the Board to consider the subject of the lighting of walkways, especially in the areas where steps were involved. This matter will be taken under advisement. Regarding home-improvement loans, it was felt that a review was necessary. Breashears also informed the Board that Dr. Eisner had agreed to vacate his present offices on the corner of Ridge and Gardenway by January 30.

The Board also approved Breashears' appointment of Dave Kane as Assistant Manager for GHI. Kane has been Superintendent of Maintenance for many years.

AAA SAFETY AWARD

The City of Greenbelt received a special citation on June 28 for Casualty Record by the AAA and the Automobile Club of America, noting that there has not been a pedestrian fatality in Greenbelt for more than twenty years. Only Bowie has a better pedestrian safety record in Maryland, with a 28-year record.

Registration Confusion

With the city council election just around the corner (September 19), it would be well to remind Greenbelters that the city elections are quite distinct from the Greenbelt Homes, Inc. elections, as well as from the county, state, and national contests.

A person must qualify separately to vote in each of these elections. Eligibility for the GHI elections for the county, state, and national elections does not qualify a person to vote in the city elections.

To vote in the city election, you must be a registered voter. Registration is automatic if you have voted in at least one of the two previous city elections. But be sure it was a city election. Many a prospective voter has showed up at the polls, convinced that he had voted "in Greenbelt" before, only to find out that it was a GHI election or a state or national election.

A citizen can register any day in the week by dropping in at the city offices during business hours (Monday through Friday, 8:30 a.m. to 4:30 p.m.) and asking to see the City Clerk. Registration closes August 21.

Qualifications? A citizen of the United States, at least 21 years of age, and a resident of Greenbelt for six months at the time of the election.

6-Day Parcel Deliveries

Postmaster Emory A. Harman today announced that parcel post deliveries in Greenbelt will be expanded from five to six days a week, beginning July 15, 1967.

The boundaries of the expanded service include: Springhill Lake, Beltway Plaza, Lakeside North, and Boxwood Village, as well as the Goddard Space Village and Brae Brooke apartments off Glenn Dale road.

This is in line with a recent directive from Postmaster General Lawrence F. O'Brien, following the signing of the Post Office Department appropriation bill by President Johnson. The legislation contains an \$8.5 million item for restoration of the six-day a week delivery, which was cut back in May 1964 as an economy measure.

The Greenbelt postal official noted that the improved service will remove an inequity for many business and residential routes.

Postal customers served by "motorized" letter carriers have been receiving six-day deliveries all along. They were not covered by the 1964 cutback, inasmuch as carriers on vehicles can deliver parcels of any size. Customers living on routes serviced by foot carriers have received larger parcels from a parcel post route covered by a truck operating 5 days each week. Carriers on foot deliver small packages only.

Con-Con Delegates to Hold Public Hearing

Local government will be the subject of the first in a series of public hearings by Prince Georges County Delegates to the Maryland Constitutional Convention.

The meeting, called by Carlton R. Sickles, Chairman of the County Constitutional Convention Delegation, will be held on Tuesday, July 25th, at 8:00 P.M., in the Commissioners Hearing Room, County Service Building in Hyattsville.

Sickles urged County citizens to join with municipal and other officials in discussing such topics as municipal responsibilities in a County government and regional relationships at this meeting, and in others to follow.

City Sues to Acquire End of Crescent Rd.

In a brief meeting on Monday, July 17, the city council authorized the city solicitor to institute proceedings for the abandonment of Crescent road near Greenbelt Lake and the new municipal warehouse site. The city desires the property as part of the warehouse complex to house the Public Works Department equipment. The street is no longer required as a public right-of-way.

July Fire Prevention Tip

Read the Label Carefully - Deadly Bombs in Spray Can

Any aerosol container regardless of what product it dispenses is as dangerous as a live hand grenade.

A few items from a newspaper are as follows:

Toledo, Ohio: Empty de-icer left on ledge of car's rear window. Several days later on the way home from shopping, the can exploded from the heat of the sun; the mother was killed from piece of metal from the can going into the jugular vein; her three children were hospitalized for several months due to pieces of flying glass and metal causing multiple lacerations.

Oakland, California: a man tossed an empty aerosol bug-spray can into a trash fire. Can exploded causing permanent blindness in both eyes.

Philadelphia, Pennsylvania: A fifteen year old boy put a spraying can in hot water to "perk up" the propellant. Explosion followed causing him to lose half of lower jaw.

There are many other incidents such as these, but they are too numerous to print.

The fire hazards of pressurized paints, lacquers, as well as some liquid gas propellants, are a matter of deep concern to fire departments throughout the nation.

Fire prevention authorities know one thing for certain, "The Boom in aerosols is accompanied by a Boom in explosions, fires, and poisonings."

The entire aerosol container industry must come up with a strong Safety Campaign of education in the use of their high-pressure containers. Until this is done, use these precautions when using any type of aerosol:

DON'T SPRAY INDOORS UNLESS YOU'RE POSITIVE OF GOOD VENTILATION.

DON'T SMOKE WHILE SPRAYING.

DON'T USE NEAR HEATING UNITS OR WHERE ANY TYPE OF HEAT, ESPECIALLY THE SUN, CAN GET AT IT.

KEEP THE BODY WELL COVERED AND WASH ALL EXPOSED AREAS AFTER SPRAYING. THIS IS ESPECIALLY IMPORTANT WITH INSECTICIDE SPRAYS.

STOP USING AT THE FIRST SIGN OF DIZZINESS, NAUSEA, HEADACHE, BLURRED VISION OR SKIN IRRITATION.

DON'T PUT EMPTY AEROSOL CANS IN THE INCINERATOR OR IN GARBAGE FIRES.

BUT THE MOST IMPORTANT THING TO KNOW IS THAT - "EVERY SPRAY BOMB IS EXACTLY THAT - A DEADLY BOMB."

On any emergency, call fire or ambulance, DO NOT call direct to the fire department. This will only delay the response. Place your call to the Hyattsville Fire Control Board, 864-1122 and they will immediately push the siren switch sounding the alarm that will send you the help needed in a matter of minutes.

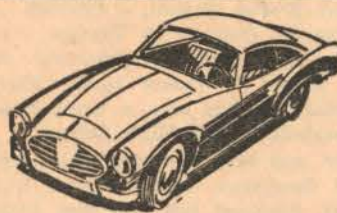
Expo '67 Tour

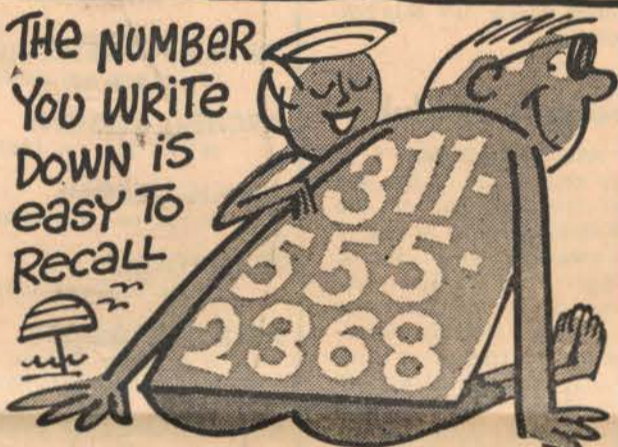

NOTICE OF CHARTER AMENDMENT

Amendments to the Charter of the City of Greenbelt, Maryland were adopted on June 27, 1967 by the City Council of Greenbelt. The title of each Resolution, which is a fair summary of each amendment is as follows:

Resolution No. 123

Resolution of the City of Greenbelt adopted Pursuant to the Authority of Article 11E of the Constitution of Maryland and Section 13 of Article 23A of the Annotated Code of Maryland (1957 Edition as amended), Title "Corporation-Municipal", Sub-Title, "Home Rule", to amend the Charter of the City of Greenbelt, said Charter Being Section 40 of Article 17 of the Code of Public Local Laws of Maryland (1963 Edition) and Containing in Whole or in Part the Charter of the City of Greenbelt, by Repealing and Reenacting with Amendments Section 40-25, Title "Election of Council" to Provide that the Five Council Offices be Filled by the Five Candidates Receiving Votes Amounting to Forty Per Cent or More of the Number of Electors Voting at the Election, and to Provide for a Second Election in the Event One or More Council Offices Remain Unfilled Because of a Failure of Five Candidates to Receive Votes Amounting to Forty Per Cent or More of the Number of Electors Voting in the First Election or Because of an Equal Number of Votes Being Received by Two or More Candidates, and to Provide that There Shall Be Printed on the Ballot for the Second Election Twice as Many Names of Candidates as There are Positions to be Filled from the Unelected Candidates Polling the Greatest Number of Votes in the First Election or in the Event of an Equal Number of Votes for an Unfilled Office the Names of Those Candidates Receiving an Equal Number of Votes in the First Election.

Resolution No. 124

Resolution of the City of Greenbelt Adopted Pursuant to the Authority of Article 11E of the Constitution of Maryland and Section 13 of Article 23A of the Annotated Code of Maryland (1957 Edition as amended) Title "Corporation-Municipal", Sub-Title, "Home Rule", to amend the Charter of the City of Greenbelt, said Charter being Section 40 of Article 17 of the Code of Public Local Laws of Maryland (1963 Edition) and Containing in Whole or in Part the Charter of the City of Greenbelt, by Repealing and Reenacting with Amendments Section 40-4, title "Creation; Qualifications; Compensation", as amended by Resolution No. 38 approved August 19, 1963, to Provide Increasing Salaries of the Mayor and Council, \$1,800 for the Mayor and \$1,500 for each of the other Councilmen.
