## GHI LOTTERY WILL RANK BUYERS OF REMODELED MEDICAL CENTER

Discussion concerning the remodeled medical center homes took up most of last Thursday's GHI board meeting, following the lottery drawing from the names of 24 members and 14 non-members who had expressed interest in the units. The order of eligibility was established by the drawing, with members given precedence over all non-members. These people (as well as others) will be able to view the homes from May 1-8, with a deposit due on the 8th if they are seriously interested in purchasing.

The board unanimously accepted the joint finance and Ad Hoc Larger Homes Committees' report recommending that the sales formula for the medical center homes be at fair market value "with the minimum down-payment to be at least the out-of-pocket costs of the corporation, and the remainder of the selling price to be financed by the corporation with a mortgage of not more than 30 years with interest to be determined at the time of sale."

Since management had been directed to come up with a method of pricing the four homes, Roy Breashears presented the following formula.

He added the original book prices of the homes as they were in 1953 when purchased by GHI (\$7000 for the ends and \$6000 for the middle ones) plus approximately \$6000 for renovation, (this figure being subject to adjustment since final totals were not yet available) plus a \$2000 appreciation figure, to arrive at the rough estimate on the homes: \$15,000 for the end homes and \$14,000 for the middle ones. It was noted that the \$6000 renovation figure is over and above the regular maintenance costs (e.g., roof repairs) which GHI would have regularly performed on the homes.

### Discussion

Director John O'Reilly opposed the formula, stating that "the fair market value is what people are willing to pay for a similar house. You never have a fair market value unless you allow people to bid on them."

Nat Shinderman agreed in theory with O'Reilly but stated that owners usually do set a figure on their houses unless there is a public auction. This formula "represents the best judgement of the manager," he stated. "It is not infallible, but it is fair."

The manager's formula passed.

## Two Sites Considered for Senior Citizens Housing

Two representatives from the Philadelphia office of the federal Housing and Urban Development Agency—Richard Krakow, head of the Senior Citizens Housing program for a 5-state area, and Jay Halperin, staff economist — met last week with a local committee consisting of Dave Kane, GHI; Charles T. McDonald and James Cassels, Senior Citizens Assn.; and City Manager James K. Giese for the purpose of surveying two possible Greenbelt sites for a housing cooperative for senior citizens. In addition, a county representative from the Community Development Department, James Chmelik, joined with the group. The two sites under consideration are the 3.17-acre tract of the Lutheran Church on Ridge and a 3-acre section of a tract owned by the Greenbelt Development Corporation (GDC) at the intersection of Parkway and Crescent, where the present GDC garages are located.

In a few weeks the HUD representatives are expected to send in an evaluation of the feasibility of building on either of the two sites.

6-2, with Cliff Simonson also opposing it on the basis that he didn't think there should be a firm figure for appreciation yet.

In other action the board unanimously passed the larger homes committee report on accepting the tentative offer of a loan at 7% interest from Suburban Trust for construction of the townhouses, with the "most favorable arrangements to be worked out in terms of prepayment privileges and other items that would benefit the corporation."

The board also approved for consideration by the general membership, at the May annual meeting, a number of minor changes in the by-laws.

## Candidates' Deadline Is May 4, For GHI Elections

Saturday, May 4, is the deadline for candidates for the Greenbelt Homes, Inc. elections to file with the nominations and elections committee. Thereafter, any GHI member wishing to get his name on the ballot must submit a petition signed by at least 10 GHI members to the GHI office by 5 p.m. Wednesday, May 8.

At stake in the elections which will be held in conjunction with the annual membership meeting on Wednesday and Thursday, May 15 and 16, are four openings on the 9-man board of directors and all seats on the 3-man audit committee. The terms of directors are two-years and of audit committee members one-year.

All nominees (including incumbents) are required to signify their willingness to serve in writing. Candidate's Consent Forms can be obtained from the elections committee or the GHI office. Biographies must be submitted by Tuesday, if they are to be printed in next week's issue of the News Review.

So far six candidates have announced for the board of directors and one for the audit committee. The board candidates are Nat Shinderman, Steve Polaschik, Katherine Keene, James C. Smith (4-H Southway), Douglas T. Hawes, and Norman B. Charles. The first three are present members of the board. The audit committee candidate is incumbent Thomas White.

Members of the nominations committee are George Adams, Elizabeth Allen, Darwin Beck, and Bertram Donn.

Official proxy forms are available from the GHI office for any member who wishes to vote but will be unable to get to the ballot box. Such forms can be obtained only upon written request made directly to the GHI office. No member may vote more than one proxy. The official proxy forms must be turned in to the GHI secretary by midnight, Thursday, May 9.

## CITY SEEKS INJUNCTION TO HALT CONSTRUCTION AT CHARLESTOWNE

At a hastily-convened meeting on Tuesday night, the city council reacted promptly to news that building permits were issued on April 18 for construction of 21 additional units on the Charlestowne Village townhouse tract. It unanimously authorized its attorney to seek injunctive relief to enforce the covenants, which, the city contends, will be breached by the proposed two apartment buildings of 12 and 9 units.

The site of the new apartments is the 11-acre Parcel A which already has 144 townhouses. According to city manager James Giese, the proposed location is approximately at the intersection of Lakeside Drive and Lakecrest Drive on a piece of land now having trees and picnic tables. The owners of the property according to the building permits are Charles and Fleur Bresler.

With the new construction, the total density of Parcel A would be more than 13 units per acre. The land is zoned R-18, which permits a density of up to 21 apartment units per acre. However, there is a covenant on the land limiting the density to 7 units per acre. The Maryland Court of Appeals in a ruling last December declared that the Charlestowne Village covenant was legal and valid, but refused to enforce the covenant against the construction of an 8-story high-rise apartment, which the city contended violated the covenants. The court said that Greenbelt waited 65 days before filing a formal protest against the high-rise project, when it was required to object within 30 days under the terms of the covenant.

The city learned of the April 18 permit when the builders (Charles Burton) requested permission to locate a construction trailer on the street right of way.

### History of Tract

The Charlestowne Village tract had a long and controversial history. In April 1962, the owners of the tract (the Breslers), which then consisted of 50 acres, signed a sealed declaration of covenants agreeing to limit the number of dwelling units to 7 units per acre, in exchange for which the city agreed to recommend apartment zoning (R-18) to the county commissioners. The covenant also pro-

vided that construction would be in conformity with the R-30 zoning category, which prohibits high-rise apartments.

In June, 1965, 25 of the 50 acres were sold at foreclosure. Subsequently, the 25 acres were purchased by Theodore Lerner and associates, who proceeded to construct the 494-unit University Square Apartments at almost the full density permitted by the R-18 zoning. The city contested this action, but the courts ruled, with respect to these 25 acres, that the foreclosure had effectively destroyed the covenants.

On the other 25 acres, Bresler and associates first constructed 144 townhouses, following with the high-rise project of 178 units, bringing the total number of dwelling units to 322. It is on this land that the additional 21 units would be built.

The covenant, if abided by, would have limited the density for these 25 acres to 175 units. The city sought to enforce the covenant through the lower courts to the Court of Appeals, only to lose on a technicality — failure to file a timely suit.

The city attorney, Emmett Nanna, has indicated his intent to file suit within the 30 days required by the covenant.

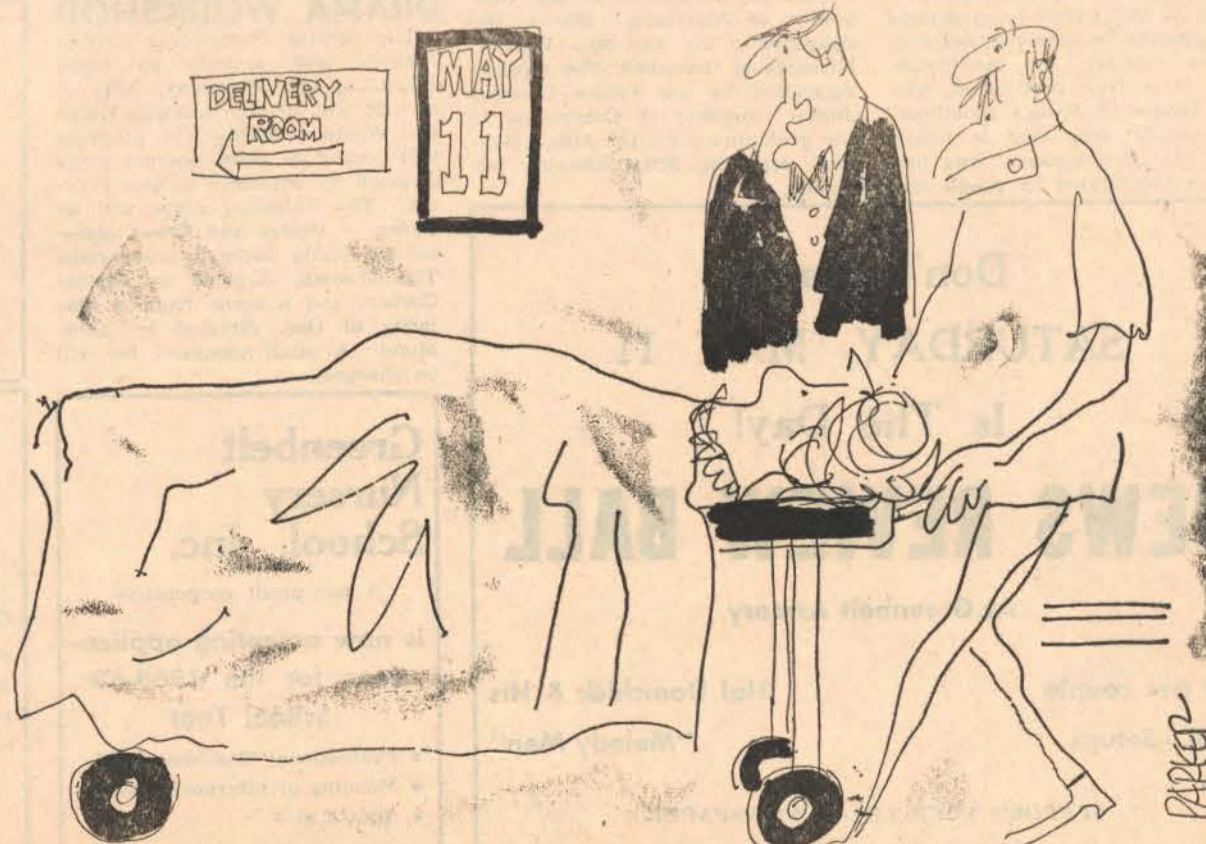
## Driver Education Registration May 11

### Questions Cause of Violence

Although I normally do not write "Letters to the Editor," I feel compelled to comment on the letter in a recent News Review titled "Disgrace to Mourn Dr. King" even though I believe it voices a minority view.

It is not necessary to be in sympathy with Martin Luther King's goals or methods to recognize and acknowledge his sincerity and dedication to the cause he promoted or the status he achieved, not only in this country, but worldwide. While it is true that often "violence shadowed King's footsteps," it is equally true that in nearly every case this violence was provoked or instigated by people who

could not accept his ideals of full citizenship for members of his race.

To condemn Dr. King because of this violence is to propose that no man, white or black, may endeavor to correct wrongs and injustices he sees existing as long as there are others in disagreement with him and who might express their disagreement in violence. If we accept this proposition, we might also consider our commemoration of Jefferson, Washington, Henry, Hancock, et al., a "national disgrace" because these men also espoused ideals and methods that resulted in the violence and civil disobedience we refer to as the Revolutionary War. By what criteria can the freedom and equality that Martin Luther King sought for the Negro citizens of this country be considered less noble or right than the freedom and equality sought by our Founding Fathers for the people they represented?

## THE PROPOSED MD. CONSTITUTION

The new constitution proposed for Maryland, worked out by the Constitutional Convention elected last year, will be presented to the voters in a special election scheduled for Tuesday, May 14. The new constitution - intended to replace the 100-year present one, with its over 200 amendments - has already been hailed by supporters as a model for future state constitutions all over the country.

Voter interest in Maryland, however, has been relatively light, and authors of the constitution are wondering whether this will lead to a light turnout at the election itself, giving the few opponents of the document a relative advantage.

Free copies of the constitution have been distributed in Greenbelt and may be obtained from public libraries and from the Twin Pines office. Here is a brief summary, published by the University of Maryland, of items of special interest contained in it. This, then, is what the new constitution does:

1. Unifies the judicial system of courts and judges at four levels. All judges are required to serve full time. A non-partisan system of nomination, appointment and election is provided.

2. Reduces the length of residence requirements for voting.

3. Lowers the voting age from 21 to 19.

4. Requires home rule for every county by 1971. With a few exceptions, the state General Assembly would no longer debate and pass purely local laws. Four counties and Baltimore City presently have home rule. Each county will determine its own form of government.

5. Gives to the counties all powers of local government not expressly reserved to the state. Taxing power and judicial powers are notable exceptions that would be retained by the state.

6. Provides a uniform statewide system of property assessment for purposes of taxation. Specifies that agricultural property, as defined by the General Assembly, is a special

## Baltimore Symphony Performs Excellently

A limited audience had the pleasure of hearing - and seeing - a rewarding performance by the Baltimore Symphony Orchestra and pianist Eugene List, Monday evening at the P. G. Community College Hall in Largo. The acoustics of this new modern hall are excellent, according to the comments of several listeners, and its size is such that each instrument of the orchestra is in full view of the audience; there is nothing like seeing the music created at its source.

Weber's Overture to Der Freischutz provided a melodic warm-up for the orchestra. There followed a sparkling collaboration between pianist List and conductor Elyakum Shapira, through the medium of the orchestra, in Tchaikovsky's Concerto No. 1 in B flat minor. List set the pace, with full dynamics, yet the accompaniment was always equal to the occasion. This was the highlight of the evening; what could easily be a hackneyed selection emerged as a fully satisfying experience.

The majestic Beethoven Symphony in A Major, though in general ably carried out, did not quite unfold as it should have, perhaps. The momentum developed before intermission did not seem to carry over. Individual performances were outstanding, however - the violas and wind instruments especially stood out. At evening's end the appreciative audience was rewarded with a brilliant encore of Bernstein's Candide; this reviewer was impressed by the way the orchestra responded to Shapira's rapid demands in what is a very tricky piece.

..... **City Notes** .....

In anticipation of a new state anti-pollution law, which prohibits open airburning after May 28, and because of the present fire emergency in the surrounding area, the city has discontinued its former practice of burning off special trash at the landfill site. (Garbage was never burned, and as a precaution against its being burned by vandals at night, the last load of garbage is not unloaded until morning.)

The large bulk of many special trash collections, much of it cuttings from trees and shrubs, makes its own problem, however, in the more rapid consumption of available space at the fill site. As a partial solution, the city has recently been depositing such woody debris below the dam at the lake park, an area which they plan to raise to a higher level eventually for use as a ball field. Each load of trash is immediately covered with a load of dirt, excavated from the hill at the rear of the fire house, where an extended parking lot will be built.

Two refuse trucks were out of commission last week. The diesel vehicle was sent to Baltimore for repairs. The older, gasoline-powered truck, which needed a new transmission, was quickly repaired by the city's mechanic, using the transmission from a discarded, but not yet disposed of, even more ancient truck.

Over the weekend one city employee and a truck were assigned to assist engineers from the state

Soil Conservation Service in their preparations for taking a sedimentation survey later in May at the Greenbelt Lake. Their work last weekend was to establish benchmarks.

The swimming pool will be filled with water on May 13. All staff for the 1968 summer operations of the pool have now been hired by the Recreation Dept. Two large canvas gazebos (oversize umbrellas) have been delivered and will be set up for use at the pool.

A total of 383 children participated in the Easter egg hunt this year.

**Fallout Shelters Designated**

The Prince Georges County Civil Defense Agency, working in conjunction with the Department of Defense, has established the following Public Fallout Shelters in Greenbelt: Greenbelt Parkway Apartments, 2-6 Parkway; Greenbelt Jane Apartments, 8-14 Parkway; Greenbelt Center Elementary School; High's Store; Greenbelt Theatre.

Civil Defense Public Fallout Shelters can be identified by black and yellow "Fallout Shelter" signs posted on buildings. Sites selected meet Defense Department standards inasmuch as the buildings' structural design provides natural "barrier shielding" against the hazard of gamma radiation.

**The Police Blotter**

PFC Krob has finished his training course at the Police Academy.

The Greenbelt Police Dept. has obtained another training aid which involves the use of colored slides to depict various situations an officer might encounter. When the image is flashed on the screen the trainee has three seconds to decide whether to use arms. Special plastic reusable bullets are used and this has been made a regular part of in-service training.

Two run-away boys, ages 15 and 16, have been reported missing.

A strong-arm robbery was reported outside the Blue and White Restaurant in Beltway Plaza on April 11. Three youths, aged approximately 16 or 17, attacked a man delivering eggs to the restaurant and removed currency from his pocket. He struck one of them with a pipe as they ran off. A look-out has been posted.

**HOW TO DEAL WITH OFFENSIVE MAIL**

Mail patrons offended by pandering advertisements can now take steps to curb such mail, Postmaster Emory A. Harmon said today in announcing plans for administering a new law which gives each family the right to decide that an ad is "erotically arousing or sexually provocative."

When an advertisement sent through the mails is offensive on these grounds, a postal patron can now ask the post office to direct the mailer to send no more mail to him and to remove immediately the patron's name from all mailing lists he owns, controls or rents.

To assist patrons, the Post Office Department has published a brief pamphlet — **How You Can Curb Pandering Advertisements** — which is now available at the Greenbelt post office. In addition to explaining how the law works, the pocket-size leaflet contains a form letter one can use when sending his complaint to the post office.

**C-O Zoning Amended**

A provision allowing for changes in the Prince Georges County skyline was adopted recently by the Board of County Commissioners.

The amendment to the zoning ordinance will allow an alteration of height limitations and set-back requirements in the C-O zoning (Commercial Office Buildings) as a special exception.

The change reads, in part, "In order to provide flexibility of architectural and site plan design, height limitations and set-back requirements may be altered as a special exception, provided that no increase in building floor area is permitted beyond the regulations established..."

A new subsection was also included in the amendment requiring that a plat plan for any special exception request must accompany all applications for changes.

**Voters Information**

A new voters information service, via telephone, has started in Prince Georges County, with general information for old and new citizens.

Chief Elections Clerk Salvatore A. Capritta pointed out that with the special Constitutional Convention referendum in May and primary and general elections this fall, his office was swamped with queries from voters, many of the questions repetitious.

The special phone tapes give such general information as when to register, who may register, dates and times of elections.

"The girls in the office made a list of the most frequently asked questions," Capritta declared, "and we tried to include all the answers."

The tapes will be updated from time to time to provide the most current information.

## Greenbelt Pool Keeps Head Above Water

Because the swimming pool season each year is cut into two parts, financially speaking, by the beginning of the city's fiscal year on July 1, budget hearings before the City Council give little insight into the financial solvency of the pool's annual operations. For that reason, City Treasurer Mabel Kandler prepares a special financial report on the swimming pool season as a whole. Her report for the 1967 season, which is now available will take on special relevance when Council, in connection with the budget hearings later this spring, confronts the task of setting fees for pool use and considers possible cost of pool maintenance and improvement.

Despite seasonal expenses of over \$25,000 for a period from May through September, the pool showed a net profit for \$791.44 in 1967. The concession stand, on the other hand, showed a seasonal loss of \$168.87.

Among the major expenses incurred in operating the pool last year was an item of \$11,431.89 for salaries for employees. These include not only the pool manager and his assistant, life guards, cashiers, and attendants but also Public Works employees during the periods that they were actually engaged in maintenance and repair operations at the pool. The second major expense was \$9,165, which includes payment of principal and interest on the bond fund for the rebuilding of the pool in 1966. Total expenses for operating the pool last year were \$25,646.63.

The major source of income for the pool - \$19,815 - came from the sale of seasonal passes. Five hundred and three resident families and 76 individuals purchased such passes, totalling \$13,715. Among non-residents 119 families and 5 individuals purchased season passes, bringing in income of \$6,100. (Resident passes were \$25 and \$15, respectively, for family and single; non-resident passes were \$50 and \$30.)

Swimming lessons netted \$1,857.50, as against expenses in instructors' salaries of \$1,342.29. Sale of daily admissions brought in another \$4,539.35. Total income was \$26,438.07.

## TROUT GALORE

Maryland anglers found a total of 59,000 adult trout stocked in Free State waters when the season opened April 15, according to Director George B. Shields of the Maryland Department of Game and Inland Fish.

A complete list of the number and species of trout to be released in streams, lakes and ponds open to public fishing has been issued by the Division of Game and Fish Management. The total include 2,700 brook trout, 10,500 brown trout and 110,800 rainbow trout.

## Camping for Crippled Children and Adults

Applications are now being accepted for handicapped children and adults by the Maryland Society for Crippled Children and Adults. Eight camping periods, including two for adults, are scheduled between June 23 and August 31 at Camp Fairlee Manor in Kent County on the Eastern Shore and at Camp Greentop in Thurmont, north of Frederick.

"Applications already indicate that we'll have more than the 52 campers who took advantage of this program last year," reported F. Robert Knight, director of the Prince George's County Easter Seal Treatment Center.

Applications and cash donations in the form of camperships are being accepted by the Easter Seal Rehabilitation Center, 9422 Annapolis Rd., Lanham, Md.

## Foster Parents Needed For Homeless Children

Urgent requests are now being made for foster parents by the Prince Georges County Welfare Board. Homes are needed for children of all ages, but especially for new-born babies prior to adoption, for teenagers, and for the handicapped. A foster child's expenses are paid by the welfare board, and couples may specify the age and sex, of the child wanted.

Couples living in Prince George's County who are interested in becoming foster parents should call the home finding division of the County Welfare Board at 779-2530 ext. 385 for additional information. Group meetings are also held periodically to answer the questions of those couples considering application for foster children.
