\$950,000 Bond Issue Ordinance

The City Council of Greenbelt will hold a public hearing on Monday, August 26, 1968 at 8:00 p.m. in the City Council Room, City Offices, 25 Crescent Road, to hear citizen views on an ordinance under consideration which would authorize the City to issue \$950,000 in General Obligation Bonds for Capital Improvements.

Summary of Ordinance

Authorizes bonds to be known as "950,000 General Obligation Bonds for Capital Improvements" to be issued.

Proceeds of bond sale to be used for the purpose of providing capital improvements to municipal facilities which shall include:

- Acquisition of land for parks
- Acquisition of land for street right-of-way including perimeter road
- Development of land acquired
- Construction and development of park facilities, including tennis courts, ball fields, comfort stations, picnic areas, parking areas.
- Construction of addition to Greenbelt Fire Station
- Construction of addition to Greenbelt Youth Center
- Construction of recreation center facility in Springhill Lake
- Reconstruction of portions of Southway and Crescent
- Construction of access roads and extra width roads in newly developed areas of City
- Construction of an addition to Municipal Office Building

Bonds may be sold all at one time or at more than one time in partial amounts

Cost of selling bonds shall be deducted from the proceeds of the sale.

Ad valorem tax upon all assessable property shall be levied sufficient to pay all principle and interest costs each year

Faith and credit of city pledged to pay for bonds and interest.

Ordinance not effective until approved at referendum.

Capital Budget

The following budget has been tentatively approved by the City Council:

Item	Budget
1. Parkland Acquisition For the acquisition of Parcel 8, the vacant portion of parcel 7, approximately 15 acres in Parcel 1, and approximately 5 acres on the east side of the Baltimore-Washington Parkway north of Glenn Dale Road.	\$402,000
2. Parkland Development This would be primarily for the development of Greenbelt Lake Park and the construction of additional tennis courts.	68,000
3. Youth Center Addition It is intended that the addition would provide special lounge facilities for the Greenbelt Golden Age Club and special facilities for the exclusive use of Greenbelt teenagers plus additional classroom space and athletic facilities.	150,000
4. Springhill Lake Recreation Building This facility would be located on land adjacent to the Community Center and would supplement existing recreation facilities provided by Springhill Lake and insufficient for present needs of that section of the community.	60,000
5. Road Construction For the reconstruction of Southway Road, the construction of extra-width streets and access roads in Springhill Lake and the reconstruction of Crescent Road.	170,000
6. Right-of-Way Acquisition To be used for the acquisition of right-of-way needed for the perimeter road	45,000
7. Fire Department Addition This is to finance the cost of an addition program by the Fire Department in order to obtain the best possible interest rates. The Fire Department would reimburse the City for the cost of the bond principal and interest out of their own funds so that this construction would not require the levying of a tax by the City.	55,000
8. Addition to City Office Building Proposed by the City Manager, funds could be made available if any surplus resulted in other programs.	None

Revised Area 13 Master Plan Generally Approved by Council

Except for a few items, the city council on Monday, August 19, expressed its general approval of the newly-revised Area 13-N Master Plan being proposed by the Maryland National Capital Park and Planning Commission for the College Park-Greenbelt area. Council members stated that the plan was a great improvement over earlier versions which were rejected by the county commissioners in July 1965 because development had been proposed at too high a density.

Among the features of the revised plan which struck a favorable note were (1) designation for single-family homes of parcels 7 and 8 at the entrance to Boxwood Village and parts of parcel 1 (the land between GHI property and the Baltimore-Washington Parkway) and the Smith-Ewing property (east of the Parkway) (2) designation of R-T (townhouse) zoning category for the GHI properties — a new zoning category designed for individual ownership rather than rental occupancy with density limited to 10 units per acre and requiring a predetermined site plan; and (3) no change to C-2 (General Commercial) zoning from the present garden-type and high-rise apartment zoning for the Jaeger tract the land jutting into the Greenbelt Regional Park alongside Kenilworth Ave.

Exceptions

The following exceptions to the Area 13 plan were voted unanimously by council, who

(1) Disapproved the routing of the perimeter road through GHI property near Northway and expressed a preference for putting the perimeter road though the proposed senior high school site on parcel 2, preferably along the easterly portion of the 60-acre tract located between GHI property and the sanitary landfill. City manager James Giese said that the MNCP-PC staff has indicated its willingness to consider alternate routes approved by the city and the County Board of Education. The council tentatively approved the rest of the perimeter road which is to start at Greenbelt Rd. near Beltway Plaza, proceed north through Springhill Lake cross the Beltway and Kenilworth Ave., then proceed northeast to parallel the city's northern boundary before turning south through parcels 1 and 2, finally crossing the Parkway and striking across the Smith-Ewing property to connect up with Greenbelt Rd. again.

(2) Disapproved the R-T zoning category for 22 acres north of Prince James Way on parcel 15 (land south of Greenbelt Lake adjacent to the Charlestowne Village project) and recommended R-80 (single-family) zoning. The council agreed with the R-T zoning for land south of Prince James Way and approved reserving 2 to 3 acres around the Lake for parkland.

(3) Recommended substituting

R-80 zoning for R-T for two small parcels totaling 4.6 acres in the vicinity of Ridge and Research rds. A similar recommendation was made for the nearby Furey property.

(4) Recommended that acreage be set aside on the Smith-Ewing property for municipal recreation and park use.

(5) Recommended that additional area on parcel 1 be designated for park, to be centered upon a stream valley along the eastern boundary of the city.

(6) Recommended that the Area 13 plan follow the city's recently approved recommendations for 24 acres of C-O (Commercial Office) zoning and 6 acres of C-2 zoning for the Springhill Lake property north of the Beltway and west of Kenilworth Ave. The city's approval is based on the developer deeding to the city for park purposes a buffer strip along Kenilworth Ave. The Area 13 plan calls for C-O for the entire 30 acres.

(6) Recommended that consideration be given to showing an overpass with ramps for the Greenbelt Road-Kenilworth Avenue intersection.

Further Suggestions

The city council is planning to get additional suggestions from the city's Advisory Planning Board before sending its recommendations to the county commissioners who will be considering the Area 13 plan shortly. The APB has been devoting considerable time to studying the traffic pattern and the impact of the rapid transit system.

The Area 13 plan shows a subway running from Prince George's Plaza to the B & O Railroad at Calvert Street and then north along the B & O line to Greenbelt, with stations at Greenbelt Road and Sunnyside Avenue just north of the city. The city of College Park has proposed that these two stations be shifted southward to the Lakeland area and the Capital Beltway. The latter proposal would necessitate an interchange at the Beltway in the vicinity of the rapid transit station, possibly with the perimeter road.

Giese was asked by council to review the present zoning status of the apartment properties located along Crescent and Parkway Rds. to determine if the designated zoning categories on the Area 13 plan are in accord with the city's long-term goals.

Council Favors Special Assessment For Financing Center Improvement

The city council has approved a public hearing for Monday, September 9, on the proposed special assessment for financing the improvements to the Greenbelt Commercial Center Mall. Half the estimated \$40,000 cost is to be paid by the city, the other half by benefiting property in the area. Assessments would be on ad valorem bases (taxes proportionate to assessed valuation) for those properties within the special taxing district making up the commercial center. The cost would be spread over a ten-year period.

The money would be spent to up-grade the city-owned property that lies between Centerway and the statue. Included would be new benches, drinking fountains, pole lights, replacement of sidewalks, ornamental work, and a new setting for the statue. Also sums would be spent for new shrubbery and a permanent Christmas tree.

The council approved a change in the boating regulations which would rescind the \$3 fee for annual permits. Instead there would be a \$3 initial registration charge, as now, with annual permits required but at no additional charge.

Legislation

The council agreed to propose

the following areas of legislation for the consideration of the county delegation to the State Legislature: Inclusion of perimeter road in emergency needs programs, inclusion of overpass at Kenilworth and Greenbelt Rd., inclusion of city policemen in State police pension plan, clarification of procedures for special assessments, and gun control legislation.

Council approved the appointment of Lawrence Goldberger of Springhill Lake to the APB to fill the unexpired term of George Neuman. Goldberger previously served on the board.

A Decision of Policy

To the Editor:

The recent article published in the News Review concerning the clothesline controversy, was hardly adequate in explaining the real details and possible effects of a wrong decision in this matter. The article hardly touched on the objections and reasons for objections of the people of 5 Court Gardenway and other numerous GHI members. In fact, the decision of the Board in this case could affect the entire community and the GHI Handbook would have a few more pages torn out to console 4 families in their breach of rules.

The entire face of Ridge Road would have to be lifted to rid it of clotheslines to concur with the line of thinking of the few members who object to abiding by the original concept of the service and garden sides of Greenbelt Homes.

The clothes poles in question were erected without permission of the GHI Board and adjoining homes in 5 Court Gardenway, whom they would directly affect.

The survey team noted in the News Review article did not include any members of 5 Court Gardenway.

The decision of the Board we feel in this case should not be one of consolation to any individual or group, but a decision of policy as to whether we are going to abide by the regulations set forth by the planners of Greenbelt or succumb to the whims of every member who desires to make a change to suit his individual conditions. Complete chaos would result if the latter policy is followed.

We therefore ask the Board to please carefully weigh all angles of this case before a decision is reached.

Firefighting Training

The City of Greenbelt has been selected as one of 10 cities in the United States that has been asked to run this Civil Defense Field Test.

The Office of Civil Defense, using material provided by the International Association of Fire Chiefs' Review Committee, calls this program the "Self-Help Emergency Firefighting Training." The program is being set up for all urban or rural residents, all local organizations, and older members of the Boy Scouts are being asked to send two or three members from each troop. Paid and Volunteer firemen are not included in the training.

The program is devised to acquaint you, as an individual, with what can be done in your own home or how you can assist a neighbor in case of a fire. This, of course is to be used only in case of an all-out war or during civil disorder such as was encountered during the April Riots of this year in both Washington and Baltimore. In short, when a large portion of our firefighting personnel has been deployed to a trouble area and will not be able to respond to your home with the promptness that is usual under normal circumstances.

The series of three classes will be held in the Greenbelt Fire Department Training Room, Wednesday, September 4, September 11, and September 18, from 8 p.m. to 10 p.m.
