Voter Registration Open Through Oct. 7

Election registration rolls in Prince Georges County will remain open thru Monday, October 7. During that period, new voters may register and old voters will have the opportunity to bring their addresses and/or change of names up to date.

Registration will be held in the Election Office at the Court House in Upper Marlboro, through October 7; Monday through Friday, from 8:30 a.m. until 9 p.m.

Four county shopping centers are also cooperating in this last minute registration of new voters by making space available at the following locations: Capital Plaza - Montgomery Wards; Prince Georges Plaza - Murphy's and Hecht's; Laurel Shopping Center - Shirley's Dress Shop; Iverson Mall - Upper Level. The times of registration at the four locations will be, beginning Saturday, Sept. 21, on Thursdays and Fridays from 4 p.m. until 9 p.m. and Saturdays from 10 a.m. until 6 p.m. On the final day of registration, Monday, Oct. 7, all four locations will be open from 10 a.m. until 9 p.m.

Greenbelt-NSA Bus Service

The WMA Transit Company started a two-week trial period last Monday of bus service between Greenbelt and the National Security Agency at Fort Meade, Maryland. The bus leaves the Beltway Plaza bus stop in front of Klein's at 6:20 a.m. and proceeds through the Springhill Lake Apartments area by way of Cherrywood Lane, Springhill Drive, and Edmonston Road.

After exiting from Kenilworth Avenue at Crescent Road, the bus passes near the Lakeside North Apartments at the corner of Ridge Road and Ivy Lane. It turns onto Lastner Lane from Ivy Lane and proceeds up the hill to the main part of Ridge Road. The bus then travels along Ridge Road until it reaches Southway, where it proceeds to the Baltimore-Washington Parkway entrance on Greenbelt Road. The expected time of arrival at NSA is 7 a.m.

The return bus will leave NSA at 4 p.m. and travel the same route in the reverse direction. Bus fare will be 75c each way. The bus company will provide regular service if a minimum of 35 persons ride daily during the trial period. If so, there will be a lot of happy wives driving around town!

Lions Sponsor Tests For Glaucoma, Diabetes

On Tuesday, Oct. 8, the Greenbelt Lions Club will again present to the residents of the Greenbelt an opportunity to participate in a Glaucoma and Diabetes testing program. The services connected therewith will be provided by the Prince Georges County Health Department and are free.

A Glaucoma test is recommended for those who are 40 years of age, or older, and for those who have blood relatives with a history of Glaucoma. No one will be turned away. A blood test for diabetes will be offered at the same time.

These tests will be given in the Greenbelt City Municipal Building between 6 and 9 p.m.

GHI Board Makes Decision On Clothesline Exception

Two controversial issues, clotheslines on the garden side and proposed new painting policies, took up most of the Greenbelt Homes, Inc. board members' attention at their regular meeting on September 26.

The first issue came to a head when members of 30 court Ridge (the converted medical center homes) put up clotheslines on their garden side. While some neighbors did not object, others, particularly those in 5 court Gardenway, objected strenuously.

Board Explains Decision

A three-member committee, consisting of board directors Nat Shinderman, Jim Smith, and Charles Schwan, was formed to study the complaint and come up with its recommendations. In effect, the committee felt that it could not ask the people of 30 court to put lines on their service side because 1) 32 court Ridge had lines on its garden side and no one had ever objected, and 2) that corner of Ridge Rd. was particularly attractive, one which many GHI members and all prospective members passed, and board members felt that it would be desirable to preserve its appearance.

Director Shinderman stated that homes throughout the community were different and that, therefore, there could be "no simple, single regulation (which could be) applied rigorously to each home in GHI." Therefore, he felt each case must be viewed individually, and perhaps the entire clothesline policy ought to be reviewed.

Director Smith concurred with Shinderman, and further stated that non-GHI homeowners had their lines in their backyards along with their gardens, picnics, and recreational activities, so why should GHI require lines to be placed on the street side.

On the other hand, Director John O'Reilly stated that the problem did not necessitate a review of the regulations which within their framework, already allowed for sufficient flexibility to solve individual cases, including this one.

Objections Heard

Speaking on behalf of 5 court Gardenway, William C. Ruppel stated there was no personal feud with 30 court. He simply wanted a clarification of the rules. Further, he stated, clotheslines were in evidence all along Ridge Rd. for passing motorists to view, so that a few more would be no novelty. Also, lines were less offensive to those passing by than to those who sat in their yards and had to view them for long periods of time. Furthermore, he had no objection to the lines on the garden side of 32 court because it was far removed from his court, whereas his yard was parallel to 30 court's yard.

There followed a discussion as to what the rule means when it states, "the consent (for putting lines on the garden side) of member-owners whose yards face that building is also required." Strictly speaking, neither the buildings nor the yards and buildings face each other, although the yards themselves are parallel. Members could not decide what the rule meant, or if there was truly a significant distinction to begin with.

Members of 30 court agreed that clothes would be hung out seldom as each member had a dryer and only one was home all day during the week to do laundry. After an hour discussion, the board voted (Katherine Keene and O'Reilly dissenting) to permit the lines to be placed on the garden side, suggesting that the manager work out with the members of 30 court the location and type of lines which would be the least offensive to all concerned. It was further suggested that, where possible, the mem-

bers use retractable or removable lines.

Painting Policy Discussed

The question of whether GHI should stay with its same painting policy or should liberalize that policy was again before the board, this time for a final vote. The board managed, however, after much debate and parliamentary maneuvering to postpone that vote until its next regular meeting.

To summarize the action, manager Roy Breashears submitted his recommendations for a new painting program, based on the recommendations of the painting committee. In this program, GHI members would have a number of possible color patterns (over 5,000 according to Nat Shinderman) from which they could choose to paint their houses. The only restrictions would be that a row must agree on a pattern and submit the pattern to management before painting and there must be a uniform trim. Also, it was recommended that there be regulations on choosing the quality of paint. Preferably, only one brand of paint would be used to assure quality and uniformity of color.

Flexibility Urged

Members of the painting committee urged that individual members not be held back from painting if one or more members in their row do not want to paint. As long as they use an approved color and pattern, members should be allowed to paint even if their neighbors do not. However, when and if the neighbor paints, he must paint his house one of the approved colors in the pattern. The committee felt that the individual should not be stymied by the "do nothings." It was the view of the committee that this new painting program would dramatically change the overall impression of Greenbelt as "a barracks community or old WPA project."

Director O'Reilly felt that these new proposals were so drastic, he needed more time to study them. He also felt there should be a referendum, polling members' votes by mail. In addition, he feared that if the new policy was not

more specific it would create a "hodge podge."

The board voted 5-3 not to refer the regulations to the membership as the new proposals "have been kicked around long enough".

Finally, the board decided (6-2) to take final action at next Thursday's regular meeting when directors could see the actual motion in writing and after each had sufficiently studied the matter.

City and GHI Meet

Breashears reported on his meeting with city manager, James Giese, to discuss the following mutual problems:

Trash removal: It is against regulations to leave trash on the street, and the city does not pick up such trash so as not to encourage others to do so. Possibly a different day might be decided upon for trash pick ups.

Trash receptacles: One area in GHI will be designated as a target area which will be saturated with receptacles to test their utilization.

Inner walkways: GHI is to look into possible easements or gifts of land for the maintenance by See GHI page 2

Clothesline Controversy

To the Editor:

Last Thursday, September 26, at the G.H.I. Board Meeting, a decision was reached concerning the Clothesline Controversy, allowing certain members to erect clotheslines on the garden side. The decision, we feel, was unjust, and made without any valid reasons being given to justify same. It also comes at the expense of five families who objected vigorously, and who will be affected most, by this decision. Two members of the Board pointed out that there was absolutely no reason for granting this special permission to breach the rule as written by former G.H.I. planners and written in the G.H.I. Handbook of regulations.

However, we feel at this time that the Board had already decided and could not or would not heed any sound reasoning, but made a decision parallel to those kings of old whose decisions were without any reason at all. If ever we felt we had had a sojourn behind a tin curtain it was last Thursday evening. A kingdom at work.

God help Greenbelt and its law-abiding citizens if this sort of justice can be expected from a group of people who hold such power in their grasp and are able to re-write the rules at every meeting and ignore the pleas of the people who abide by them.

the city of inner walkways.

Parking: Because both the city and GHI own land where perpendicular parking is proposed near 4 court Plateau, the city suggested GHI share in the cost of providing that parking.

Visitor parking for trailers: Members who have visitors with trailers are requested to notify the city for permission to park temporarily on streets or city lots. Also, permission will be granted to load and unload near residences.

Playground on Southway and Ridge: Breashears is to suggest a site to the city for such a playground.

On a matter to be discussed at some future date, O'Reilly noted that the city doesn't require other builders to put in sidewalks, so why was it requiring GHI to put sidewalks in front of the new townhouses. O'Reilly suggested someone on the GHI board ought to run for City Council to look after GHI interests.

Other Business

It was decided that there would be no significant benefits to the four people on Laurel Hill Rd. if the sanitary lines for the townhouses were relocated. Their yards would still be dug up and it would cost GHI an additional \$1300 for relocating. Their fences will be put back to the correct yard lines.

The board authorized an expenditure of \$125 to be used for a gift for each retiring employee who retires under GHI's retirement plan.

Also, Breashears was instructed to give the highest priority to employing an assistant maintenance superintendent. It was noted that qualified Cuban refugees might be recruited for maintenance positions as this practice has proved successful for other employers. As an additional incentive for recruitment of maintenance personnel, GHI will give a \$50 reward to each maintenance person who recommends a man for a maintenance job and that man is hired and stays on the job for at least six months.

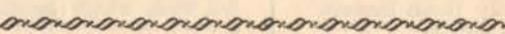

**Fire Prevention Week
October 6th to 12th**

Be your own home Fire Inspector. The theme of your local fire department is to "Free your home of all fire hazards". A good idea for each and every one of us is to keep this in mind throughout the entire year. 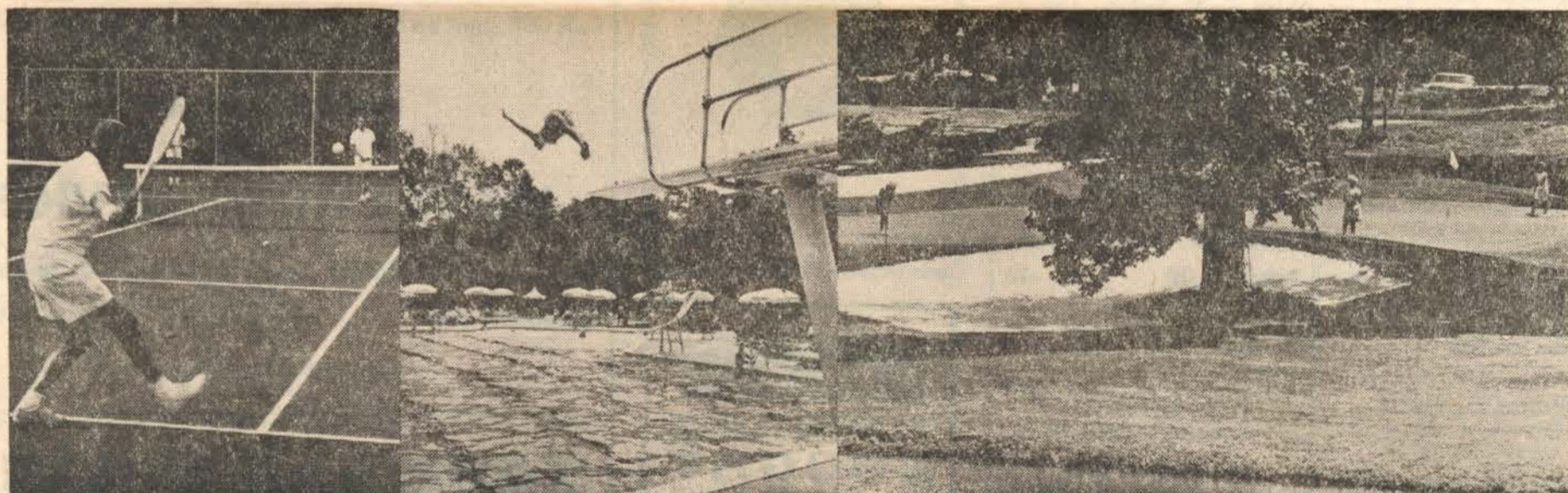
