County Delays Action on Gas Station Petition

The county commissioners, sitting as the District Council, took under advisement on Wednesday, April 16, a zoning application for construction of a gasoline station on the south side of Glenn Dale Rd., about 540 feet west of the Baltimore access ramp to the Baltimore-Washington Parkway. The special exception petition was filed by the Frankford Drive Construction Company, with co-owner Donald Gengery, speaking on its behalf. The property is located just outside the city limits.

Opposing the special exception was the City of Greenbelt, represented by city manager James K. Giese. One reason cited by the city was the excessively large site sought for the gas station (2+ acres) and the fear that the property not used for the station itself would become another storage yard for junked and damaged vehicles. The city also felt that before approval is granted, plans for the entire area (which is zoned C-2 General Commercial) should be prepared so that the land would not be developed in piecemeal fashion. There was also concern that the site would require large, unattractive signs because of its distance from the highway.

Gengery, in reply, indicated that the developers had already completed planning and financing of the entire commercial project and expected to make an announcement revealing the entire plan in the near future. The plan would include a 400,000 square foot shopping center, a motel, and an office building.

Gengery said that the reason for the large acreage for the gas station is the necessity for a setback from Glenn Dale Road, be-

cause of utility easements and a 4-lane roadway plus a one-way driveway entrance into the commercial center. When these are deducted, he said, the gasoline station is about one acre in size.

In reply to city requests that strict controls in terms of screening and buffer zones be applied to the station, Gengery said that there would be landscaping along Glenn Dale Road, and along part of the side adjacent to the Smith-Ewing property. The lease, Gengery says, restricts the use of the facility for the storage of vehicles, automotive repairs, and rental vehicles.

Nine Candidates Announce For GHI Board Positions

Nine members have signified their intention to run for the Greenbelt Homes, Inc., board of directors, it was announced this week by George Adams, chairman of the GHI nominations and elections committee. Five spots are open on the nine-man board for 2-year terms. The election will be held in conjunction with the annual membership meeting on Wednesday and Thursday, May 14 and 15. The meeting on Wednesday night will be held at the Greenbelt Theatre, starting at 8 p.m. Balloting will begin that night and resume the next day at Twin Pines.

Five of the nine candidates are incumbent board members Charles Schwan, John O'Reilly, James W. Smith (Greenhill Rd.), Norman Weyel, and Josephine Seay.

The other four candidates are Dorn Kirk Brasfield, 4 Woodland Way, Aram Beloitian, 2-B Ridge Rd., David W. Lange, 6-X Plateau Pl., and Lee B. Shield, 8-C Plateau.

Also to be elected is a 3-man audit committee for 1-year terms. Five have announced; two are incumbents Thomas X. White and Janet M. James. The other three candidates are Milton Hoffman, 7-G Research; Wayne Horman, 4-H Gardenway; and Robert Lauber, 2-E Eastway.

GHI members wishing to run for the board or audit committee are urged by Adams to contact any member of the nominations and elections committee to pick up a Candidates' Consent Form. Other members of the committee are Darwin Beck (474-2073); Andrew Feeney (474-6051); Cathy Foster (345-2025); and Jackie Shabe (474-6998).

Candidates' Consent Forms are to be completed and returned to the nominations committee by midnight, Saturday, May 3. Board members receive a salary of \$500 a year and officers \$750.

The committee requests that each candidate run as an individual rather than as a member of a slate.

Council Withholds Decision On Lake Concession Requests

A hang-up on two issues in connection with the SCH corporation's lease for operation of a concession facility at the lake park prolonged what would otherwise have been a short two-hour city council meeting on Monday night, April 21. The council was again without the services of Leo Gerton, who is still at Prince Georges Hospital.

The first issue concerned modification of the requirement that a person holding a senior life saving certificate be on duty at all times. Dr. Cantwell, on behalf of SCH, sought as an alternative "having an adult on duty." He saw a need for having a responsible person supervising the operation of the boat concession so as to avoid accidents. He felt that an adult who could perform this function might be more valuable than a teenager who held a life saving certificate. He also said that it was more difficult and expensive to hire a person with the latter qualification.

Individual councilmen, however, were reluctant to accede as they wanted maximum safety precautions. The council therefore voted against the alternative, but not before a long discussion ensued as to other possibilities, such as that the city hire a lifeguard and that all boat passengers be required to put on lifejackets before embarking.

The other issue concerned expanding the number of leased boats allowed on the lake from last year's 12 to 18 this year, with six more to follow next year. Lakeside residents had petitioned for no additional boats because of the noise problem and the fear that the lake area would take on a circus aspect. The council generally favored the increase to 18 this year, but decided to hold off final action until the next council meeting. The city's Park and Recreation Advisory Board (PRAB) had approved the request of the SCH corporation for the additional boats.

Other elements in the lease were relatively noncontroversial. The city agreed to reduce its share of revenue from the concession to 1 1/2 percent. There was also agreement that the lease would be extended another three years and that a public telephone would be installed at the concession stand.

Extra Polling Places

The council placed on the May 5 agenda the matter of special polling places for Springhill Lake and North End. Councilmen

generally indicated that they were receptive to a special polling place for Springhill Lake after the large registration on March 15 when 501 Springhill Lake residents signed up to vote in the city September elections. The council also decided to meet with officials of the newly formed Springhill Lake Civic Association, successor to the SHL Civic Committee. The latter are asking for another special registration date in June.

Bond Notes

Final approval was given by council to issuance of bond anticipation notes, for use until such time as the \$950,000 worth of bonds authorized by the voters last November are sold. The first of the latter are not expected to be sold until fall, but in the meantime some moneys will be needed at present to meet the cost of constructing the addition to the fire station and to meet fees of professional consultants.

Swim Team Coach

The council heard a request by Mrs. Martha Sutton, Social Director for Springhill Lake, for a \$300 allocation for the employment of a swim team coach in Springhill Lake for the coming season. The council agreed, but with the proviso that SHL swim team be open to all Greenbelt residents. The council did not feel it would be proper to grant recreation funds to a program that limits membership to one area of the city. Councilman Dick Pilski mildly objected on the grounds that he first wanted to know more about the status of the municipal pool's swim team.

Open-Space Grant

The council received word that the Maryland National Capital Park and Planning Commission approved on April 16 the city's application for a Federal open-space grant for purchase of parkland on parcels 7 and 8 near the entrance to Boxwood Village. It is a Federal requirement that local planning bodies approve parkland acquisition sites.

Cemetery

The city will explore a suggestion by councilman Francis White that part of the 3-acre city-owned cemetery site located near the State Roads Commission building on Kenilworth Ave. be converted for use as parkland. The Federal deed of the property calls for its exclusive use as a cemetery, upon penalty of being reverted back to the Government. In the meantime, the city will initiate clean-up efforts in that area.

Funds Approved

The council approved an additional expenditure of \$1,350 for codification of the laws. The extra amount was needed to cover the expense of printing the codification in offset, rather than multilith. The former is preferable. The contracting company is Michie City Publication Co. Charlottesville, Virginia.

Also approved by council was \$1,500 for the purchase of July 4 fireworks and up to \$75 as a contribution for a dedication ceremony at the new Parkdale Senior High School scheduled for next month.

The council approved a general resolution authorizing the city to pay conference registration fees for advisory board members attending local meetings dealing with their area of interest. The first to benefit are PRAB members, who asked to attend a National Recreation and Park Association meeting scheduled for April 23-26 in Washington, D.C. Giese indicated that the municipal budget for 1969-70 will be presented at next council meeting. Lakeside Citizens Association President John Bogumill was told that many of his requests for park and recreational improvements will be considered at budget time.

The Police Blotter

Police Chief William Lane reports a rash of thefts of articles from cars parked in Greenbelt, mainly from the apartment complexes, especially Charlestowne Village and Springhill Lake Apts. Most of these robberies have occurred between 2 a.m. and 3 a.m. Chief Lane advises that car doors, trunks and glove compartments should be securely locked and that tempting articles should not be left in full view in the cars.

Also, since objects such as hubcaps are easily stolen from the exterior of parked cars, the Police Department requests the public to notify them of any suspicious actions in the parking lots, particularly at night. Within the past week, as a result of calls from Springhill Lake residents, four men have been arrested and charged with possession of stolen property, thus closing the books on several cases.

Last Thursday Corporal Goodwin and PFC Salvatore, on investigating a call from SHL about some smoke, discovered two white males hiding between two parked cars. One of the cars had two tires removed and the men had in their possession lug and tire wrenches. The men were held for questioning, the car's owner was located, and then the men were arrested and charged with larceny and tampering with a vehicle. They are now awaiting trial in People's Court in Hyattsville.

Last Friday several cases were closed as a result of a call from a SHL resident at 2:30 a.m. Police responded, arriving at 3:15 a.m., but found no one there. However, they continued to check the area and later stopped a vehicle containing two men, in the back of which they spotted articles, including hubcaps. The men were arrested and the trunk of the car searched, revealing other items of property stolen in three SHL cases. These men are awaiting trial. None of the four men arrested is from Greenbelt.

To repeat, don't be afraid to call the Police Dept., if you think you see anything suspicious—the police will be glad to check it out.
