## Negotiations in Progress On Lutheran Property

Substantive talks have been going on between city and Lutheran church officials regarding the city's possible purchase of the church site. Two meetings have been held thus far. At the first meeting council members got a rough idea of the price the church is asking for the property.

The second meeting was a study session in which council tried to develop all aspects of such a purchase. Particularly, council was concerned about where the funds would come from. Mayor Francis White indicated that the city could purchase the site over a ten year period and could make application for open space and parkland funds. "The present budget does not have funds for this venture," he stated.

The subject will be on the agenda at council's first meeting in January and will be the topic for a public hearing on the second Monday in January.

White stated that "Council is keenly interested. I hope we can make and discuss an offer for the site at the first (January) meeting." Councilwoman Elizabeth Maffay also commented that there seemed to be "unity" among council members when they discussed the project. She noted also that since GHI could not purchase the property, she felt the city ought to do so unless the price is out of sight. The land is a "good prospect for future development," she added.

## PG School Board Withdraws Road Abandonment Petition

Just prior to the scheduled hearing before the county commissioners on Friday, December 5, Board of Education Attorney Paul Nussbaum withdrew the petition for abandonment of the city sanitary landfill road. The school board had asked for the abandonment as part of its plans for development of the 72-acre tract between Greenbelt Homes, Inc. property and Baltimore-Washington Parkway as a three-school complex.

The city had informally agreed to these plans in exchange for the school board's making available the right-of-way for the perimeter road. Uncertainty regarding the school board's ability to dedicate the perimeter road because of the repurchase agreement between the school board and the former owners, however, led the city council to ask the county commissioners to "hold in abeyance" its decision.

Conversations between city and school board officials prior to the meeting indicated that too many unsettled items existed to reach agreement at this time on the abandonment petition.

## County Hearings Set

State Senator Steny H. Hoyer, Chairman of the Prince Georges County Senate Delegation, today announced that the five Prince Georges County Senators would be holding several hearings within the County in the next few weeks.

On December 18, at the County Service Building, at 7:30 p.m., a hearing will be held to discuss the proposals by the Prince Georges County Commissioners for additional tax sources. The Commissioners have proposed four such sources including an additional tax on apartment dwellers, a 10% tax on commercial, industrial and residential utility bills, a 6% transfer tax on re-zoned property at the time of sale, and a raise in the county's conventional real estate tax from 4 to 1%.

In addition, on Dec. 18 the Senators will hear from representatives of the Washington Metropolitan Area Transit Authority as to their desire for authorization to operate a bus service, as well as a rapid transit service, and for proposals for additional state revenue for WMATA. Also scheduled is a discussion of the proposals to merge Parks and Recreation as a unit of the Maryland-National Capital Park and Planning Commission.

On January 6, at 7:30 p.m., at Crossland High School, the Senators will consider legislation dealing with education matters in the County. Of particular interest, Hoyer noted, were the proposals pending before the delegation to provide for an elected school board. In addition, the Prince Georges Board of Education, the Prince Georges Community College, the Prince Georges PTAs and the Prince Georges County Educators Association, have been asked to make comments and recommendations on pending legislation. Senator Hoyer expressed his hope that many citizens would attend this hearing to make their views known on the issue of the elected school board.

## HIGHER MONTHLY CHARGES TO BE VOTED TONIGHT BY GHI BOARD

Practically all the major decisions on the Greenbelt Homes, Inc. budget for 1970 were made at last Thursday's board meeting, but final adoption was held over until tonight's (Dec. 11) meeting. These decisions foretell an increase in monthly charges ranging from \$4 to \$6 for frame homes and \$3 to \$5 for brick homes.

A major decision was to add approximately \$19,000 to the budget as a cushion against a 1970 hike in the tax rate. GHI manager Roy Breashears had originally budgeted an amount for taxes (\$369,000) that assumed no change in the present combined city and county tax rate of \$4.861 per \$100 assumed valuation.

Press reports that the county might be forced to increase the county tax rate significantly in 1970 induced the board to increase the budget by a sum equivalent to 25 cents in the tax rate. It was also reported at the meeting that GHI's protest of the assessment increase will be heard by the Maryland Tax Court on February 11, 1970. The uncertainty of the tax situation led the board to budget the additional \$19,000 as a contingency reserve rather than as taxes.

### Sales Office Operations

A second decision by the board was to put the sales and administrative operation on a self-sustaining basis, either through an increase in the sales fee or through other sources. Earlier Breashears had presented a formula for accomplishing this end by eliminating the sales commission fee of 3 1/2% entirely and raising the membership fee from \$150 to \$325.

The board, however, felt that this step was too significant a departure from current procedure to be decided quickly and without membership reaction. There was some feeling that the proposal might be unfair to selling members wishing to use outside realtors, in that a commission, as well as the increased membership fee, would have to be paid.

A compromise proposal just to increase the membership fee from \$150 to \$210 (with no change in the commission) was defeated on a tie vote. The board then decided to let management try once again to come up with a formula that would cover the estimated deficit of almost \$10,000 in sales department operations for 1970.

### Capital Improvements

Another decision by the board was to approve a budgeted amount of \$205,000 for capital improvements in 1970. Original plans for a \$282,500 program in 1970 were considered too optimistic in light of the corporation's inability to do more than \$65,000 worth of work in 1969.

In light of this change, the amount set aside in the budget for amortization of a ten-year loan at 9 percent per year came to \$41,050. This represents the payments on the \$65,000 borrowed to cover the 1969 capital improvements and the \$205,000 expected to be borrowed during 1970. To meet this amortization cost, the board proposed to use the \$40,273 which was collected from members during 1969 for this program but not yet used. The difference between \$41,050 and \$40,273 would be charged against the members' monthly payments for 1970.

Of the \$205,000 in capital improvements, \$125,000 would be for the frame homes, the major items being \$60,000 for boiler repairs and water line replacements and the balance for such programs as porches and doors, windows and sills, gutters roofs, exterior doors, trash closet and downspouts, and sidewalks.

Of the \$80,000 for the brick homes, the major item would be \$48,000 for flat roof replacement. Other items would be porch roofs, casement windows, slate roof preservation, attached garage roof repairs, gutters and downspouts, and sidewalks.

### Administration

A final decision was to make a small reduction of \$5,500 in the proposed budget for the Administration and Sales Department to reflect the lapsed funds in payroll costs. All other items in the budget presented to the board at the November 20 meeting were left un-

changed.

As a result of these changes, operating payments (defined to exclude mortgage payments) may be expected to go up by 8-9 percent, which is equivalent to a 6-7 percent increase in monthly charges including mortgage payments. A proposed increase in operating payments of 10 percent or more would have required the approval of the membership at a membership meeting.

### Debate on Reserves

After making all these decisions, the board then decided to enjoy the luxury of a two-hour discussion on corporation policy with respect to reserves. The discussion was touched off by an audit committee report which deplored the "depletion of reserves" over the last few years and recommended that "the board begin a policy of measurable replacement immediately." The audit committee, which is composed of chairman Tom White, Milton Hoffman, and Janet James, said that families need protection against the adverse effects of unforeseen contingencies and that such protection cannot be achieved from a low cash position. In further oral statement, the audit committee also seemed to favor building up reserves to cover capital improvement items as well as unforeseen contingencies.

It was the latter view that drew the fire of director John O'Reilly. Terming the report "ridiculous" - an accusation which led audit committee chairman White to stalk out of the meeting demanding an apology - O'Reilly said that it made no sense to build up reserves for reserves' sake at a time when the corporation is borrowing for capital improvements. He thought it was unrealistic to expect members to pay in advance through monthly charges for long-range capital improvements that might total in the millions of dollars.

Other members of the board thought the audit committee report was helpful. Directors Nat Shinderman, Dave Lange, and Steve Polaschik stressed the need for flexibility so that the corporation could be in a position to go either the route of using reserves or borrowing, whichever would be more advantageous at any particular time.

There appeared to be some confusion over what kind of reserves the participants were talking about. For example, in answering the audit committee charge that reserves were being depleted, GHI president Charles Schwan said that the reserves had been built up for the purpose of being spent. Apparently Schwan was referring to reserves built up to cover planned capital improvement items, while the audit committee was referring to reserves set aside for unforeseen contingencies.

Shinderman made the point that no one knows at what point reserves would be adequate but again it wasn't clear whether the reference was to capital improvement reserves or reserves for unforeseen contingencies. Finally, in recognition of the complexity of the subject, a motion was passed by the board to ask the finance committee to come up with a policy statement on reserves that could be presented to the annual membership meeting in May.
