Primary Election Tues., May 18

This year's primary election ballot will contain names of seven candidates for the Democratic nomination for U. S. President and two for the Republican nomination. There are also eight Democratic competitors for the U. S. Senate seat held by Republican J. Glenn Beall Jr., who is unopposed in the primary.

In the Fifth Congressional District, incumbent Democrat Gladys Noon Spellman has two challengers, Richard E. Lee and Thomas J. Mooney. The Republican primary will see John Burcham, Jonathan Stanley, Frederick Taylor, and Lee Emery fighting for the honor to oppose Mrs. Spellman in November.

The polls will be open on Tuesday, May 18, between the hours of 7 a.m. and 8 p.m. Greenbelt voters have three polling places: Center School (third precinct); North End School (sixth precinct); and Springhill Lake Elementary School (eighth precinct).

On the ballot for the Democratic nomination for President are the leading contenders Edmund C. Brown, Jimmy Carter, Henry M. Jackson, Morris E. Udall, and George C. Wallace and two others: Fred D. Harris and Ellen McCormack. On the Republican side, President Gerald R. Ford is opposed by Ronald Reagan.

For the Senate seat, the main Democratic contest is between former Senator Joseph D. Tydings and Paul S. Sarbanes. Others running are William A. Albaugh, Roy L. Chambers, Monroe Cornish, Walter C. Finch, Edward L. Gates, and David E. Shaw.

Democratic voters will also choose five delegates to the National Convention and Republican voters will choose three delegates. Two Greenbelters are running as delegates — Joanne Becker in the Democratic primary for Udall and Eunice Coxon in the Republican for Ford.

Voters can only participate in the primary of the party in which they are registered. Independents (unaffiliated) may not vote in primaries.

Democratic registration in the city of Greenbelt exceeds Republican registration by nearly 3 to 1, the same margin as two years ago. About 5,260 Democrats are registered in the three precincts and 1,794 Republicans. Excluding the unaffiliated, there are 2,500 voters registered at Center School, 2,065 at North End, and 2,489 at Springhill Lake.

Journal Features Greenbelt Article

Greenbelters might find of interest an article that appeared in the Prince George's Journal of April 29, 1976. Entitled "Greenbelt: The Oldest New Community Around," the article describes the unique features of the town and includes reactions of many residents interviewed. Also included are pictures of local attractions and cartoons, including one reproduced from an early issue of the News Review dealing with the formation of the cooperative housing project.

The author of the article, Luis A. Luna, thought one of the distinct features of Greenbelt is that it is still one of the few planned communities where "you can get whatever you want without going too far from home." The role of the center mall is noted, as well as the many-featured, large recreation program sponsored by the city.

Part of the article deals with Greenbelt Homes, Inc. and the central role it plays in the life of the city. Extolled is its design which one person interviewed termed "the best retirement community ever invented. It's well laid out and easy to walk around in."

Also quoted were some critics of the co-op who accused GHI of neglecting to keep up the old structures. The GHI manager quoted in reply that improvements must be approved by members, and "if we don't start a reclaiming program soon some homes will be beyond saving."

PERENNIAL RECREATION QUESTION- TO CHARGE OR NOT TO CHARGE

To charge, or not to charge — that seems to be the question that the Greenbelt city council feels must be answered with reference to public recreation activities. This was a good part of the discussion at the budget workshop meeting of the council on Wednesday, May 5, at least; although it was an unresolved matter about which no particularly strong feelings were expressed.

The proposed recreation budget increases were of no surprise to anyone, constituting primarily an expansion to the first full year's operation of the new Springhill Lake Recreation Center, although the budget as submitted to council contains a few disappointments for the recreation department director, Hank Irving.

As Irving himself explained to council, some of the items he had originally included in his submission to the city manager, James Giese, were understandably deleted in the final submission to council. "As soon as I heard that there was a \$15,000 loss in revenue-sharing fund from the Federal government, I said to myself 'Oh, Oh, there goes the turning wall that we wanted constructed in the swimming pool'". Irving said.

He had also wanted a separate maintenance crew and budget for the recreation-activity related parks areas such as the ball fields. "In fact," he stated, "I feel strongly that parks and recreation should be combined into one department."

Giese responded that the latter approach would be a more activity-oriented approach to parks than the current arrangement with parks maintenance in the public works department. He felt that either approach had both positives and problems related to it and was, therefore, not inclined to recommend any changes at this time. No one on council seemed eager to make this an issue either.

Irving also wanted to spend \$6,000 for a used bus which he felt would be paid for out of summer day camp fees which now must be used for transportation costs. Giese did not believe that this item could be accurately depicted as a self-supporting item and it, therefore, was not included.

Budget up 10%

The total projected recreation and parks budget of \$431,200 represents an increase of approximately \$44,000 or approximately 10%. This reflects the increase in use of city recreation services and facilities—an increase last year of over 10%, from approximately 211,000 to approximately 235,000 persons served.

More specifically, the increase is related primarily to two items: an increase in the Springhill Lake Center operating budget of approximately \$20,000, which represents a full year of operation in contrast to just a partial year last year; and a request for two additional full-time recreation assistants—at \$8,300 each—the cost for which will be partially offset by reduced expenses for part-time help.

Both Irving and Giese felt that it is not possible to adequately monitor the centers without having two paid staff persons on duty during activity hours, and that the city council had requested that the centers remain open longer to meet the needs of youth—particularly after vandalism was experienced following a shortening of activity hours.

Council seemed to agree that the additional staff was needed, and this led to the discussion about increasing income through making more recreation activities self-supporting. Irving agreed that it would be possible to put the entire recreation program on a self-supporting basis—that the consumer groups pay for the services through usage fees.

However, this raises the question as to why citizens support public recreation—or, conversely, why, for example, the police department should not be expected to pay its way through fees. Council felt that it is a matter which should be looked at over the next year due to its complexity.

Notice of Charter Amendment
On May 3, 1976 the City Council of Greenbelt, Maryland, adopted Charter Amendment Resolution Number 1976-2 (Resolution Number 325) and the following Title of the Resolution is a fair summary of the amendment:
Charter Amendment Resolution Number 1976-2
RESOLUTION OF THE CITY OF GREENBELT ADOPTED PURSUANT TO THE AUTHORITY OF ARTICLE 11E OF THE CONSTITUTION OF MARYLAND AND SECTION 13 OF ARTICLE 23A OF THE ANNOTATED CODE OF MARYLAND (1957 EDITION AS AMENDED), TITLE "CORPORATION-MUNICIPAL", SUB-TITLE, "HOME RULE", TO AMEND THE CHARTER OF THE CITY OF GREENBELT, MARYLAND, SAID CHARTER BEING SECTION 40 OF ARTICLE 17 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND (1963 EDITION AS AMENDED) AND CONTAINING IN WHOLE OR IN PART THE CHARTER OF THE CITY OF GREENBELT, BY REPEALING AND REENACTING WITH AMENDMENTS SECTION 59, TITLE "CONTRACTS OVER ONE YEAR", TO PROVIDE THAT A MORTGAGE CONTRACT WITH THE STATE OF MARYLAND RELATING TO THE CONSTRUCTION AND OPERATION OF A FEDERALLY SUBSIDIZED HOUSING PROJECT FOR ELDERLY PERSONS MAY EXTEND FOR A PERIOD OF NOT MORE THAN FORTY YEARS.
The above amendment shall become and be considered a part of the Charter of the City of Greenbelt, Maryland, according to the terms of the amendment, in all respects to be effective and observed as such, upon the 22nd day of June, 1976, unless on or before the fortieth day after passage, which shall be the 12th day of June, 1976, there shall be presented to the Council of the City of Greenbelt, Maryland, or mailed to it by registered mail, a petition for referendum signed by twenty percent or more of the persons qualified to vote in the general election of the City of Greenbelt, requesting that the above Charter Amendment be submitted on referendum to the voters of the City of Greenbelt.

PRAB Submits Reports

The city's Park and Recreation Advisory Board (PRAB), under the chairmanship of Ronald Ott, has been quite busy preparing reports for the council's consideration. These reports will be coming up at the next meeting of council on Monday, May 17 or considered at budget meetings.

In a supplement to Report #3-76, PRAB recommended that a seasonal full-time enforcement officer for the Lake Park area be assigned to enforce parking and other regulations relating to control of alcohol, permits, boats, swimming, and pets.

In Report #5-76, PRAB endorsed the development of parcel 7 (adjacent to Boxwood Village) as a recreational area, including a layout plan that would provide for a combination baseball-football-soccer field. In doing so, it submitted a number of recommendations to assure that the development of parcel 7 does not impact upon Boxwood.

The most significant new recommendation is the erection of a fence on the Lastner Lane side of the field, so that participants using the field who drive will park on Ridge Road and Crescent Road. Other recommendations include provisions for angular parking along Ridge Road, no field lights for night activities, retention of as many trees as possible, and restrictions on organized activities in favor of youth and women's programs.

Registration for Summer School

Registration for summer school for Junior and Senior High School students is being held during the month of May at all Junior and Senior High School guidance offices. Final registration will be held on June 14 and 15 at designated centers.

Registration forms are available in school guidance offices. These forms must be signed by the principal and the guidance counselor. Tuition fees must be paid at the time of registration; no tuition will be waived. A late fee will be charged for those who register June 21. At that time students will be admitted only if space is available.

Course for grades 7 and 8 will be held June 23 - July 27; those for grades 9 and 12 will run June 23 - July 19 and July 20 - Aug. 12. Parents should be aware of whether their children are failing a major subject since this will be the student's last opportunity to pass the course.

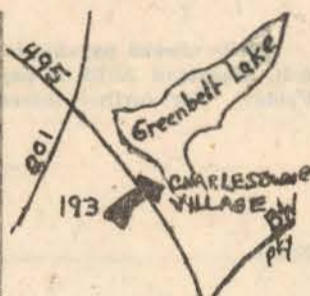

Rent Tax Hearing on May 19

A May 19 public hearing has been scheduled for 1:30 p.m. in Upper Marlboro on legislation reimposing the apartment tax, this year at four rather than two percent. In-dwellings except those occupied by a tenant 60 or older, a family of six or more living in an apartment charging \$275 or less monthly, and families receiving a housing subsidy other than military housing allowances.

Apartments charging \$165 monthly or less and single-family homes that are rented are exempted, along with dwellings rented to those receiving public assistance from the county's Department of Social Services, and to tenants permanently and totally disabled and earning less than \$8,000 gross income annually.

The tax is expected to net \$7 million this year.

Residents of local apartment projects should note that a recently

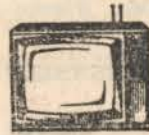
