## Senior Housing Project Keeps Council Busy

As expected, city council at its regular meeting on Monday, August 9, gave final approval to the holding of a referendum on elderly housing on Tuesday, September 28, 1976. The ballot boxes will be open in three precincts — Springhill Lake, Center School, and North End school — from 7 a.m. to 8 p.m. Voting machines will be used.

Actually, the electorate will be voting on the question of approving an amendment to the city charter permitting the city to enter into a mortgage contract for up to 40 years for the purpose of constructing and operating a federally subsidized housing project for elderly persons.

A "yes" vote on the question would be a vote in favor of elderly housing.

### Hires Consultant

The council considered several other matters dealing with the housing project which is being proposed for the Ridge Road Center property. It authorized the hiring of a consultant at a cost of \$850 to gather certain data that might be needed for the referendum. These included a preliminary determination of economic feasibility and information on the Section 8 Housing Assistance Payment program.

In addition, because of the tight deadline set down by the Federal government, the consultant will get started on establishing criteria for and assisting in the selection of an architect and in preparing a preliminary analysis of the methods of ownership through which Section 8 program could apply in Greenbelt.

The city council made clear that should the voters decide against the project in the referendum, no further work would be performed by the consultant. If the project is approved, then additional work will be required of the consultant such as preparing necessary applications, monitoring the preparation of plans and specification, assisting in the selection of a builder, assisting in the construction, financing, and the establishment of a management agency, and in developing a management plan. The total cost for the consultant, according to city manager James Giese, would be \$12,500 and would be chargeable as an expense to the housing for the elderly project, if the project is approved.

The council also authorized the city manager to employ an appraiser to evaluate the Ridge Road Center property, at a fee of \$750 to \$1,000. Such an appraisal is needed now as the city is preparing its land acquisition applications for the Federal government. The city's thinking is to request the Department of Housing and Urban Development to replace the Ridge Road property with other open-space property, so that the Ridge Road Center property can be utilized for housing for the elderly.

### Expenditures Approved

The council approved the expenditure of \$1,500 from contingency funds to pay for the costs of the referendum. Also introduced for first reading was a resolution authorizing that the rate of compensation for the chairman

and members of the Board of Elections be established at \$75 each for the referendum. The elections judge's rate was set at \$60 and that of each clerk, \$45.

Council received a report from the Advisory Planning Board suggesting that, should the elderly housing project be approved, consideration be given to improving the inner walkway system that serves the Ridge Road Center property. APB noted that the pedestrian access to and from the property to the center involves a steep hill. It suggested that modifications of the slope through the installation of railings, landings or some other means be included in the planning and costs for such a facility.

Council set aside Wednesday, August 18, as a committee-of-the-whole meeting to consider the kind of literature that should be distributed prior to the referendum. Under the new rules council is adopting for committee-of-the-whole meetings, such meetings are to be open to the public with advance notice given as soon as practicable. The council noted that the meetings are held for the purpose of receiving and discussing information and that no formal actions are to be taken.

## Parcel 7 Plans, City Ballfields On Agenda For Council Meeting

Next Monday, August 16 at 8 p.m. the city council will hold a special meeting to discuss and consider implementation of plans to develop Parcel 7, the 8.8-acre tract located at the entrance to Boxwood Village (see history on page 2). Additionally the city staff will present a report which will cover the (1) needs of the city with respect to ballfields, (2) additional and/or alternative locations for fields, and (3) costs of development. Additional locations include the old landfill site (south of Northway Road extended between the Baltimore-Washington Parkway and the GHI homes on Ridge Road) and the land located across from the GHI administration offices on Hamilton Place.

### Parcel 7

Development plans include (1) one unlighted field area - either a baseball diamond with an overlapping football-soccer field or a combination football-soccer field located near the corner of Ridge and Crescent Roads; (2) a free-play area near the middle of the tract; (3) a tot playground on the corner of Ivy and Lastner Lane, and (4) a small multi-purpose court separated by buffers from the playground. City consulting engineer John D. Emler prepared the plans.

Funds are not available at this time to undertake the development of the total parcel. However, city manager James K. Giese notes that a decision should be made on the overall plan so that the proper grading, cuts and fills can be made for the construction of the free-play area. The playground, which is apparently supported by council, could be constructed as soon as city work schedules permit.

The proposal for the athletic field has created the most controversy. Opponents of the field feel that (1) nearby residents would be inconvenienced, (2) property values would be decreased, (3) an increase in noise pollution would result, (4) a park-like setting for the tract would be more appropriate since it is located near the entrance to the city and (5) a ball-

field would attract more Lake-Park visitors and compound the parking problems in the area.

Proponents of the field argue that (1) parcel 7 was acquired for the purpose of developing more recreational fields if needed, (2) it is more equitable to locate ballfields in various sections of the city rather than centralize them in one area, (3) the valuation of Lake-side Homes next to Braden Field has not been adversely affected, (4) the city's population has more than doubled, but playing fields have not kept pace with the growth, (5) increased participation by women and the addition of such sports as soccer indicate the need for more fields, (6) safeguards to nearby residents can be provided by buffers and planting of trees, (7) the field will not be used when the Lake-Park is most crowded, and (8) Braden Field is in dire need of renovation work, but nothing can be done until more ballfields are provided elsewhere.

The Boxwood Civic Association at the May 8, 1976 public hearing on the Lake-Park approved of a "free play area and tot lot in an adequately buffered spot" and "in the event of future development, no more than one unlighted ball field (near the corner of Crescent and Ridge) be considered."

### PRAB

The city's Park and Recreation Advisory Board has approved the plan calling for the unlighted combination baseball-football-soccer field, subject to a number of modifications and restrictions. The most significant of its recommendations was the erection of a fence on the Lastner Lane side of the field, so that participants using the field who drive will park on Ridge Road and Crescent Road. Giese noted, however, the installation of fencing would make accessibility to the area difficult for a great many Greenbelt residents, including Boxwood children. It is envisioned that the parcel 7 field would be used mainly by the Boys & Girls Club and women's teams.

### Landfill

To establish ballfields on the old 5-acre landfill site, the area must be filled and graded. Developers have been providing fill at no cost to the city and about 50% of the required fill has been dumped on the tract. City crews have also graded half of the area. The expense to the city includes labor, top soil and related materials for growing a good stand of grass and a possible expense for the remaining 5,000 cubic yards of fill, since the slowdown in the construction industry has made it difficult for the city to obtain free fill.

### Hamilton Place

The 4-acre Hamilton Place site is among those tracts in parcels 1 and 2 slated for acquisition by the city.

**Background of Parcels 7, 8**

October 12, 1966 was a red-letter day in Greenbelt. It was on this day — almost ten years ago — that the city started to reverse the trend toward high-density development of the vacant land surrounding the planned community.

The occasion was a hearing before the county commissioners at Upper Marlboro on a petition filed by Crescent Leasing Corporation for commercial zoning on parcel 8 located at the intersection of Kenilworth Ave. and Crescent Rd. (entrance to Boxwood Village).

Despite the united opposition of the community to the petition, the outlook was not good. A tentative master plan proposed by county planning officials in 1964 had encouraged developers to proceed post-haste with large-scale garden apartment projects and commercial development. The city's previous efforts to stop high-density development and achieve balanced growth had been thwarted by adverse court decisions and unfavorable zoning decisions at the county commissioners' level.

The city was now faced with the proposal of Crescent Leasing Corporation for constructing four stores and possibly a gas station as part of a neighborhood shopping center on the 2.45-acre site opposite Boxwood Village between Kenilworth Ave. and Ridge Rd.

Not part of this proposal, but also at stake was the fate of the larger 8.8-acre site (parcel 7) bounded by Crescent and Ridge rds, and Lastner and Ivy Lanes, whose owners (Charles Bresler and associates) had a petition pending for commercial zoning also.

**Two-Hour Hearing**

At the two-hour hearing, the developer argued that commercial zoning was justified for parcel 8 because of the change in the neighborhood. He pointed to the dual highway and Kenilworth interchange, the new State Road's office building across the highway, the plans for Springhill Lake apartments, and the proposed city warehouse on an adjacent site.

The city presented a united front in opposition to the commercial zoning. The city had hired a special zoning attorney, Emmett Nanna, and a planner, Malcom H. Dill, who were supported by presentations by Greenbelt Homes, Inc., Citizens for a Planned Greenbelt, and Boxwood Village. All argued for retaining the residential character of the area in accordance with the city's own master plan, with Mayor Edgar Smith observing that Crescent Road is unique in its scenic attractiveness with its thick line of trees.

**Commissioners Unanimous**

The county commissioners (among whose ranks was present Congresswoman Gladys Noon Spellman) were impressed by the array of witnesses from Greenbelt and in an unusual move, acted on the petition the same day. They unanimously denied the petition, noting that the general area around the subject property was zoned for single-family homes, there was no need for commercial zoning, and approval would lead to commercial strip zoning in other nearby tracts. Within two weeks of the decision, the owners of parcel 7 leveled the trees on the property, stating that their intent was still to develop it as commercial.

But it was a last gasp, although the owners of parcel 8 tried again two years later to secure commercial zoning. But by now the city had initiated plans to purchase the land as parkland to help fill the natural boundaries of Greenbelt Lake Park and provide a scenic entrance to the community. In August 1969 the petition was again denied by the county.

**Bond Issue**

The money for the purchase of parcels 7 and 8 was voted by the citizens on November 26, 1968 as part of a \$950,000 bond issue. In the official literature circulated by the city justifying the purchase, the following explanation was given.

"Even now many park facilities are inadequate. This year more ball games were scheduled on Braden Field than anywhere else in the county, and maintenance became a problem. Tennis court users have long complained of inadequate courts, and each year many more young people become tennis enthusiasts after taking Recreation Department sponsored lessons . . . .

"The \$950,000 bond issue proposes . . . acquisition to the Lake Park of Parcels 7 and 8, and development of park land . . . .

"By acquiring (parcels 7 and 8) a number of objectives will be accomplished:

1. Additional land will be added to the Lake Park. Much of this land will be suited to development as ball fields and play fields and is centrally located for the entire city.
2. A scenic entrance into Greenbelt will be preserved and improved, assuring that no unsightly commercial development takes place.
3. Crescent Road will eventually have to be relocated further north because of the hazard created by its proximity to the Beltway Interchange. The acquisition of these parcels will assure the best routing for the relocated road.
4. Boxwood Village could obtain a playground for children adjacent to it and not separated by major streets."

**Purchase Price**

The price paid by the city for acquisition of parcels 7 and 8 turned out to be larger than estimated. In the case of parcel 7, the agreed-on price was \$18,000 per acre for a total of \$158,625 for the 8.8-acre tract.

In the case of parcel 8, the owners insisted upon going to condemnation proceedings which set a value of \$75,000 or more than \$30,000 an acre for the 2.45-acre site. The city had budgeted \$49,000 for parcel 8, but the owners had argued that the land was highly suitable and well located for commercial use.

The total cost for both tracts, after counting legal and other expenses of acquisition, was \$247,871. Federal and State open-space grants of \$180,611 eventually helped to meet most of the acquisition costs.

**Park Development**

The bond issue also approved the expenditure of \$68,000 for the development of park land — the highest priority being the development of additional ball field facilities and more tennis courts. Since 1971, the city council and its advisory boards have been attempting to carry out this commitment to the voters, but differences have developed over the use of parcel 7.

Next Monday, the council will try once again to reach a consensus as it reviews the latest plans developed by a staff engineer.

**Sister to Make Final Vows**

On Sunday, August 15, at Saint Hugh's 12:30 p.m. Parish Mass, Sister Patricia Anne Roland will make her Final Vows in the Sisters of the Holy Cross. Sister Patricia's family resides at 2B Plateau Place. All members of the Greenbelt community are invited to attend.

Sister Patricia graduated from Saint Patrick's Academy, Washington, D.C., in June 1959 and was employed in the Washington area until her entrance into the Order in September 1967. She received her B.S. degree in Business Administration Management from San Jose State University, San Jose, Calif. in June 1974. She is now teaching and counseling at Saint Francis High School, Mountain View, Calif.

(The sisters teaching at Saint Hugh's parish school are also Sisters of the Holy Cross.)

**Amer B. Thurston**

Mrs. Amer B. Thurston, age 79, of West Hyattsville passed away suddenly on August 2 at Providence Hospital. Mrs. Thurston and her husband Raymond were among the first 25 families to move into Greenbelt in October 1937.

She is survived by her husband, daughter Lottie Falter, 4-B Gardenway, grandsons Ronald, Thomas, William and Robert, 6 great-grandchildren, 4 sisters and 3 brothers.

Long time Greenbelt resident Frank I. Henegar, 6-C Hillside, died August 6. His survivors include his wife, Frances O. Henegar, sons, John A., Robert I. and Douglas W. Henegar, three brothers and nine grandchildren. Interment was at Fort Lincoln Cemetery on August 10.
