## Solutions to Over-crowding At Lake Park to be Debated

The Greenbelt City Council has scheduled a public hearing on April 25 at 8 p.m. in the City Council Chambers regarding proposed parking restrictions at Greenbelt Lake park to discourage its use by non-residents. The hearing has grown out of findings from a city-conducted survey last year of park users, which demonstrated that more than 50 per cent were non-residents.

In a work session on March 16, city council members and representatives from the city's Park and Recreation Advisory Board (PRAB) discussed overcrowding at the lake park.

"The lake park is grossly over-used," said Robert Greig, PRAB member. "It's being brought down to such a level that (residents) don't want to use it."

The council plans the April 25 hearing to obtain proposals discouraging non-residents use of the lake.

The first proposal is to eliminate parking on Crescent Rd. near the lake park. In order to prevent park users from parking on the residential streets adjacent to the lake, further restrictions would have to be made on Ridge Rd. and Lastner Lane from Crescent Rd. to Ivy Lane in Boxwood Village.

These parking restrictions "could be the biggest factor as a disincentive for non-resident use," said Mayor Gil Weidenfeld. Parking on the dirt shoulders off Crescent Rd. also creates a traffic hazard.

A second proposal is to have resident-only permit parking for all or a portion of the 85-space lake parking lot. Residents would have to obtain stickers from the city offices for just the cost of printing. But this policy could also be self-defeating by diverting non-resident parking into the surrounding residential areas.

PRAB members and the council

did not favor additional parking areas at the lake park because it would further encourage non-resident use of the park. "We have enough asphalt at the lake already," said Mary Clarke, PRAB member.

"The parking facility would probably be adequate for the number of residents who use the park," said Greig.

If it becomes harder to park, Weidenfeld feels non-residents would not come to the lake. "Something has to be done," said Ronald Ott, PRAB chairman. "If it doesn't work, we can try something else."

Weekly Sunday evening concerts at the lake park during the summer also attract many visitors as well as residents. The program offers a wide variety of bands, including rock, concert and country.

A highlight at the park is the Fourth of July fireworks display, which draws about 8,000 spectators to the lake. Parking restrictions would have to be lifted during the concerts and the fireworks display, according to Weidenfeld.

A concession stand featuring snacks and boat and bicycle rentals also makes the park attractive to outsiders. Greig favors lessening these attractions to discourage non-resident use. This could also make the lake less attractive for residents, however.

"The key to all of these things is the control," said Hank Irving, director of recreation.

At the sixth annual City Employees' Banquet held Saturday, March 19, City Mechanic Cecil Breeden was selected Outstanding City Employee for 1976. ## CITY NOTES

The general crew has worked all week on the swimming pool. All of the bad concrete decking has been removed and replaced. All snow plows and salt spreaders have been removed from vehicles.

The park crew has been planting shrubbery around the Youth Center building and the Springhill Lake Recreation building. Leaves and gumballs were cleaned from around Candy Cane City. ## Council Raises Swimming Pool Fees Discusses Lake Parking, Glen Ora

As warmer weather approaches, the city council concerned itself with matters traditionally associated with summer: the pool and the lake park. At its April 4 meeting, council set new rates for the swimming pool. Citing higher maintenance costs and the fact that pool expenses exceeded revenues by more than \$10,000 last year, the season and daily admission fees have been increased.

The season rate for a Greenbelt family has gone up from \$40 to \$50. The single person season rate rises from \$20 to \$25. Daily admission for an adult will go from \$1.25 to \$1.50 while the child's (6-18) fee will go from 75c to \$1.00.

Other changes in the rate schedule benefit senior citizens who will be able to swim at the pool free of charge. Last year those 62 and older paid \$13 for a season pass or 50c for a daily admission charge.

Swimming instruction rates remain the same as last year. A season pass for a household guest will rise from \$25 to \$30. Another change in the pass system is that non-Greenbelt residents seeking to purchase a season pass will no longer have to be sponsored by a Greenbelt resident. Instead a limit of 150 non-resident family passes from \$85 to \$110. A single pass for has been established. The non-resident family pass also increases a non-resident will rise from \$50 to \$55. Daily admission for non-residents also will increase by 50c on week-ends and holidays.

A complaint about campers from Greenbelt campground using the pool for a variety of cleaning and grooming purposes was brought to council's attention and council was assured that the campers (designated as temporary Greenbelt residents) will be made aware of the city regulations concerning the use of the pool.

### Lake Park Crowds

Facing the problem of crowds of non-residents at the lake park swarming over the area — particularly on weekends — and making it unpleasant for residents as well as causing parking and traffic headaches, council set April 25 for a public hearing to discuss the situation.

Several partial solutions have been suggested by the city staff as well as the Park and Recreation Advisory Board. These include restricting parking in the vicinity of the park to include the area around parcel 7 in Boxwood and Lastner Lane to Rosewood Drive. (Residents as well as non-residents would be prohibited from parking in these areas); reducing facilities such as picnic tables in order to temporarily discourage park use; and requiring permits for use of the picnic areas and tables.

Other problems such as prohibiting dogs at the park were seen as not directly related to the matter of over-crowding, but could be dealt with as separate issues.

### Glen Ora

Council agreed to send the recommendations of the Advisory Planning Board concerning recreation at Glen Ora to Maryland-National Capital Park and Planning Commission. Since the developer waived mandatory dedication of green space to the city in favor of creating his own recreation facilities (pools, tennis courts, etc.) the city has no real influence on what these recreational facilities will be nor how adequate they will become in the next five or ten years. The developer is working with MNCPPC on the recreational facilities which PRAB describes as "minimal".

However, APB recommended that these facilities be expanded, that the path system should be continuous and should be paved in its entirety; that an inner-sidewalk system should be shown; and that a maximum amount of tree coverage should be retained. APB also noted that pedestrian access to either the ballfield on the school board's property or the major recreation complex (to be built when 51% of the total (750) number of units are occupied) requires crossing streets from this parcel in mid-block and APB suggested that an underpass be considered.

Council was very concerned about this problem, but was uncertain about the underpass since construction would be very expensive.

In addition, there is the problem of going from the city-owned street to the school board property, with probably no incentive for the school board to contribute to the cost of such an underpass. The issue was not resolved other than to include the matter in the city's letter to MNCPPC.

### School Study

Howard Savage, chairman of the city's study group on school closings, recommended that council write to the Board of Education requesting that the children from Greenbriar, who are presently being shifted from C. T. Reed to Magnolia Elementary, be sent to Center instead. The reasons for this were that Greenbriar would have a closer association with the city if its children attended a city school, Center is closer to Greenbriar than Magnolia, and such a move would improve the racial balance of the city. In addition, Center needs more children to stem the declining enrollment.

### Budget Time

City Manager Jim Giese presented the annual budget to council. The following dates were arranged: public hearing, April 25; budget hearing, May 23; budget adoption, June 6.

Giese took the opportunity of dedicating this year's budget to the News Review's late president, Alfred Skolnik. Giese reflected that "this was the fifteenth budget which I have submitted to the City Council and citizens of Greenbelt. It is the first budget not to receive the careful scrutiny of the late Alfred Skolnik. . . . Al enjoyed budgets. . . . He spent the time necessary to understand what it contained and the accuracy of the figures. . . ."

"Al was unique in that most reporters of budgets do not understand the budget and are not able to report it accurately. Greenbelt citizens could rely on the News Review for a clear reporting of budget considerations. His passing will leave a gap that will be difficult to fill. It will place an added burden upon the City Council and the citizens to make sure that the city manager's budget is in proper order. I, too, will miss his fair coverage of the budget, as well as the many other attributes that made him an outstanding Greenbelt citizen.

"This budget is dedicated to his memory in appreciation for his help in explaining to the citizens my fourteen other budgets", Giese concluded.

### July 4

Zambelli Fireworks Manufacturing Co. was again retained to provide the city's annual fireworks display on July 4. There will be 21 less aerial rockets and two less ground displays than last year. The amount for fireworks will not exceed \$2,500, about the same as last year.

## Three Candidates Seek Election To GHI Board; Another Likely

The election is to be held on Wednesday and Thursday, May 18-19, in conjunction with the annual membership meeting. There are five openings on the board, since directors Ted Byerly, Mary Clarke, Stephen Polaschik, Don Volk and James Wright have completed regular two-year terms. One incumbent, Mary Clarke, is among the candidates. The other two are Margaret Hogensen, 53-F Ridge Road, and Henry R. Fisher, 7-E Southway, Wayne Williams, who has been serving on the Nominations and Elections committee, has informally announced his intention of running for the board also.

## P.G. Schools Announce SHIP Testing Program

The Prince Georges County Public Schools has announced the schedule for its SHIP (Systematic Help Through Identification and Programming), early identification program for children entering kindergarten next fall.

The SHIP program is designed to identify the learning strengths and needs of each child and to provide information about each child that will be helpful to the school in planning the instructional program.

Parents are encouraged to make an appointment at the school their child will attend. Each child will receive vision, hearing, speech and language, motor skills, and visual perception screenings. Also included will be an opportunity for each child to visit the present kindergarten class. During this time parents will have an opportunity to meet some of the school staff. The total program will take approximately an hour for each child. The schedule for Greenbelt is as

Also surviving are six grandchildren and six great grandchildren.

An article about the landscaping work of the late Angus MacGregor appears in the twenty-fifth anniversary volume for the city of Greenbelt. Prior to his association with Greenbelt he had been head gardener for the J. P. Morgan estate.

**Mary C. O'Connor**

The many friends of Cyrilla O'Connor in Greenbelt were saddened by news of her death March 30 at Seminoles Hospital in Sanford, Fla., where she had undergone surgery. Immediate cause of death was heart failure.

Miss O'Connor formerly lived in Greenbelt and took an active part in community and civic affairs, many times supporting principles she believed in even though they were controversial and unpopular in the early history of Greenbelt.

Miss O'Connor was a member of the Greenbelt Citizens' Association, which was affiliated with Prince Georges County Federation of Citizens' Associations. In addition, she served as an active member of Greenbelt Co-op, St. Hugh's Catholic Church, member and president of the Women's Club of Greenbelt and in 1953 was elected President of that organization. During the war years she worked in a government defense agency, and was affiliated with the Red Cross; after retirement from the government, she sold real estate in Greenbelt.

In the 1960's Miss O'Connor moved to Deltona, Florida, where she continued her activity in church and community until shortly before her passing. Cyrilla will live in the memory of those who knew her for her dynamic personality and charm, and her many acts of kindnesses and especially her awareness of the needs of those less fortunate.

Surviving are: a brother, Edward O'Connor, Roanoke, Virginia; three nieces and four nephews, and her Greenbelt "family" to mourn her passing. Funeral services and burial were at Roanoke, Virginia.

# City to Break Ground Mon. On Municipal Bldg. Annex

Groundbreaking ceremonies on Monday, April 11, at 6 p.m., will herald the start of construction on the new addition to the Municipal Building. Construction is scheduled to begin next week. A speedy schedule has been dictated by the fact that the funding for the new building comes from a \$282,860 Federal public works grant which required the city to begin construction within 90 days of acceptance of the grant January 17.

At its March 21 meeting council selected the Linton Construction Company to build the annex. While Linton's bid was the lowest offered, it in fact tops the Federal grant funding the project by more than \$72,000. City Manager James K. Giese told council the extra money is available from the city's Capital Improvement Fund.

The building will consist of two stories and a basement, containing in all 8,562 sq. ft. The building will occupy the site where the police cars are now parked and will be connected with the old building by a lobby-corridor. A new parking lot will be constituted behind the addition where a grassy area now exists.

Upon completion of the addition, City administrative offices will be relocated into the facility and the entire first floor of the existing building will be converted to a

## Car Thefts Plague City

An alarming number of auto thefts have been reported in Greenbelt in the last two weeks. Six cars and one motorcycle were reported stolen, of which only three cars are still missing, and three additional stolen cars were recovered when Greenbelt police responded to routine calls.

Of the six reported thefts, one car taken from the north end of the city was found behind the Jewish Community Center, another was recovered by Prince Georges County Police after a fast chase in Bowie, and the third was located by Maryland State Police at the base of a 40 foot cliff in Calvert County. The motorcycle was recovered by the Greenbelt Police the same day it was stolen.

A hit and run accident was reported early one morning. Greenbelt Police located the offending car on Pinecrest Court and found it had been stolen from Westway Road.

As the result of a citizen's complaint about a car parked in a strange manner, two additional stolen vehicles were recovered. One had been stolen from Springhill Lake, and the other from Colmar Manor. Both have been returned to the owners.

## Our Surroundings

The closing of the special trash collection station behind the Fire House is another example of how just a few people can wreck a convenience which many have enjoyed. We often found it an easy matter to throw discards into the auto and take them to the collection station, rather than clutter the yard during the weekend, while waiting for special trash pick-up. We also found that by doing this we could lighten the work of busy city workers.

Now for a positive note: The trees and shrubs throughout Greenbelt have weathered the severe weather very well, so we should be enjoying vivid spring and summer colors. Similarly, the many birds that call Greenbelt their home seem to have rested well during the cold season and have started their early morning symphonies with great spirit.

Many relatives and visitors who will be coming to see us and to enjoy Greenbelt's unique sights and sounds will also, unfortunately, again be treated to piles or roadside trash, even though Greenbelt has a special pick-up trash service from yards which can be had by calling 474-8004.

The next time you drive through Greenbelt, try to see is through the eyes of a visitor. If you piled your trash along the roadside, you may see it as an eyesore and a defecation from your neighbors' yards and homes and a blight on your neighborhood.

## Police Blotter

Upon receiving a complaint, Cpl. Miskell investigated and found four teenagers loitering in an apartment basement. All were returned to the custody of their parents and warned against trespassing in the apartment buildings.

A breaking and entering was reported at the Transmission Shop on Centerway Road. Lookouts have been placed for the missing items and investigation is continuing.

Several flags were recently stolen from the Center School.

Several calls were received concerning an accident at the intersection of Plateau Place and Ridge Road. Investigation by PFC Caccarelli revealed that the striking vehicle had apparently been speeding and struck a car on Ridge Road, then jumped the curb, travelled over a grassy area and struck a second car parked on Plateau Place. The operator was apprehended and charged with various offenses, including operating under the influence of alcohol.

As the result of a complaint that a juvenile had been assaulted at Eleanor Roosevelt High School, PFC Duprat apprehended a suspect. He was charged with assault and released to his parents while awaiting Juvenile Court action. He was not a student at Roosevelt.

## Public Supports METRO

The American University conducted a poll from Feb. 22-28, 1977 regarding the Metro subway system. The poll, directed by Dr. Robert Hitlin, Association Professor of Government at A.U., demonstrates that there is strong support for completion of the Metro system. In February of 1976 Dr. Hitlin, then a professor at Georgetown University, organized a similar survey by students and found that D.C. residents had favorable attitudes toward the subway system.

The 1977 telephone poll was conducted along specific guidelines. The telephone numbers were selected randomly and all respondents were aged eighteen or older. The

areas surveyed were the District of Columbia, (365 interviews); Montgomery and Prince Georges counties (358 interviews); Alexandria, Arlington, Fairfax County, Fairfax City and Falls Church (403 interviews). The data shows that support for Metro ranges over all age groups. Seventy-two percent of the D.C. populace interviewed, 62% of those in Virginia, and 66% of those surveyed in Maryland favor the completion of the subway despite rising costs.

# Notice of Charter Amendment

On March 7, 1977, the City Council of Greenbelt, Maryland, adopted Charter Amendment Resolution 1977-3 (Resolution No. 353) and the following Title of the Resolution is a fair summary of the amendment:

## Charter Amendment Resolution Number 1977-3

RESOLUTION OF THE CITY OF GREENBELT ADOPTED PURSUANT TO THE AUTHORITY OF ARTICLE 11E OF THE CONSTITUTION OF MARYLAND AND SECTION 13 OF ARTICLE 23A OF THE ANNOTATED CODE OF MARYLAND (1957 EDITION AS AMENDED), TITLE "CORPORATION-MUNICIPAL," SUBTITLE "HOME RULE," TO AMEND THE CHARTER OF THE CITY OF GREENBELT, SAID CHARTER BEING SUBTITLE 40 OF ARTICLE 17 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND (1963 EDITION AS AMENDED) AND CONTAINING IN WHOLE OR IN PART THE CHARTER OF THE CITY OF GREENBELT, BY RE-NUMBERING SECTION 72, TITLE "SEPARABILITY" TO SECTION 73, AND BY ADDING A NEW SECTION 72, TITLE "LEGAL DEFENSE OF CITY OFFICIALS AND EMPLOYEES" TO PROVIDE AUTHORITY FOR THE APPROPRIATION OF FUNDS TO DEFRAY EXPENSES AND TO INSURE PROPER LEGAL DEFENSE FOR CITY OFFICIALS AND EMPLOYEES FOR POSSIBLE LEGAL ACTIONS THAT MIGHT RESULT FROM THE LAWFUL PERFORMANCE OF THEIR OFFICIAL DUTIES

The above amendment shall become and be considered a part of the Charter of the City of Greenbelt, Maryland, according to the terms of the amendment, in all respects to be effective and observed as such, upon the 26th day of April, 1977, unless on or before the fortieth day after passage, which shall be the 16th day of April, 1977, there shall be presented to the Council of the City of Greenbelt, Maryland, or mailed to it by registered mail, a petition for referendum signed by twenty percent or more of the persons qualified to vote in the general election of the City of Greenbelt, requesting that the above Charter Amendment be submitted on referendum to the voters of the City of Greenbelt. A copy of the above Charter Amendment Resolution is posted in the Greenbelt Municipal Building in accordance with the requirements of Section 13(d) of Article 23A of the Annotated Code of Maryland, and may be obtained from the City Clerk, 25 Crescent Road, Greenbelt, Maryland, telephone 474-3870 or 474-8000.

# D. Come and P. Birner Set World Record in Marathon

David Come and Paul Birner, seniors at Parkdale High School, have set a world record for one-on-one basketball — going 41 hours and 47 minutes. There had been no previous record for this event, so the boys have set a standard for other record-breakers to follow. This record has been accepted by the Guinness Book of World Records, according to David who spoke long-distance to Guinness representatives in London, England.

The event started on April 1 and lasted until the third. Rev. Birner of the Holy Cross Lutheran Church and father of Paul started the event in the Center School gym with a short prayer asking the Lord to help the boys. The game was high-scoring, but set at a slow pace, since the rules stated that the boys had to take a shot only every two minutes. At the end of each hour the boys were allowed a five-minute break, during which time they could eat, drink, have their blood pressure checked and go to the bathroom. Throughout the game David did a lot of razzle-dazzle shots while Paul played conservatively.

On the third day David was in bad shape and oxygen and smelling salts were used often to keep him from collapsing. At 9:52 a.m. Mrs. Come stopped the game after David had collapsed two times. Each time he was pulled back up. After David was led off the court, he collapsed on a stretcher and taken to the hospital. He was released within a short period. David and Paul each slept 40 hours. David had lost 12 pounds.

Even though the boys did not make their goal of 42 hours, they still set a new record.

The money donated by local businesses and visitors was used to pay for the event—renting the gym, insurance for the gym, shoes, basketballs, Sox, etc. If the record stands until the next printing of the Guinness Book of World Records, Guinness would pay for publication rights. That money would be used to help the boys pay for their college educations.

The Jaycees kept the official records for the game, provided the referees, food and supported the boys all the way. Other donations were made by: 3 Bros. ### GHI Fuel Figures

Fuel oil consumption figures for the winter heating season have been released by Greenbelt Homes, Inc., (see accompanying chart on this page). The greatest savings in gallons of fuel oil consumed per "degree day" appear in the column under frame home large heating plant number 23. Also high in the savings column are the frame home small heating plants.

A quick survey of the improvements responsible for the savings is in order. In the brick homes, variable temperature controls installed prior to the 1975/76 heating season now show even greater savings. The increased heating maintenance staff has been able to keep the plants cleaner and running more efficiently, thus effecting a 16% savings over last year.

Next, pilot projects, converting several small frame home heating plants from steam to hot water again prior to the 1975/76 heating season, were found to be successful. During the summer of 1976 the remaining small steam plants were converted to hot water, thus paving the way for the 29.8% fuel oil savings this past winter. 76 of the 81 buildings that have been converted from steam to hot water have had the floors insulated. Work on the remaining five buildings is expected to be finished soon.

Finally, convinced by the success of the small plant conversions, GHI moved to convert one of its four large plants, number 23. This work was completed before the 1976/77 season thus allowing a "41.8% savings of fuel oil. The remaining three large plants are now in the process of conversion to hot water and should be completed before next fall. In fact, all the major improvements that could be made on the various heating plants will have been completed before the next heating season.

Not listed in the chart, but equally impressive, are the solar heat savings. The solar unit (2 A-D Southway) has been operational since Feb. 7 and achieved a 35.1 per cent saving over the base unit (2 E-H Southway).

### GI Bill Eligibility Extended Nine Months

Many former servicemen and women in the Greenbelt area may be eligible for a new Federal benefit that allows them additional GI Bill entitlement. ### Prince Georges Schools Name Title IX Coordinator

Goldstein worked on several nationwide efforts in which attempts were made to bring schools and their communities closer together. He has traveled throughout the country, visiting schools in Maryland, Connecticut, Florida, Utah and Iowa, where school community outreach programs were underway. He was responsible for monitoring and reviewing the local programs and providing technical assistance when necessary.

In addition to his Title IX responsibilities with the Prince Georges schools Goldstein also conducts training sessions and workshops for the school system staff in the areas of community and human relations. Part of that "in-service" training for faculty and administrators is aimed at developing them to better respond to problems which may arise in their schools.
