Preview of Hot City Election on Sept. 18 As Council Struggles With Overpass Issue

Temperatures in Greenbelt during the "dog days" of August will probably be the hottest in the Washington area. A unique combination of weather and a sizzling upcoming city council election is expected to contribute to the record-breaking highs.

City Manager James K. Giese, the first to feel the effect, told council on July 30, "You tossed me a hot potato" on the overpass. On July 9, council directed the staff to draw up a citizens advisory question or questions on the issue.

"I tried to write something that was not biased," he explained, "and first came up with a question two typewritten pages long. It is difficult to put a question on the ballot that is short and has adequate description."

Council members thought Giese's final draft was well prepared and, with some refinements, Mayor Richard Pilski and Councilmen Richard Castaldi and Thomas White were ready to ask the electorate to vote "Yes" or "No" on: "Should the city continue to proceed to acquire by condemnation an easement through private property located in Greenbriar Condominium's Phase I, in order to provide access for a pedestrian-bicycle overpass across the Baltimore-Washington Parkway at the location near the end of Gardenway selected by the majority of the city council and approved by the Federal government?"

Original Decision

(In May 1978, after many months of hearings on the overpass alternative locations, Councilmen Charles Schwan, Gil Weidenfeld and White voted for the Gardenway "preferred route." They considered it the best in terms of direct route, actual use, public safety, lower cost and optimal topography. Opposed were Pilski and Castaldi who supported the Mandan Road location, running from Hamilton Place east to Mandan Road between Greenbriar Phase II

and III. They were against using .09945 of an acre of private land, most of which is an 8-foot path in the median of the parking lot between 7716 and 7718 Hanover Parkway in Phase I. Generally speaking, Phase I residents opposed the Gardenway site; Phase II opposed the Mandan location.)

Wants Choice

Reiterating their support for the Gardenway location, Schwan and Weidenfeld had no quarrel with the question drafted but thought the alternative of the Mandan Road overpass should be included to give council maximum guidance. This would be responsive, they said, to Greenbriar Phase I owners' request for an advisory question that would include alternatives.

"Suppose we get a 'No' answer on the question," said Schwan, adding "... we would be in no position to get an overpass ... If we're going to ask for advice, it ought to be meaningful."

Weidenfeld was concerned that "it could appear to many people that they would be voting for or against an overpass ... this would be their only choice ... I'd like to see people have a choice ... to see whether the position of the city council is largely supported." He offered a second part to the question:

"Should the city support a pedestrian-bicycle overpass across the Baltimore-Washington Parkway at the location near the end of Mandan Road in Greenbriar?"

Weidenfeld's amendment was supported only by Schwan. All members of council then voted unanimously for the original question, with Schwan reserving the right to change his mind after studying the matter. "I'm concerned about a negative vote on the question," he said.

Mandan Road overpass supporters Pilski and Castaldi said they were against the amendment including the Mandan location, because the majority of council supported the Gardenway site.

Pilski said, "Council listened to a lot of testimony and attended hearings ... I didn't support Gardenway then and I don't now ... I

still support Mandan."

Castaldi also felt there was no need for the amendment. "Council has taken a position which the majority support," he said, "this tells the story pretty much ..."

Confusing

White, a Gardenway supporter, thought the two questions would be confusing because of the various "combinations and permutations" that could result. He also believed that placing the Mandan location on the ballot would be "raising false hopes to a group of citizens" because the Federal government rejected the Mandan location and favored a Gardenway overpass. He noted that he might have been persuaded if the government thought the Mandan site had merit, "to get an overpass in a timely fashion."

William Ayers, president of Phase I, speaking as an individual, countered, the Federal Highway Administration said "Gardenway was the only one, but if the electorate votes for Mandan, we will have additional ammunition and will use our persuasive powers just as the citizens did when they went to Congresswoman Spell-

Christacos-City Agree On Sidewalks, Parking Waiver In Center Rezoning

In its consideration of a rezoning petition for the center mall by owners, George and Lisa Christacos, council has been concerned about sidewalk upkeep and parking facilities. At a special council meeting July 30, council authorized Mayor Richard Pilski to execute an agreement about parking and sidewalks thus moving closer to the solution of the "oldest problem" city solicitor Emmett Nanna could recall during his twelve years of service to the City.

At an earlier council meeting on July 16, City Manager James Giese informed council of the progress of the rezoning applications which would rezone the shopping center to C-S-C (Commercial Shopping Center) from R-P-C (Rural Planned Community). On June 29, the Zoning Hearing Examiner recommended approval on the condition that the city and property owners establish a continuing agreement to assure the required off-street parking. The recommendation was sent to the District Council for action.

In his agenda notes, Giese ex-

plained, "While I believe that the decision is intended to be helpful to the city, I do have some concerns about how it may be worked out in detail." Thomas Gentile, Christacos' attorney, felt it was better to get the property rezoned unconditionally. To do this an agreement on parking facilities and a sidewalk easement was drawn up by the attorney and city staff. A request for an oral presentation before the District Council has been filed. The request will be made that the condition of a parking agreement be removed on the grounds that the agreement has already been made.

The question of sidewalks has long been connected with city approval of the rezoning petitions and parking waivers. Council is concerned that the sidewalks be kept in better repair. To do this, council had suggested that they be dedicated by Christacos to the city. However, Christacos cannot get approval for mandatory dedication so he has offered the city an easement. One advantage of an easement, Giese explained, was that it could be removed more easily if there was ever a need in case of major remodeling of the center. Christacos has agreed that the sidewalks will be improved and he will

pay for the improvement through a special assessment not to exceed \$25,850.

In return for the easement, the city will allow Christacos to use 340 parking spaces in the center. Nanna pointed out that the spaces, which Christacos is already using, will not be used exclusively by him. The city will still be responsible for the upkeep of the parking lot and sidewalks after they are brought up to standard. One major stumbling block is the shortage of parking spaces available to meet county requirements. These requirements are for 915 parking spaces for all the center usages including Christacos. There are 356 spaces. As part of the agreement, the city will support Christacos' position for rezoning and any necessary parking waivers up to 340.

Councilman Richard Castaldi was concerned that the agreement gave the owner carte blanche. Councilman Thomas White also felt that "this agreement binds the city to support future uses. I don't like the blank check," he said. Nanna stated that much of the agreement came from the requests of Park and Planning. However, council did delete the words "of the exist-

City Elections Sept. 18 To Include Referendum

At a Board of Elections meeting of August 8, a drawing was held to determine the order of candidate's names on the ballot. The order is as follows: Charles F. Schwan, Gil Weidenfeld, Richard Ley, Konrad Herling, Thomas X. White, Richard Pilski, Richard Castaldi, and Jeanette Gordy.

Incumbents Richard Pilski, Richard Castaldi and Thomas X. White and newcomer Konrad Herling filed their nomination petitions with the city clerk this past week. The deadline for filing was August 6.

In the city election, September 18, registered voters will select five members to serve two years on the council. In addition there will be one referendum and probably one advisory question on the ballot.

Up for referendum will be the approval of a new section to be added to the City Charter providing for revenue bond financing for the rehabilitation of existing structures within the city.

At its meeting Monday night, council is expected to place an advisory question on the ballot concerning the city's acquisition of private property in Greenbriar Phase I to provide access for a pedestrian-bicycle overpass across the Baltimore-Washington Pkwy.

Voter registration will continue through Monday, August 20. Residents may either come to the city offices Monday through Friday from 8 a.m. to 5 p.m. or call the city clerk's office, 474-3870 or 474-8000 to request a form to register by mail. Persons may also register in person at the Springhill Lake and Greenbriar community houses and at the Greenbelt Homes Offices. (See City of Greenbelt Voter Registration ad for days and times.)

The biographies of incumbents Charles F. Schwan and Richard Pilski follow:

Schwan

First elected to council in 1971 and re-elected in 1973 and 1975, Charles Schwan's prior service to the city includes his having been chairman of the committee which recommended setting up the Advisory Planning Board (1959-60), member, Charter Review Committee (1966-67), and chairman, Indoor Swimming Pool Committee (1971). During his tenure on council, Schwan has been a member of the Land Use Policy Committee, Metropolitan Washington Council of Governments. He served as a member of the Greenbelt Bicentennial Committee and the Advisory Committee on Housing for the Elderly.

A member of the Greenbelt Homes, Inc., Board of Directors from 1963 to 1971, Schwan served as president from 1964 to 1970. His other community activities have included his being a member of the Steering Committee, Citizens for a Planned Greenbelt; co-chairman, Greenbelt Freedom of the Press Committee; and chairman, GHI Advisory Committee on Housing for the Elderly.

Schwan received an A.B. degree from Hiram College, and did graduate work in political science at Syracuse University. There he was variously a Graduate Teaching Assistant, Fellow, and Instructor in the Maxwell School. He served in World War II until discharged a captain in 1945. He was Washington Representative of the Council of State Governments from 1952 to 1962, when he became Director of the Council's Washington office.

At various times during these years he served as principal staff aide to the National Governor's Conference on intergovernmental aspects of roads and highway safe-

ty, corporation taxation, natural resources and environmental health. In 1968, he became a partner in Wendell and Schwan, Consultants on Governmental Affairs. The following year he joined with others to form Environments for Tomorrow, Inc., a consulting firm organized to assist public and private entities in meeting environmental requirements. In February 1973 Schwan retired from both firms.

Schwan is a former member of the National Committee on Uniform Traffic Laws and Ordinances; the Advisory Council on Police Training, International Association of Chiefs of Police; and Advisory Committee on Air Pollution Control Grants, U.S. Public Health Service.

Schwan participated in drafting the Water Resources Planning Act, and the Multistate Tax Compact. He is the author of articles and reports on federal-state relations, federal grant-in-aid requirements, multistate taxation, highway safety, and radiation protection.

Schwan has lived in Greenbelt for 26 years, first at 7A Crescent Road and, since May 1977, at 20T Hillside Road. A widower, he has three children. Charles lives in Lanham with his wife Betty and four children. Paul resides with his wife Connie at 7A Crescent Road. Peggy lives in Washington.

Pilski

Richard Pilski served four terms as Mayor with another four terms as councilman. He has been a resident of Greenbelt for 20 years. A native of Kingston, Pennsylvania, he lives in Boxwood Village with his wife, Claire, a Registered Nurse, and three children, Richard, Jr., Nancy, and Chris. He has been employed as tax representative and consultant for Prentice-Hall Inc. for the past 21 years.

He is also a member of the faculty, Prince Georges Community College.

Pilski attended King's College, Wilkes-Barre, Pennsylvania, and holds a B.S. degree in Business Administration from Syracuse University. He is a member of the Lambda Chi Alpha Fraternity. He also served three years in the United States Navy.

Pilski is on the National League of Cities Transportation Committee. He has served 8 years on the Council of Governments' Board of Directors and the Energy Policy Committee. Previously, Pilski has represented Greenbelt on the Prince Georges County Tax Differential Committee, the Executive Committee of the Maryland Municipal League, and the Environmental and Public Safety Committee of the Council of Governments.

Locally, he has served on the Charter Review and Advisory Planning Board, Committees of the city; board of directors of Greenbelt Credit Union, Manager of Minor Leagues; and President of the Lakewood Citizens Association.

Pilski is currently active in the Greenbelt American Legion and the V.F.W. He serves as a citizen counselor to the Prince Georges Boy Scouts and to the Greenbelt troops.

In Response To the Editor:

In the August 2 issue of the News Review, Eunice Coxon indicates that more than half the members of Greenbelt Homes have chosen not to sign the subordination amendment to the Mutual Ownership Contract. It is true that as of the date this issue of the News Review goes to press, 818 members have neither signed the amendment nor a new contract which contains such a subordination. Those 818 are 16 more than half the members of GHI. However, neither Mrs. Coxon nor I know how many of those have "chosen" not to sign and how many are just lackadaisical, have lost their copy of the amendment, or just think that things will turn out all right and we will have the rehab program whether they sign or not. How many have consciously chosen, after getting legal advice we do not know. I do know that some have signed after receiving such advice and some have not.

I am shocked, however, that Mrs. Coxon would criticize the News Review for giving an editorial opinion on an issue of great interest to its readers. I am not surprised that she should disagree with the position taken editorially, but I am surprised that she should object to the publishing of any editorial which reflects the position of the board of the paper.

As to her criticism of the board of directors of GHI, she speaks truly when she says they have been struggling with rehabilitation since 1972. I was on the board from 1972 to 1974. A small group of dissidents has worked constantly and loudly from then until now to oppose any constructive action taken by any board. Those who recognized the need for rehabilitation knew that most of the board also recognized it, so they stayed home from board meetings in droves. Those who opposed were present at every meeting. That the boards during that time and since have persevered is to their credit.

They have produced a splendid package, with the help of committees and the hard work of management. The danger we are in because of present and future oil shortages and rising prices should prompt us all to encourage them and cooperate with them.

man (to get funds for an overpass...) He favored a question that included both the Gardenway and Mandan locations to "bury the issue once and for all."

White suggested there might be another way of getting public input without having the question placed on the ballot. "A written questionnaire... asking do you favor this... or that... won't have the problem of permutations..."

Delay

It could take a year before the city's condemnation case is brought before a judge and jury. Proceedings were filed in February 1979. Weidenfeld said he was hopeful that, by including the Mandan route in the question, Phase I owners will be willing to reach an accommodation with the city if the voters choose the Gardenway location.

At previous meetings, Phase I Board members indicated that, if their requests for an advisory question were met, they would work for such an accommodation to avoid the expense of a long drawn out court battle.

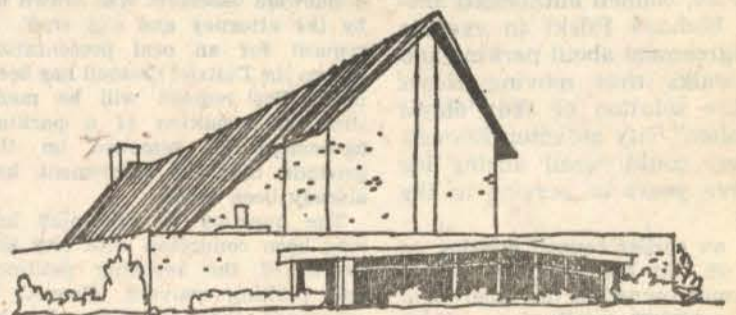

ing use" in the phrase "provided, however, that parking requirements of the existing use do not exceed 340 spaces in the aggregate." This made the agreement more acceptable and council passed a motion to support it.

At the July 16 council meeting, many individuals felt parking facilities in the center were adequate for the present usage. Citizen Ed James echoed the thoughts of many saying that a high percentage of

shoppers walk to the center or stay for only twenty minutes. He felt that people should not be encouraged to drive and park at the shopping center. On July 30, Nanna reminded council that the center was a marginal operation and "it would behoove the city to encourage decent use; with the fuel shortage, these small centers might eventually make a comeback."

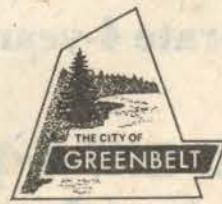

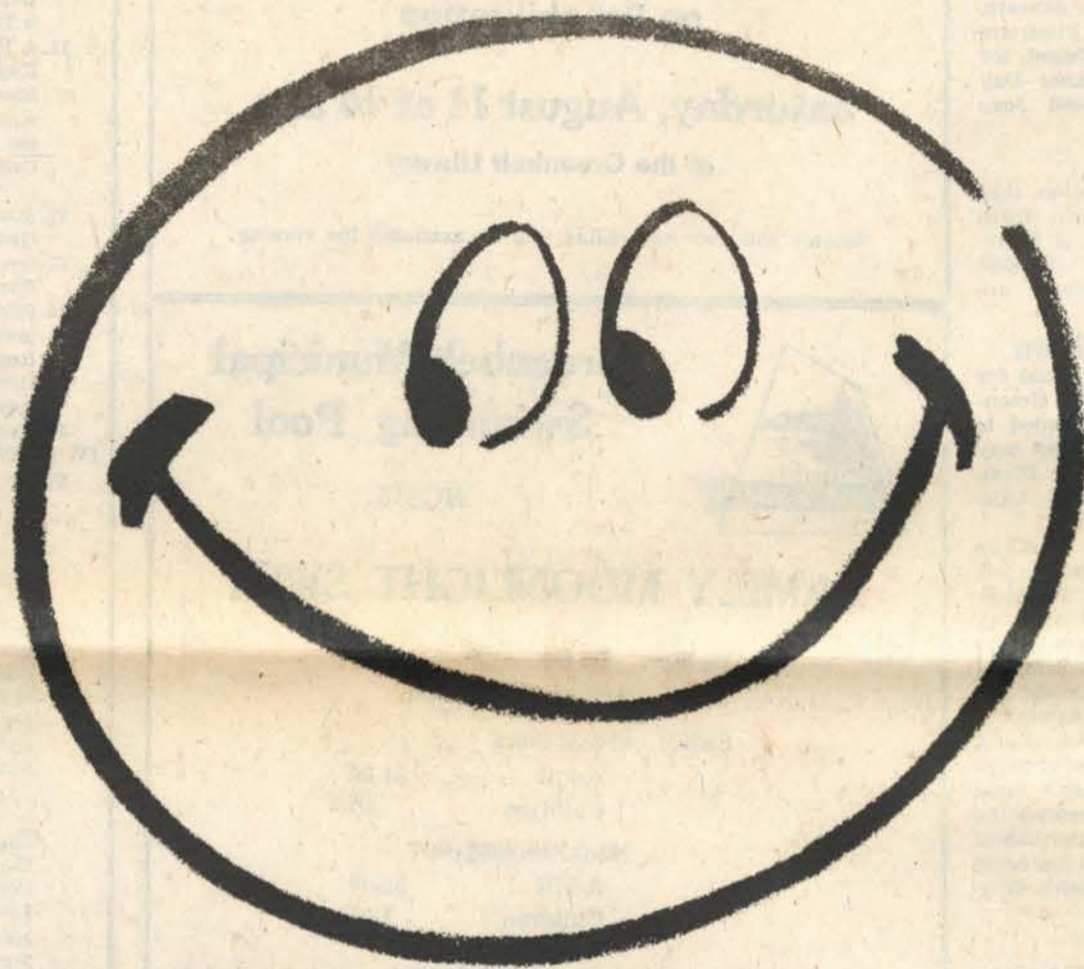

Metro Rail System To Be Completed

The Metro Board on Thursday, July 12, unanimously adopted a construction and funding program for completion of the 101-mile regional Metro rapid rail transit system.

Key to the program is enactment of a bill pending in the House of Representatives which authorizes \$1.7 billion for the completion of the system. A vote on the House floor passed Monday, July 16. The resolution now goes to the local governments for review and enactment of funding plans covering the first two years of construction.

The funding and construction program calls for completion of the last 40 miles of the system in the next nine years. The schedule provides for the completion of the green/yellow line to Greenbelt in early 1990.

Greenbelt Auxiliary Elects Officers

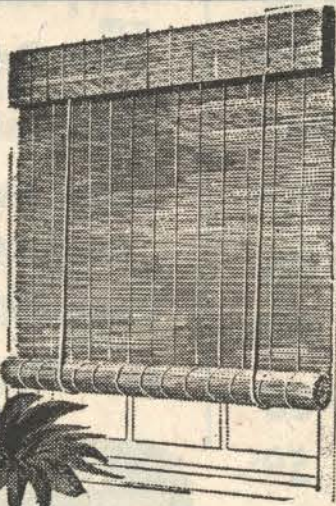

CITY NOTES

The general crew is patching base on Crescent Road. The base on Lakecrest is completed. Debris left by last week's storms was cleaned along the streets and underpasses.

The building maintenance crew has completed the railing on the new addition to the Firehouse.

The Springhill Lake golf course is in a state of disrepair due to the installation of W.S.S.C. sanitary sewer line across the fairways. The summer park crew is finishing the landscaping on the peninsula.

The Parks Crew has completed installation of playground equipment at the following Community Development Block Grant funded sites: Park #2 at 12 Crescent, Park #6 west of 1 Southway, Park #11 at 2 Eastway, Park #15 at corner of Plateau and Ridge, Park #16 at 73 Ridge and 15 Laurel Hill at the entrance of the city's perimeter trail. Nine additional sites will be improved during the month of August.

Potholes were repaired throughout the city. Line painting was done on various parking areas in the city.

The building maintenance crew has been concentrating on work at the city office building and the Recreation Department facilities.

The general crew reset inlet basin tops and raised inlets at curb line on Crescent Road curb and gutter project, and also finished excavation for curb and gutter from Parkway to Gardenway.

Monuments and reference markers on perimeter trail boundary lines (including end of row points for Laurel Hill and Plateau Place) were set.

The new playground equipment is being installed by the parks crew. The first piece is being installed at Laurel Hill Park (perimeter trail), and another placed on the Westway playground.

Joseph Alucio has been hired as a mechanic. Barbara Watson, a part-time summer employee, is now a full time building maintenance employee. Frederick Altire is the new summer crew leader.

CARES

For the month of July, 50 counseling sessions were held (exclusive of the July 4 clinic which was cancelled for the holiday) involving 96 individuals, 36 of whom were under age 18.

Johnnie Franklin has accepted the Youth Supervisor position with CARES and will begin employment August 13. He has had extensive experience working with volunteers in a hospital setting, has served as an assistant manager of a savings and loan institution and taught in the public school system.

Motorcyclists Need Goggles

The Motor Vehicle Administration today notified all law enforcement officers that the Maryland vehicle laws still require motorcyclists to wear protective eye devices approved by the Administrator.

"Even though the helmet requirement was repealed by the legislature with regard to adult cyclists,

the eye protective device is still required unless the motorcycle is equipped with a windscreen," Motor Vehicle Administrator William T.S. Bricker said.

Bricker noted that minors who operate or ride on motorcycles must still wear helmets. Since the new law went into effect July 1, ten motorcyclists have died as a result of accidents; seven without helmets.
