## State Funding of Youth Services Bureaus Threatened in Wake of Reagan Budget Cuts

A proposal averted last October to cut state funds for Greenbelt CARES and similar Youth Services Bureaus in other Maryland communities has resurfaced this summer. With the city budget adopted long ago and the new fiscal year already a week into its span of accountability, such a reduction at the state level could cause serious problems for the highly regarded local program.

The first sign of possible problems came in a directive by Governor Harry Hughes to all cabinet secretaries, asking them to indicate the priorities within their respective departments if it became necessary to trim their budgets by 3% during the current fiscal year. Such an eventuality was seen as probable as the Reagan administration's budget axe cut more and more deeply into funding for social programs. Maryland is expected to lose \$200 to \$215 million in Federal funds.

On June 26 Jack Kent, Assistant Secretary of Administration for the state Department of Health and Mental Hygiene (DHMH), informed his subordinates at the Juvenile Services Administration (JSA) that the entire budget line for the Youth Services Bureaus was marked for possible elimination. Kent informed JSA Deputy Director Jesse Williams that while DHMH was "not insensitive to the impact of the proposed cut," such an action would be "consistent" with the reduction proposed last October.

Word of these actions first reached Greenbelt in a phone call to the city manager from state delegate Gerard F. Devlin. Devlin expressed his own concern about withdrawal of support for the CARES program in a July 1 letter to Gov. Hughes.

Five days later Greenbelt Mayor Gil Weidenfeld also sent Hughes a letter and another to cabinet secretary Charles R. Buck, Jr. of DHMH. In his letters Weidenfeld noted that CARES funding from the state amounts to \$52,300 and that the city's recently adopted budget reflects that commitment.

"Therefore the City's ability to make up for the loss of State funding from other sources is severely limited," Weidenfeld noted. "It is too late, for example, to increase our property tax rate."

Apparently the governor's office has been feeling a good deal of similar pressure from constituents and legislators. The governor's press secretary, Lou Panos, referred to "an avalanche of pressure and calls from Youth Services supporters." And on

July 7, Delegate Devlin was informed that the governor is considering rescinding the decision to cut DHMH because of the serious cuts that department had already sustained. "There's a glimmer of hope," Devlin told the *News Review*.

Panos described the process as "excruciating" of "looking at the needs and requirements of constituency groups with terrible problems to be solved by government against the limitations that the results of the Reagan budget requires.

"It's like a school with 1,000 kids each having lunches . . . then 100 lunches are taken away and it ends up with 900 lunches being divided among all the kids."

Why were the Youth Services Bureaus (YSB) singled out by JSA to have their state funding withdrawn rather than merely cut 3%? Several theories have been expressed: 1) that since their employees are not classified within the state civil service system, fewer safeguards protect them and they are easier to drop; 2) that YSB's are seen as peripheral to the JSA operation, not "within" that system; 3) that YSB's reflect "soft services" — prevention rather than the training school or punishment model, which is more visible.

A fourth theory has it that the Maryland Association of Youth Services Bureaus has previously shown political strength and the ability to survive. Possibly DHMH pre-selected a program best able to fight its own battle.

The battle in any case, seems to be on.

## Greenbelt CARES Accomplishments

The current threat of withdrawal of state funding for Greenbelt CARES has brought into the foreground the question of what this organization has come to mean to the community. It is not easy to place a value on a service like CARES—particularly in the kind of quantitative terms that constitute the language of budget analysts. How can you put a dollar value on the improved quality of life for members of a troubled family whose destructive behavior has been turned around? Even when part of that turn-around includes a new financial stability?

Some quantitative analysis for CARES is, however, available in a report prepared this spring for the calendar year 1980. The figures in the first paragraph of the report are stunning: in the eight years since CARES was founded, juvenile arrests by Greenbelt police have dropped from 370 for 1973 to 90 for 1980. "We think," the report states, "that a major ingredient . . . has been CARES, which provides a preventative program accessible to the community and most available to those in need of its counseling and support."

The report, prepared by Behavior Service Consultants, Inc. (Molly Schuchat, Leopold Walder, and Rowell Hoesman) also credits demographic changes, attitudinal changes by both community and police, and other juvenile service programs (including "a fine police Juvenile officer") with contributing to the decisive drop in juvenile arrests.

## Council Not Happy With New Fire Dpt. Command Structure

In a work session on June 30, the Greenbelt city council met with representatives of the local Volunteer Fire Department and Rescue Squad (GVFDRS) to hear their views on a recent change in County rules governing the chain of command at the scene of fires occurring during the day. According to an order issued by County Fire Chief M. H. Estep in May, the area battalion commander takes command of a fire scene in the absence of the volunteer chief or deputy chief of the "first due"; that is, geographically nearest, volunteer fire department. This order changes the previous command sequence which had placed any volunteer fire chief or deputy chief, in order of proximity, in command of a fire scene before command would fall to the battalion commander, a paid career officer.

The effect of the rule is exacerbated in a jurisdiction like Greenbelt which covers a wide area. For example, the Greenbelt fire department is not "first due" at a fire in Springhill Lake since the Berwyn Heights department is closer. Therefore, assuming the Berwyn Heights volunteer chief or deputy chief were not present at a fire in Springhill Lake, the area battalion commander would assume command even in the presence of the chief or deputy of the Greenbelt department despite the fact that Springhill Lake is in Greenbelt.

Deputy County Fire Chief Walter Lanier and Bureau Chief Stan Poole, presenting the County point of view, explained that the rationale behind the change in command structure centers on giving the battalion commander more opportunities to utilize his professional training by commanding an emergency scene, eliminating possible confusion about who is in charge and giving the paid firemen, who usually work the day shift, assurance that they would know who was in charge and that command would in most cases rest with one of their number. However, GVFDRS Deputy Chief William F. Dunn took issue with the implication that there had ever been confusion over who was in charge, saying that the command hierarchy had always been announced by radio at each fire according to established rules.

The new rule applies Monday-Friday, 7 a.m. to 3 p.m. Outside those hours command is assumed by volunteer chiefs and deputy chiefs in the old order of precedence. Greenbelt Volunteer Fire Department and Rescue Squad Chief Michael W. Dutton pointed out that this gives the appearance that he is somehow qualified to command a fire scene after 3 p.m. but not before. In fact, he indicated, volunteer officers are equally qualified and as thoroughly trained as career officers.

### Council Reaction

Councilman Thomas White


summed up the new order by saying that the intent seemed to be to increase the opportunity for the career officer to be in charge and to decrease the opportunity for volunteers to be in charge. Accepting this formulation as basically correct, several councilmen expressed concern about the effect of the new rule on volunteerism. Councilman Richard Castaldi feared that the volunteer spirit, so strong in the local fire department and rescue squad, would be eroded by what is perceived to be a downgrading of their prestige. Councilman Charles Schwam pointed out that the only remuneration the volunteers get is the knowledge that they have been of service and that it is very important that nothing be done to diminish that feeling of reward.

Greenbelt officials and fire department representatives and the County spokesmen agreed that it is very difficult to run a department which includes both paid firemen and volunteers. While both groups have the same goal—the best possible fire protection—there may be vested interests in the two groups which are difficult to reconcile. Deputy Chief Lanier said that County Fire Chief Estep did not want to make a difficult situation and was currently conducting a series of meetings with a committee of the Volunteer Firemen's Association to work on problems being created by the order. He expected to make adjustments as needed.

To underline the city's concern, council agreed to put this subject on the agenda of the next regular city council meeting and to consider what, if any, steps the city wishes to take to support the local volunteers' position.

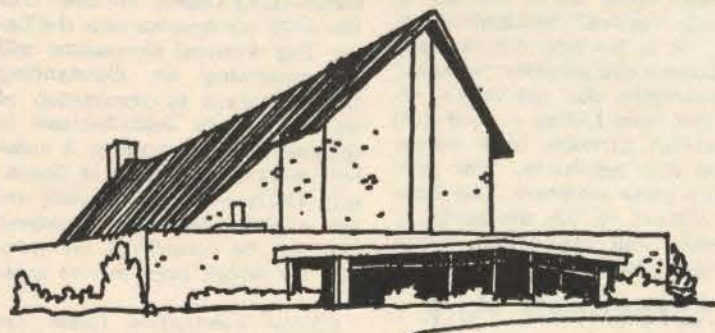

## Police Blotter

A case of indecent exposure occurred on July 3 in a wooded area west of 135 Crescent at approximately 3:15 p.m. The suspect is a white male, about 18 years old, 5'10", medium weight, with brown hair, wearing light colored pants and sports shirt.

Sgt. Ceccarelli has arrested a suspect in an armed robbery of the ARCO Mini-Mart located in Springhill Lake. The robbery took place last January. The suspect, a Landover resident, was charged with robbery.

Just before the 7 p.m. closing time on June 29, the Mr. Foto booth located in the parking lot of Beltway Plaza was robbed of cash at gunpoint. The suspect is a black male in his 20's, approximately 6 feet tall, weighing about 170 pounds, with brown eyes and medium-length black hair combed flat against his head. He was wearing green, possibly fatigue, pants, a white pullover shirt and low-topped tennis shoes.

A woman reported that while she was shopping in Beltway Plaza a man approached her and offered to sell her a TV set for \$50. The man appeared to be a salesman. She accepted the offer and gave him the money in cash and he told her that he would meet her in the rear of the shopping center. When he did not show up, she called the Police Department. The suspect is a black male in his 20's, approximately 6 feet tall and 170 pounds, wearing green pants and white T-shirt.

Upon receiving a call concerning tampering with an auto on Springhill Drive on July 1, Officer Cancelose arrested a suspect and charged him with theft of auto and tampering.

In a similar case, Officer Lynn apprehended one of three male juveniles and charged him with tampering after he was observed going into a parked vehicle on Cherrywood Lane on July 2.

# GHI Board Unanimously Approves Co-op Bank Loan; Staff Gives Rehab Progress Report

In a long meeting, the Greenbelt Homes, Inc. board of directors authorized closing on the National Consumer Co-operative Bank (NCCB) loan, heard a rehab update report, and began planning the next phase of rehab. The new assistant manager, Shekar Narasimhan, was introduced.

## NCCB Loan

President James Smith reported on the June 29 meeting held with NCCB representatives. He related the NCCB desire to go to closing on the loan soon. A spirited discussion followed.

Reading from a lengthy written statement, Ben Abramowitz objected to the loan as subordinating the mutual owner's interest in his home. Eunice Coxon decried what she termed a "revolving loan" of a limitless nature. Smith explained that any additional loan amount above that already approved by the membership would require additional membership approval. Member Bruce Bowman expressed the high esteem in which he holds the NCCB. Speaking as the head of the Greenbelt Cooperative, he said Co-op had experienced an amicable relationship with NCCB, when it had borrowed from the bank.

Member Ed James asked whether GHI could use any of the loan funds to assist Twin Pines in lending mortgage money. Smith replied no not now. General Manager Tim Mitter, in answer to a member question, said that there was no agreement with NCCB that a certain percentage of GHI units must be low income. He cited this as an improvement over other sources of loans that had been considered.

Member Joe Comproni said that the time provided to study the NCCB loan proposal was inadequate. While agreeing that more time would have been desirable, Smith reminded Comproni that the proposal had been under discussion for some time. Further, he related that the letter of commitment from NCCB runs out on July 9, and that the NCCB officials who must approve the loan will be away beginning next week. The second reading and final passage of the authorization would have to be approved that evening, he said. Smith responded to Coxon's earlier comment saying that the proposed loan is a closed one, not a revolving loan.

Director Frank Gervasi reminded all that borrowing money for rehab has been approved on numerous occasions. Director Steve Curtis said that monthly charges will lessen after rehab.

Director John Lewis moved for the second reading of the NCCB loan agreement. Abramowitz interjected that GHI can get a majority of members to approve anything, saying that "they drag in" 200 or so members to vote at membership meetings. The motion passed unanimously. Gervasi's motion to authorize the officers of GHI to execute the loan documents was also approved unanimously, thus authorizing the corporation to borrow \$13,677,978 at 13.5%. Mitter said the loan would be closed some time this week.

## Rehab Update

Commenting on highlights of a staff-prepared progress report on Phase I frame rehab, Mitter related that the plumbing, and roofing and attic work are over 80% complete. The quality of work has improved. Electrical wiring is proceeding with no major prob-

lems; county inspection is up to date, finally, he reported. Structural repair is 98% complete; work is being accelerated on this item. The quality of work is considered to be good.

A member complaint that tarpaper is blowing off a unit will be investigated. Gervasi said that the required one-day notification to members before work begins on their units, is being neglected by some contractors.

Mitter also reported that the contractor installing the windows is doing a good job. Almost all crawl space work has been done.

Insulation of sidewalls and attics is 89% complete. Gervasi said that the first installations of insulation were blown in too loosely, causing empty spaces to develop when the insulation settles. The insulation is being packed in more firmly now. Smith asked management to develop a method of ascertaining the degrees of settling and remedial steps that need to be taken.

## Planning

When attention turned to the planning stage of rehab, there was much discussion of siding color. Some members felt that another, final, last survey of member siding color preference was in order. Management said final choice of colors should be made after an installation contractor had been chosen. Otherwise, GHI would be "locked into" a particular brand, potentially raising the cost as distributors of other brands would have no incentive to bid. Siding color will again be on the agenda of the July 23 meeting.

Because all specifications for rehab contracts under Phase II must be approved by NCCB before any contracts can be let, management requested policy decisions from the board. Curtis' motion to authorize staff to engage the Columbia Design Collective was approved.

Management outlined guidelines on window rehab. The money GHI has borrowed can't be used to install double hung windows in masonry or brick homes because the Maryland Historical Trust disapproves. Individual owner installation of such windows is not prohibited. Fifteen to twenty per cent of brick and block homes have individually installed new windows, or rehabbed the original ones. Staff will bring suggestions on window specifications to the July 9 meeting.

Mitter said that the frame home siding will be completed within 12 months. He hopes to have the heating conversion done within 12 months, also. Management will bring suggestions on heating conversion to the next meeting.

Board member Margaret Ho-

gensen recommended that staff prepare rehab update report for the membership on a fixed schedule.

## Objections to Procedure

Several members protested the current method of handling members wishing to speak on matters not on the agenda. In answer to director Joe Jenkins' question, Smith indicated that he plans to continue taking names of members who want to speak, prior to the member comments portion of the agenda. Curtis objected to the procedure.

At the beginning of the meeting four board members — Curtis, Donaldson, Lewis and Jenkins voted against approval of the meeting agenda because they do not approve of the way meetings are being conducted with respect to visitors and members portion of the meeting. The agenda was approved on a 5 to 4 vote.

Smith then recorded the names of those who wished to speak: Eunice Coxon, Joe Comproni, Betty Dietch, Ed James, Sylvia Rosen, Jerry Dancis, Evelyn Feller and Charles Schwan.

Comproni criticized the member comment procedures and Rosen objected to the rules proposed by the Audit Committee concerning member participation at Board meetings. Audit Committee member Bettie Denson added that she has now prepared a minority report. Betty Dietch stated her preference for a "town meeting" approach to board meetings.

Ed James wanted the buying back of the newer townhouses on the agenda of the next meeting.

Dancis spoke of his desire to rent his townhouse to a group of unrelated persons. The matter will be handled on July 9.

Expressing concern about the previous week's vote against siding and insulation for the masonry homes, Schwan said he would submit to the board a list of questions about that decision.

nile arrests.

In terms of quality of staff and their reimbursement, the city of Greenbelt and the state—the jurisdictions supporting CARES—have been getting a bargain. Many CARES counselors, the report notes, are "professionals who volunteer their time to engage in therapeutic interventions that they are elsewhere paid to make." Some hold PhD's in psychology; all are licensed psychologists and social workers. All, furthermore, are supervised closely by expert practitioners. If paid, the time contributed by these volunteers would last year have cost the state \$30,000.

Besides clients helped through the counseling services of CARES, the youth services bureau provides a GED program through which young adults are enabled to earn a high school equivalency diploma. Fifty percent of those enrolled have reached this objective; only one-third of enrollees have also been CARES counseling patients. In other words, the GED program extends the bureau's outreach into the wider community.

How wide is this community? Over the eight years of CARES' existence, 61% of those served have been Greenbelters. College Park residents account for another 10%, and most of the remaining clients have been drawn from Beltsville, Landover, Lanham and Riverdale. The largest number (41%) of participants have been self-referred into the program. Others have been referred by school personnel, the state Juvenile Services Administration, social service and medical practitioners and by the Greenbelt police.

Although single and married adults avail themselves of help provided through CARES, 85% of the cases involve families with children—a figure that appears to support Behavior Service Consultants' claim that CARES counseling may have been a decisive factor in lowering the juvenile arrest statistics in Greenbelt. The three major categories of problems dealt with have been personal problems such as addictions and phobias (19%), family problems such as fighting (49%), and school problems such as truancy or academic failure (14%).

Over the eight-year span, 42% have successfully completed counseling, 34% have dropped out, and 24% have moved away or been referred to other agencies.

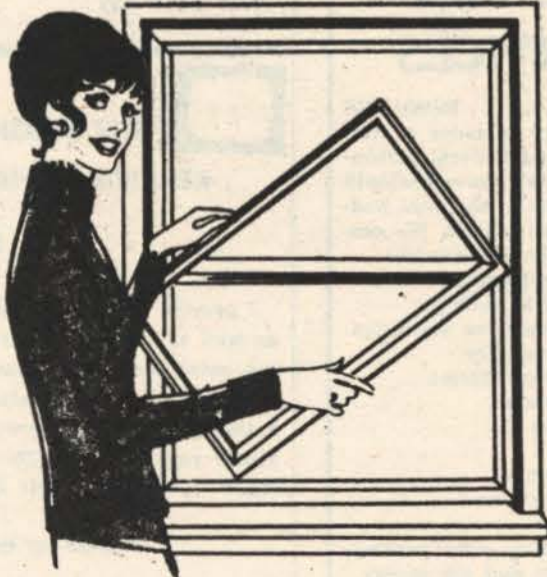
