Bram Withdraws; Zugby Appointed

Robert Zugby now occupies the fifth seat on Greenbelt's city council. He was selected by unanimous vote of the four incumbent members during the council's regular meeting on Monday, February 7, after Antoinette (Toni) Bram withdrew herself from further consideration for the position. Bram's action served to break the impasse over a successor to Richard Castaldi in which council had locked itself for the past several weeks.

As soon as mayor Gil Weidenfeld opened the subject of the council vacancy, Bram asked for recognition and read a prepared statement to council in which she announced her withdrawal. (The complete text of her statement is printed below.) Weidenfeld, and then councilman Edward Putens, each said that he would now switch his support to Zugby, while mayor pro tem Richard Piland councilman Thomas ski White each reaffirmed his earlier choice of Zugby. At that point, the formal vote became a unanimous formality.

After being sworn in by Weidenfeld, Zugby paid tribute to the other candidates for the vacancy, "with special mention of Toni Bram, who has given much evidence of her devotion to the city for many years," and who, he continued, had evidenced that devotion again in withdrawing. Zugby took note of his own previous statements that he thinks he is well qualified to serve on council. But, he concluded, "I've never served on a city council before. I have a lot to learn. Let's get started."

"Heavy Metal" Music Returns to Utopia

The show starts at 8:15 p.m. (Ed. note: Following is the complete text of the statement made to council by Antoinette (Toni) Bram in withdrawing herself from further consideration for the council vacancy.)

"Gentlemen, the time has come for some plain talk. The past few weeks have been very encouraging for me. I have been gratified by the support of many outstanding citizens. But it was also disappointing to me when their wishes were not heeded by all' of council. Community support is something which in Greenbelt is apparently only effective at the polls. I have been astonished that in spite of that support I have not received any feedback from two councilmen. But I harbor no anger towards them. Two other councilmen, Mayor Weidenfeld and Councilman Putens, have been courageous in their support of my candidacy. Strong men do not fear adversity and their continuous support for me as a qualified woman candidate since the beginning is an indication of this.

"To put the community through an election in April or May when there is another election due in September will be expensive and disconcerting. Meanwhile, there is the long tedious job of the city budget to resolve. To reevaluate the other candidates would also delay the conclusion and possibly result in still another tie vote.

"But above all I am committed to this city and realize that continued division is unhealthy.

"Because I have the temperament and qualities which would

serve the council well, I have made a carefully considered decision-a decision which is mine alone. I hereby withdraw my name as a candidate for the appointment to city council for the sake of those steadfast council-men, Mr. Weidenfeld and Mr. Putens, who supported me, and for the sake of continued efficient city government. I would like to thank Mayor Weidenfeld, who conducted these past meetings and hearings with intelligence and wisdom. I am among many who are proud that you represent the city as our Mayor. Mr. Putens has only been on council less than one term and he has already displayed leadership found in a seasoned and effective councilman.

Hearing Set for Feb. 16 On BARC Resolution

Maryland Senators Leo Green, Thomas Yeager, and Arthur Dorman have introduced Joint Resolution No. 9 for the purpose of urging the federal government to prevent an ill-advised sale of a 247-acre portion of the Beltsville Agricultural Research Center (BARC), and to further request the halt of the steady reduction over the last 12 years of open space and natural buffer surrounding the installation in the area of the Beltway and Greenbelt.

A hearing before the state Senate Finance Committee on this resolution is scheduled for Wednesday, February 16, at 1 p.m. in the James Senate Office Building, Annapolis.

In our February 3, 1983, issue, we reported on a proposal to city council by Richard Cripe of Putens Associates, Inc., for development of a computerized crime information system for the city, to be done in cooperation with the University of Maryland. The university assistance and computer services would be free for the first year. Thereafter, the city would pay the university only for actual computer costs.

Giese to Participate In "PG-2000" Forum


