# Top Vote - Getter Hoyer, Democrats And Gun Law Win in Greenbelt

U.S. Congressman Steny H. Hoyer once again received the largest number of Greenbelt votes, 4996, in Tuesday's 1988 General Election. Almost 80 percent of Greenbelt's registered voters trekked to the 4 precincts here. Greenbelters gave their support, as expected, to the Democratic candidates and to the gun law.

On the State's hottest issue—question 3, a referendum on the state legislature's law to ban certain kinds of handguns, there was no contest here as 4461 Greenbelters voted "For" to 2133 "Against." The 67.7 percent approval showed the community hasn't changed its mind since a 1969 city referendum in which voters supported gun control by two-to-one. (See box, page 2.)

Governor Michael Dukakis in his bid for the presidency garnered 58.1 percent to Vice President George Bush's 40.9 percent a victory in Greenbelt, but clearly not by a large enough margin to assure victory at the state level where the candidates remain even. A count of the state's 85,000 absentee ballots may be required to settle who won. In the rest of the nation, President-elect Bush swept 30 states to Dukakis's seven with 13, including Maryland, too close to call late Tuesday night. The

formed both Mondale-Ferarro in 1984, 55.1 percent, and Carter-Mondale in 1980, 48.3 percent.

Paul S. Sarbanes won handily over Alan L. Keyes, by 69 to 31 percent in Greenbelt, 70 percent in Prince Georges County, and 63 percent statewide.

Hoyer trounced his opponent
John Eugene Sellner by 77.3 to
22.7 percent here, and 79 percent across the 5th District.

Questions

Of the three state and seven county questions, all but Question 1 easily won the needed votes. Turned down by the voters was the right of the Anne Arundel County government to take land for certain public uses in a condemnation proceeding prior to a jury's determination of compensation. This issue apparently struck home for Greenbelt residents distressed by the State Highway Administration's ability to take a portion of Greenbriar land for the new Baiti-

more-Washington Parkway ramps without waiting either for negotiations with the owners or a jury trial to set the price for the land.

#### Turnout

The turnout of 79.8 percent easily bested both the 1984 election turnout of 76.4 percent and that of 1980, 76.1 percent. The county turnout was 77 percent, while a cross the nation only forcent of the voters went to the polls on Nov. 8.

# Task Force Proposed for City Arts Policy Receives Positive Response

Approximately 35 people attended the October 17 public hearing on the proposed city arts policy, with five speaking in favor of prompt adoption and implementation of the policy and no one speaking against the proposal.

The proposed arts policy was developed by a task force established by the Parks and Recreation Advisory Board (PRAB). Task force chairman Tom Renahan summarized the policy, focusing attention on the statement of purpose that begins the report. This statement calls for the integration of the performing, visual and literary arts into "the lives of the individuals and the community as a whole." The policy consists of a series of goals and strategies to achieve this result.

Under the proposed policy the city would: establish a variety of high-quality arts opportunities and encourage citizen participation in the arts, provide high quality facilities for the performing and visual arts, establish Greenbelt as a "cultural center," ensure adequate and increasing funding for arts organizations

and programs, and advance policy goals through effective planning and cost-effective use of resources.

To oversee the implementation of this policy, the proposal calls for assignment of all city-run arts programs to one Recreation Department staff member. In addition, council would establish an Arts Committee to develop a detailed arts policy and to guide the city in its implementations. The committee would consist of a PRAB member, at least one person from each of the visual, performing and literary arts, an arts educator and two or more business representatives, for a total of nine to 11 people.

Cost Estimates

The city staff, which has reviewed the proposal, is generally supportive. However, City Manager James K. Giese pointed out that provision of performing and

visual arts centers would be expensive. The staff estimates that renovation of 10,000 square feet of the North End school building for a visual arts center would cost \$500,000 to \$750,000. The cost of providing a performing arts facility depends upon the nature of the facility and until that is decided, cannot be estimated. Given current shortfalls in the city's capital improvements budget, Giese said that to accept the establishment of these arts facilities without funding to accomplish them would be "meaningless."

The proposed city capital improvements budget, not yet adopted by council, allocated \$552,300 for renovations to the North End Center. However, \$396,400 is already committed as matching funds for state grants for a senior day care center and a senior activities center. This leaves approximately \$156,000. In addition, the city has recently received a county grant of \$190,000 for North End renovations.

"The problem is that they (Public Works) see this"—he pointed to the map showing precisely drawn blue lines—"and we see this"—and he pointed to the picture of the recreation facilities, nestled among dark green trees.

# Wait And See

The question of what to do with the North End School building has been complicated by the county Board of Education's debate over the future of Center School. Citizen activists have long urged the rehabilitation of all or part of the city-owned North End facility for use as an arts center as well as for child day-care and senior citizen programs. Now the county school system is also eyeing this site as the possible location for a zew elementary school building to serve Greenbelt.

There are still many unknowns. Before any city decision on use of the North End School is made, a number of issues must be resolved, including the terms under which the school system would seek to reacquire the North End facility, what other sites the school board may have under consideration, and the future of Center School if it is not renovated. Most importantly from the city's standpoint, how will the city, its citizens its students, its structures and its green spaces have fared when all the decisions have been made?

With so many variables now in the mix, we think the city council would be wise to hold off a decision on what to do about rehabilitating North End School. Sometimes the most significant act is to wait and see.

feld pointed out that the backers of an arts center at the North End will have competition for those funds from other interest groups, such as those suggesting child day care or a nursery school at the site.

Renahan said that PRAB did not ask the task force to consider cost in developing a policy, but he did question the staff's estimate that an additional fulltime recreation staffer would be required. Given that the Recreation Department is already providing arts programs, the committee did not feel that an additional full-time staffer would be required. Giese said that the Recreation Department estimated that at least one additional full time staffer would be required to perform all the duties proposed in the draft policy.

## North End Availability

Uncertainty over the future of Center School may affect the implementation of the arts policy. The Board of Education has listed the North End School site as possible location of mentary school if they decide not to renovate Center School.

While the policy assumes that the visual arts center would be housed in the North End School, Renahan said that the policy is not dependent upon any particular location.

Renahan urged council to act quickly to adopt the policy and establish the Arts Committee. This request was supported by Eileen Peterson, John Ward, Beatrix Whitehall, Kevin Kneisley and Keith Chernicoff.

Ward said that the provision of an arts facility is too large a task for the individual arts groups to do privately. However, he said that once council made a commitment to provide such a facility, these groups could seek private benefactors. Ward said that private donors will not contribute to groups who can offer only their dream of an arts facility, with no promise of city support.

The proposal calls for the Arts Committee to establish fundraising criteria for private groups seeking financial help from the city. Kneisley objected to having a city advisory body submit fundraising plans for private arts groups. He said the committee's function should be to distribute any grants received by the city. Despite this objection, Kneisley said that it is important for the city to adopt an arts policy.

Councilmembers Antoinette M. Bram, Joseph Isaacs and Edward Putens and Mayor Weidenfeld all supported the proposal. Councilmember Thomas X. White was not present.

Bram suggested that the proposed Greenbelt Foundation, a city sponsored endowment fund, could be used to raise funds for the arts. Weidenfeld agreed, saying that Bram's idea could not only benefit the arts but also provide a focus for the founda-

The proposed Arts Policy will appear on the next council agenda for formal action.

# Police Blotter

When Pfc. Thomas Keifline stopped a car on Oct. 28 for a traffic violation on Greenbelt Rd. near Walker Dr., he noticed the handle of a handgun sticking out from under the passenger seat. A search of the vehicle revealed 201 grams of "crack" cocaine. The small caliber handgun had had the serial number filed off to avoid identification. Two men, residents of Greenbelt, were arrested and charged with posses-sion of "crack" with intent to distribute, possession of a handgun, and removing the serial number from the gun. In addition, the driver was charged with speeding and driving with a suspended license and is being held without bond pending trial. The second man is being held on \$500 bond pending trial.

Stolen Vehicles Two nonresidents were arrested on Nov. 2 and charged with auto theft when Officer Thomas Moreland, while on patrol, saw their car fail to stop for a red light on Greenbelt Rd. at Hanover Pkwy. A registration check revealed the car had been stolen in Virginia on Oct. 31

Two other nonresidents were arrested following a stop for a safety violation. The men attempted to flee and were caught. The car had been stolen in Virginia and the license plates had been stolen in Prince Georges County.

# Roosevelt Tech Center Applications Are Available

Applications for entry into the 1989-90 Science and Technology programs at Eleanor Roosevelt high school are available at all guidance offices of public secondary schools in Prince Georges County. The application deadline is December 2.

The Science and Technology Program is a four-year pre-college high school course of study which provides increased educational opportunity in the scientific and technological fields for selected students from all areas of Prince Georges County.

Approximately 225 ninth graders will be accepted for the program at Eleanor Roosevelt High School. In addition, a limited number of tenth-grade students will be accepted. Students applying for the programs should remember that no applications will be accepted after the December 2 deadline.

# **Panel Debates Approach** To Curbing Drug Abuse

by Robert Williams

A nine-member advisory panel met before about 50 Greenbelt citizens on October 11, advocating a coordinated, three-pronged approach of prevention, enforcement, and treatment programs to curb drug and alcohol abuse.

Prince Georges County Assistant District Attorney and chairperson Valerie Siegel of Greenbelt's Crime Prevention Committee led the discussion among indrug/alcohol counselors, program directors, family therapists, and law enforcement officials. The meeting, which was held at the Municipal Building, was sponsored by the Greenbelt City Council and the Crime Prevention Committee.

"What works is coordination and cooperation," said Ruth Phillips from the Governor's Office of Justice Assistance. All agencies must work together if the state and its communities want to make an impact on the demand for illegal drugs, she said. "Singly, they sabotage each other,"

It takes many different types of programs to dry up the de-mand side of the drug problem, said Siegel. There are many different causes of addiction, just as there are many different kinds of cancer and cancer treatments. "We must treat the people that are using (drugs) and help the people who are not to make the choice not to use (drugs)," she said.

Ray Lorion, Director of the Clinical Psychology Program at the University of Maryland and substance abuse researcher, said

a war on drugs calls for a "Joint Chiefs of Staff," consisting of trained parent and teacher groups equipped with adequate funding and information.

Their job would be to design and implement programs specific to the needs of this community, said Lorion. He also recommended the hiring of a program coordinator to oversee and advise on community efforts.

Family counselor and consultant to the Greenbelt CARES Youth Services Bureau, Dr. David Pelligrini said recreation programs such as Greenbelt's are non-conducive to drug and The alcohol abuse behaviors. community can support recovering addicts by providing these activities to supplement treatment and prevention programs, he said.

Community after-care and relapse prevention programs are for long-term recovery, said John Boren, because once a person is addicted, "it's a life-time proposition." Boren is group therapist and head of the Clinical and Behavioral Pharmacology Program at the National Institute on Drug Abuse.

Churches and civic organiza-tions can support relapse prevention programs, Boren said, by donating space for groups such

as Alcoholics Anonymous or Narcotics Anonymous to hold their meetings.





# Council and CRAB Discuss **Idea of Greenbelt Foundation**

At a worksession on October 5, the City Council and representatives from the Community Relations Advisory Board (CRAB) discussed the possibility of forming a Greenbelt Foundation which would create funds to be used for unique and worthwhile community purposes.

Discussion of such a foundation has been going on for over a year. Councilmember Antoinette Bram first suggested that there should be some sort of established mechanism whereby citizens could leave contributions, either in property or funds, to the city. Council then referred the idea to CRAB, asking them to look into the foundation's feasibility. CRAB has been meeting with community residents and organizations, and has submitted recommendations to the Council.

Among their recommendations, CRAB has suggested that a committee be formed to set up a framework for the foundation its goals, the and determine foremost goal being to fund worthwhile city projects. Mayor Gil Weidenfeld said the city staff will draw up a resolution and begin to search for committee members, especially from among those who have had previous fundraising experience.

Mayor Pro Tem Joseph Isaacs expressed concern that such a

foundation may cut into the fundraising efforts of other existing city organizations. He suggested that the foundation should have specific causes and projects in mind before approaching possible donors. Having only vague goals, he added would make it more difficult to raise funds, especially considering the competition of other groups. City manager James K. Giese noted that much of the success of such a foundation would depend on a hardworking, experienced individual to take hold of the foundation's goals and move

on them. He added that the foundation would not like run on a volunteer basis, but would require some sort of revenue for a paid staff.

Council discussed CRAB's recommendation that seed money be made available by the city to fund the initial organizational and advertising costs.

Upon a resolution drawn up by the city, an effort to find committee members will begin. One suggestion made at the worksession was that the committee's Board of Directors be made up of the foundation's donors.

Citing the growth of business in Greenbelt over the past several years, Mayor Weidenfeld noted a great potential for raising money by tapping the tremendous new resources in the area. The Council resolved that in the formation of a Greenbelt Foundation, the emphasis will continually be on community pro-

# **Gypsy Moths Discussed**

Next spring as the leaves on the trees begin to unfold, tiny gypsy moth caterpillars will start emerging from egg masses laid late this summer. In some parts of the county it is likely that defoliation of entire trees will occur if nothing is done to aid trees in their battle for survival.

A number of organizations and concerned citizens throughout the county have combined efforts and coordinated a public meeting regarding the Gypsy Moth. A panel of experts will make presentations on November 17 to inform and educate residents to the possible devastating effects the caterpillars can and may have on trees. The panel will include: Bob Tichenor, Director of the State Gypsy Moth Program; Dr. Michael Raupp of the Department of Entomology at the University of Maryland Extension Service; Dr. Richard Ridgeway, Research Leader for the Insect Chemical Ecology Laboratory of the USDA Agricultural Research Service; Dr. Kevin Thorpe, staff entomologist for the National Coalition Against the Misuse of Pesticides; and Tim Zastrow of Tree Masters Pest Management Systems. The panel will be moderated by Margaret Mallino, Mayor of University Park.

What are plaque-diissolving agents?

Plaque is a sticky, almost invisible film that constantly forms on the teeth. Most dental problems occur as a result of the failure to thoroughly remove plaque daily through the use of dental floss and proper brushing.

Research has been underway for many years to discover a means of dissolving the plaque that iis left behind even after a thorough daily cleaning. Mouthwashes seem the most promising plaque-dissolving agents. Although not completely understood at this time, the effectiveness of any mouthwash is apparently linked to its ability to destroy the bacteria found in plaque.

A recent study released by a major brand of mouthwash claims 50% reduction in plaque formation in carefully moniitored test subjects. Past studies using several different brands have resulted in varying degrees of success. What is common to all research is the fact that mouthwash is to be considered an additional, rather than a substitute means of plaque control. Also, it must be remembered that further research is necessary to verify and repeat the findings before this can be considered an acceptable form of dental disease prevention.


