Council Seeks to Expedite Development Plans for Schrom Hills and Lake Park

At its August 7 regular meeting, the Greenbelt City Council, at the request of the Coalition of Greenbelt East Communities, set a goal to complete the development of Schrom Hills Park within two years. However, City Manager James K. Giese cautioned that development of the pond area may be delayed beyond that time. The city is still trying to determine whether it will be permitted to construct the pond under state and federal wetlands regulations.

In another parks related matter, council directed staff to prepare a request for proposals for a professional planner to prepare a Master Plan for the lake park. This consultant would serve the same function as consultants hired earlier to develop, with community participation, the Schrom Hills Park Master Plan.

City Planning and Development Coordinator Celia Wilson, in written comments, argued that an outside consultant was not needed for the lake park. Unlike Schrom Hills, she said, the park is "use and theme" are well developed. She said that the greatest unresolved issue is how much more development should be added to the park, such as restrooms, additional parking, more picnic and plan facilities. Wilson noted that these facilities will encourage increased use of the park, leading to congestion and possibly increased activity in the Lakeside area.

Since the issues are well defined, Wilson did not believe that the hiring of an outside consultant would bring the same benefits as in the Schrom Hills Park development.

However, the council members argued that the consultant would serve as a facilitator and lead to the completion of this project.

As part of the consent agenda, council directed staff to develop

a city-wide park master plan. As part of this work, the Maryland National Park and Planning Commission has agreed to perform a needs assessment for city park and recreation facilities. In addition, a "Greenbelt Land Survey," listing and prioritizing potential land for city park acquisition will be needed. A second consent agenda item directed staff to prepare maintenance guidelines for all city parks.

Petitions and Requests

Council referred a petition from the Housing Committee of the Greenbelt Consumer Cooperative to staff for comment. The committee renewed its request for a low-cost lease of city property upon which to build a limited equity cooperative apartment building for seniors. Parcel 12, next to Greenbelt Lake, is the group's favored spot, but they would also consider a portion of Parcel 2, across from the Greenbelt Homes, Inc. offices.

Council also referred to staff for comment a request by the Greenbelt East Advisory Committee. GEAC expressed concern about the effect of development on traffic in the eastern part of the city and requested updated traffic counts at the intersections of Hanover Parkway and the Greenway Center entrance, Hanover Parkway and Greenbelt Road, Greenbelt Road and the Greenway Center entrance and Greenbelt Road and Southway Road.

Council also received a request from Sheldon Goldberg to look into better markings to ensure handicapped access to Greenway Center. He said that cars were parking at the Safeway loading zone, blocking access to the entrance ramp. Keith Chernikoff requested better enforcement of the no bicycling rules at Roosevelt Center.

Legislation

Council approved an ordinance financing improvements to privately owned sidewalks at Roosevelt Center by a special assessment against the property owners. A second resolution, intro-

duced for first reading, requests that the state Department of Housing and Community Development designate a portion of the Roosevelt Center as eligible for a state revitalization loan program.

Several pay issues were addressed as council approved legislation setting pay for election judges and clerks at \$125 and \$100 respectively. A Charter Amendment Resolution raising the mayor's pay to \$6,000 per year and council members to \$5,000 was introduced for first reading. This increase will not take effect until after a new council is elected in November.

A Citizens Task Force on Refuse Collection Procedures and Recycling was formally created by legislation approved at this meeting. The task force will consist of four members of Greenbelt Homes, Inc. one each from Lakeside, Boxwood, Lakewood and Woodland Hills and two members from areas not served by city refuse collection. The group will evaluate current procedures and alternatives, and develop ways to meet state and county mandates for increased recycling.

Other legislation introduced for first reading at this meeting would establish an eleven member community center task force including one member each from the Advisory Planning Board, Park and Recreation Advisory Board, Community Relations Advisory Board, Arts Advisory Committee and the Senior Citizens Task Force. Six citizen members, including some with

SENEGALESE MARCHERS IN LABOR DAY PARADE

A 22-member delegation from Ziguinchor, Senegal marched in the Labor Day Parade this year and visited the festival afterward.

Ziguinchor, Senegal and Prince Georges County signed a formal agreement initiating their sister-county relationship on February 5, 1987. The objective was to bridge the cultural, economic and educational interests of both jurisdictions.

In March 1987, County Executive Glendening led a delegation of Prince Georgians to Ziguinchor in one of the first visits under the sister-county agreement. Six months later, a 21-member Senegalese delegation made a reciprocal visit to Prince Georges County.

The current tour is being coordinated by the County's Senegal Friendship Committee. Committee members and other county residents will serve as hosts and open their homes to delegation members during the visit. The committee is providing home hosts to enliven people to people exchanges and to further the goals of sister-county relations.

Florence Holly Is Selected 1989 Outstanding Citizen

"Some say we just like to keep people guessing." Those were the words of Tom Renahan, chairman of the committee to choose Greenbelt's Outstanding Citizen for 1989, explaining the tradition, established some years ago, to hold till the last name of the winner. "Those of you who know this citizen might identify the winner," Renahan said, "without a name or even an organization or activity being mentioned."

Then the clues built up: "smiling," "patience," makes people "feel important," "can dominate a room without saying a word," "a reassuring presence wherever she goes." If we were playing 20 questions, we would have lopped off by now one category. This year's citizen is a woman, and automatically she becomes Parade Marshal for the Labor Day parade, riding in a position of prominence in the lead car of the procession.

Indeed, Florence Holly is well known in many ways for her good works. For four terms she was president of the Golden Age

Club. She was instrumental in getting public transportation for senior citizens, especially in the city's establishment of the Greenbelt Connection. For years she has worked with both adult and children's programs at the Holy Cross Lutheran Church. She has also been an active member of the Greenbelt Woman's Club and has participated in the Labor Day Festival.

Many of Mrs. Holly's contributions have been less structured. Renahan cited her kindness in driving to church and on errands those who were elderly and handicapped.

Toni Bram, Konrad Herling Declare Council Candidacy

Two more Greenbelt citizens have announced their candidacies for the Greenbelt City Council. They are incumbent Antoinette M. (Toni) Bram who filed petitions on September 5, and challenger Konrad Herling. They join incumbents Joe Isaacs, Tom White, and Gil Weidenfeld, who also have filed petitions in this year's race, as well as newcomer and challenger Ruth Kastner. Bram is the only woman in Greenbelt history to be elected to three consecutive terms on city council. She will be a candidate for a fourth term. Herling, a lifelong resident of Greenbelt, ran previously for council in 1979.

Bram Biography

Bram was born in Washington, D.C. and graduated from Notre Dame Academy. She attended Wilson Teachers College. In 1956, she married Dr. Ralph A. Bram, a Gonzaga High School graduate and currently a scientist with the U.S. Department of Agriculture. Toni completed her education at the University of Maryland, receiving a Bachelor of Science degree, summa cum laude, in urban studies and a Master of Arts degree in urban history. Her studies also include archaeology and the Italian language in Rome, Italy.

Bram moved to Plateau Place in 1960. The Brams currently reside on Tamarisk Court.

Toni and Ralph raised four children in Greenbelt: Regina, Timothy, Simone and Jennifer.

Her interest in youth activities resulted in her appointment to

the Greenbelt Parks and Recreation Advisory Board, where she served as Vice Chairman until 1981. Subsequently she served on the Greenbelt Advisory Planning Board until she was elected to city council in 1983.

Bram is a past president of the Homemakers Club, was a Camp Fire leader, board member and coach for St. Hugh's C.Y.O., coach for the Greenbelt Boys and Girls Club, board member and meet official for the Greenbelt Aquatic Boosters Club, and PTA vice president. She is Scholarship Chair for Alpha Sigma Lambda Honor Society, University of Maryland University College.

In early 1984 Bram organized and founded the Prince Georges Elected Municipal Women, an organization which continues to grow in membership and in

Mishkan Torah Celebrates 50 Years With Fair

Mishkan Torah Synagogue will be celebrating the 50th Anniversary of the Greenbelt Jewish Community during the coming months. The kick-off will feature a fair on Sunday, September 17, from 1 p.m. to 5 p.m. at the synagogue, Ridge and Westway Roads.

Among the events planned for the afternoon are: Live music, games, videos, trivia, an exhibition of photographs, a photo booth and food. Persons will also have an opportunity to exchange reminiscences and memorabilia. Greenbelt residents have worked together many times during the 50 years, and even actually helped to build the first Jewish Community Center of Prince Georges County.

Admission is free and the members of Mishkan Torah wish to share with all their friends and neighbors.

The history of the JCC building is unusual, for it was largely a do-it-yourself project by the members, with the support and assistance of many community groups in Greenbelt, including several churches.

The amateur carpenters, bricklayers and masons learned as

they worked, and Protestants, Catholics, and Jews worked side by side in a practical demonstration of the brotherhood of man. The building took three years to construct, and was formally dedicated on March 20, 1955.

dicapped, her visiting of shut-ins in nursing home and hospital, her tutoring of students, and her activities in raising college scholarships. "Once in a while," he said, "someone's contributions become too numerous to remain unnoticed. . . . Tonight, that moment in time has arrived.



which she is still active. She also represents the City's position at hearings on the county and state levels. She is a member of the Maryland Municipal League, the National League of Cities, and the Washington Metropolitan Area Council of Governments.

Herling Biography



backgrounds in architecture and historic preservation and some business representatives would complete the group.

Other Actions

At an earlier meeting, council had received a petition from Bruce Bowman asking that the gate at the Research Road entrance into the Beltsville Agricultural Research Center be left open at all hours. The city has received a letter from K. D. Murrell, Acting Director of BARC, stating that the gate is still needed to curb vandalism. In addition, approximately 31 Research Road residents, by letter or petition to council, opposed extending the open hours of the gate. Council unanimously approved the staff recommendation to forward Murrell's letter to Bowman but to take no position on the matter.

Council went on record against the proposed transfer of the county school bus lot to the adjacent Beltway Plaza in exchange for property in College Park.

Council member Thomas X.

White, citing concerns about pedestrian safety, requested consideration of a four-way stop at the intersection of Crescent and Gardenway Roads. Rick Meetre supported this request, saying that there is little visibility for cars turning onto Crescent from Centerway, due to Crescent's curve. Further, he said that the underpass is not a good alternative since it is not lighted and pedestrians in the tunnel are not visible from surrounding areas. He said the underpass "unnerves me" and that he has told his children not to use it.
