Proposed City Ordinance Sparks Developers' Concerns

During the September 15 Greenbelt City Council meeting. councilmembers held a public hearing for a newly proposed ordinance to establish a city building code. At odds with the new ordinance were representatives for area devel-opers. The developers' position is that the ordinance duplicates established laws already in effect under the codes of Prince Georges County and the State of Maryland.

The ordinance would adopt the Basic Building Code of the Building Officials and Code Administrators International, Inc., as the official city code. The code is designed to protect against substandard construction by establishing building requirements for new construction and improvements to existing structures. It also establishes standards for the maintenance of property. In cases where the city ordi-

nance is in conflict with either the county or state codes, the ordinance stipulates that, "The provision which establishes the higher standards for the promotion and protection of the health and safety of the people shall prevail." The term "higher stan-dard" was not defined in the draft and its opponents seemed concerned by what they per-ceived as vagueness in other provisions as well.

Opposition Expressed Beltway Plaza Developers at-torney M. "Kap" Kapastin addressed the council about the concerns that overregulation might cause commercial tenants who want to build in Prince Georges County to bypass Greenbelt. He said that the ordinance, which includes building permit fees, would increase start-up costs and questioned the enforceability of some of the provisions included. Kapastin also noted that zoning regulations in the ordinance duplicate those of the county and state

Greenbelt city attorney Robert Manzi responded, saying that the intent was not to duplicate zon-ing which by state law is a county responsibility but to allow the city to insure compliance with current county zoning requirements in an attempt to protect the city's interests.

Nancy Slepicka represented the Capital Office Park, which is comprised of six office buildings and the Greenbelt Marriott. Slepicka was concerned that "adding another layer of regulation would have serious results." She said that developers are concerned, especially during the current economic times, that duplication of services may cause too much of a financial strain on area businesses. Manzi's position was that Greenbelt's city gov-ernment "is closer to the issues (geographically) than county officials in Upper Marlboro."

Dorothy Pyles of the Green-belt East Advisory Committee (GEAC), wanted to know how the ordinance would affect condominium, townhouse, and single See COUNCIL, page 2, col. 3

other than police and fire by 22%, including that for code enforcement." In response to a priority es-tablished by the city council in a goal setting process last year. City Solicitor Robert A. Manzi and the city staff have prepared

an ordinance now being scrutinized by property owners and citizens to enable the city to undertake code enforcement and to issue permits for building construction. Those involved are invited to comment at two meetings scheduled for Monday, October 5, which will be conducted by City Planner Celia Wilson and Manzi. At 3 p.m. commercial property owners or their representatives will be heard. At 7 p.m., the meeting will concern residential property. If the ordinance is adopted, the

city would assume responsibility in place of the county for enforcement of codes relating to the maintenance of property. Instead of the county, the city would also collect fees from rental and commercial property. "At this time, we are not proposing any changes to the existing code regulations," Hobbs noted.

The existing county regulations for the most part adopt the model Basic Building Code of the Building Officials and Code Administrators Interna-tional, Inc. After the code is in effect for a year, council requests that the city staff propose changes which it feels may be desirable.

Besides property standard regulations, the proposed ordinance will require property owners to obtain building permits from the city as well as the county. However, the county will continue to be responsible for inspection of all new construction and building additions. The city's role will be limited to ascertaining that there is compliance with city road construction and sediment control regulations, as well as property covenants.

Under the proposal, all rental units licensed by the county will be licensed by the city. Licenses will be annual, and all existing county licenses at time of ordinance adoption will be honored for their full term. Although all housing inspections will be performed by city staff, the fire marshal will continue to retain authority over fire safety regulations. Occupancy permits will be required by the city for all non-residential units.

The recommended fee schedule is \$33 per year per unit for See CODES, page 2, col. 4

Hats Are Flying as Politicos **Declare for State Delegate**

The ink on State Delegate Charles "Buzz" Ryan's res-ignation was barely dry when at least 15 contenders threw their hats into the ring. Shaping up for what could become an intense fight for Ryan's seat, the first round is already crowded with heavyweights from Greenbelt and Bowie, two politically active and rival cities that dominate the 23rd Legislative District. Bidding for Ryan's seat, also, are hopefuls from the district's unincorporated areas.

Announced candidates from Greenbelt are council member Antoinette "Toni" Bram who lost a bid for a delegate seat in 1990, council member Edward Putens, and Advisory Planning Board member Roberta McCarthy. Mayor pro-tem Thomas White told the News Review that he was considering a bid for the seat. White also represents the 23rd District on the Prince Georges County Democratic Central Committee.

Non-Bowie candidates view the vacancy as an opportunity to gain a geographical balance in Annapolis. For two decades Bowie's population advantage has been a key factor in that city's monopoly of state senate and delegate offices.

"Buzz" will be missed. He was a team player and worked for the best interests of the citizenry," said State Senator Leo Green who will play a major role in selecting Ryan's replacement.

A delegate for 14 years and chair of the powerful House Appropriations Committee, Ryan, a Bowie resident, will become vice-president for governmental affairs and lobbyist for the University of Maryland Medical System. He was considered the chief budget specialist in the House, had considerable clout and was protective of Prince Georges County interests.

Ryan's successor will serve in the General Assembly for two years before having to face the voters.

Process

In selecting a replacement for Ryan, observed Green, "We will be vesting in a person who will hopefully have continuity," one who will have "overwhelming experience, a good record, electa-bility, a particular expertise . . . a potential leader."

Candidates will appear before Green, delegates Joan Pitkin and Mary Conroy and three members of the Prince Georges County Democratic Central Committee who represent the district on Thursday, October 15 at he Glenn Dale Country Club. The public hearing will start at 7 p.m.

The panel will reach a consensus on one candidate and forward its recommendation to the 22 members who represent their respective districts on the Central Committee.

"The final arbiter is the Central Committee," Green said, add-ing that the Central Committee's recommendation will be sent to the governor, who apploints.

The Central Committee is holding its public hearing on Tues-day, October 20 at 7:30 p.m. in the Free State Veterans of Foreign Wars facility on Good Luck Road in Lanham. Candidates will

make presentations and inter-ested citizens may speak. Ordinarily, in the decision-making process, Central Committee members defer to the district where the vacancy occurs. Although Green wields the most power in the selection process, other county state senators could choose to influence the selection process through their respective district's representatives on the Central Committee.

The process, so far, has been characterized as a "checker game." Green noted it was diffi-cult to "focus on the process un-til we know who is in."

In addition to those Greenbelters aspiring for the delegate of-fice, other "ins" include, from Bowie-Mayor Richard Logue, city council members Gary Allen and G. Frederick Robinson, Terry Devaney, Dick Nacewicz, Ron Kotz; Lanham-Ray Krasnick (former Greenbelter), Central Committee member Virginia Burnette; Glenn Dale/Mitchellville areas: Roger Goll and Jim Hubbard; Upper Marlboro — John "Jay" Harvey.

George Nicodemus Hanyok

Navy Petty Officer First Class George Nicodemus Hanyok died unexpectedly on his birthday, September 26. He was 32.

Hanyok had gone to the movies in Riverdale with his wife Sharon and their three children and a friend. Hanyok fell asleep in the theatre, but was not breathing when the film ended. Efforts to revive him by a nurse in the audience who performed CPR and by the Leland Memorial Hospital emergency room staff were not successful. Ac-cording to his family he had seemed healthy; his death was a complete shock.

George grew up in Greenbelt, the youngest of the eight children of Stephen and Angela Hanyok in the family home on Lastner Lane. He attended North End Elementary School, Mary Bethune Junior High School and Parkdale Senior High School. He was in the first graduating class of Eleanor Roosevelt High School in 1978.

Hanyok had collected many athletic trophies over the years. He won 21 games one year as a Little League pitcher. He played pick-up basketball at the Youth Center. More recently he had been the MVP in several games on the Patuxent Naval Air Station's football team.

At age 17 George joined the Navy. He and his wife Sharon were married in 1983. The family resides in Lusby near the Patuxent Air Station where he was assigned to Aviation Support. They frequently spent weekends with his parents in Greenbelt.

While in the Navy for 15 years Hanyok received nine medals and commendations. He was serving on the Iowa at the time of the ammunition explosion and was among the men honored later for volunteering to retrieve the bodies of those who had died in the explosion, men he had worked with and known. He received a superior performance award as leading petty officer and pioneer of the RPV (remote piloted vehicle) which assists gunners in improving firing accuracy. He was on the Iowa during Desert Shield, receiving a good conduct award with three stars. He also served on board the Kennedy and the Independence and was due for another sea tour in March

A service, Parastas (The Great Panachida), will be held tonight at 7 p.m. at Chambers Funeral Home in Hyattsville. A memorial service of Divine Liturgy will be held at St. Gregory's Church in Beltsville on Saturday at 9 a.m. followed by a Mercy Meal (Repast) in the church hall. Interment will be in Arlington Cemetery on Friday at 9 a.m.

Hanyok is survived by his wife Sharon, daughter Jessica, age 9, and twin sons Matthew and Anthony, age 6; his parents Ste-phen and Angela, of Greenbelt; his brothers and sisters, Stephen. John Andrew, Michael. Karen H. Freeman, Gregory and Christine, (his brother Nick died in 1986), 15 nieces and nephews; and many aunts, uncles and cousins, of Greenbelt.

family residential units. She was advised that these units would be regulated as well. Pyles then questioned the proposed regulation and increases in occupancy permit fees for homeowners who have rental units. Council member Edward Putens called for clear definitions regarding the rental of single family homes.

Time for Comments Mayor Gil Weidenfeld explained that the ordinance was de-signed to "maintain quality in terms of building within the city." He recommended that the council keep the record open for the next two weeks so that builders and residents could present comments on the proposed ordinance. Two separate meetings were suggested, one addressing commercial building regulation and the other concerning residential housing construction and property maintenance. Both meetings have been scheduled for October 5 in the classroom at the Greenbelt Police Station. The first meeting, beginning at 3 p.m., will address commercial building concerns; the second will begin at 7 p.m. regarding residential building and housing matters. City Planner Celia Wilson and City Solicitor Robert A. Manzi will conduct the meet-

(Continued from page one) rental unit licenses, \$100 per unit per year for non-residential occupancy permits and, for city building permits, a flat fee of \$15 plus \$3 per \$1,000 of value of building construction work or fraction thereof.

The ordinance also establishes Greenbelt Board of Appeals consisting of three members who are qualified city voters and hold

no office or position in the city government with pay or compensation. Board members will be paid \$1,200 per year. The board will hear appeals from property owners of orders to comply with regulations issued by the city. The board can affirm. amend, modify or withdraw the order for which the appeal has been made. The decision of the board is final for the city but will be subject to review by
