## Council Votes to Annex Parkside; Police Chief Reviews Blotter Rules

By a vote of 3 to 2, City Council passed an ordinance to annex the Parkside subdivision. Parkside consists of 31 free-standing homes located off Good Luck Road in a "notch" in the southern edge of Greenbelt. The Park, but not the subdivision, is within the corporate limits of Greenbelt, and Parkside homeowners had petitioned to be annexed by the city.

A lengthy discussion preceded the vote, centered mostly on the distance of Parkside from the core of the city and the centers of city services as well as the possible dilution of these services — versus the added city tax revenues that the development would generate.

### The Nays

In voting against annexation, Councilmember Alan Turnbull cited the close-knit character of Greenbelt, which would now have a neighborhood separated by a significant distance from the core. Councilmember Rodney Roberts said there was a lack of sufficient information on true costs to the city to make a proper judgment on annexation. Roberts, in voting against, said "I'm not happy that this has been made a personality issue. I approached this on a strictly fiscal and resource basis."

### The Yeas

After voting for annexation, Councilmember Ed Putens wel-

comed the Parkside residents to Greenbelt saying, "It may be land we are annexing but there are people with that land. I understand everybody's side and I also understand the non-financial values."

Councilmember Thomas White emphasized the need for

more single family free-standing homes in Greenbelt. He said, "Now there are potentially 31 additional places that a Greenbelter whose life situation has changed can move to without leaving the city."

Mayor Judith Davis said she weighed the financial aspects, land-use issues and infrastructure impacts, balancing them with the non-financial values — the people — before she voted for annexation. Addressing the Parkside residents in attendance she said, "Welcome to our city, welcome to our taxes, welcome to your responsibility to vote and to offer your services to our boards, committees, and service organizations."

The resolution to annex takes effect 45 days after passage by the city council unless, within 45

days, there is a petition for a referendum.

### Weekly Report

Police Chief Jim Craze talked to council about newly formulated guidelines for completing the weekly activity report of the Police Department. As background, he said the weekly report was started before his time in the department as a way to let crime-watch groups know what was going on in their neighborhoods. It was soon recognized to be a valuable tool to get police information to City Council and the media.

The guidelines state that all crimes, especially if an arrest is made, and incidents (both criminal and non-criminal) of a nature that might attract media attention, are normally included in the report. Exceptions are: when the information may jeopardize an investigation or endanger a victim, witness or defendant, or cause embarrassment to a victim; suicides or attempted suicides; domestic assaults where no arrest is made on the scene; allegations of child abuse unless an arrest is made and the identity of the victim cannot be ascertained from the report; non-criminal incidents, such as emergency psychiatric evaluations, runaway juveniles and traffic accidents, unless a fatality occurs; traffic offenses, including DWI arrests.

## Opponents Seek Broader Vote on Annexing Parkside

Greenbelt residents are circulating a petition calling for a referendum vote on the Greenbelt City Council's split decision to annex the Parkside subdivision of 31 homes off Good Luck Road and bounded on three sides by Greenbelt Park. An organizational coordination meeting for the petition drive was called for Sunday, October 4, by annexation opponent Doug Love, through an advertisement in this paper. According to a press release from Vail Mueller, 17 people attended that meeting. Fifteen had attended an earlier meeting two days prior.

The petitioners cited two reasons for having a referendum: the city council acted too hastily in reaching its decision two and a half weeks after a public hearing was held and the issues were "too complex and poorly understood" for a decision to be reached at this time. The release quotes Love as saying that the petition circulators will have their work cut out for them as they seek to obtain the signatures of 2,200 registered voters by November 12. The press release claims that 265 signatures were obtained in the first few days.

### Requirements

According to Greenbelt City Clerk David Moran, more than 1,976 signatures of registered voters residing within the city will be needed in order for the peti-

tion drive to be successful. The exact number is uncertain because new registrations were being actively sought before this November's election and the close of the registration books for the election did not take place until October 4. Moran expects to get the final count of registrants within a week. As of September 30, there were 9,876 registered voters in Greenbelt.

According to the annexation laws, the city council's decision to annex becomes effective not less than 45 days after the council's action unless it is petitioned to referendum. There are three groups who can make a petition—the residents of the area to be annexed, the residents of the city doing the annexation and the county council. To be successful, a petition must be signed by at least 20 percent of the registered voters within an area, or by two-thirds of the members of the county council. While petitions could be received and votes held in both the city and the area to be annexed, it is only within the city that petition drive efforts are known to be taking place.

### If Petition Succeeds ...

If a petition is successfully filed, the city's chief executive or administrative officer would then be required to suspend the annexation resolution from taking effect until a referendum was held. It is expected that in Greenbelt's

## City Museum Wins State Grant For Coming Decorative Arts Show

The Friends of the Greenbelt Museum (FOGM) is proud to announce the receipt of a \$7,000 grant from the state of Maryland, Dept. of Housing and Community Development, Division of Historical and Cultural Programs. The funds will be used for FOGM's next exhibition on the decorative arts, entitled "Fashionable, Functional, and Frugal: Modernist Design in Everyday Objects, 1930 - 1945." FOGM has also been awarded a \$1,200 mini-grant for the exhibition by the Maryland Humanities Council (MHC), which is funded through a grant from the National Endowment for the Humanities. The grant will pay for printing costs associated with the exhibit.

FOGM has hired an exhibit designer who is re-designing the museum's exhibition room at the Community Center. New modular cases are being constructed especially for this exhibit. The room will be painted in bright art deco colors. FOGM curator Katie Scott-Childress is the project director for the exhibition, which will feature Fiesta ware, Manhattan glassware, and other objects

from the Greenbelt Museum's permanent collection and several items on loan. The grand opening for the exhibition will be Friday, November 20. A lecture entitled "The Decorative Arts in the Machine Age" will be held Thursday, November 19, at 7:30 p.m. in the Municipal Building. Smithsonian fellow Shelley Nickles, a nationally acclaimed expert in the field of the decorative arts, will be the guest speaker.

FOGM is grateful to all of the individuals and groups that contributed to its \$2,500 challenge grant match issued by the city of Greenbelt. There were 75 groups and individuals that contributed, including 11 pioneer families. One contributor was Bill Lassell, whose family was the first to occupy the home that is now the museum.

Coupled with the flea market proceeds, donations at the museum, and other miscellaneous funds, FOGM raised over \$3,000. Special thanks to the following community organizations for their support of FOGM: Greenbelt Homes, Inc., Boxwood Civic Association, Springhill Lake Insignia Financial Group, Greenbelt Federal Credit Union,

Greenbelt Volunteer Fire Department and Rescue Squad, Greenbelt Cultural Arts Center, Greenbrook Village Homeowners Association, and Greenbelt Golden Age Club.

## Public Hearing to Be Held On Wetlands Mitigation

There will be a public informational hearing on plans to impact nontidal wetlands, their buffers or waters of the state of Maryland caused by the reconstruction through widening of existing roads within the Beltsville Agricultural Research Center in the vicinity of the U.S. Department of Agriculture (USDA) office building on Sunnyside Road. These improvements, which include the widening of Edmonston Road from two to four lanes from Cherrywood Lane to Sunnyside Road and some widening work along Sunnyside Road will result in permanent impacts of 44,287 square feet to nontidal wetlands, 83,639 square feet to the nontidal wetland buffers and 90 linear feet to the waters of Beaverdam Creek as well as another 3,700 square feet to the nontidal wetland buffers and 90 linear feet to the waters of Beaverdam Creek as well as another 3,700 square feet to nontidal wetland buffer along the creek. The hearing will be held on Wednesday, October 14, at 7 p.m., at the Beltsville Public Library, 4319 Sellman Road. It is being conducted by the Maryland Department of the Environment (MDE) Water Management Administration (WMA).

The MDE has approved phase I of a mitigation plan for the project. This would consist of the off-site creation of no less than 2.80 acres of forested nontidal wetland at the Beltsville Agricultural Research Center South Fields 18, 19, and 20. The land to be used to mitigate the impact caused by the road construction is located on the Paint Branch tributary to the Anacostia River. It is in back of the Paint Branch Golf Course, which is on the north side of University Boulevard, west of U.S. Route 1.

The application and related information are on file at the Nontidal Wetlands and Waterways Division (NWWD) of WMA at 2500 Broening Highway, Baltimore, MD 21224. Arrangements may be made for the inspection and copying of file materials. Information may also be obtained by contacting David Boelner at 410-414-3400, extension 306.

The NWWD is affording interested parties the opportunity to provide written comments on the application or to be placed on the interested persons list for the application. These written comments or requests must be

Please do not support the petition for referendum

Why ...

First, three of the five City Councilmembers, elected by citizens of Greenbelt voted "yes" to the annexation of Parkside. Secondly, a letter from Michael P. McLaughlin, city manager, dated June 18, states "there would be little or no impact on the city services as a result of this annexation. Given the small size of the development (31 homes), there is no justification for adding additional police officers or other city employees or facilities as a result of this annexation." The two services questioned most often are police and snow removal. The Greenbelt police have an established patrol route including Kenilworth Avenue to Good Luck Road where they turn around. However, Bill and I have seen Greenbelt police in Parkside. From Kenilworth Avenue to Parkside is a half mile. Is it not possible to include Parkside in with this patrol route already established?

The snow removal service is the other service which Parkside would impact, but this service is not needed every year. Cul-de-sac's are known to be last on the list for services, and Parkside has three. Greenbelt has the best snow removal service in the area, so being last on their list could put us days before the county.

As for fire and rescue services, trash removal, recycling, care of common grounds, care of the stormwater pond, water and sewage treatment services, Parkside will have no impact on Greenbelt. All of these services will remain the way they are now.

Bill and I will pay a higher tax due to the value of our home. A \$15,000 surplus annually from our community has been estimated. We would hope that this would help pay for the trip from Greenbelt to Parkside. Bill and I have traveled to Greenbelt thousands of times for Labor Day Weekend to the movie theater, to do our banking, softball and soccer games, our dry cleaning, dentist/doctors' appointments, and visits to friends and never thought of wear and tear on vehicles.

Bill and I ask when they knock on your door, that you do not support the petition to referendum and let the decision for annexation stand as is.

### Open Letter

To Greenbelt City Council:

Both my wife and I were dismayed to learn of the City Council's approval of the annexation of Parkside into the City of Greenbelt. Council members were elected to represent the interests of the citizens of Greenbelt, not the residents of Parkside. As a result of your vote, we will now receive diluted city services without any reduction in taxes. In particular, police patrol coverage will be reduced. While this is great for the residents of Parkside, it is distressing to us. The council ignored the opinions of a majority of Greenbelt citizens and placed the welfare of nonresidents ahead of residents.

While we empathize with Parkside purchasers over the claimed misrepresentation by the developer that the subdivision was within Greenbelt city limits, Parkside homeowners should seek redress through a civil lawsuit against the builder, not by asking the city and its residents to correct the matter. Furthermore, the boundary of Parkside is contiguous with the City of Riverdale Park, which could provide police and other city services much more efficiently than could Greenbelt.

Years ago, the city annexed the area now known as Greenbelt East. This was done not as a benefit to the residents east of the B-W Parkway, but as a benefit to the then already existing citizens of the city by controlling new development. More recently, the Council unsuccessfully opposed development of Parkside. This was done as representing the best interests of the current residents of the city. Now the Council proposes to reward this development with annexation.

The Parkside subdivision construction did not have to comply with Greenbelt building standards or inspections. Our family paid a premium over houses in other locales to purchase a home in Greenbelt that did meet these standards. The residents of Parkside did not, but may realize a windfall increase in the value of their homes as a result of annexation. A reasonable argument may also be made that the annexation of Parkside could eventually lower our property values.

We have never before noted an action by the City Council that so blatantly ignored the best interests of the citizens of Greenbelt as does the annexation of Parkside. We urge you to reconsider this issue at the next meeting of the City Council.

**A Review**  
**Ted Kliman Exhibits**  
**At Center Gallery**

The Greenbelt Community Center Art Gallery will present an exhibition of artist Ted Kliman's "The Lamentations Series" beginning October 14 and running through November 14. The exhibition includes paintings, drawings, and prints.

Kliman will give a lecture on his work on Saturday, October 17, at 4:15 p.m. in the Gallery. Following the lecture there will be a reception for the artist from 3 to 7 p.m.

"The Lamentations Series" is a stark collection of works in black and white dealing with the effects of light and shadow on the drapery of impossibly long prayer shawls. The shawls appear to be wrapped around palpable human forms, but there is no human in any of the works. The shawls float in limitless space.

The works are brilliantly designed, and executed with meticulous craftsmanship.

While interest in drapery may have been the starting point, these works go far beyond simple representation. Influences on Kliman's work include the work

of Kathe Kollwitz, Judaism, and Jewish history, but Kliman's work transcends the specifics of its origin. Ultimately his works are an exploration of universal human spirituality.

The title "lamentations" is too narrow. There is lamentation, to be sure, but there are many other things. The figures in lamentation are the most predictable in the collection. Some of the works are mysterious. Some of the figures are asleep or waiting. Some dance. Some are in agony. One seems to ascend in glory and exultation.

There is enough mystery in Kliman's work to intrigue anyone, but the ultimate meaning remains elusive. It's worth a trip to this excellent exhibit by a Greenbelt artist.

## GHI to Renovate Corporate Offices

At the Greenbelt Homes Inc. (GHI) board meeting held October 1, they discussed renovations, heating options, and salary increases.

### Renovations

The GHI administrative building is in need of extensive repairs, which will take several years to complete. A new heating, ventilation and air conditioning system is needed because there are air quality problems in the building. Additional space is needed for record storage.

Eldon Ralph, director of GHI physical plant operations proposed that the board approve \$10,000 to commission an architect now to prepare plans with a view to starting the work in 2000.

The board passed the request for first reading.

### Heating Options

The board discussed a number of possibilities for heating options without taking any action. The prime consideration is what gas heat would cost. GHI engineer Jay Freedman said the Washington Gas Company would probably require at least 600 members to sign up, but gas would be available to all. President Keith Jahoda said there would be an eight year payback on the conversion to gas, but there are other options. Freedman said that on a large project like this, everything is negotiable. This issue will require further study.

### Salary Increases

There was some discussion as to how the 4.2% salary increase would be allocated. General Manager Gretchen Overdurff explained that increases will not be given across the board. Salary increases are based on merit and performance. Some staff may not get any salary increase, others

may get more than the 4.2%.

### Complaints

Two GHI members complained of vandalism, hate language, vulgar language and music, noise, and loitering. The members requested anonymity, fearing reprisals. President Jahoda agreed to look into the matter and to keep it as confidential as possible.

### Unit Conversion

The board attempted to resolve the issue of the member who wishes to combine two units into one at 4E and 4F Plateau Place. Jahoda offered three possible motions. The board approved the one which has a small impact on other members as the co-op costs will be divided among 991 frame units, one less than the current total of 992. The motion was not the one preferred by the member, who agreed to consider whether to accept the board's offer.

### Co-op Month

In celebration of National Co-op Month, a two page advertisement will be placed in the News Review next week with greetings, news, and information from all the Greenbelt Co-ops. The board voted to pay \$300 from marketing funds toward the cost (about \$720).

### Closet Roofs


The board voted to make closet roof repairs for two members GHI's responsibility.

### Meetings

Finance Committee meetings will be held October 19 and 26. The first work session on the budget will be held October 22. There will be a second budget hearing to get members input on November 2.

A meeting will be held October 29 to discuss heating options.

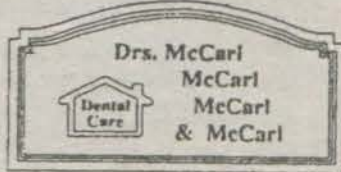

received on or before the date of the public hearing. Correspondence should be addressed to the NWWD at the above address and should refer to the case number for the project, 97-NT-0867/199861211.

Although the improvement of Sunnyside Road and Edmonston Road has been agreed to since the time that the USDA obtained approval to build the headquarters facility, the work cannot be done until a wetlands permit has been obtained. The city of Greenbelt has opposed the roadwork, contending that this work is only a part of the ultimate work required as a result of building the office facility and that the overall impact to wetlands will be greater than now indicated. The city is on record as being an interested party and has asked that its rights be reserved to offer comments either at the hearing or within a reasonable time thereafter.

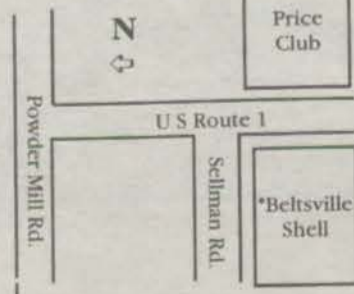

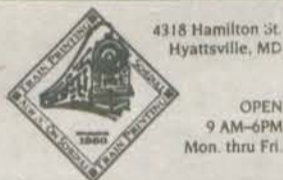

unless involved in a fatal accident, or if the person is also charged with another criminal violation; shoplifting, unless the suspect is charged with another criminal offense, such as assault, resisting arrest or possession of controlled dangerous substances. Generally, the names of all adults and juveniles charged as adults will be included unless it may jeopardize an investigation or put the defendant at risk of serious bodily harm or death. The names of juveniles charged as juveniles are not to be released except by court order.

Turnbull asked why DWI (driving while intoxicated) violations are not included in the report. Craze replied that it was a policy decision that could be changed if council so wished.

Roberts asked how other municipalities reported their crimes; that it seems like they are hiding something. In The Washington Post and other publications, Greenbelt has a long list of incidents and other localities just have a few. Craze said that Greenbelt is the only city in the state, perhaps the nation, that has this type of report. Other municipalities report individual incidents as news releases or wait for the media to inquire. This may have the effect of making Greenbelt look like a hotbed of crime. But the citizens of Greenbelt have a need and a right to know. Council members are agreed that the information is vital to Greenbelt but have misgivings about distributing it to outside media.

### News Review Position

James Giese, president, Greenbelt Cooperative Publishing Association, Inc. (The News Review) told the council that as a matter of policy the News Review reports only what happens in the community that affects the community. For instance, traffic violations on the major arteries, not involving Greenbelt citizens, would not be reported. What is seen in the News Review is abbreviated from the full police report.

### Other Actions

An ordinance to authorize the City of Greenbelt to contract with Crestar to borrow no more than \$225,000 for the purpose of acquiring a new computer system for the Finance Department was introduced.

Council unanimously approved the purchase of Pentamation financial software and the necessary hardware to process the financial transactions of the city. The purchase price for this sys-

tem and a consultant to develop a master plan should not exceed \$225,000.

Council unanimously authorized the city manager to enter into a one-year contract with Fleetpro to provide vehicle preventive maintenance. The cities of Bowie and New Carrollton use Fleetpro and recommend it. The estimated first year cost is \$59,731, 70 to 80 percent of which will occur this fiscal year.

A decision concerning the removal of the concession stand at Attick Park has been postponed until the next regular council meeting (October 12) pending further exchange of information between the city staff and the interested parties.

Michael Clem, the new senior administrative assistant (Recycling Coordinator) was introduced by Kenny Hall, acting director of Public Works.

case, this action would be taken by Mayor Judith Davis. The state law also requires the chief executive or administrative officer to set a date for the referendum. How Greenbelt will handle this remains to be seen, but it is expected that the city council will set the date.

Moran believes that the council will have the choice of either calling for a special election for the referendum or including the referendum as a part of the next city regular election scheduled for November, 1999. However, he is still attempting to clarify the matter.

The state law does not set a time for holding the referendum. It does require that two legal advertisements giving notice of the referendum must be published at weekly intervals before the election. Once the ads are run, the referendum must be held not less than 15 nor more than 90 days thereafter.

Assuming that only one petition is filed, the annexation issue will be resolved by the count of the voters. If a majority of the voters favor the annexation, Parkside will be annexed. If the majority opposes the annexation, Parkside will not. If both the city and Parkside residents petitioned for a referendum, then favorable votes from both areas would be required for the annexation to be approved.

### Other Action

One quirk in the annexation law is that there seems to be no provision for preventing the residents of Parkside from petitioning for annexation, should this effort fail. If they chose to do so, the city would be obligated to go through the entire process again. However, a negative vote of the electorate would most probably put a chill on any new efforts, and a favorable vote would, of course, eliminate the need for any other efforts.

Nor does there appear to be any other recourse for the opponents of annexation than to seek a referendum. In a memo dated September 24 to City Manager Michael P. McLaughlin, City Attorney Robert A. Manzi has advised that the power to annex or not annex is permissive, that is the city can annex or not, as it chooses, and the decision is not subject to appeal to any higher court. Only if there were glaring procedural errors in the annexation or referendum process might there be an avenue for legal recourse.
