A Conversation with Proponents And Opponents of Annexation

Some Greenbelt residents deem the March 9 referendum election as a chance to express their opposition to the annexation of the small enclave of unincorporated homes, but Parkside residents hope that the majority of the citizens will vote to welcome them into the Greenbelt family with opportunities for service.

"I'd feel great," said Parkside resident John Engels, who is a writer and editor. "I think we would try to move on and keep our



promise [to serve]. We are ready to participate. We are ready to volunteer."

The former Westchester Park resident said there are many reasons he wants his neighborhood annexed by Greenbelt.

"We like their inclusion and approach to taking care of each other," said Engels, who moved to Parkside to enjoy Greenbelt Park. "We would like to be a part of it [Greenbelt]."

"It has a very democratic process it practices and very liberal," said Engels, a member of the Friends of the Old Greenbelt Theatre. "It is about saving buildings and keeping the quality of life high."

An Analysis

Annexation: No Good Reason To Do It or Not to Do It

There is no good reason for the City of Greenbelt to annex Parkside in Greenbelt. Then again, there is no good reason for the city not to annex Parkside. Whether annexed or not, the impact upon the city will be negligible. Parkside is only 31 homes, 7.7 acres. The city already has 9,800 dwelling units and 3,800 acres of land — some 2,700 excluding Greenbelt Park. Parkside would constitute less than one-third of a percent, if annexed. The city staff estimates

Bill "Ozzie" Osborne, a uniform delivery driver, said he also would be pleased with annexation.



"I'd be happy if the citizens of Greenbelt felt the same way [as the Greenbelt City Council]" said Osborne, who grew up in Greenbelt, as did his wife Eileen. Osborne, who moved to Parkside to admire Greenbelt Park, also said that the annexation would be good for Greenbelt to even out the city's border down Good Luck Road.

Hands Are Full

Although Sandy Fleri of Boxwood Village views Parkside's desire for annexation as a compliment, she does not think such a move would be in the best interest of Greenbelt.



Fleri and her husband, Piero, whose three sons participate in the Community Center's drop-in art classes, moved to Greenbelt because of the parks and the city services, such as those provided by the fire and police depart-

ments. She was not privileged with these amenities growing up in Lewisdale, an unincorporated part of the county and had to rely on the county, for basic services. Services, she said, would be threatened if Greenbelt annexes Parkside.

"I think the police really have their hands full in Greenbelt and to take on a remote area would take away from the part of the community that already exists," said the tour guide owner Kathleen Hamby of Greenbrier.



"I think it's going to spread the police too thin and put an extra burden on the public works," said Hamby, a retired city worker who moved from Anne Arundel County to Greenbelt for its small town feel, clean streets, and city layout. "It will place a financial drain on the rest of the city."

But Parkside at Greenbelt Homeowners Association copresident Tim Edwards, who submitted Parkside petitions to the Greenbelt city manager, does not see annexation as an undue burden on Greenbelt's services or its economy.

"We don't have a police

voters in the city — not just by a select few.

Valid Issues

What are the best reasons for voting for or against the annexation? Although much has been said, only a few reasons strike me as meaningful.

On the "For the annexation" side, the city will add 31 large homes to its single family housing stock, now close to 850. With all the apartments and small cooperative and condominium homes in Greenbelt, there have always been Greenbelters who seek larger homes within the city in which to move growing families. The annexation will give those homeseekers a little more opportunity and a little more choice in larger housing within Greenbelt. It will also bring a little extra money into city coffers while expenditures are expected to be negligible. Finally, many are reluctant to say no or to exclude or build a wall to keep out a nice group of people, some of whom are children of longtime Greenbelt residents.

City Council Sets Law Suit In Motion; Plans Park Path

At its regular meeting on February 22 the Greenbelt City Council approved the construction of a path in Schrom Hills and authorized the filing of a lawsuit related to road improvements associated with construction of the U.S. Department of Agriculture building on Sunnyside Avenue.

Council also okayed plans to alleviate the parking problem at Green Ridge House. (See story next week.)

Lawsuit Authorized

In a quick, unanimous vote council authorized the law firm of Linowes and Blocher to file a law suit challenging the permit process which allowed improvements to Kenilworth and Sunnyside Avenues in connection with construction of the new USDA building on Sunnyside. Attorneys will make a presentation on the suit at the next council meeting on March 8.

Schrom Hills Park Path

Council approved the construction of a path in Schrom Hills Park to connect Greenbrook Lake to the active parts of the park. The path would be located on the

old Schrom airport runway next to the woods and would be constructed from asphalt millings to create a semi-hard surface. A good deal of discussion preceded the three to two approval vote. Both Roberts and Turnbull voted against the path. Turnbull was concerned about losing the more natural character of the park; both objected to the material being used and advocated a more "natural" chip. Turnbull also wanted to hold off on a decision until having a path along Hanover Parkway and keeping the pathway out of the park itself could be further explored.

White and Davis spoke against a path along Hanover Parkway from a pedestrian safety perspective. Putens expressed the interest of Greenbelt East citizens in having access to the park and that families who used the park would want to bike or push strollers along the path. White emphasized that this path had always been planned as part of the Schrom Hills Park master plan. Finally, Davis requested that a

Parkside Election Polls Open 7 a.m. to 8 p.m.

About 10,000 Greenbelters are eligible to vote in next Tuesday's Special Election. Voters will be asked to vote "yes" or "no" on the question of whether or not the Parkside Community should be annexed into the City of Greenbelt. A subdivision of 31 single family homes, Parkside is located off Good Luck Road and is adjacent to the boundaries of the city, surrounded on three sides by Greenbelt Park. (See separate articles.)

Polls will be open from 7 a.m. to 8 p.m. Registered voters residing in Precinct 3 (Center), where 2,485 residents are registered, will vote at the Municipal Building. Precinct 6 (North End) voters have 2,175 eligible voters who will cast their ballots at the Greenbelt Police Station. Precinct 8 (Springhill Lake) registrants numbering 1,854 will vote at the Springhill Lake Recreation Center (Club House). The polling facility for Greenbelt East's Precinct 13 is the Greenbrier Community House. Precinct 13 has 3,548 registered voters.

Applications to vote by absentee ballot may be obtained in the City Clerk's office in the Municipal Building, 25 Crescent Rd. They must be submitted by noon on Monday, March 8. Completed ballots must be returned to the City Clerk no later than 6 p.m. on the day of the Special Election, Tuesday, March 9. For more information call 301-474-8000.

On election day the Greenbelt

Dial-A-Ride will be providing free transportation to the city's polling locations between the hours of 8:30 a.m. and 3:30 p.m. Interested citizens are asked to call 301-474-4100. Pickups will also be made at Green Ridge House at 10:30 a.m. and 2 p.m. (See ad.)

City Clerk David Moran estimates the Special Election will cost about \$5,000.

Get Out and Vote

Last fall 3,500 people signed a petition calling for a referendum on a request for annexation of a new development into the City of Greenbelt. This community of 31 homes is adjacent to the municipal boundaries, which include Greenbelt Park. The park itself is separately administered, however, under the National Park Service.

Citizens opposed to the annexation request originated the call for referendum. They conducted a vigorous campaign for signatures on their petition, including outside the polls on election day in November when registered voters were easy to identify. Many voters signed the petition — enough to meet the state law requiring the referendum. Many of these, regardless of their feelings about annexation, said they felt happy to endorse this call for citizen action in a democracy.

A vigorous debate ensued. The many letters to the editor and advertising by both proponents and opponents have provided opportunities for all to become informed.

We urge each registered voter in Greenbelt — whether or not their name was on the petition — to vote on March 9.

My Letter Was Distorted

A letter to the editor I had written appeared in the February 25 News Review. While I appreciate the opportunity the News Review gives people to voice their opinions, my letter was edited in ways that distorted and changed the points I was making.

I had written "Riverdale Park provides" -- present tense -- "public works and police services to Madison Hill and both lanes of Good Luck Road from Kenilworth Avenue to Parkside." The News Review changed the verb tense to "provided," which incorrectly implies police and public works service is no longer provided. What I had written was correct. Riverdale Park has been providing and continues to provide public works and police services to Madison Hill and both lanes of Good Luck Road from Kenilworth Avenue to Parkside.

The News Review also changed the topic in one of my sentences. In describing the property on which the Parkside houses are built, I had written, "Before it became Parkside, it was the DiCamillo property, which had a Riverdale address." The News Review added the words "post office." I had not mentioned anything in my letter about post offices. I was writing about addresses and the point I had wanted to make clear was that the DiCamillo property has always been in Riverdale, never Greenbelt, just as Parkside has always had the same Riverdale address, not Greenbelt.

Since the News Review has interjected "post office" and has opened the door to mail delivery, I think it only fair to add the following. In December and January I had discussions with Lula Alexander, postmaster of the Riverdale 20737 post office. She confirmed the same carrier from the Riverdale post office delivers mail to both Madison Hill and Parkside, and also referred me to her superiors who further confirmed the Riverdale post office delivers mail to Madison Hill and Parkside and that is the way it will stay.

Services to Parkside Are "Problematic"

When I vote on the Parkside annexation question on March 9, that vote will be a vote of support for our city manager and the rest of our city's staff. Parkside is across the street from the city services (police, public works, etc.) provided by the town of Riverdale Park. Parkside is not across the street from the city services of Greenbelt. It is miles away.

Be Friendly

Supporters of Parkside annexation say they wish to be part of the civic and cultural life of Greenbelt. This sounds fine but there is much worthwhile that is nearer Parkside.

Parkdale H.S. is across the street from Parkside and the church is two miles. The Catholic School and church in Greenbelt, St. Hugh's, are 4.5 and 4.6 miles. There is no Orthodox church in Greenbelt. Here we do have Mishkan Torah. Near

Parkside there is no Jewish house of worship.

As for Protestant churches, there are at least nine nearer to Parkside than the nearest in or near Greenbelt. About half the churches close to Parkside are small fundamentalist. There is a nearby Episcopalian church. No church of that denomination is in Greenbelt.

The Kenilworth Station of the Riverdale P.O. is 2.3 miles. The present Greenbelt P.O. is 4.6 miles and the site of the future Greenbelt P.O. is 3.6 miles.

All firefighting is a county responsibility. There are four fire houses near Parkside. The Greenbelt fire house will be called upon only in the case of a two alarm fire.

The police situation is more complicated. The City of Greenbelt serves those areas within the city. The Town of Riverdale Park serves the area within the town. Right now the county has jurisdiction over Parkside. However at times one police department aids or supplements another. The Greenbelt police station is further from Parkside than the Riverdale Park station and at least one of the county stations.

Whether annexation wins or loses residents of Parkside are most welcome to shop and eat, attend our places of worship, theaters and other cultural events. I believe that residents of Greenbelt must at all times be friendly and neighborly to those in Parkside.

More Letters

Compelling Reasons

It has been said that I gave no compelling reasons for my vote to annex Parkside. I did, indeed, give several reasons for my decision the night council took its final vote. Though those opposed to annexation were not convinced, these reasons were logical and compelling enough for me:

1. The city manager's report stated that no additional employees or equipment would be needed to service Parkside.

2. Annexing Parkside would increase the city's tax base and provide an annual \$15,000 net revenue benefit.

3. Greenbelt's number of single-family homes would increase — a goal the city council has worked and negotiated toward for many years.

4. Greenbelt's boundary along Good Luck Road would be filled in, a process which was discussed in a 1994 Planning Office Annexation Report.

5. Parkside's roads were inspected by public works and found to be in better condition than many older roads in Greenbelt. Should Parkside's roads ever need repair or replacement, they would be added to the Capital Projects list that is set by council each year.

6. City services would not be unduly strained. Fire and ambulance service would be provided by West Lanham Hills Fire Department. Parkside contracts with a private trash collector. Their stormwater management pond will be maintained by the county. From the police station the police can get to Parkside more quickly, by almost four minutes, than to parts of Greenbelt East.

Since the council's vote, I have learned that our police and public works radios operate just fine in Parkside. In three years, Parkside residents have made only one call to the county police. Furthermore, the tax benefit was refigured, using the same methodology as in 1992, and still remains almost \$15,000.

Some have voiced concern about what kind of homeowners might move into Parkside in future years. This concern could be raised about any of Greenbelt's neighborhoods. The quality and condition of a community depend on the vigilance of its citizens, its homeowner associations, and its city government. The present quality of life in Greenbelt is testimony to our past success and suggests that these cooperative efforts will continue.

These are my compelling reasons for deciding to welcome Parkside and its residents into our Greenbelt community.

Two Relevant Issues

There are (at least) two issues relevant to the upcoming election on the annexation of the Parkside homes: one is political in nature especially with respect to tax revenue and the second relates to community. On both of these issues, I stand strongly opposed to the annexation. This letter is in response to previous letters to the News

Review arguing for annexation 1) because of the significant revenue that will be generated and 2) it would be un-neighborly not to welcome the people of Parkside.

Although it is certainly right and good to welcome people into our community, there are practical constraints imposed upon a municipality, two of which are financial and geographical. Both must be honored and both indicate the inappropriateness of the proposed annexation.

First, the financial issue. The tax generated by a given household is proportional to the assessed value of that home. While townhomes in old Greenbelt sell at around \$50,000, the value of the houses in the Parkside development are estimated at around \$250,000 to \$300,000. So, by these estimates, a Parkside unit will produce five to six times more tax revenue than that of a typical GHI unit. That the city is very interested in the tax revenue is clearly evident in Mayor Davis' comment upon the all-too-eager city council's vote to annex: "Welcome to our city, welcome to our taxes." While the current city council may have pure intentions for deciding to annex, the disproportional tax base generated by the larger, more monetarily valuable Parkside homes may result in these homeowners having a similarly disproportional influence over the rules and activities of the City of Greenbelt.

Now, let me move to the issue of being neighborly. It seems apparent to me that the most un-neighborly action possible is for the people of the Parkside community to turn their backs on the natural community adjacent to them and desire annexation to the discontinuous Greenbelt community. While it is true that they are surrounded on three sides by the City of Greenbelt, all three of these sides are Greenbelt park, while the fourth side is the Madison Hill subdivision community and Parkdale High School across the street. I live in Greenbelt because I chose to move into the community. It is irrational and unwise to think that you can move this community to you. I believe it is part of the spatial proximity — being "nearby" — which helps bring the people and actions of Greenbelt into harmony. It is this same belief that has me strongly opposed to tearing apart the natural and spatially connected community of Parkside and their neighbors across the street by annexing Parkside into the City of Greenbelt. It is naturally a part of the city of Riverdale Park. I have only been in Greenbelt since last summer and was not part of the struggle to keep the Parkside community from being built and, so, have no grudge against the people or community of Parkside. I also believe in considering things rationally. The annexation of Parkside to the City of Greenbelt would be unfair and unwise.

Hire More Cops

I agree we need civility in discussing this Parkside annexation issue — or any other matter. I certainly am not angry at any Greenbelter on either side of this controversy. Of course, that doesn't apply to the two guys who gave me good reason one evening to want a cop urgently — and there were no cops. So discussion about whether annexation nets the city more or less than \$15,000 cuts no ice for me. Other numbers do count:

When I appeared before Council in January on this, my friend Mayor Davis told me council budgeted last year for hiring four more cops (they're in the pipe line). I'm grateful for this tiny start, but it isn't enough. Hire four more cops and you get less than one cop on the ground in Greenbelt at any one time. That's because our cops work about 42 hours per week and there are 168 hours in a week, and sometimes a cop is off ill, or on vacation, or in court to testify about an arrest or ticketing. We need to hire a lot more than four.

The other significant numbers you must derive each week by reading the "Police Blotter" column in the News Review. How many armed robberies, other robberies, assaults, thefts, burglaries, vandalisms? How many not arrested? All in Greenbelt, but not enough cops. More cops might deter some of that. But some folks want now to take in more territory, miles away, although that'll require more police time travelling there and less time here.

Awareness Key

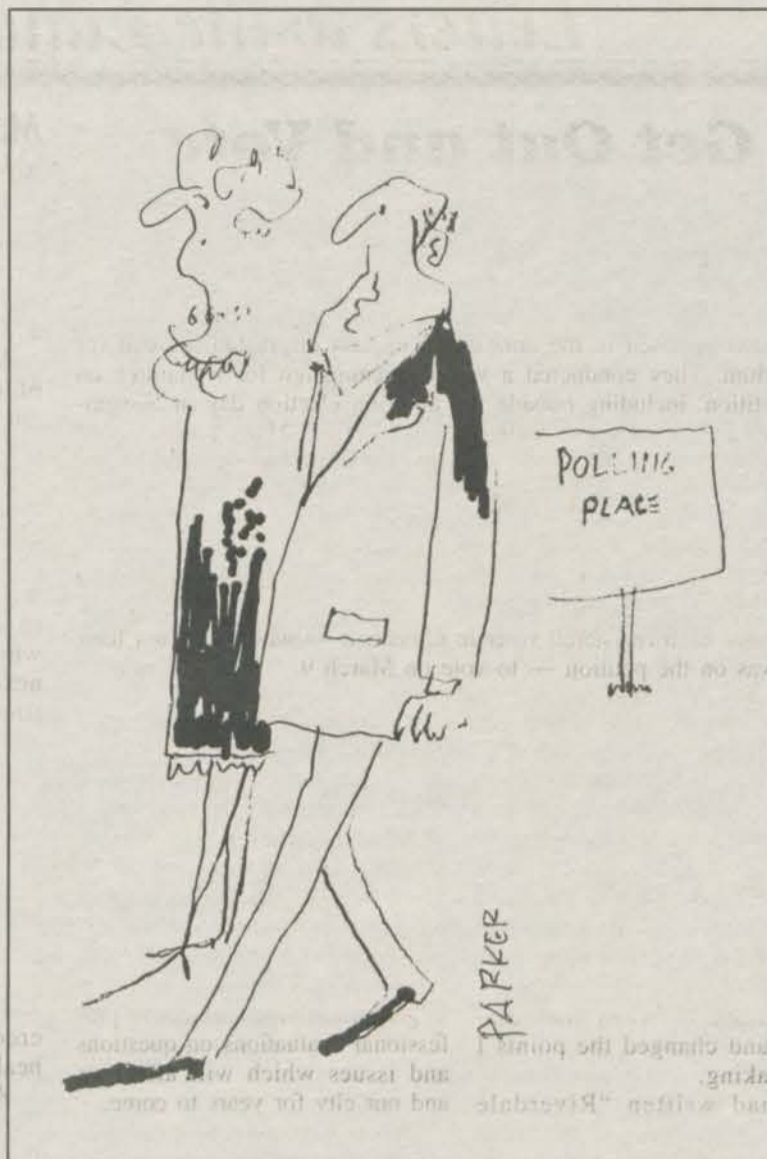

Last Sunday (Feb. 28) I attended a crime prevention program at the Greenbelt Community Center sponsored by the GHI Member/Community Relations Committee. Flyers had been hand distributed to each GHI home inviting members of the cooperative to attend this program. The guest speaker was Greenbelt Crime Prevention Officer Britt Cave. Topics discussed were personal safety, safety in the home and while walking and driving, the Neighborhood Watch program, and what to do if you become a victim. The officer answered written questions submitted beforehand.

I asked the officer when would the city again have an active animal control officer, as the current one has been out for over a year on disability. Officer Cave stated that it was unfortunate that we did not have an active animal control officer and that he did not know when they would resume duties.

My other question pertained to the fact that some in Greenbelt have not observed our police routinely patrol our neighborhoods

as regularly as before. The officer acknowledged that they (Greenbelt police) are currently understaffed somewhat, with one officer out on disability, one out on paternity leave and another out on administrative leave pending legal action. He referred to the fact that six officers are presently assigned to the Springhill Lake area but that only four officers are currently "covering" SHL.

He also mentioned that the Bike Patrol program has been effectively put on hold due to this present manpower shortage. Officer Cave is to be commended for sharing with us many tips we can use in protecting ourselves.

Other Business

Council approved for first reading resolutions for the negotiated purchase of treatment and restoration of the Mother and Child statue, site furnishings, and paving and concrete work for the Roosevelt Center Mall. Council passed an ordinance granting a non-exclusive cable television franchise to Jones Communications of Maryland, Inc. Subsequently council approved a transfer of control of the franchise from Jones Communications to Comcast Corporation, which has assumed parental control over Jones Intercable.

City Manager Michael McLaughlin announced that work had begun on the Roosevelt Center renovation. Trees and furniture have already been removed; he expects the project to be completed in late spring or early summer.

Mayor Davis complained that many street lights were out again on Hanover Parkway and other areas in Greenbelt East. In response, McLaughlin said he would call for a meeting with Pepco.

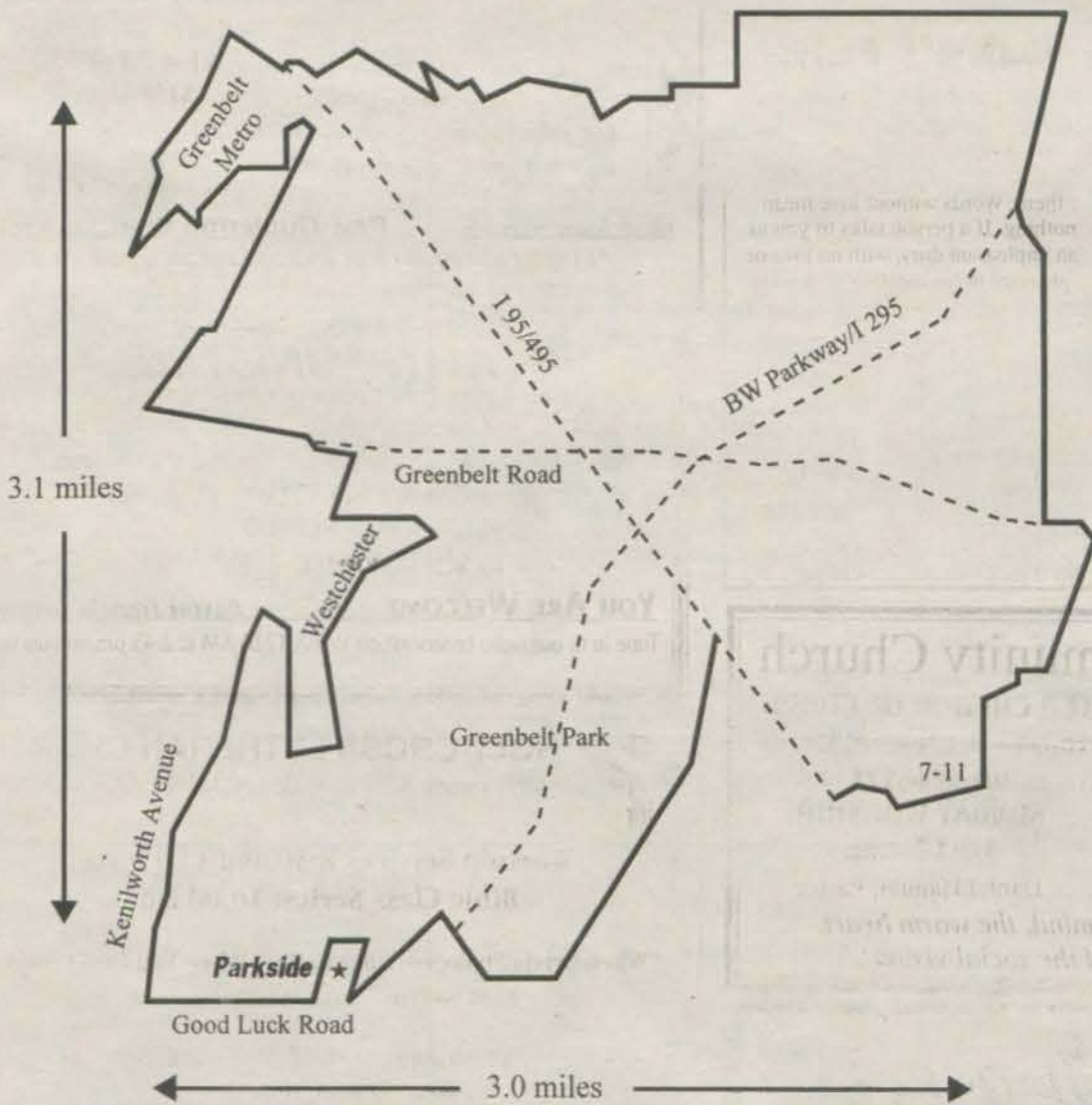

problem here. The schools won't be overly affected. The most it is going to cost Greenbelt is the election," said Edwards, a real estate property manager.



"We are not going to impact Greenbelt at all," said Edwards, who moved from the District of Columbia to Parkside because of its proximity to Greenbelt shops, banks, movies, and Greenbelt Park, where he volunteers.

Silly Argument

Greenbelt Homes Inc. (GHI) resident Dale Fink does not think annexation would have a huge effect on Greenbelt services, either. Fink, who grew up on a farm in Illinois said the nearest town was six miles away but their family still received city services. "I think it's a silly argument," said Fink, a



computer scientist, who moved to Greenbelt so he could bike or walk to work. He said the residents' care of Greenbelt Park is of value to the environment, thus increasing the quality of life for everyone, but that would not be the only reason for annexation.

"Now that Parkside is developed it would be a smart thing that it was part of Greenbelt because we would have control over its future development," said Fink, who serves on the GHI newsletter committee.

Not only that, but Edwards said annexation would bring closure to some unfinished business. "It would clean up a messy arrangement," he said. "We thought we were in Greenbelt [when we bought our homes]."

However, Ed Day, a GHI resident who attended Parkdale High School across the street from Parkside, said he does not see how this could be so.

"Never in a million years did we [students at Parkdale] think we were in Greenbelt," said Day, who is a museum manager, a current member of the GHI ad hoc committee for historic preservation, and a former member of the board of directors for the



Greenbelt Museum. Day said the architectural design of Old Greenbelt fosters a closeness with its neighbors that would not carry over to Parkside.

"I think geographically it [the annexation of Parkside] does not make sense."

Different Kettle of Fish

GHI resident Sylvia Lewis concurred. Lewis, who likened Greenbelt to a village in her native home of England, was one of four Greenbelt citizens who approached

the city about taking the annexation to a referendum vote and along with others went door-to-door to get petition signatures. Over the years, Lewis said leaders



have striven to psychologically and geographically mesh the three contiguous sections of the city: (Old) Greenbelt Central, Greenbelt East, and Greenbelt West (Springhill Lake apartments).

"If we annex Parkside, this will be an entirely different kettle of fish," said Lewis, who moved with her husband Robert from Bethesda to Greenbelt because of the recreational activities for their children. She explained that the effort spent on unifying the three sections would be diverted to bringing Parkside into the city.

"All that energy will be of benefit to only 31 houses," said Lewis, a retiree. "The effort required will be out of proportion to the number of citizens who will be benefiting."

What If?

And if the annexation campaign is defeated?

"I will be pleased I had a part in giving Greenbelters a voice in the future of our city," said Lewis, who is a member of the GHI audit and member and community relations committees and treasurer of the Eleanor and Franklin Roosevelt Democratic Club.

"I would be sorry for them, and glad for us," said Hamby, who lived in GHI as a child. "They were sold a bill of goods when they were told they would be a part of Greenbelt."

"We would take it personally," said Edwards, who said he likes his neighbors and his home. "Who wants to be in a situation where no one wants you?"

But Engels said he would not take a no-vote to heart.

"I wouldn't feel particularly bitter or vindictive," he said. "I would respect the democratic process."

Osborne said he would be disappointed.

"I would still do all the things I

do anyway," said Osborne, who has played on the Greenbelt adult football and softball leagues and whose children have taken swimming lessons at the Greenbelt Aquatics and Fitness Center.

"I just wouldn't get the city rate, I guess," he chuckled.

But Fink hopes this will not be the case and that Greenbelt will annex Parkside. "I think we are stronger with them than without them," he said. "I would be pleased to welcome them into the community."

GAC's Roses Bloom in Son of York

Family troubles? Inlaws bugging you? Tired of political intrigue? Sick of sex at the seat of power? Come to 15th century England at the Greenbelt Arts Center and see how things really were in the good old days!

The Greenbelt Arts Center (GAC) just opened Katherine Dubois' play, *Son of York*, a delightful spoof of the English War of the Roses.

(Now is the winter of our discontent made glorious summer by this sun of York.... sun of York.... sun of York.... get it?)

This wacky play stands history on its head. To be sure, there's the wimpy Henry VI who falls down the stairs and breaks his neck. And there's his wife, Margaret of Anjou, one of the world's great shrews. But somehow the stories and the characters aren't quite as history paints them. Rogues, knaves, good guys, queens and flirts get promoted, demoted, exiled, sent on wild goose chases, or slaughtered by accident or on purpose and/or

for all the wrong reasons — all with comic effect.

Andy Greenleaf is credible as the capable but vain King Edward IV stumbling through life on his good looks and his many female conquests. His brother, Richard Duke of Gloucester (later Richard III) is amiably played by Kevin Inouye. Richard is usually considered a great villain, but here, he means well but everything goes wrong anyway, again with comic results.

Lloyd Rawley turns in a fine performance as the third brother, the inept and whiny George, Duke of Clarence.

This trio of stooges blunders along steamrolling over history to everyone's delight.

Tanya Badgley is formidable as the Lancastrian battle axe, Lady Margaret Beaufort.

The talented Laura Anne Fisher turns in a good but too brief performance as Ann Neville, who is alternatively witty, flirtatious, and tragic. She has a brief mad scene reminiscent of Ophelia.

Tom Zanner and Trix Whitehall (reprising her role as Edith) are enjoyable as the earthy peasants who manage to survive all the political turmoil.

Heather Martin plays the peasant girl (raised to lady-in-waiting and not quite fitting). Martin has a sharp knack for comedy and a rubber face perfect for comedy. But her constant mugging and changing facial expressions did not serve her character.

Penny Martin makes a too brief appearance as Margaret of Anjou, the woman we love to hate.

The delight of the show is the irrepressible Jennifer Rapp as the flirtatious and always available Jane Shore. She electrifies the stage and reminds us what comedy is all about.

Oh, don't worry about the history! Go see it, and laugh anyway!

In the Arts Center's production of the prequel *York 8, Lancaster 6* a few years ago, Trix Whitehall and Ben Fisher played the peasant couple. Tom Zanner dedicated his performance in *Son of York* to the memory of Ben Fisher, whose role he assumes in this production. Ben was very talented and funny and deserves to be remembered. Ben would be proud of Tom's performance.

Graduation Incident Fallout Leads to Criminal Charges

The fallout from crowd control problems at last June's Greenbelt Middle School's graduation ceremony at Eleanor Roosevelt High School has cost a Greenbelt police officer his regular "police powers." Officer John Rogers, a nine-and-a-half year member of the department, was suspended on February 24 with pay and reassigned to administrative duties until further notice. This action followed an official charge of second-degree assault brought against him in Circuit Court by the Prince George's County State's Attorney's office. The victim named in the charge against Rogers is James Kizer, a cameraman with WRC TV Channel 4, who was filming the event.

No date has been set for trial in the Circuit Court. If convicted, Rogers faces up to \$2,500 in fines and a maximum of 10 years in prison.

The assignment to the Circuit Court is seen by those familiar with the case as unusual. Defined as "simple assault" or "misdemeanor," second-degree assault is normally heard in District Court. According to Rogers' attorney, James Papirmeister, in eliminating the District Court stage, the State's Attorney has denied Rogers his full rights to due process. Responding to this charge, Paula Burr, spokeswoman for the State's Attorney's office, said that "it is the State's Attorney who decides which court to file a case in."

History
At the ceremonies on June 15, 1998, crowd control measures were called for by the Fire Marshall after school offi-

cial and security personnel became alarmed at the unexpected overflow crowd numbering about 1,000 to 1,300 parents and friends of eighth grade graduates. This number, which far exceeded the capacity of Roosevelt's 850-seat auditorium, presented safety and fire hazards.

With people crowding into the auditorium aisles and blocking exits, school and security personnel closed the door against others who wished to enter. Unable to control the crowd, they called for help and reinforcements from the Greenbelt Police Department, the Prince George's County Fire Department, and the Sheriff's Office. The overflow crowd, upset and frustrated when they could not see the graduation from the auditorium and unhappy about being sent to the cafeteria, were then escorted out of the building. During this process of moving people away from exits and entrances, a confrontation occurred between the crowd and police, including the incident involving officer Rogers and cameraman Kizer, who in the melee fell to the ground. Kizer suffered a broken collar bone.

According to Greenbelt Police Chief James Craze, in a criminal investigation report, school officials had asked the police to have the news crew leave the school. The crew was complying, according to Craze, but, when officers were then requested to move the crew still further back from the building

entrance toward the parking lot, PFC Rogers came into "physical contact" with Kizer, who claims that Rogers assaulted him.

In the report Rogers denies the charge. He claims instead that in carrying out his duty, he had announced his presence and, while he was attempting to touch Kizer on the elbow to get his attention, Kizer reacted and lost his balance. While Rogers was trying to break Kizer's fall, they both fell to the ground.

This information was included in the report prepared by the Greenbelt Police Department's Criminal Investigation unit. Chief Craze emphasized that in order "to ensure objectivity," his department had initially contacted the Maryland State Police to conduct the investigation; however, the request was denied. Craze said a negative response was also received from the Prince George's County Police

Department and a request to the State's Attorney's office was also not responded to.

Investigation

Only then did the Greenbelt Police Department undertake the criminal investigation. Help in enhancing the video filmed by Kizer was provided by the Federal Bureau of Investigation. According to the criminal investigation report, the enhancement showed that PFC Rogers announced his presence to Kizer but the video does not show "how the physical contact occurred." However, the report states that both men were in some degree of physical contact.

In conclusion, the report states that: (1) based on "conflicting information" from witnesses "there is inconclusive evidence to support a criminal charge against PFC Rogers" and (2) the case has been "hampered" by legal counsel for Kizer and a Mr. Handly, a WRC

reporter on the scene, for not allowing either man to be interviewed. According to the report, "An incident cannot be properly investigated" when the person initiating the claim refuses the opportunity to be interviewed.

Chief Craze said the Police Department deferred to the State's Attorney's Office for placement of a charge if it were deemed appropriate based on the conflicting statements of eye witnesses, half of whom supported the officer's version of the events and half who believed that an assault had occurred.

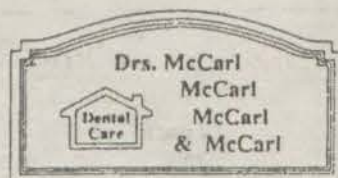

side, Parkside is distant from any of the other developments in Greenbelt. It is on the other side of Greenbelt Park on Good Luck Road, near Parkdale High School. If Parkside were annexed to the city, it would be inconvenient for city crews to service and maintain it — they would have to travel extra minutes and extra miles to get there. Extra minutes and extra miles will make doing maintenance in Parkside a little more costly than other places in the city.

Although some other parts of the city may be farther distant by road from the police and public works facilities, they are contiguous to other developments in the city and, like it or not, they are already a part of the city. While the possibility is somewhat remote, there could be a delay of a few minutes in emergency police response to an existing area of the city because an officer is at Parkside, if it were annexed. However, that needed officer could as easily be in another place remote from where the call is.

Too Big?

And, if you feel that Greenbelt is already too big, as some do, Parkside would make it a teeny bit bigger. But don't think that annexation will encourage more development or more annexations. There just is not much land left around here to be developed, and whatever is

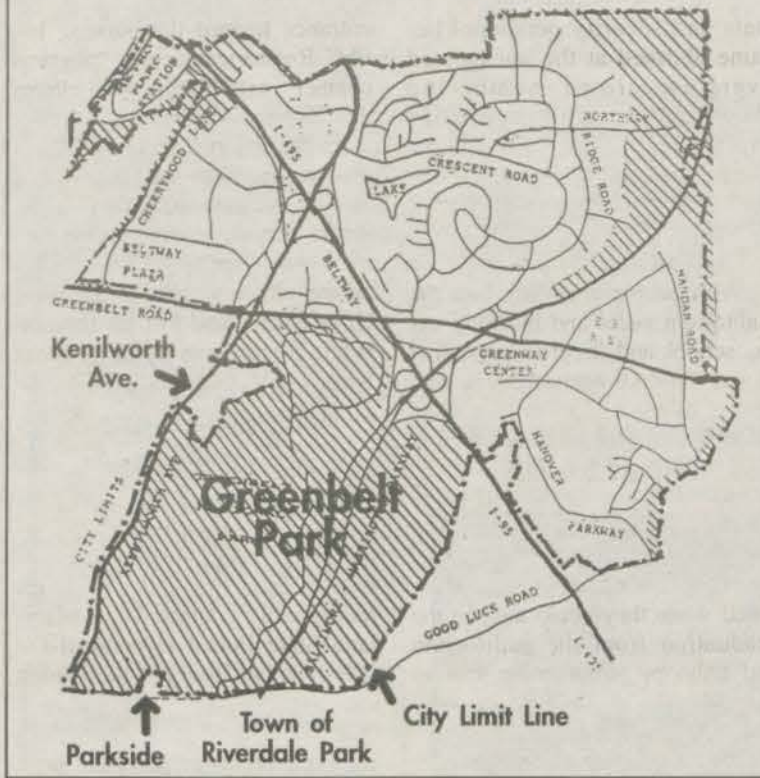
left that is privately held will be developed whether or not Parkside is annexed.

Also, each annexation is a case by itself. Many areas adjacent to Greenbelt could have requested annexation but have never wanted to — for example, Westchester Park, Good Luck Estates, Dresden Green and Madison Hill, the area that recently chose to be annexed to Riverdale Park. It is unusual for a group of homeowners to seek annexation because annexation means higher taxes.

Two irrelevant issues I have heard tossed about hopefully will not be the basis for voters' judgements at the referendum. One is to vote "no" to punish the developers of Parkside for developing land that should be part of Greenbelt Park. The developers are long gone, never sought city annexation and could care less about what happens to Parkside now.

The other is to oppose annexation as a means of punishing the majority of city council who voted on this issue without giving sufficient time for public input. If you're mad at councilmembers, fine — don't vote for them the next time they are up for election.

But there has been plenty of public input into the annexation issue now, and your vote should be based on the merits of that issue, not something irrelevant.

Your Call

In the final analysis, however, it is up to each reader who can vote to decide what are the important issues and to vote as he or she may see

fit. For that decision to count, however, it must be registered at the election polls on Tuesday, March 9. Please don't disappoint all those Parksideers and their friends who have worked so hard to become a part of the city, or all those opponents who worked equally or harder to make certain that the decision would be made by the voters and not the city council.

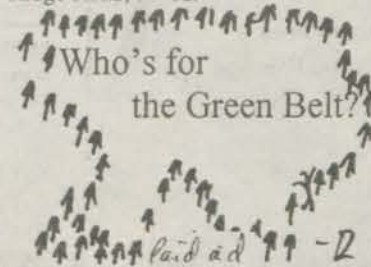

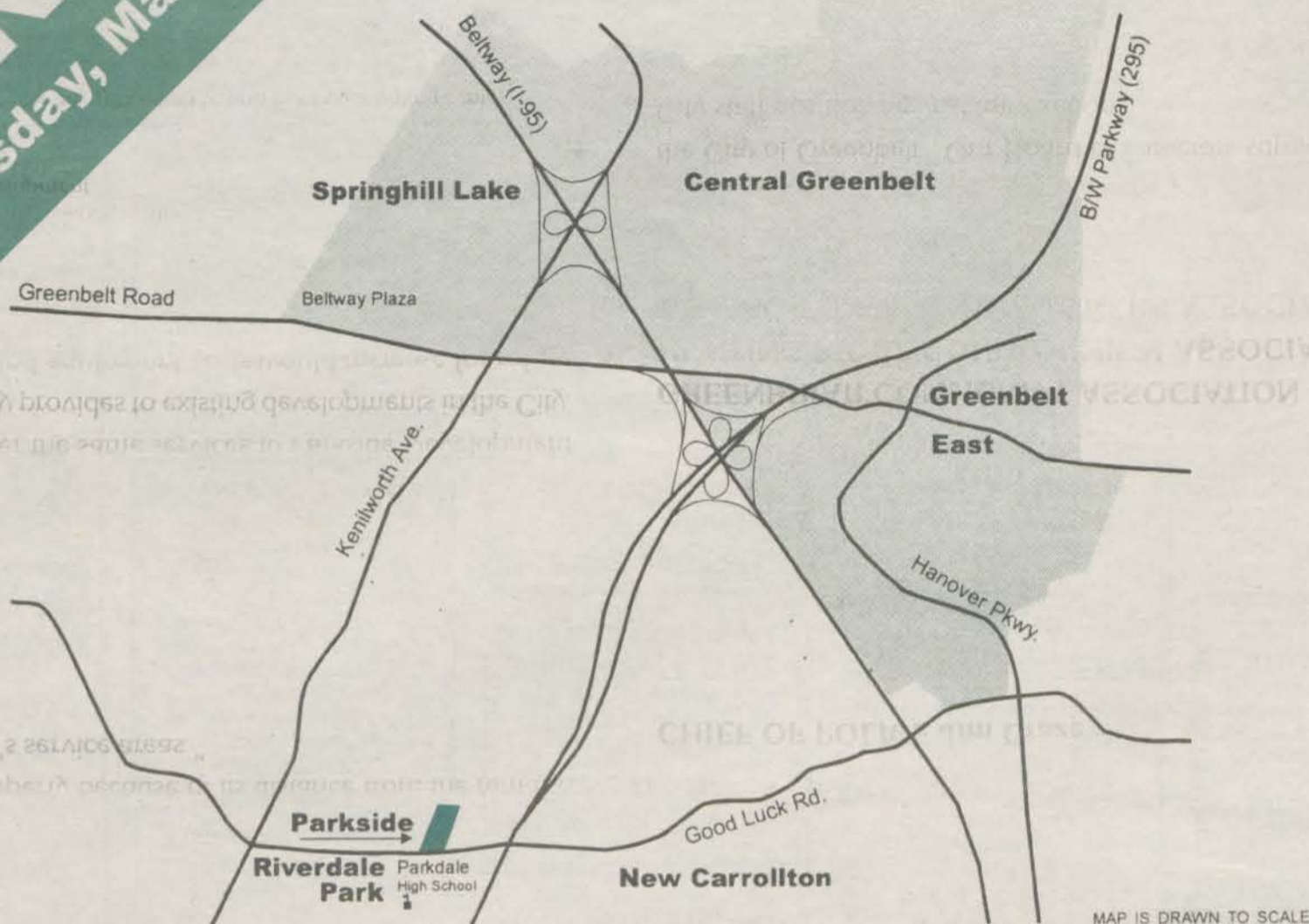

Views On Dental Health
