Council Annexes South Core Tract of Greenbelt Station

During a three-hour-long meeting on December 12 the Greenbelt City Council voted to annex to the city 86.4576 acres of additional land, the South Core of the proposed Greenbelt Station development located to the west of the Springhill Lake apartments and south of the Greenbelt Metro station – a potentially valuable new year gift to the city. Originally planned for adoption at the November 28 council meeting, this annexation resolution was postponed due to a lack of clarity regarding metes and bounds. That separated this action from the annexation of stateowned land along Cherrywood Lane, 75.4634 acres "more or less" of "sensitive land surrounding Indian Creek," which was enacted then. Resolution Number 991, annexing the state property, will become effective after 45 days unless it is petitioned to referendum by registered voters of Greenbelt.

Public Hearing

Before acting on the South Core annexation, a required public hearing was held by the council. Greenbelt residents Bill Orleans, Robert Fireovid and Joan Falcao volunteered opinions and reservations about aspects of the proposed annexation. Orleans said he did not object to the annexation per se

but remains concerned about the city's financial obligations, especially if the developers should be investing in roads, services and related infrastructure.

The mayor explained that the financing issue "has not been decided at this time." Orleans said he is "happy about the annexation part" but pressed council on whether the city would some day ask Greenbelt residents to pay more for this deal.

City Manager Michael Mc-Laughlin stressed that "the financing issue is not before the council tonight but would come later as an ordinance or resolution." He also noted a 45-day time period before the resolution becomes finally adopted. During this time Greenbelt residents or the owners of the property to be annexed who do not wish the annexation to take place may collect signatures for a petition to put the proposal on the ballot for the voters to decide.

According to Mayor Judith Davis and Department of Planning and Community Development Director Celia Craze, the city is wisely buying influence over the design of a development that will come to this re-Neighboring gion anyway. towns are also interested in annexing the land in question or certain parcels of it.

Greenbelt Station Continuance

The Conceptual Site Plan (CSP) presentation before the Prince George's County Planning Board (PGCPB), scheduled for December 22, is expected to be continued until January 12.

Norman Rivera, attorney for Greenbelt Metropark, LLC. stated in a letter to Elizabeth Hewitt, Chairman of PGCPB, that ". . . due to remaining differences of opinion between the developer and the City of Greenbelt on several items related to CSP, both parties are confident that additional time would result in a harmonious presentation to the Planning Board."

Confirmation of the continuance will be decided on December 22.

Annexation Benefits

Councilmember Rodney Roberts, along with self-described newcomer to Greenbelt, Falcao, questioned the benefits of the city's financing a projected \$8 million in public facility

ICC's Final Environmental Impact Statement Is Ready for Review

According to State Highway Administration (SHA) spokespersons Wesley Mitchell, project manager for the Inter-County Connector (ICC), and David Buck of the agency's communication department, the Final Environmental Impact Statement (FEIS) for the ICC is expected to be in the hands of SHA officials by December 30. The Federal Highway Administration (FHWA) will be sending the document to the SHA project team.

Input from various agencies such as the Wetlands and Waterways Program of the Maryland Department of the Environment, the Environmental Protection Agency, U.S. Fish and Wildlife Service, the Corps of Engineers and the National Park Service as well as comments by the public were said to have been considered in preparing the FEIS. Buck noted that after receiving FHWA's signature on the FEIS, there will be 30 days for comment from the public – January 3 to February 2. After this phase is completed and evaluated, FHWA will issue a Record of Decision identifying the Selected Alternative for the project to pro-

On July 11, 2005, Maryland Governor Robert L. Ehrlich, Jr., announced that Maryland had selected the southern Master Plan Alignment (Corridor 1) as the preferred alternative for the proposed ICC. Two alternatives were also considered but rejected at the time - the northern corridor route and the no-build alter-

The southern master plan route, a 17.5 mile six-lane toll parkway with two transit/carpool lanes will link I-370 near Shady Grove Road with U.S. Route 1 north of Muirkirk Road near Laurel.

When Governor Ehrlich made his announcement in July 2005, the reaction of the Prince George's County Council was negative. In a press release at the time, they stated that "despite the County Council's steadfast opposition, the ICC is moving closer to approval." Today the county council's position remains in opposition according to a spokesperson for County Council Chair Thomas Dernoga. There has been talk, however, about a possible meeting with the county and SHA.

For decades a succession of Greenbelt City Councils have opposed the ICC. Mayor Judith Davis reiterated the city's longstanding and well known opposition. She observed, "The ICC represents a large expenditure of funds for a project that will have significant environmental costs, while doing very little to improve the region's traffic congestion problems."

Greenbelt officials feel that the ICC will be tied into a proposed extension of Kenilworth Avenue, resulting in Montgomery County eastbound traffic being funneled into Greenbelt. College Park and Bowie are also concerned with potential traffic impacts from building the ICC. The City of Laurel supports the construction of the ICC's Corridor 1, provided that the alignment continues easterly until reaching Kenilworth Avenue extended or U.S. Route 1.

Tree Lighting Kicks Off Celebration in Greenbelt East



Obituaries

Rose Haber



A longtime Greenbelt resident Rose Firester Haber, 87, died Tuesday, December 13, 2005. She had been living

at Sunrise of Silver Spring where she had moved in March 2005 from her home on Westway.

Born January 1, 1918, in Brooklyn, N.Y., Mrs. Haber was the seventh of nine children born to immigrant parents from Eastern Europe. Mrs. Haber grew up in Brooklyn, spending summers at Coney Island, where the family also owned a home. Eventually they moved to Coney Island yearround and it was there that she developed her passion for swim-


She met Raymond Haber, who shared her love of swimming, at Coney Island. They were married July 30, 1939, when Ray was working at the New York World's Fair. Mr. and Mrs. Haber moved to Washington, D.C., when he got a job as a messenger for the federal government. After the move to D.C. they met people who told them about the new community of Greenbelt. The Habers put their name on a list for the government-owned housing and waited for several years.

In 1944, shortly after the birth of their second daughter, the family moved to a home on Eastway. When the federal government sold the houses and GHI was formed they bought a "defense" home on Southway and in 1958 they bought their home on Westway.

Mrs. Haber was always devoted to her family and her community. She was a Girl Scout leader, made sure that her daughters had dance lessons and sewed costumes for recitals. She and her husband were founding members of Mishkan Torah Synagogue and even helped in the construction.

She worked as a bookkeeper for Goldenbergs and Hahn Shoes. Later Mrs. Haber worked at the University of Maryland at the dairy and then in the Physics Department.

She had hurt her back and her doctor recommended that she swim to strengthen her muscles. She got special permission to use the indoor pool at the uni-

versity during her lunch hour. Soon word spread and she had a group of women joining her in the pool.

After retirement Mrs. Haber became active in the Golden Age Club. She and Mr. Haber took classes at the University of Maryland and Prince George's Community College (PGCC). She took classes in exercise at PGCC, which she combined with swimming to develop a senior exercise and swim class at the Greenbelt pool; she also led a group of seniors in a weekly walk around the lake park. She continued leading this class for over 20 years until her health deteriorated in 2004. When her husband was in the Greenbelt Nursing Home in 1998, Mrs. Haber would often hold exercise sessions for the residents.

Mrs. Haber is survived by daughters Glenda Goodman of Silver Spring and Imogene (Robert) McCleary of Lothian; sisters Gertrude Firester of Brooklyn, N.Y., and Sadie Copperman of Winterhaven, Fla.; grandsons Mark Goodman, Greg (Michele) Goodman and Jason (Debbie)

Goodman; granddaughters Kelly (Rob) Miller, Holly (Brendan) Burrows and Shannon (Eddie) Jones; and 12 great-grandchildren. Her husband Raymond died in 1999.

Services were held at Mishkan Torah Synagogue on Friday, December 16, 2005.

Greenbelt Pioneer Julius Joseph "Joe" Andrus died on Wednesday, December 14, 2005, after a brief illness.

The son of Guy and Mary Jane Andrus, Joe was born in Williamsburg, Penna. He moved with his



family to Greenbelt in 1938, living in the 11 court of Ridge Road. They were one of the original Greenbelt families. Mr. Andrus graduated from Greenbelt High School and had a bluegrass band with Emmett (Zip) Nanna. He was captain of the high school 1939 and 1940 baseball teams with Coach Ben Goldfaden and Assistant Manager Bob Sommers.

In the 50s, the family moved to Greentree Place in Lakewood. Mr. Andrus enlisted in the Navy and served as a Machinists Mate First Class on the USS Iwo Jima in the South Pacific. After he was discharged in 1946, Mr. Andrus enrolled at the University of Maryland. He played centerfield for the university baseball team and for two summers he played with the Keene Blue Jays. He also signed up to play for a season with the Northern Virginia Piedmont League.

After graduating from Maryland with a degree in physical education, he taught for a year.

In 1949, Mr. Andrus joined the U.S. Park Police. He then met his wife Anna in Keene and they were married in 1951. They had one child, Julie Ann.

Mr. Andrus enjoyed hunting and fishing. He also played the guitar, piano and violin. He was a lifetime member of the American Legion Post #136, the Birmingham Lodge and the D.A.V. Mr. Andrus retired from the U.S. Park Police in 1969.

He is survived by his wife Anna, his daughter Julie Ann, granddaughter Joanna; two sisters – Betty Pierpoint of Cary, N. Car., and Gerry Willett of Indian Harbour Beach, Fla.

The interment will be at Cheltenham Veteran's Cemetery at a later date.

Notice of Amendment to the City Charter

Addition of Power to Engage in Collective Bargaining

At its December 12, 2005, meeting, the City Council adopted a resolution to add a new paragraph to the City Charter to empower the City to develop a labor code for the purpose of engaging in collective bargaining with representatives of the non-managerial sworn officers of the Police Department. This action was taken in response to a binding referendum question that the Council placed on the ballot of the November 8, 2005, City election, which permitted the voters to decide whether this change should be made. There were 1,105 (58%) votes in favor of the amendment and 797 (42%) votes against it. The charter amendment resolution will become effective on January 31, 2006, unless a proper petition to submit the amendment to the voters on a referendum is filed as permitted by law.

Charter Amendment Resolution 2005-4

A Resolution of the City of Greenbelt Adopted Pursuant to the Authority of Article XI-E of the Constitution of Maryland and Section 13 of Article 23A of the Annotated Code of Maryland, (1957 Edition as Amended), Title, "Corporation-Municipal," Subtitle "Home Rule" to Amend the Charter of the City of Greenbelt Found, in Whole or in Part, in the Compilation of Municipal Charters of Maryland (1983 Edition as Amended), as Prepared by the Department of Legislative Reference Pursuant to Chapter 77 of the Acts of the General Assembly of Maryland of 1983, by Amending Section 3, Titled "General Powers" to Add a New Paragraph 22 to Empower the City to Provide a Labor Code to Recognize the Right of Certain City Employees to Organize and Bargain Collectively

The resolution will add the following paragraph to the Section of the City Charter titled "General Powers":

22. To recognize and engage in collective bargaining with one or more designated bargaining representatives of non-managerial, sworn police officers of the City of Greenbelt, Maryland, Police Department; to enter into a binding collective bargaining agreement with said representatives; and to enact by ordinance or amendment a system of rules and regulations to govern this process. The City Council shall approve all collective bargaining agreements entered into by the City with a collective bargaining representative prior to their becoming effective. In the event the parties negotiating a collective bargaining agreement are unable to reach agreement on one or more terms of a collective bargaining agreement, the City Council shall have the authority to set those terms and conditions of employment that remain in dispute upon a majority vote.

As required by state law, this resolution will be posted in its entirety for 40 days, until January 21, 2006, at the Municipal Building at 25 Crescent Road. Police Will Conduct Sobriety Checkpoint

The Greenbelt Police Department, in cooperation with the Prince George's County Municipal Drunk Driver Reduction Task Force, will conduct a sobriety checkpoint on Friday, December 23 in the 6900 block of Greenbelt Road. Drunk driving in Maryland continues to be a serious problem. In 2004, 239 people, roughly 37 percent of all lives lost in fatal crashes on Maryland's roads, were due to impaired driving-related causes.

Studies show that sobriety checkpoints can reduce alcohol-related crashes by as much as 20 percent. Use of sobriety checkpoints and patrols deters motorists from driving under the influence and results in arrests of those who do drink and drive. In 2004 alone, a total of 376 people were arrested for driving while impaired during 66 sobriety checkpoints in Maryland.

The grant was made available by the Department of Homeland Security's Office for Domestic Preparedness to assist states and cities in preventing, preparing for and responding to terrorism and to help first responders offset costs associated with extra security measures.

battle in the early 70s to build Greenbriar in Greenbelt East and open it for residency against strong opposition from environmental activists and, at times, the Greenbelt City Council.

Brugger played a significant role in county affairs. According to the Washington Post, Brugger held a number of gubernatorial appointments during the Parris Glendening administration, successfully led the effort to build a federal district courthouse in Greenbelt, chaired from 1995 to 2001 the Prince George's County Economic Development Corporation and served as a director of the Prince George's County Chamber

of Commerce and the Suburban Maryland Building Association BUILDPAC.

His charitable work included being a director of the Ardmore Developmental Center Mitchellville, president and director of the Laurel Regional Hospital Foundation and he was active with the Prince George's Law Foundation, the Maryland Bar Foundation, the American Cancer Society and the American Paralysis Association.

Mr. Brugger is survived by his wife, Ann, three children and two stepchildren and nine grandchil-

Brugger Was Best Known For Greenbriar Battle

George Brugger represented developer Alan Kay in his efforts to get the Greenbriar apartment condominium development along Hanover Parkway and Mandan Road built in spite of a moratorium imposed on connecting new development to the Washington-Suburban Sanitary Commission sewerage system. At that time there was inadequate treatment capacity.

Greenbriar faced the additional obstacle of being in a drainage basin that flowed to the Blue Plains treatment facility in Washington on the Potomac River but separated from the sewered portion of that drainage area by great distances. The natural gravity flow for surface water and sewerage from Greenbriar was across the Baltimore-Washington Parkway, then north through the now designated greenbelt land of Parcel 1 and then flowing north and west following Beaverdam Creek through the Beltsville Agricultural Research Center. It was not possible to tie the Greenbriar sewer system into the existing sewer system for the rest of Greenbelt. The cost of extending a sewer line such a distance and the obstacle of getting federal government permission to do so caused Kay to propose a pumping station to lift the sewerage over a ridge on the east side of the Greenbriar development and to then connect with nearby sewer lines flowing into the Western Branch sewerage treatment plant.

With the moratorium imposed on that area as well until such time as plant expansion construction was completed, Kay proposed building a temporary sewerage treatment plant for the new development. Kay's efforts, however, were strongly opposed by a new Greenbelt organization, Save Our Community Committee (SOCC) led by Rhea Cohen. While Brugger, working with Kay, eventually won the conditional support of most of the Greenbelt City Council for the sewerage treatment plant, he still faced strong opposition from SOCC and from Cohen who was elected to the city council in 1971. Thomas White, who had become chair of SOCC, succeeded Cohen on the council in 1973, continuing the strong opposition to building the plant. Their opposition successfully caused delays for the completion of environmental studies.

It was not until October 1974 that the first Greenbriar residents were able to move in to the new development. In April 1976 the permanent pumping station was put into operation and Greenbriar sewerage was diverted to the Western Branch treatment facility. The temporary sewerage treatment plant, located at the northernmost point of Greenbriar was dismantled and removed.

While Brugger generally had an excellent demeanor in dealing with governing bodies and citizens, he clearly became frustrated with the difficulties he had in dealing with the Greenbelt council and its citizenry. However, News Review reporter Elaine Skolnik, who frequently talked to Brugger while covering the many issues arising out of the Greenbriar development and who frequently encountered difficulties in dealing with other developer representatives challenged by Greenbelt intransigency, found Brugger to always "be a gentleman."

improvements for the development. Davis argued that annexations happen for many reasons, "recreational, environmental, etc.," and that the city has worked to make an agreement with Greenbelt Metropark, LLC that has given the city and Greenbelt citizens many levers to sustain a bargain. "We've done the math," she added. In return for services and costs thereof for the proposed annexed area, "we'll get more," Davis said.

Councilmember Konrad Herling mentioned that the annual cost projection through the end of 2011 is estimated at \$1,496,000 but annual revenue during that time is estimated to be almost double.

Fireovid, previously of Gaithersburg and currently residing at Julian Court, expressed doubts that upwardly mobile couples would choose to live near railway tracks with their attendant disadvantages. The mayor thanked Fireovid and the few Greenbelt residents who participated for their insightful comments and questions. She observed it is encouraging that the Hollywood section of College Park, also close to the railway tracks, has kept pace with recent property values and that we are not aware of complaints regarding noise pollution.

Details of plans and construction will be available for review in early January. McLaughlin and Mach agreed with the mayor that new urban designs have sophisticated noise attenuation provisions. Councilmember Edward Putens stated that the situation remains "very fluid" but that Greenbelt has won every time it has taken developers to court.

Putens indicated that the city has never been a pushover for developers. Davis concurred that some developers had received an education in enlightened development through working with the

After the public hearing on Resolution Number 992 to annex the South Core, the council adopted it by a 4 to 1 vote, with Roberts voting against. Roberts named at least two reasons - the cost to the city and ecological concerns. A proposed outline for the extension of services and public facilities into the annexation area had already been submitted to the county.

Other Matters


Before the public hearing representatives from the State's Attorney's Office made a presentation on road safety and impending DWI checkpoints.

After the hearing but before the annexation resolution was adopted, an enthusiastic Keith Chernikoff, under committee reports, expressed singular pride in serving as chair of a "superb" Forest Preserve Task Force. He presented council with the committee's report, Draft Management and Maintenance Policy Guidelines for the Forest Preserve. Council received the report for review and future consideration.

Collective Bargaining

Another important resolution was adopted after a second reading. Resolution No. 933 relates to the city's recognizing the right of certain city employees (the police) to organize and bargain collectively. This matter arose from the May 23 council meeting when representatives of the Fraternal Order of Police Lodge #32 (FOP) requested council to either grant it the right to collective bargaining with binding arbitration or to place the question on the November 8 ballot. The council decided to place on the ballot the question of whether or not the city charter should be amended to empower the city to develop a labor code for the purpose of engaging in collective bargaining with representatives of the non-managerial sworn officers of the Police De-

On election day, Greenbelt citizens voted 1,105 for and 797 against amending the City Charter. At this meeting Council voted unanimously to adopt Resolution Number 933. The city will now advertise the amendment for four weeks in relevant media. During that time, citizens could petition the matter to referendum. If that does not happen, the charter amendment will become effective.




