Council Begins Budget Review In Semi-darkness from Outage

Greenbelt City Council review of the proposed Fiscal Year 2007 city budget got off to a shaky start on Monday, April 3 in council chambers darkened by a fast-moving thunderstorm. When the power didn't return, the worksession moved into the second floor hallway, dimly lit by emergency power.

This first budget worksession covered budget overview, revenues and social services. Attending were Mayor Judith Davis, Councilmembers Rodney Roberts and Konrad Herling, City Manager Michael McLaughlin, Assistant City Manager David Moran, Treasurer Jeff Williams, CARES Director Liz Park and Boxwood resident Robert Fireovid. Park had to complete her presentation on Social Services in the hallway's dim light.

The Greenbelt Social Services budget, proposed at \$425,900, is for city seniors, children and families. Services include family counseling by Greenbelt CARES, counseling for school-based youths, school-based skill building/discussion groups, adult workshops, crisis intervention re-

sources, vocational education services including tutoring, GED and babysitting courses, staffing for the Greenbelt Advisory Committee on Education (ACE) recognition plus award programs, the ACE reading programs and the Greenbelt Assistance in Living program.

The Social Service budget is supported by \$77,500 in a direct grant from the state, Prince George's County grants totaling \$17,300, \$2,000 from the GED co-pay fees and city funding of \$329,100.

The largest increase in operating expenses for next year is slightly more than \$10,000 for supporting the Strengthening Families program in Springhill Lake. Park said that the school principals are reporting good experiences with the participating families and that the parents tend to offer mutual support after taking part.

The proposed budget would increase staffing from 7.2 full-time equivalents to 7.3 to provide extra hours for family counseling.

Other issues in the Social Services budget include scheduling for the school-based discussion

groups and restructuring the ACE Reading Club program next year to rely more on after-school club meetings, Teen Book discussion groups, Parent/Child Book Discussion, Book Buddies, Summer Club meetings plus a variety of contests and newsletters.

These adjustments to the program delivery stem from the limited time available during the school day for extracurricular activities since start of the No Child Left Behind Act.

GAIL Program

Another issue for FY07: to develop a strategic plan to look at expanding programs under the Greenbelt Assistance in Living Program (GAIL). Park noted that the program has been operating for four years, led by the city's Resource Advocate, it has expanded services, including a brown-bag food delivery and visiting nurse programs, a monthly GAIL newsletter, Cable Cast information shows, an AARPsponsored money management program and three new programs: for adaptable medical equipment,

Friends' Seventh Graders Study Greenbelt's Founding Principles

(The following article was prepared by the seventh grade students of Friends Community School with the assistance of their teacher Elizabeth Hole. Their new school is being built on land next to Greenbelt Park.)

During the last two months, the 7th grade class at Friends Community School has been studying the founding principles of Greenbelt in order to learn about the components of a planned community. We were interested in the original beliefs and in the ways they shaped the construction and design of Greenbelt. Then we wanted to know how the original founding principles are seen today.

We interviewed five generous people: Jill St. John, the curator of the Greenbelt Museum; Bill Phelan, assistant director of the Department of Public Works; Peter Curtis, Greenbelt resident; Susan Richardson, Greenbelt resi-

dent; and Hardy Cook, former Greenbelt resident. We asked them questions including: Why do they live in Greenbelt? What would they now change about the founding principles and what do they value about the founding Greenbelt philosophy?

Still Committed

As we interviewed these people, we discovered they are still very committed to the original founding principles of Greenbelt – a green environment; a healthy, active life style; cooperation; affordability and active participation in the running of the community. We learned that the only changes these residents would make today in the founding principles are changes our society as a whole has made since that time.

For instance, Bill Phelan now uses more native, drought-resistant plants in landscaping. But that is something our society has learned to do since the 1930s. Similarly, many of the people we interviewed were relieved by the desegregation of the city and by the redefinition of a family unit that can be allowed to live in one house today.

Finally, many of the people we interviewed appreciated the change from the early rules designed to keep the community neat and tidy because it was a showcase community. People today are glad to have more freedom about what they can wear in public and when they can hang out their laundry.

It is very interesting to conclude that all these changes in the original, founding principles are essentially changes that have occurred in our society as a whole since that time.

Greenbelt Today

When asked what these residents value about Greenbelt today, their answers again affirm the founding principles of Greenbelt. These residents like the opportunity to walk to the shopping area without crossing roads. They value living in a small, court-based community where young children can play in relative safety with slightly reduced supervision and within a caring adult community.

They like working cooperatively within their courts to solve problems about issues such as pets or to plan group activities and parties. They enjoy living in a community where people can actively disagree about an issue and yet continue their friendship because no one takes the issues personally.

Several of those we inter-

ICC Deadlines Come and Go One Has Passed, One Ahead

Yogi Berra said, "It ain't over till it's over," and once again the deadline for public review of the Intercounty Connector (ICC) has been extended. This time it's hard to explain. The deadline for the public comment period of the Final Environmental Impact statement (FEIS), already extended several times, is over. That date - April 11 - has come and gone. The response deadline to an additional report prepared by the Maryland Department of Transportation, which analyzed new requirements by the Environmental Protection Agency and initially shared with FEIS that April 11 deadline, has been extended to April 26. Comments on this technical report, "project-level PM2.5 conformity determination," must be received by 5 p.m. on April 26.

A copy of the ICC PM2.5 report and the technical analysis can be reviewed at the ICC website (www.iccstudy.org), by calling and making a request toll-free at 1-866-462-0020 or by visiting the Maryland State Highway Administration District 3 Office, 9300 Kenilworth Avenue, Greenbelt, MD 20770.

The Maryland Department of Transportation, State Highway Administration and the Maryland Transportation Authority conclude in their report that their analysis shows the construction of the preferred alternative (Master Plan/ Southern Route) "will not cause

Adult Care Center Lease Under Discussion with City

The renewal, terms and conditions of the To God Be the Glory Adult Care Center's (TGBTG) lease agreement remained undetermined after the city council's scheduled worksession to review the organization's operations on March 29.

Council required the six-month review as a condition of giving the organization a one-year lease last year. Council gave the center a one-year lease after CEO LaWonne Booker explained that the adult care center would have problems obtaining credit and leasing equipment with a six-month lease. TGBTG and council are scheduled to meet again in October when the lease expires.

During the meeting, Booker said that she would like to have

a minimum of a three-year lease.

"We're not asking for a 20year lease nor a one-year lease since we're giving out almost half a million dollars for vehicles, maintenance and improvements to the center," Booker said. Improvements to the center include painting, re-carpeting and purchasing new furniture for the kitchen. "With that investment, we would like to have a lease to back up what we're setting out to do," she said.

Many of the tenants in the Community Center are on a year-to-year lease, said City Manager Michael McLaughlin. Most of these tenants are smaller operations such as artists renting studios. The largest tenants in the

State Responds On Roosevelt Stoplight

In response to a letter from Michael McLaughlin, city manager, the Maryland State Highway Administration sent the following letter.

Dear Mr. McLaughlin,

This letter is in response to your concerns regarding the installation of a traffic signal at MD 193 (Greenbelt Road) at Frankfort Drive/Eleanor Roosevelt High School in Greenbelt MD. The State Highway Administration (SHA) appreciates your interest and shares your concern for roadway safety.

My traffic engineering staff has completed their review and we would like to share the findings with you. Please note that the SHA follows the nationally accepted "Manual on Uniform Traffic Control Devices" (MUTCD) as the guide for when and where various traffic control devices should be installed. Numerous factors are evaluated including traffic volumes, crash history, delays and pedestrian volumes, just to name a few. We have initiated a process consisting of fluorescent signage and school pavement markings in addition to a request to Mr. Thomas Hicks, director, Office of Traffic and Safety, for consideration of additional traffic control at the intersection. At this time our office is not convinced that a traffic signal would adequately replace the control and safety that the crossing guards currently provide. While the signage and pavement markings will be implemented as soon as weather and scheduling permits, we will gain insight into our request shortly.

or contribute to a new violation of the PM2.5" air quality standards

Meanwhile, in a 129-page document, the Environmental Defense, Coalition for Smarter Growth and other major environmental and citizens groups "assailed the seriously flawed" proposed 18-mile toll road.

The report claims that the

FEIS fails to adequately evaluate the significant adverse impacts that air pollutants generated by the ICC are likely to have on human health, including the health of children and elderly located nearby the proposed sixlane highway, such as the playground fields of Drew Elementary School, located less than 400 feet away from the ICC right-of-way.



Manned Space Flight Easter Sunrise Is New SAGE Topic

A new Seasoned Adults Growing through Education (SAGE) class begins at the Community Center on Wednesday, April 19 from 9:45 a.m. to noon. The class will be taught by Greenbelt resident Lawrence Suid. The course will be on the image and reality of manned space flight, a subject Suid researched under a contract with NASA. He has published several articles about how film images contributed to President Kennedy's decision to go to the moon.

The course will first look at how science fiction films portraved a manned expedition to the moon. It will also consider "alien" space flight movies since they portrayed beings from other planets traveling through space. In virtually all such alien films, whether the aliens came in peace, such as "The Day the Earth Stood Still" and "Starman" or came to conquer, such as in "War of the Worlds," the American military attacked the visitors.

The course will then consider how President Kennedy made his decision to go to the moon, how the Apollo landings changed the cinematic portrayals of space flight and how 2001 served as the model for all future science fiction mov-



a preferred provider program and a spin-off from the visiting nurse program offering pediatric care services.

Although these programs cost relatively little, there is concern that they have an administrative impact on GAIL. Park recommended that the city determine its vision for future program and personnel growth.

One need cited in the budget: a part-time case manager to help seniors including regular assessments of their needs. Also to be looked at in the coming year: the extent of homelessness in Greenbelt.

Budget Overview

When the Social Services review was completed, electrical power had been restored and the worksession returned to council chambers for the budget overview. This mostly consisted of ground already covered in the city manager's budget presentation at the council's March 27 regular meeting; plus additional detail from Williams.

McLaughlin started the discussion by tracing the level of the city's "undesignated and unreserved fund balance" since Fiscal Year 2004. The proposed FY07 budget calls it "prudent for the city to maintain some reserves, should the city experience either a revenue shortfall or an emergency major expenditure." An "unreserved" fund balance of at least 10 percent of current year expenditures is recommended.

At the worksession, McLaughlin noted figures from the past three years, dropping from \$2,486,661 to \$877,155, 4.5 percent of the then-current year expenditures.

Now recovering, the fund balance is expected to reach 6 percent in June 2006. FY07 is projected at \$1,442,330 or 6.8 percent of the current year operating expenditures.

Both McLaughlin and Williams noted that a healthy fund balance is needed to keep the city's favorable bond rating. Williams then provided more detailed analysis of projected revenues for FY07.

Real Property Taxes

Next year 51 percent of all Greenbelt revenue will come from taxes on real property, contrasted with 41 percent in 2003. For FY07, estimated real estate property assessments are 8 percent higher than those for 2006 and reflect an increase of 10 percent for residential property and 5 percent for business property.

Noting that Greenbelt is finishing its third year of the state-required triennial assessment, Williams said the average annual assessment increase since FY95 is less than 3 percent.

On the other hand, the Greenbelt yield from the personal property tax is bleaker, increasing only 0.9 percent for FY07. This poor performance is due to business losses last year, such as the Sports Authority closing at Beltway Plaza. A further risk for FY08 pivots on disposition of Northrup Grumman operations in the Maryland Trade Center.

Income Taxes

The proposed budget projects an increase of 3 percent from Maryland Income Taxes paid by Greenbelt residents. Williams noted that this percentage for the city lags behind the statewide average of 5.5 percent. With the closing the six-theater complex at Beltway Plaza and recent council-approved reduction of the admissions and amusement tax as an incentive for the upgrading (and continuing operation) of the Plaza's Academy 8 Theaters, city revenue from theater admissions for FY07 are projected at iust \$70,000, down from over \$200,000 last year.

On the up side, city staff expect that the state will reinstate previous cuts in Highway User Taxes flowing to the city and project \$730,000 in FY07. Other revenue increases include income from city parking tickets and improved income resulting from higher interest rates (on city-invested reserve funds).

On expenditures, it was noted that fee revenue for both the Aquatic & Fitness Center and the Community Center was trending down. The Aquatic & Fitness facility is projected to drop to 59 percent in FY07, from 66 percent in FY05. The Community Center is expected to achieve only 33 percent, as opposed to 39 percent in FY05.

With the delay due to the power outage, council did not take up some budget matters raised in a March 30 memo from McLaughlin. One dealt with proposed revisions the manager was recommending for the city's self-insurance program for prescription medicines and proposed changes in the city's approach for handling employee overtime. Council expressed a desire to take up these issues at its scheduled April 26 worksession on the Public Safety Budget.

viewed valued the ability to have a say in community rules. They enjoy being part of an active community which has often been ahead of its time, for instance in the case of recycling. Several of the people we interviewed do not mind relatively small regulations about their housing exteriors because they have a voice in making those very rules.

Debate

As several of our interviewees suggested, the community can actively debate civic issues and not be torn apart by it. This happens because people do not let the issues become personal and because people are still more deeply committed to the fundamental principle of an individual voice within a larger cooperative

community.

As we studied Greenbelt, we were very impressed by the current commitment to the founding principles of a healthy life style, cooperation and community as influenced by our more modern knowledge and understanding. We were also impressed by Greenbelt's ability to debate, disagree, vote and then continue as a united, working community. It made us wish that all of our society could actively debate an issue and then reunite as a cooperative, democratic community the way Greenbelt does. This was a very interesting and useful subject for us to study because it gave us a model we could try to apply in our own future communities.

building are the nursery school and the adult care center, he said.

TGBTG, which also operates adult care centers in Brentwood and Bowie, wanted to trade-in its fleet of buses for a newer one but financing for the new fleet is contingent on the company's lease agreement. TGBTG received 11 buses from the former owner and spent \$37,500 on inspections. Four of the buses serve the Greenbelt location.

The facility is in compliance having completed its 90-day inspection with the state Department of Health and Mental Hygiene last May. There were no citations, violations, fines, penalties or fees, said Booker. Assistant City Manager David Moran reported that TGBTG was in compliance with the city's lease agreement.

TGBTG bought the adult care center from Baptist Senior Adult Ministries (BSAM) last year when it was determined that BSAM would be sold to a forprofit company that would most likely close the adult care centers. Council agreed to transfer the lease from BSAM to TGBTG on the condition that the new owners provided a receipt of a copy of a license to operate a medical adult care center from the appropriate state Department of Health and Mental Hygiene offices; proof of liability insurance; and satisfactory evidence that the executive management team operating TG-BTG has experience in the adult care field.

After purchasing the adult day centers, programs and staff were increased, said Booker. Programs include Pets on Wheels, arts and crafts and other interactive activities. Staff at the Greenbelt location doubled and includes a director, a director coordinator, two social workers and two full-time registered nurses. Booker also added 65 volunteers from Prince George's Community College who provide nursing and therapeutic services.

Election Law Changes Public Forum by LWV

Maryland's League of Women Voters, in partnership with its Prince George's County chapter, will hold a public information forum on Saturday, April 22 at 3 p.m. in the Community Center.

The topic of discussion will be the recent changes in the election laws of Maryland that will affect voters in the Tuesday, September 12 Primary Election and the General Election on Tuesday, November 7. Issues to be covered include "early voting," regulations and procedures for absentee ballots, the rights of "provisional" ballot voters and the possible election of a Board of Education for Prince George's County.

Robin Downs Colbert, executive director of the Prince George's County Board of Elections will provide information on the position of election judges, who are employed by the board and the rules for the use of poll workers and poll watchers by the various political candidates.

Elected officials from the 22nd Legislative District as well as other members of the General Assembly will attend.





Fire & Rescue Log

The Fire Department Log is a bi-weekly report of the activities and news from the Greenbelt Volunteer Fire Department and Rescue Squad, Inc. (GVFD&RS) The report includes recent incidents, news and upcoming events, fire safety and other fire department related information.

Incident Report

For the month of March, GVFD&RS responded to a total of 131 engine and 152 ambulance calls. Among those calls were 42 reports of smoke or fire, 12 automatic fire alarms, six gas leaks, 48 motor vehicle accidents and 118 medical calls.

Beltway Accidents

On March 25 at 1:44 p.m., Greenbelt was alerted to respond to a motor vehicle accident on the Beltway with possible entrapment. Units from West Lanham Hills and Berwyn Heights also responded. Responding units found a two-vehicle accident on the Inner Loop near Good Luck Road with one occupant trapped. The trapped person was freed and transported to an area trauma facility with life-threatening injuries. Greenbelt's ambulance transported an occupant from the other vehicle to an area hospital for non-life-threatening injuries.

Shortly after returning from that accident, Greenbelt was alerted to

another motor vehicle accident on the Inner Loop near Route 1. Greenbelt's engine and ambulance responded with units from other area stations. Two cars were involved in an accident as they approached the traffic backup due to the first accident. Only one occupant reported injuries and that person was transported by Greenbelt's ambulance to an area hospital.

BARC Highlights New Technologies

On February 23 the Henry A. Wallace Beltsville Agricultural Research Center (BARC) highlighted examples of the research and development currently underway at its facilities during "Bioscience for Life: Technology to Enhance Health, the Environment and Agriculture." This allday event, held in College Park, provided attending entrepreneurs and local companies insight into potential commercialization opportunities at BARC. The showcase was hosted by the Maryland Technology Development Corp. (TEDCO) and the Tech Council of Maryland.

During the showcase BARC researchers illustrated why it is the largest and most diversified agricultural campus in the world and an international leader in agricultural research. Attendees learned about studies into protein as material for fuel cells and organic conductors, swine immunology capabilities at BARC and research into anthocyanins (pigments in plants responsible for certain colors) in food ingredients and supplements.

The program featured a keynote presentation from Roger Dehnel, director of Cocoa Sustainability at the Mars Corporation, who discussed its Cooperative Research and Development Agreement with BARC. The two organizations have been working together for more than a decade on projects including research into cacao trees that are more resistant to fungal diseases such as witches' broom, frosty pod rot and black pod.


Leaders from Atlantic Biomass Conversions, Imagilin Technology, AGDIA and AeroView International also shared their experiences in partnering with BARC. Attendees participated in customized tours of the BARC facilities and also had the opportunity to visit TEDCO's new office at BARC where TEDCO officials provided an overview of state and federal funding support and the process to carry out technology transfer agreements.

Glen Oaks to Become Roosevelt Reserve

This summer there will be a new condominium community in Greenbelt East to be known as Roosevelt Reserve. Eleven of the Glen Oaks rental apartment buildings on Mandan Road nearest to Greenbelt Road are to be converted to condos. The one, two and three bedroom apartments, some with dens, will be priced from the mid-\$200,000s according to a website for the community. Roosevelt Reserve, as well as Glen Oaks, are a part of the Greenbriar Condominium Association and share in ownership of the community association clubhouse, swimming pool and tennis courts at the corner of Hanover Parkway and Greenbelt Road.

Advertising literature describes Roosevelt Reserve in Greenbelt to be a "secluded condominium community" set "amidst majestic trees and parkland" that will cater "to those who desire tranquility . . . a home one step removed from the hectic pace of the city, yet close to every modern convenience imaginable."

Greenbelt Mayor Judith Davis said that she had been advised that the remaining Glen Oaks buildings next to Greenbriar section 3 are to remain rental apartments for now.



Art Deco Lecture Set for April 18

by Jill St. John, curator The Museum's "Metro Deco" lecture has been rescheduled for April 18 at 7:30 p.m. in the Community Center, Room 201. The speaker for the museum-hosted free lecture is Linda Lyons of the D.C. Art Deco Society.

The area has a rich collection of buildings of the Art Deco era, a design movement that flourished between the two world wars. Art Deco is associated both with the Jazz Age of the 1920s and the machine-age streamlining of the 1930s. In the Washington area, although official buildings tended to be conservative in design, many commercial and residential buildings were Moderne (the term for Art Deco at the time) in style. These included the Hecht Company Warehouse, the Kennedy-Warren apartment house, movie theaters such as the Silver Theatre and the Greyhound Bus Station. But more modest storefronts, garden apartments and publicly financed housing also were built. Lyons will discuss historic preservation efforts of the Art Deco Society of Washington and explain where the name Art Deco came from.





Registration for GED **Courses on April 25**

Greenbelt CARES will hold the spring 10-week GED courses every Tuesday and Thursday, April 25 through June 29. Registration for the courses will be held on Tuesday, April 25 from 10:30 a.m. to 12:30 p.m. only. The first class of instruction will be held on Thursday, April 27.

GED I classes are from 10:30 a.m. to 12:30 p.m. GED I is for students who need review of basic math (addition, subtraction, multiplication, division, fractions, decimals, percentages and word problems) and English grammar

GED II classes are held from 1 to 3 p.m. GED II is for students who have successfully completed GED I and/or are ready to learn algebra and geometry, English literature and writing skills and prepare to take the GED test.

GED classes are held in the Municipal Building Conference Room, 25 Crescent Road. Students are required to show proof of residency (i.e., current lease, phone or electric bill, driver's license or Motor Vehicle ID card).

There is no charge for Greenbelt residents in either course. Nonresidents are required to pay a registration fee. All students are required to purchase a copy of the GED textbook and calculator (purchased from Greenbelt CARES).

Students do not have to be 16 years of age in order to take the GED course. Students may take a GED pre-test given at Greenbelt CARES at no cost. The actual GED test is given by the State of Maryland, not Greenbelt CARES. However, students who are ready to take the test can obtain the application forms from Greenbelt CARES.

Schools in the News



Co. Exec. Approves School Bd. Budget

The Prince George's County Board of Education and Interim CEO Howard A. Burnett have applauded County Executive Jack B. Johnson's proposal to fully fund the school system's operating budget for the next school year. Johnson approved the board's \$1.5 billion Fiscal Year 2007 operating budget. If approved by the county council, the public schools would receive an increase of \$127 million over last year's budget. For the third straight year, the county's investment in schools would increase by at least \$100 million.

Nearly \$50 million is dedicated for salary increases for the 17,000 school system employees. Additional investments will be used to open new schools and expand early childhood and special education programs. An additional 17 middle school and 44 high school teaching positions will also be funded to strengthen instruction in core learning areas.

Additional focal points of the FY07 budget request include student preparation for state assessments as well as targeted preparation and extended learning opportunities to ensure students' progress to the next grade level. Before, after and Saturday school programs will continue to help expand students' algebraic and literary competencies.

The budget development process included three public forums in October and November to receive input on budget priorities. The Board of Education held three public hearings in January and public work sessions on the budget in January and February. In addition the school system surveyed public opinion on its website.

County council will hold public hearings and work sessions on the county executive's proposal in April and May before adopting a budget for the county by June 1. The Board of Education will meet in June to reconcile its FY07 budget request with amounts approved by county council and adopt a final budget by June 30, submitting any related transfers to the county council for approval in June or July.

Applications Sought For Principal for a Day

Prince George's County Public Schools, in partnership with the Prince George's Chamber of Commerce, is inviting local business, government and community leaders to participate in the third annual Principal for a Day program on April 27 in the county's public elementary, middle and high schools.

"More than 150 business professionals participated in this extraordinary experience last year," said Howard A. Burnett, interim chief executive officer. "This year we challenge the business community to provide a participant for each of our 199 schools. This is an excellent opportunity for the business community to experience the challenges and rewards encountered by our principals on a daily basis," he said.

The Principal for a Day program allows stakeholders an opportunity to come into the public schools for a very up-close, very real view of school life. Each participant will shadow the school's principal, allowing them access to information from teachers, staff and students about the challenges faced in public education.

Principal for a Day participants are assigned to a school where they will spend the entire school day working with the principal on a variety of duties. Participants should arrive approximately 30 minutes before the start of school and should remain at school until the final bell of the day in order to experience a complete school day. Participants will dive into the normal workday schedule and observe the scope of the daily responsibilities of principals in Prince George's County public schools.

Typical Day

A typical school day would include: greeting students upon arrival; reading the pledge of allegiance and/or morning announcements; visiting classrooms; cafeteria and/or playground duty; meeting with students, parents and faculty; participating in student activities or special events at school; visiting an after-school program; and assisting in the supervision of the dismissal of students.

Applicants are asked to select three schools in order of preference, which will be honored if possible. However, if their selections have already been assigned, a substitution will be made. Each Principal for a Day will receive a school profile at the orientation session of their choice

ACT Test Deadline To Register May 5

The next nationwide ACT test date for college-bound high school students is Saturday, June 10. Students must register online or have their paper registrations postmarked by May 5. Late registration postmark deadline is May 19 and requires an additional \$18 fee.

Around two-thirds of test-takers in June have just completed the eleventh grade. Many of them take the ACT, check their scores and then decide whether to re-test in the fall or winter of their senior year. ACT allows students to report only the scores that they want to colleges.

The ACT includes an optional writing test. Most colleges do not require a writing score, so students should check the admissions requirements of colleges they're considering before registering for the test. The fee is smaller without the writing test.

Students can receive registration information from their high school guidance counselors or they can register online at www. actstudent.org. The website also features test tips, practice tests, an online test prep program and a database for students to find out if a prospective college requires a writing score.

The ACT is an exam that includes four tests: English, reading, math and science. Students who opt to take the writing test will add 30 minutes to the normal 3-hour testing time.
