

Students Tell Mayor and Council What They Would Do as Mayor

You couldn't have thrown a stick into the city council room on May 27 without hitting someone who was thinking about what it would be like to be a mayor. And they weren't all on the city council either.

This year produced a bumper crop of successful Prince George's County entries from nearby schools in the Maryland Municipal League's annual "If I Were Mayor" essay contest. The contest is open to fourth graders throughout Maryland who must write an essay beginning "If I Were Mayor, I Would" This year's theme was "Engaging My Community" and students were directed to "think like a mayor and share how you would engage your community to make it a better place."

The Prince George's County winner and three of the four finalists visited the May 27 meeting to be recognized by the Greenbelt City Council, all of

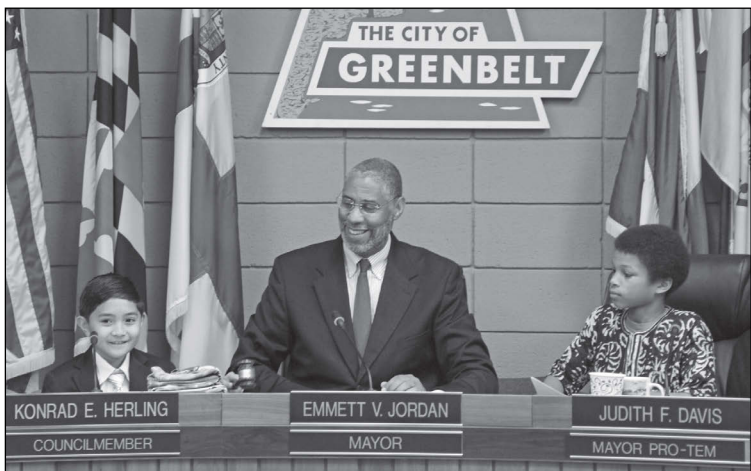

whom were present, and to read their essays from the council dais. Their presentations are available for viewing on the city's website,

State Representatives Give Their Wrap-up to Council

Greenbelt's representatives in the Maryland state legislature presented a legislative wrap-up at the May 12 Greenbelt City Council meeting. State Senator Paul Pinsky and Delegates Tawanna Gaines, Anne Healey and Alonzo Washington were all in attendance.

The council meeting had begun with the annual ACE (Advisory Committee on Education) student awards. That ceremony was covered in a separate article in last week's issue.

Senator Pinsky said since this was the last year of a four-year term, he would highlight and summarize actions of the entire term. He described passage of the Gun Violence Act, the Dream Act, removal of the death penalty, the marriage equity act and raising the minimum wage.

Regarding the minimum wage bill, Pinsky said the governor wanted the new \$10.10 minimum wage phased in over a three year period. As passed,

however, it would be phased in over about 4.5 years.

He said the minimum wage bill did not just affect young people but employees of all ages in lower wage jobs. Raising the minimum wage may cause wages for others to rise also, he said.

Regarding environmental issues, Pinsky said that in some years proposed legislation has been kept in a holding pattern but that there still have been some positive outcomes over the last eight years. He noted that the vision of the 22nd district delegation is not shared by all legislators across the state.

Healey's Comments

Delegate Anne Healey, as senior member of the delegates, spoke next. She said that she, Tawanna Gaines and Alonzo Washington work as a team and "are formidable when they work together." Healey chairs the House Rules Committee and sits

Everything Voters Should Know Before June 24 Primary Election

Early voting for the 2014 gubernatorial Primary Election began on June 12 and will continue through June 19. Precinct balloting will take place on Tuesday, June 24.

The primary has drawn relatively little attention and interest. Voter turnout is expected to be low. Those who vote, however, will cast ballots that really do count, considering a low turnout, and what is decided can have a

significant impact on the future course of our county and state governments. They can affect the nation as well.

Only registered Democrats and Republicans can vote at this election and their choices will be limited to selecting the candidates only for their political party. For Democrats, there will be a full slate of candidates for state offices open for election, as well as for county offices.

Republicans will have fewer choices offered, since candidates are lacking for many lesser offices up for election in this heavily Democratic state.

State offices up for election are governor/lieutenant governor, comptroller, attorney general, representatives to congress (for Greenbelt this is the Fifth Congressional District), and seats in the Maryland General Assembly (for Greenbelt a state senator and three delegates running in District 22).

At the county level, offices up for election are the county executive, some members of the county council (for Greenbelt, the District 4 Councilmanic District, in which present councilmember Ingrid Turner must step down due to mandatory term limits), state's attorney, clerk of the circuit court, register of wills, judge of the Orphans' Court and sheriff.

At the party level, voters will choose members of each party's central committee.

Council Has Worksession To Discuss Abell Petition

On Monday, June 23 the Greenbelt City Council will hold a worksession in the Municipal Building to discuss the petition submitted by resident John Abell following the disclosure that a library employee had been convicted of possession of child pornography. The petition was submitted to council in October 2012 and referred to the Community Relations Advisory Board (CRAB).

Police Chief James Craze and City Solicitor Robert Manzi also reviewed the petition, which was later referred to the Public Safety Advisory Committee (PSAC) and the Youth Advisory Committee (YAC). PSAC issued a report with its recommendations. The News Review was unable to determine, however, if the YAC had issued a report on the matter.

Abell's petition asked council to 1) inform the community of arrests where children have been the victims; 2) ask the News Review to include such arrests in the police blotter; 3) create a classification of jobs that should not be held by suspects under investigation of child pornography; 4) inform employers of arrests, asking how they will handle the matter; 5) use CARES and other city resources to educate the community about child pornography and 6) encourage the court to order convicted child pornographers, once released, into therapy.

While the city staff and committees reviewing the petition

were generally open to the suggestion for further education and that offenders receive therapy, all raised concerns regarding Abell's other requests, for a variety of reasons.

Premature Disclosure

In a March 27, 2013, letter to City Manager Michael McLaughlin, Manzi advised that it would not be appropriate for the city to notify employers regarding suspects under arrest or under investigation prior to conviction. These actions could later harm a suspect found not guilty. Further, Manzi advised such information could prejudice a case to the point that it would be impossible to obtain a conviction or fair trial in the environs of the county. Such actions could open the city up to claims of libel or slander or to claims for damages against the city for interfering with the employment of someone only charged with a crime.

Manzi noted that it appears courts are already requiring convicted child pornographers to undergo therapy. If convicted offenders do not also register as sex offenders after release, they can be found in violation of their probation, which would put them back into the criminal justice system. Manzi termed this "a fairly substantial penalty."

Police Information

Craze, in a May 7, 2013, memorandum, said that release of information about individuals

The Question:

The city council has adopted a budget for the year 2015 with a ¾ cent property tax increase. Since most of the councilmembers have been on the same job for more than 10 years, it would be interesting to look at the past 10 years of the property tax and the budget in Greenbelt.

The city budget for the fiscal year 2005 is less than 20 million, and it is a little more than 25 million for the current fiscal year. The city council raised the property tax rate on fiscal year 2005 (2 cents), 2006 (5 cents), 2008 (2 cents), 2011 (0.4 cents), 2014 (1.5 cents), and 2015 (0.75 cents). The frequency of raising the property tax is more than once in every two years. There was a significant opposition to the tax increase for the fiscal year 2008, but the city council increased the tax rate in any case. The city property tax rate for the current fiscal year is \$0.805, which will be increased to \$0.8125 for the fiscal year 2015. The property tax rate in Greenbelt is one of the highest in the state of Maryland.

The question that every taxpayer should ask is whether the pace and the rate of the tax increase is sustainable. The necessity of every wish item is always relative, and every position that the city has added means the financial obligations for the future budget, which includes the health care and retirement. The property value is expected to increase in the next round of the assessment, which means that we all expect to pay more taxes. Is the city council going to hold the line on spending, and give us some relief? Don't bet on it, and what is missing in the city council's wish list is you, the taxpayer.

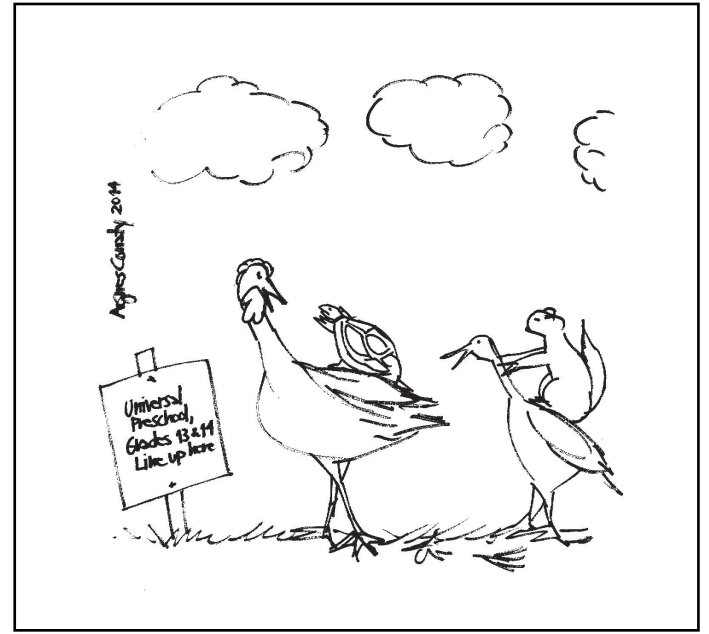

Obituaries

Joseph Anthony Morris

Dr. Joseph Anthony Morris, a 65-year resident of Greenbelt, died at Malta House Assisted Living in Hyattsville on May 31. He was 95 years old. He was fortunate to be attended by members of his family, including his wife, Ruth, in his final hours. Both he and Ruth have been residents of Malta House since 2013.



"Tony," as he was known by family and friends, lived on to survive the battle that he and his attorney, James S. Turner, fought as whistleblowers against the actions of the U.S. Government regarding vaccine development and dissemination. The battle came to a head during the Swine Flu Epidemic of the late 1970s when President Ford mandated the mass immunization of hundreds of millions of Americans.

Dr. Morris, in his position as chief vaccine officer for the Food and Drug Administration's Bureau of Biologics Standards, adamantly and publicly opposed the swine flu immunization program. He based his opposition on research carried out by his division that no reliable proof existed that vaccines were actually effective in preventing the disease. He accused the government of releasing vaccines mainly on claims of efficacy of the vaccines by their pharmaceutical company producers.

For his claims of government inadequacy and the government's collaboration with the vaccine makers to push the product on the American people, Dr. Morris was fired on the grounds of insubordination. Ultimately he was vindicated by being fully recompensed for his lost benefits and by the fact that the government itself stopped the program after only 49 million individuals had been vaccinated with the swine flu vaccine.

Dr. Morris leaves his wife of 71 years; Ruth, their four children, Cam Esser, Marilyn Stoughton, Joseph Morris, Jr. and Lawrence Morris; and seven grandchildren: Julie Ana Dobo, John Esser, Gaby Dobo, Stephanie Stoughton, Melanie Stoughton, Kathryn and Michael Morris. He also leaves three great-grandchildren, Eva-Marie Ruth Stoughton, Luca and Emile Esser.

A Mass of Christian Burial was held at St. Hugh of Grenoble Church, Greenbelt on June 5.

Michael Lundregan

Michael (Mike) Wayne Lundregan of New York, N.Y., died on Saturday, June 7, 2014, at the age of 62 following a year-long battle with cancer. Mike was born at Prince George's Hospital Center to Margaret and Ken Lundregan on



March 4, 1952. Siblings Rick, Kathy (Gregory) and Karen soon followed. The family moved to Greenbelt in 1955 where Mike attended St. Hugh's Elementary School and graduated from Parkdale High School in 1970. He worked for the Greenbelt Recreation Department, eventually

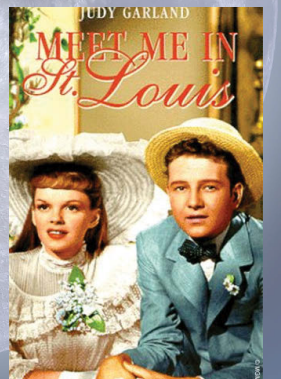

on several other committees.

She referenced a bill that affected cooperatives, indicating that she worked closely with GHI (Greenbelt Homes, Incorporated) to try to get an outcome that was acceptable to the housing co-op. The city and GHI opposed the bill.

Delegate Tawanna Gaines, on the Appropriations Committee, mentioned that Greenbelt CARES will continue to receive some funding for the youth services bureau as it has for a number of years. She is concerned, however, that it might not be continued in the future.

Gaines mentioned money for potholes in county roads but said that problems with Southway are complicated by separate responsibilities of the State Highway Administration and the National Park Service. She is keeping an eye on that problem area, she said.

Gaines mentioned funding for noise barriers for Franklin Park Apartments (formerly Springhill Lake). Councilmember Ed Putens later said they have been promised noise barriers along the Beltway for 18 years.

Among other items, Gaines said the bond bill for renovating the Old Greenbelt Theatre had been extended. The county had also received \$20 million in education funds, she said, and a new arts center will be coming to Hyattsville.

Delegate Alonzo Washington mentioned that Gaines and he will receive Friends of the Maryland Municipal League Awards in May. He also described passage of a bill to extend pre-K classes to more schools. There will also be formation of an Enterprise Zone to grow business around the University of Maryland.

In response to a later question from Councilmember Konrad Herling about whether Greenbelt was in this zone, Washington responded there is no limit on the zone as to miles from the campus.

Forest Preserve Hikes

Jonathan Murray from Ancestral Knowledge asked to speak during the petitions and requests part of the meeting. He said

it has been four months since he sent the city a proposal for conducting hikes in Greenbelt's forest preserve. He indicated the issue has been covered extensively in the News Review.

Ancestral Knowledge is a nonprofit organization that holds paid camps and activities which include walking in the woods. Summer plans are almost complete, he said, and he is disappointed that he has not heard from the city. He has had to move some of his activities from Greenbelt to Bowie, he added.

Councilmember Rodney Roberts reminded Murray that he can take the children for hikes in the woods but not for pay. Mayor Emmett Jordan said the issue is on the work schedule list and that he appreciates Murray's patience but cannot guarantee a decision will be made in time for summer programs.

Other Action

Alla Lake, a long-time member and former chair of ACE, has submitted her resignation. She was recognized for her many contributions to the committee.

Sharon Johnson, services coordinator at Green Ridge House, received the city proclamation for Older Americans Month on behalf of the Greenbelt Assistance in Living Program, the Golden Age Club, the Senior Citizens Advisory Committee and all older people in the city.

Highlight of the proclamation was the slogan "safe today, healthy tomorrow." There is an ever-growing number of older residents in Greenbelt and the proclamation referred to the city's commitment to all of them.

Park Supervisor Karl Skaggs received the Public Works Week Proclamation, whose theme was "building for today, planning for tomorrow." The proclamation stated that residents of Greenbelt appreciate the professionalism of the Public Works Department staff and respect the importance of the work they perform to such a high standard every day.

public hearing on the budget, adopted resolutions to provide for additional theater costs and received information about a new federal grant for police and the city's speed camera program.

Although a rainy evening delayed some of the arrivals, Dustin Navarro and Khalvani Hall were on time and at the ready to help Mayor Emmett Jordan gavel the council meeting to order and lead the pledge to the flag. Dustin, the county winner, attends Magnolia Elementary School and is in Ms. Fernandez's class. Khalvani is in Ms. Esteve's class at Robert Goddard School.

Arriving somewhat later in the evening were finalists Abacac Diao and Mia Donahue. Like Dustin, they are in Ms. Fernandez's class at Magnolia Elementary. All the students read their essays and joined with family, friends, teachers and the city council for picture-taking.

So many mayors were a tough act to follow, but Rusty Beeg and Rosita Dietrich represented the American Legion Post #136 Auxiliary in making a presentation on the meaning of Memorial Day and distributing paper poppies to the council and the audience. Beeg explained how the paper poppies are made from kits, with veterans being paid to construct them. Donations made for the poppies go directly to programs for veterans.

In another presentation, Alexander Barnes, Donna Hoffmeister and Bill Orleans represented the Prince George's Peace and Justice Coalition in receiving a proclamation from the mayor naming June Peace Month in Greenbelt.

Public Hearing

Also on the night's agenda was the second of two public hearings on the city manager's proposed Fiscal Year 2015 budget. The budget was scheduled for adoption on June 4. Following several questions from Bill Orleans, George Boyce spoke regarding discussion that had occurred in budget worksessions about installing the equipment necessary to cablecast city council and other meetings from the Community Center. He described a setup he had done with a cam-

order that was sending video to the internet and said it could be done for about \$100 plus the cost of a better microphone than his. He thought the costs being discussed were excessive and that it could be done in a way that would not only be cheaper but also be portable to locations outside center city.

A third speaker, David Whaples expressed appreciation for the time that goes into the development and review of the budget, as well as the complexity of the task. He wanted to be sure that the councilmembers were always aware, when they talked about adding to the budget here or there, that changes directly impact taxpayers' budgets, which may not have the flexibility of the city's budget. He encouraged the city to take advantage of ways to raise funds other than raising taxes whenever possible.

County Funding

City Manager Michael McLaughlin made two welcome announcements about funding that County Councilmember Ingrid Turner was able to get into the county's FY 2015 budget: \$100,000 for the Greenbelt theater renovation and \$25,000 for the Greenbelt Community Foundation.

Legislation

Two pairs of resolutions to negotiate the purchase of products and services were briefly introduced for first reading. They were scheduled to return on the agenda of the June 4 regular meeting for second reading, discussion and adoption. Two are for purchase and installation of PavDrain blocks – a permeable pavement technology – at the Springhill Lake Recreation Center parking lot. This project is supported by a grant from the National Fish and Wildlife Foundation.

The other two resolutions relate to costs for the Greenbelt theater renovation project. One would amend the resolution adopted in February to approve contract costs with Gardiner and Gardiner. In order to include the cost of Pepco's upgrade to the electrical panel and service, which could not be estimated at

the time of the original resolution, as well as making other adjustments and correcting an error in calculations, the total amount was increased by \$153,698. Director of Planning Celia Craze said that even with this increase the project is still below the original estimate. She also described possibilities for adjusting the plan of work, if necessary, while the revised contract awaits state approval. The fourth resolution would authorize the purchase of projection, assistive listening, vision and networking equipment for the theater.

JAG Grant

Captain James Parker was in attendance to answer questions about the Police Department's proposal to use a \$12,012 Justice Assistance Grant (JAG) from the U.S. Department of Justice to purchase 10 ETIX (electronic citation printers), which will allow the department to complete the transition to an electronic, paperless system. Among other benefits, Parker noted that ETIX increases accuracy in ticketing and means quicker stops for the officer and less inconvenience for residents.

Speed Cameras

Parker also gave an update on the speed camera program. He noted that the program had been successful in reducing speeding, giving as an example the fact that there was a 50 percent reduction in tickets written over 2013. The highlight of his update, however, was that an arrangement has been worked out with the State Highway Administration whereby the city can now place cameras on Greenbelt Road, both east and westbound, adjacent to Eleanor Roosevelt High School. Parker said this had been a need the Police Department had wanted to find a way to meet for some time, in part because it is difficult to do conventional traffic control on that part of Greenbelt Road. They had applied for a permit from the state to place cameras there in November 2012.

"These were the ones that we needed most," he said. "It just took us the longest time to get them."

Linda Ivy, chair of the Greenbelt Labor Day Festival Committee (GLDF), has announced that Sherwood Amusements, Inc., has been hired as carnival operator for the 2014 festival. She stated that the GLDF committee interviewed three companies and "Sherwood seemed to be the best fit. The owner has been to Greenbelt before and had some wonderful stories of years gone by with the festival," she added.

Ivy stated that Sherwood guaranteed that carnival prices would remain the same as last year and there will also be a pre-sale on the wrist bracelets as in past years. Sherwood has worked with the previous carnival vendor, Rosedale Attractions, and was recommended by Rosedale's owner Tom Gaylin.

It is important to bring all paperwork related to current and former mortgages, including loan application, settlement paperwork, lending statements and any foreclosure notices or warnings. The last two pay stubs, 2012 and 2013 tax returns, two months of utility bills and bank statements should also be brought, as should a list of monthly household expenses and a draft hardship letter spelling out the reasons for falling behind and the plan for getting back on track.

relating to an incident is governed by the department's General Order 621. This provides for the release of information such as the type and nature of the incident; the location, date and time; property taken; the name of a homicide victim after next-of-kin have been notified and the name of the investigating officer.

After an arrest, the police may release the name, age, description and residence of the suspect, the substance or text in a warrant, the indictment or charging document, the circumstances immediately surrounding an arrest, the possession or use of a weapon by the person arrested or by the police and the amount of bond and/or place of detention.

The General Order prohibits the police from releasing the names of persons involved in domestic violence, information that may identify the victim of child abuse or any sex crime or the identity of any juvenile who is a suspect or defendant in an incident over which juvenile court has jurisdiction.

Craze wrote that identifying jobs that should not be held by suspected child sex offenders is outside the purview of the city and the police department.

Craze noted that suggestions to use city resources to educate and inform the public regarding child pornography and to encourage courts to require therapy as part of sentencing seemed reasonable and within the city's power to accommodate.

Manzi likewise had advised that, while there are already various programs available to educate the community, using CARES for this purpose would be "an appropriate avenue."

Interim Recommendations

In its Report 2013-2, CRAB recommended that CARES be asked to initiate a public information campaign to educate the community of the dangers to children of being victimized by persons involved in initiating, collecting or disseminating child pornography and that the police department increase its contact with schools and with other youth information activities to focus more directly on dangers to children associated with child pornography. The report noted that explicit photos taken by youths of themselves or of each other is legally considered child pornography.

The PSAC deferred to the police department's policy for how to notify the public of incidents of child pornography. However, their February 4, 2014, report stated that it would not be appropriate to publicize a person's name or other information when they are only suspected of the crime.

Noting that information about arrests is publicly available, the committee recommended against the city's making extra efforts to publicize arrests for child pornography above normal procedures.

While "we absolutely support our children being protected at all times," PSAC wrote in their report, "we also need to stay cognizant of the extreme sensitivity of this type of crime as it pertains to the person accused." They pointed out that releasing information about a person later found to be innocent "could have a devastating impact on the rest of his or her life."

The most active campaigns are those of Brown, Gansler and Mizeur. Brown has served 30 years in the U.S. Army in active duty and the reserves and eight years in the General Assembly. For the past 10 years he was lieutenant governor.

Brown has received the endorsement of most prominent state Democrats, including that of Governor Martin O'Malley, but has been criticized for his role in the state's failure to implement the Affordable Care Act.

Gansler has served eight years as Maryland attorney general and for many years before then as Montgomery County state's attorney, with only tepid support, however, from party leaders. Gansler in his campaign has criticized the O'Malley administration. He advocates reducing business taxes to keep businesses from moving to other states with lower rates.

Mizeur, in her campaign, has tended to support the O'Malley administration, while advocating a need for more to be done. She would legalize the sale of marijuana, using the proceeds from taxes imposed on these sales to help finance education.

Comptroller

Peter Franchot of Silver Spring (Website: www.franchot.com) is the only Democratic candidate. The current officeholder, he has held the office, which among other things collects income taxes, without significant controversy.

Attorney General

The candidates are:

Jon S. Cardin, Baltimore County. Website: www.joncardin.com.

Brian E. Frosh, Montgomery County. Website: www.brianfrosh.com.

Frosh is chair of the Maryland Senate Judicial Proceedings Committee. With 35 years of legal practice experience, he is a strong advocate of tough gun regulations.

Braveboy has been a delegate for eight years and in legal practice for 13 years. She advocates increasing the minimum wage in Maryland.

Cardin, a nephew of Maryland U.S. Senator Benjamin Cardin, has been a delegate to the General Assembly for 12 years.

Representative to Congress, Congressional District 05

With over 30 years as Congressional Representative for Maryland's Fifth District, Steny H. Hoyer, now of St. Mary's

County (Website: hoyerforcongress.com), is in a district that primarily includes southern Maryland, but still meanders up to Greenbelt. He again seeks reelection without Democratic opposition. In Congress, as minority whip, he holds the second ranking position on the Democratic side of the aisle.

Legislative

Paul G. Pinsky of University Park (Website: senatorpinsky.org) seeking reelection to his fifth term is running unopposed for state senator from Legislative District 22. He has been a strong advocate of educational and liberal causes.

For the House of Delegates, Legislative District 22, four candidates are running for the three positions.

Tawanna P. Gaines of Berwyn Heights (Website: tawannagaines.org) and Anne Healey of Hyattsville (Website: www.delegatehealey.com) have both served multiple terms as delegates. Alonzo T. Washington of Hyattsville (Website: www.alonzowashington.com), appointed to fill a vacancy, now seeks election in his own right. He is supported by Pinsky, Healey and Gaines.

Challenging the three incumbents is Rushern Baker, IV of Riverdale Park, son of the county executive. Baker claims his experience in growing up in the county and attending its public schools will enable him to help improve public education.

County Executive

Rushern L. Baker, III of Cheverly is seeking his second term in office without Democratic opposition. Generally he has received good reviews for his first term in office.

County Council

Vince Canales (Website: www.vincecanales.com) and Todd M. Turner (Website: www.turnerforcouncil.org), both of Bowie, are seeking the office being vacated by Ingrid Turner. Canales is a retired county police officer who was president for three terms of that department's Fraternal Order of Police Lodge. Turner has served eight years on the Bowie City Council and 11 years as a county council staffer.

State's Attorney

Angela Alsobrooks of Largo (Website: adalsobrooks@yahoo.com) is seeking reelection without opposition. She has served her first term with generally favorable reviews.

Clerk of the Circuit Court

Four candidates seek this administrative office: Sarah B. Abdul-Mumin of Ft. Washington, Marilyn Bland of Upper Marlboro, Sydney Harrison of Upper Marlboro (Website: vote4sydneyharrison.com) and Peggy Magee of Upper Marlboro.

Magee, an attorney, held this office once before. Harrison was a small business owner who for two years has worked as a civil assistant in the clerk's office. Bland, a recognized name among many county voters, has been highly criticized in some of the offices she has held.

Register of Wills

Cereta A. Lee, of Upper Marlboro is seeking her third term. By holding a Saturday open house once a month she has

made the office more accessible. Also a candidate is Derrick Redd of Upper Marlboro.

Judge of the Orphans' Court

Current holders of the three positions are seeking reelection without opposition. They are Wendy Alise Cartwright of Bowie, Athena Malloy Groves of Largo and Vicky L. Ivory-Orem of Greenbelt.

Sheriff

The incumbent, Melvin C. High of Upper Marlboro (Website: www.friendsofmelvinhigh.com), is seeking reelection. A former county police chief and commander of other agencies, High has served in this office without engendering controversy. Other candidates for the office of sheriff are Sylvester E. Jones of Accokeek (Website: www.sylvesterjonesforsheriff.com), a retired deputy U.S. Marshall with 27 years experience; Everett Sesker of Mitchellville (Website: www.everettssesker.com), a retired major in the county police department with 22 years of service; and Louis M. Wood, Jr. of Oxon Hill.

Democratic Central Committee At-Large

Once again Greenbelters are asked to choose persons from other areas of the county to serve on the Democratic Central Committee, without any significant information concerning their qualifications being made available.

Greenbelters will vote for one at-large candidate in each legislative district. The candidates are:

District 21: Derrick Richardson, Laurel.

District 22: (includes Greenbelt): Nicole A. Williams, Greenbelt (Hanover Parkway), Cheryl Landis, Upper Marlboro and Kent A. Roberson, Upper Marlboro.

District 24: Mary R. Davis, Seat Pleasant, and Pamela A. Oatis, Capitol Heights.

District 25: Wala Blegay, District Heights, Maurice Culbreath, Forestville, Shaihi Mwalimu, Upper Marlboro, and Stanley Onye, Largo.

District 26: Jibril Brown, Upper Marlboro, Cynthia Collins, Oxon Hill, Veronica Davila-Steele, Oxon Hill and Steven E. Morris, Ft. Washington.

District 27: Sydney Harrison, Upper Marlboro, (Website: www.vote4sydneyharrison.com).

District 47: Donnie Arrington, Hyattsville.

Democrats are also asked to elect two persons to the Central Committee that represent only this district and elected only by district Democrats. Four persons seek the office. One is well known to Greenbelters, the city's mayor, Emmett V. Jordan. Other candidates are: Hosea T. Chew; Lanham, Patrick A. Paschall, Hyattsville (Website: www.patrickpaschall.com); and Denise M. Riley, Hyattsville.

Republican Ballot

For governor and lieutenant governor, four sets of candidates are running, even though Republicans are given little chance of taking over the Maryland State House. They are: David R. Craig, Harford County; and Jeannie Haddaway, Talbot County (Website: www.davidcraig.com); Ron George, Anne Arun-

del County, and Shelley Aloia, Frederick County (Website: www.voterongeorget.com); Larry A. Hogan, Anne Arundel County, and Boyd Rutherford, Howard County (Website: hoganforgovernor.com); and Charles Lollar, Charles County, and Ken Timmerman, Frederick County (Website: www.lollar4governor.com).

This race appears to be between Craig and Hogan. Craig is the county executive of Harford County and a former teacher and principal and mayor.

Hogan, a small businessman, served as Governor Robert Ehrlich's appointment secretary. He is also the son of a former congressman of the same name who once represented Greenbelt.

Lollar is a former U.S. Marine Corps officer and businessman. George, also a small businessman, was a delegate for eight years.

Comptroller

William H. Campbell, Howard County (Website: www.whcampbell2014.com), is the only Republican candidate. He was a chief financial officer for the U.S. Coast Guard, the U.S. Department of Veteran Affairs and Amtrak.

Attorney General

Jeffrey N. Pritzker, Baltimore County, in legal practice for 40 years, is the only Republican candidate for this office.

Congress, District 5

Mark Kenneth Arness, Calvert County, a physician, was a pilot with five missions flown in the Middle East. Tom Potter of Charles County (tom.potter@ymail.com), worked on projects at federal installations. The other candidate is Chris Chaffee, Calvert County (Website: www.chrischaffeeforcongress.com).

Other Offices

The Republican candidate for State Senator for Greenbelt's district is Janice Denise Fountaine of Riverdale.

Lynn White of College Park (nominated by Republican Central Committee) is on the ballot for election as one of the three delegates to the Maryland General Assembly from Greenbelt's, District 22.

Fiona Moodie of Bowie is making her second try to be elected as the District 4 county councilmember. The only Republican candidate, she was only 18 on her first attempt four years ago.

Gregory Prakas of College Park is the only Republican candidate for Sheriff.

Republican Central Committee

The Republican Central Committee elects only two people for Legislative District 22 and only two candidates have been placed on the ballot. They are: Heather Lynn Olsen, Hyattsville, and Jim Wass, Riverdale.
