Council's First Regular Meeting Offers a Long Look Ahead to 2012

The newly elected Greenbelt City Council had its first regular meeting on Monday, November 28. Except for presentations and reports, the only substantive item on the agenda was discussion of the city's proposed 2012 State and County Legislative Program. All seven councilmembers were present.

Each year in December council holds a legislative dinner with Greenbelt's state delegation and county council representatives in order to communicate the city's priority legislative issues. (That meeting was held December 7 at the Greenbelt Marriott.) On the November 28 agenda was a staff prepared listing of issues council could present at the December 7 meeting.

Staff proposed three items as joint county-state programs. These include protecting municipal funding sources such as state/county shared revenue; supporting funding for renovation of Greenbelt Middle School and continuing support for improved transit services for Greenbelt.

Staff proposed two state priorities. First, revisions to noise barrier policies along the Capital Beltway and additional funding for barriers; and, second, support of environmental issues council has previously supported, such as prohibiting use of plastic shopping bags, alternative energy programs and a beverage container deposit program.

The two staff-recommended county priorities include establishment of a landlord-tenant commission for the county and support for a new fire station for the Greenbelt Volunteer Fire Department and Rescue Squad.

Council discussion of these staff recommendations was lively and directed generally to making sure the listings reflect the most up-to-date information available

from various organizations with which Greenbelt officials interact. These include the Council of Governments, the Prince George's Municipal Association and the Maryland Municipal League.

Ethics Legislation

Council was concerned by the lack of focus and a perceived difficulty about how state ethics legislation would apply at the local level, especially its application to volunteers serving on governmental bodies. City Solicitor Robert Manzi advised council that a pre-filed bill would exempt certain municipalities. For that reason the topic was added as a third priority for state legislation.

A third priority item for county legislation was added to the list to support modifying requirements for individuals and firms renting commercial kitchens within a government-owned facility. The issue arose from Councilmember Leta Mach's concern about the city's inability to maximize rentals for the well-equipped kitchen at the Community Center. Those new priorities were added to the material prepared for the December 7 legislative dinner.

Also added were two "Alert Items" for county and state legislators who would be attending. One "alert" requested keeping the city updated on state and county financial issues and their status heading into the legislative year. Another was keeping the city informed on consideration by the Maryland Transportation Department of a nearby Beltsville site (adjacent to the Beltsville Farm) for a proposed CSX Intermodal (Truck and Train) Transfer Facility. Such a facility would be linked to the Port of Baltimore, greatly increasing truck traffic in

Presentations And Awards

At the November 28 regular council meeting, the lead-off presentation was the 2011 Recycle Right Awards in honor of America Recycles Day, celebrated on November 15. Greenbelt Recycling Coordinator Luisa Robles presented to council the Greenbelt residents who were the winners of this year's competition: Alice Mitchell, Lori Den and Grace Tomantini from the Greenbelt Homes Incorporated (GHI) neighborhoods, Mark Basset of Lady Ann Court in Greenbelt East and Angie Evans for Holy Cross Lutheran Church on Greenbelt Road. Winners are selected each year based on the Public Works Department's evaluation of recycling habits of Greenbelt residences and organizations, including appropriate items in the bin, quantities recycled and cleanliness of the bins.

The second presentation at the meeting was a proclamation honoring Municipal Government Month, given to Beverly Palau, the city's Public Information and Communications Coordinator. Palau was commended for her efforts in organizing programs and activities for the annual celebration of Municipal Government Month in Greenbelt. Activities each year include the Community Health and Wellness Fair, Walk to School Day, the "If I Were Mayor" essay contest for Greenbelt fourth graders, FallFest and hosted community stream cleanings, electronic recycling events and the educational quiz show program on the city website entitled "Greenbelt Works."

75th Anniversary

David Mills, chair of the 75th Anniversary Committee, presented council with tentative plans for celebrating Greenbelt's 75th Anniversary during 2012. The kick-off for 75th Anniversary activities will take place in association with the January 8 Artful Afternoon programs at the Community Center. An anniversary-related symposium is being planned for April. In June the "Greenbelt Voices" program, which debuted at the Greenbelt Arts Center last year, will be recast as a program at the New Deal Café. Finally, the committee has targeted October 13 for the City's 75th Anniversary Gala at the Greenbelt Marriott Hotel.

Mills said a brochure and calendars are in preparation and updated information can now be obtained at the city's website. He noted as well that anniversary souvenirs and remembrances would be available during the open hours at the Greenbelt Museum.

ESOL Teacher Frontanes Arrives Early, Leaves Late

When I stopped by to meet Maria Frontanes at Springhill Lake Elementary School, she and a colleague were preparing a Thanksgiving Feast to welcome their "newcomers" – children who had arrived in the United States since March. This year's arrivals include "a family of three from Africa" and students from the Dominican Republic, China and El Salvador.

As a teacher of English for Speakers of Other Languages (ESOL), Frontanes has daily contact with students whose families speak a total of 25 languages and dialects and represent 30 countries. Six ESOL teachers share

the work by grade levels; she teaches first and fifth grades. Of the 650 students enrolled at Springhill Lake 270 receive ESOL instruction.

And what are these "Other Languages" and dialects? Here's a sampling – Spanish, Arabic, Mandarin, French, Urdu, Haitian Creole; Yoruba (Nigeria); Swahili,

Shona (Zimbabwe), Mandinke and Mende (Sierra Leone), Tagalog (Philippines), Guyana Creole and Ebo (Nigeria).

"A lot of our students were born here and learned English but we need to communicate with

From the Wolf Trap Stage To Springhill Elementary

All the world's a stage – and thanks to Nicole Nugent's infectious love of the performing arts, so is Springhill Lake Elementary School (SLES). To engage her second-graders, Nugent augments her curriculum with rhymes and riddles, role-plays and skits, storytelling, music and movement – all for the purpose of teaching English, math, science, social studies and more.

Nugent teaches her students this riddle, for example, to help them learn two-digit subtraction:

More on the top?
No need to stop!
More on the floor?
Go next door.

"If they see a bigger number on the bottom, they know they'll have to borrow from the next column. And riddles are easier to remember than rules," she says with a smile. The riddle is posted on her colorful classroom wall.

For learning short vowels, she uses a rap rhythm and for longer vowels, students

"dance around the room" as they draw out the sound. In a recent class, hands flew up to answer questions, they practiced the long "aaaaayyyyyyyyy . . . " and two students did an impromptu role-play skit about litter

The Greenbelt Greens were thinking of adopting Walker Branch years ago but moved on to politics. My study showed that half the Walker Branch drainage area is from parking lots around the Marriott. It's small when it's not raining but flow really picks up when it is.

Support Legislation To Tax Grocery Bags

The North Woods certainly are valuable to a number of Greenbelters, even if we rarely see one another on our walks. I appreciate the request that visitors to the woods clean it up as they leave; it really is a shame that our streams are the "habitat" of piles and miles of trash. We ought to seek out a local watershed group and try and run a cleanup.

But cleaning the trash up one piece at a time whenever you go for a walk is nowhere near enough – every time it rains, trash from the B-W Parkway and elsewhere overflows and into our streams. We need to stop pollution at the source. Efforts to do

just that are already going on in our area.

Prince George's County is considering adopting a law that would impose a 5-cent fee on every plastic bag sold at grocery stores. This would greatly reduce the amount of plastic bags plaguing our woods and other special places, so I ask everyone to express support for this bill and others like it that aim to reduce waste (the first step in the reduce-reuse-recycle regime).

Such places of special value to us should be truly cared for and that goes beyond simply picking up a piece or two of trash on a walk or going to a Reel 'n Meal. Learning about issues and being personally responsible are important but the buck does not stop there. I encourage everyone to engage in the front line work that really makes change, because this democratic process is the foundation of our society and requires participation in order to work well.

Corrections, Clarifications

In last week's article "Good Fences Make Good Neighbors; Thanks to BARC" it was indicated that a December 16, 1981, article brought by Velma Kahn to the council-BARC stakeholder meeting was found in this paper's archives. It was not.

In the front page article on the Hillside Stream Restoration project the location was incorrectly identified – it flows between the Lakewood and Woodland Hills neighborhoods. The author is also concerned about a second clarification (in the subhead Pollutants Filtered on page 12) where it is unclear that there may – or may not – be an ongoing problem with fecal contamination in the stream – in fact there is no current way to know if that is true.

Assistant Planning Director Terri Hruby added that while the city did not complete any additional water testing they did contact WSSC, which did sewer leak detection, including water quality testing, in the Lakewood/Woodland Hills watershed. The results did not support the levels of fecal coliform that were found in the Greenbelt Lake Watershed Assessment. Hruby also clarified that current grant funding does not include money for follow-up water quality testing although it is something the city hopes to be able to do.

Sen. Cardin to Speak, Install Dems Officers

Obituaries

Charles Anthony Fuchs

Charles Anthony Fuchs was born September 23, 1927, in Flushing, N.Y., to Charles Albert Fuchs and Margaret Connors Fuchs and was raised in College Point, N.Y., with his brothers William and Richard. A graduate of St. Fidelis High School, he enlisted in the U.S. Navy at age 17 and served during World War II. Following his military service, he graduated from Fordham University (Class of 1951).



In January 1951 Charles' good friend, George Pradarits, convinced him to attend a dance at St. Stephens of Hungary Church (New York City) and set him up on a blind date with Magdalene Bauer – a beautiful, young Hungarian who also lived in College Point with her parents Anthony and Mary Bauer. Though the evening ended at a local White Castle, the romance was just beginning. On October 31, 1951, Charles and Magdalene began their 60-year marriage and moved to upstate New York where Charles worked at IBM.

Jacqueline (September 1952), Linda (July 1954) and Valerie (August 1957) were born while they lived in Woodstock and Poughkeepsie, New York. The family relocated to Ellicott City Maryland in 1957 so Charles could begin a new job at Westinghouse. The small home on Avoca Avenue soon had two additional family members – Charles (October 1958) and Janet (March 1960).

In the spring of 1962 Charles spotted a corner lot on Lakeside Drive in Greenbelt that he was convinced would be the ideal spot to raise his family. While the house was being constructed, Charles began his federal government career at the Goddard Space Flight Center. The Fuchs family home was completed just after the birth of Mark (December 1962) and has remained the focal point of family gatherings ever since. Karen (March 1968) is the last born of their seven children.

After approximately five years with NASA, Charles transferred to the Federal Aviation Administration in Washington, D.C., where he worked on such key initiatives as the Supersonic Transport (SST) project and the initial phases of the Air Traffic Controllers technology re-engineering before his retirement on December 31, 1987. The family continues to grow and Charles and Magdalene now have 17 grandchildren and 12 great-grandchildren.

In his younger years, Charles was an avid bowler and enjoyed an occasional round of golf. However, his biggest passions

throughout his life – outside of family – were a love of automobiles and gardening. He was proud of his well-manicured lawn, meticulously trimmed bushes and seasonal plantings that provided the balance of color. He was particularly proud when his home was recognized with the 1994 Prince George's County Beautification Award.

Charles died the evening of November 26, 2011, while surrounded by his children, grandchildren, great-grandchildren and wife Magdalene. Services were held at St. Hugh of Grenoble Catholic Church on November 30, 2011, with full military honors at his interment at Gate of Heaven Cemetery.

Br. James Sommers

Brother James Sommers, O.C.S.O., 89, of Holy Cross Abbey in Clarke County, Va., died peacefully on December 4, 2011, at Carroll Manor Nursing Home in Washington, D.C. Brother James was born James Joseph Sommers, Jr., on March 25, 1922, in Reading, Pa., the son of James Sommers, Sr., and Anna Nangle Sommers, the second of five brothers. His family moved to Greenbelt when he was a child. They were among the Greenbelt pioneer families.

After high school, James enlisted in the U.S. Army as an infantryman in 1942 and served in northern France and the Rhineland during World War II. Upon his honorable discharge from the Army he began work in 1946 in the U.S. Postal Service. Several years later he felt a call from God to enter religious life and in 1952 he asked admittance to Gethsemani Abbey in Kentucky as a Trappist Brother. He wrote at the time, "To devote my whole life to Christ, I feel the Trappist vocation is the answer."

When the monastery of Gethsemani made a new foundation in the Sacramento Valley

of California in 1956, Brother James was chosen to be a founding member. He served the community of New Clairvaux Abbey at Vina, Calif., for 11 years. He asked to return to the east coast in 1968 to be closer to his family and transferred to Holy Cross Abbey in Berryville, Va.

Are you ready for snow?

Winter is fast approaching and with it the need to prepare for snow. Clearing snow is a collaborative endeavor in Greenbelt Homes. Once four inches of snow have accumulated, GHI staff will start plowing, with top priority given to courts and serviceside walkways. When those have been cleared staff will plow gardenside and common walkways. For snowfalls of up to eight inches, GHI's goal is to clear all courts and primary sidewalks within 12 hours once snowfall has subsided.

Members are responsible for removing snow and ice from sidewalks within their yard boundaries, on both the gardenside and serviceside. On shared walkways between individual units, neighbors share responsibility. Please lend a helping hand to neighbors who may be physically or otherwise unable to clear sidewalks.

GHI members can help support snow removal efforts by not piling snow on any section of plowed streets or courts. Piling snow in these areas slows snow removal efforts, increases costs for all members, and creates a nuisance for other members or court visitors, including mail carriers. When clearing off cars please place snow toward the curb or common areas in the court.

Does Your GHI Home Have an Addition?

Insulation Phase Underway in Pilot Program

GHI has begun insulating each of the 28 pilot homes, the second of three phases of the pilot program to test alternatives for weatherizing townhomes and replacing electric baseboard heaters. In late October a contractor began crawl-space improvements, which are near completion. Next year, wall and attic insulation will be upgraded, and windows and doors will be replaced, which will conclude the program's second phase.

Phase 1, which is completed, involved placing measuring devices in each of the test homes to monitor temperature, humidity, and the kilowatt hours of electricity used by the home's heating system and major appliances. These data will be used as a baseline to measure energy savings and improvement in member comfort which likely will result from the upgrades now underway.

Phase 3 of the project will be the replacement of baseboard heating systems.

Members are encouraged to participate in Buildings Committee meetings, during which pilot program activities are discussed. The committee meets on the fourth Wednesday of each month in the Board Room of the GHI Administration Building.

I delivered the News Review for a few years, beginning in about 1955. I believe it was still called the Cooperator at that time. I began delivering when Joe O'Neil was the distribution manager, working out of his house in 16 Court Ridge Road every Thursday evening.

He found himself in need of a substitute carrier when one of his regulars was suddenly "unavailable" on a very snowy night. I was assigned a route near the intersection of Ridge Road and Plateau Place, an alien territory to me, a young kid from 11 Court Ridge. Add darkness and a heavy snowfall to the mix and I was soon totally disoriented. I muddled through, completing my route as assigned. I think I had frostbitten hands and feet by night's end. Jim must have been impressed, as I was instantly given a permanent route. That \$1 per week stipend came in very handy as the years went by. In a family of 10 children, there was no weekly "allowance" doled out to any of us. Some of my brothers also followed in my footsteps as carriers for the News Review.

I was reminded of those days while reading the story "News Review Begins Its 75th Year of Publication" in the issue of December 1. (I receive the paper in the U.S. mail on the Monday following publication. I know I can read it online but I prefer a paper printed on real newsprint.) My lifelong fondness for the publication was formed in those early days.

Thanks to the entire staff for their hard work and dedication to publish a vital link that bonds all Greenbelters, past and present.

parents," she says. "We're lucky that, in most cases, at least one person in the family speaks some English. But we do get help from the county with translators." And there's help closer to home – an intern in the guidance office, for example, speaks Chinese.

Frontanes is in her third year at Springhill Lake but already is in a leadership role as the current chair of the school's ESOL program. In that role she is the school's liaison with the county ESOL office.

"My team is wonderful," she says. "Being chair is much less stressful with their support and collaboration."

She comes early and leaves late on most schooldays to manage after-school programs. She is co-coordinator of "Reading Together," a peer-mentoring group that meets Mondays and Wednesdays an hour before school and an hour after school. She trains the young mentors, teaching fifth-graders how to tutor third-graders in the program.

On Tuesdays and Thursdays after school she coordinates the "Champions" program, in which intermediate-level ESOL students from first and fifth grades are tutored in grammar, writing and work on their reading skills in a book club.

It's a lot of extra hours for someone who drives daily from Waldorf – but for Frontanes, it's worth it. When asked what she likes best about her job, her eyes light up.

"I like a ton of things!" she says. Among them – "the 'aha' moments, when a student is struggling and finally gets it. I like knowing that students who don't have a lot of resources can come here and know they are supported."

"I like connecting with parents and being able to speak Spanish with them. It's a great advantage to speak the language."

Frontanes knew early that she wanted to teach Spanish, which

she spoke growing up with her Puerto Rican parents. But she felt she would be more effective at the high school level and earned a degree in secondary education at the University of Maryland. Then she obtained a master's degree in ESOL and "with some persuasion by my mentor," decided to take the plunge into elementary education.

It was a tough decision – she enjoyed relating to high schoolers – but it ultimately proved a good fit. Among other benefits, she praises the excellence of staff and the inclusive approach used at Springhill Lake, in which ESOL and special ed students are not pulled out from the regular classroom.

Recently she has nurtured another professional interest – traveling. This summer she flew to Tanzania.

"Africa gave me a real-life perspective about where some of our students come from," she said. "I can see why there is such a culture shock when they arrive here."

What's her next destination? "Spanish-speaking countries – and I'd love to go to El Salvador, because so many of our students have roots there."

Wherever Maria Frontanes travels in her life, one can be sure that she'll use the experience to enrich her students' learning and her school.

to enthusiastic applause.

Nugent’s creative approach comes naturally – at 7, she started a novel called *The Twins and I* (about an only child who moves next door to a family with three sets of twins) and says, “I still want to finish it!” She also has a passion for marine biology and chose that as an undergraduate major until she took a theater class, saw a show and was “mesmerized.” Her first main stage performance at the University of Maryland was *The Piano Lesson* by August Wilson and it persuaded even her family that she had chosen the right field.

“What drew me to theater is that every night I could step into a different time and space and become someone different in front of a different audience, with a different energy and vibe. I could live that moment on-stage,” she recalled.

After graduation, following an internship at Wolf Trap Foundation for the Performing Arts, she accepted a full-time position there as administrative assistant in the education department. “We sent performing arts into classrooms. It was great,” she said. “During the summer we had performances for kids of all ages, many of whom had never had a chance to see live performance.

“As I saw the kids coming in and out, I wanted to leave with them,” she said. “Eventually I decided to become a teacher and use all those things I learned at Wolf Trap in my own classroom.”

She also does special segments on marine biology, like a frog diorama in its habit and a three-legged race by students to illustrate how animals depend on each other.

After three years in the classroom (and two at SLES), Nugent loves teaching and especially second grade.

“These students are just at the cusp of independence and it’s a big honor helping them to grow into that independence,” she said. “In first grade, everything is very hands-on but by end of second grade, they have to be able to read, work on their own and learn to see the world through their own eyes,” she said.

“When I’m in the room with the kids, everything else falls away.”

This year Nugent is expanding the role of performing arts at SLES with a full-scale drama club in collaboration with music teachers and other staff. “We’ll be teaching students how to act, sing and dance, build props and the mechanics of performing on-stage with voice projection and stage presence,” she said.

She also assists with PTA activities, including “skate nights” and the annual spring talent show. Next spring, in addition, she will coordinate a full-scale theater production through the drama club at the school.

At the close of a recent school day, one girl exclaimed, “I want to stay with my teacher Miss Nugent!” After the second-graders had all left, five others strolled in to say hello.

“These are my students from last year,” she said, smiling. When asked how often they stop by, she said, “Every day.”



Supporters of Overturn “Citizens United” Meet

Two years ago a Supreme Court decision in Citizens United v. Federal Election Commission ruled that corporations are people, allowing corporate donations to political campaigns on the same basis as individual donors. This led to a call for a constitutional amendment to limit corporate involvement in the electoral process on the same basis as individuals.

A consortium of activist groups including Common Cause, People for the American Way and others has banded together to host house parties nationwide to build momentum for reversing the court decision. The goal is to focus attention on the issue and a legislative remedy at the two-year anniversary of the court decision on January 21.

In partnership with the Peace & Justice Coalition, a Greenbelt house party will be held in a private home on Thursday, December 15 from 7 to 9 p.m. to discuss strategies, goals and actions on a city, state and national level, including a proposed local resolution by council. There will be a discussion of Delegate Jamie Raskin's effort to introduce a resolution in the Maryland Legislature and attempts by Congress and the Senate to introduce a constitutional amendment to overturn the decision.

Buddy Attick Park Renovation Planned

The group picnic area at Buddy Attick Park is closed in order to do ground renovation work.

The natural systems of Greenbelt’s parks are beginning to fail, according to Lesley Riddle of Public Works. Park systems provide a continuous bio-habitat for a host of wildlife. Damage to the systems is already evident and will continue to occur without proper intervention, she added.

In specific areas the understory plantings have decreased, species decline is evident and areas of sediment run-off from the compacted soil flows freely into the lake.

Renovation will begin with mitigating sediment run-off in the group picnic area through placement of stone and natural plantings.

Closing the group picnic area is planned for the 2011-2012 winter/early spring seasons. There may be a need to temporarily relocate this area for the spring season, depending on weather and timing for the initial renovation effort.

B. Guy Addresses LEED at GCAN

The next Greenbelt Climate Action Network (GCAN) meeting will be on Wednesday, December 14 at 7 p.m. in Room 114 at the Greenbelt Community Center. The speaker will be Bradley Guy from Catholic University, who will describe a variety of green and community-based projects with a focus on small scale and use of reclaimed materials.

The second part of his presentation will be a discussion of the evolution of the LEED green building rating system and the other major green building standards and codes.

Guy is an assistant professor in the Master of Science in Sustainable Design program, School of Architecture and Planning at Catholic University; a consultant on green building, deconstruction and design for materials reuse; and design for adaptability and deconstruction of buildings.
